Už Trečią Partiją

Tymsterijos unijos suvažiavime jos prezidentas Daniel Tobin paskelė itin svarbią prakalbą apie trečiosios partijos galimybes. Jó kalba tuo reikšmingesnė, kad jis kalba varde daugiau negu 600 tūkstančių organizuotų tymsterių, kurie sudaro stipriausią organizaciją Amerikos Darbo Federacijos.

Kaip sakė Daniel Tobin San Francisco konvencijoje?

Pažymėjės, kad per ištisus dešimtmiečius būdamais tymsterijos unijos prezidentu, jis buvo nusistatęs prié trečiosios partijos idėja. Dabar jis nusitarė pakeisti savo nuomonę.

"Laikai keičiasi ir man tenka pakeisti savo nuomonę. Priemės Tafto-Hartley Akto gali priversti darbo žmones iš jų draugus sukurti trečią partiją... Jeigu visas darbininkų judėjimas susivienytu, tuomet pergelė būtų mums užtikrinta."

Daniel Tobin nor, kad Darbo Federacija susivienytu su CIO. Jis mano, kad tokios vienybės nori nuošimčiai organizuotu darbininkų.

Jei kame jis klysta tai tame, kad jis vienai vilti sudeda ant organinių vienybės ir nemato reikalaujant dabar, tučtuojuas, sudaryti politinį bendrą frontą. Argi sudarymas bendro fronto neuztikrintu pergalės ateinančiuose rinkimų?

D. Tobino posukis politinėj galvenosoj, nepaisant tylų nenuoseklumų, yra ženklas bendro karejimo Amerikos darbininkų miniose.

Už trečią partiją, tik stipresniu nuosakumui, pasiskuo ir R. J. Thomas, auto unijos darbininkų vadasis. Jis sakė: "Amerikos žmonėms reikia naujos politinės partijos ir jie nori naujos partijos. Tokia partija reikia sukurti dabar, kol reakcinių neuspėjė sunaikint mūsų demokratiją."

Toliaus jis pabrėžia: "Niekad nereikia pamiršti, kad Hartley-Tafto įstatymą sužinieriavo republikonų ir demokratų kombinacija. Amerikos žmonei mūsai abi partijos. Tikrai jau laikas atmūtu tas atakas. Mūsų kova bus tuo labiau efektyvė—ir mes tikrai laimėsime—juo greičiau bus sudarytas vieningas darbininkų frontas".

Néra abejonės, kad R. J. Thomas išreikšia nuomonę didželės didžiumos auto darbininkų unijos.

Jei visi žyminėsi darbo unijų vadai užimty kokią poziciją, kokiai užėmė R. J. Thomas ir dalinai D. Tobinas, istorijos girmos pradėti maliū smarkiai. Delsimai ir lükuriavimas nieko gero nežada.

Dar j vieną dalyką reikia atkreipti dėmes. Tuli unijų vadai, jų tarpe ir Tobinas, dar neįsilaisvinio iš ligos, kuriai varandas "raudomoji silke". Jie dar vis mekeina apie "raudonąjį pavoją". Si technika tik reakcijai naudinga. Si technika skalda, o ne vienija darbininkus.

Išgyvendinimas tos ligos yra būtiniausia salyga tolimesnio progreso ir eventualės vienybės visos organizuotu darbininkų klasės.

Senatorius O'Mahoney (Wyoming) saiko, kad automobilių industriją racionuoja auto produkciją. Plienų industriją racionuoja plieno produkciją. Žibalo kompanijos taip pat pradėjo racionavimą.

Kur valdžia? Valdžia ignoruoja, bet jie nieko nemato ir negirdi.

Didysis biznis tvarkosi savaip, norėdamas palaikti aukštą kainas.

Tom Clark neišdris paliesti aukso versiū.

Tai Bent Liudininkai

Gerharto Eislerio byloj pasirodė nepaprasty liudininkų, tokijų liudininkų, kurie norėdami įklampinti Eislerį, tik save įklampino.

Vienas iš ty liudininkų, Manning Johnson, papasakojo istoriją, kaip 1933 metų vasarą, Buffalo, N. Y., įvykęs slapsas komunistų susirinkimas, kuriamo dalyvavo Browderis, Eisleris ir du Kanados komunistų lyderiai Tim Buck ir Sam Carr.

Prokuroras džiaugėsi susekės baisią konspiraciją, kurioj dalyvavys ir "koministų agentas" Eisleris! Tačiaus tolimesnėje byloje eigoje greit paaškėjo, kad Tim Buck ir Sam Carr, tuo laiku, buvo kalėjime.

Kaipgi jie, būdami Kanados kalėjime, galėjo dalyvauti Buffalo konferencijoje? Visa Johnsono istorija subiliuso.

Jei taip, tai pati Johnsono reikėjo pamiršti pakopas už krevą priesaiką. Bet atsiraodė aniuolių sargu, kurie Johnsoną pamokino "pataisyti" savo liudinimams.

Dabar jis užgiedojo iš kitos kantiukos ir utarajo, kad į Buffalo buvo atvykės kitas Kanados komunistas, Steward Smith, kuris "vartoja Tim Buck'o vardą."

Steward Smith, pirmiau buvęs Toronto miesto tarybos nariu, pasiuntė teismui telegramą, kad jokio tokiu "Buffalo įvykusių konferencijos" jis nedalyvavo, kad Eisleris jis niekuomet nėra matęs ir niekad nėra matęs to tipo, kurio vardas Mainning Johnson!

Eislerio advokatas A. Isserman sarkastiškai pastebėjo: "Ar nebūtų žiopla, jei (Smith) pasirinktui vardą žymaus komunisto (Buck'o), esančio kalėjime?"

Valstybės kaltintojas, iš esmės, turėjo pripažinti, kad Johnsonas yra melagis!

Kita liudininkė prieš Eislerį yra Ruth Fischer, aklia trockeninkė, kuri savo neribotu "kairumu" pridarė tiek ir tiek žalos Vokietijos darbininkų judėjimui. Nereikiu net būt komunista, kad šlyktėtis jos haliucinacijom.

Bet štai socialistas Rosenfeld (jau miręs) ir jo žmona apie Eislerį labai gerai atsiliaupia, kaiapio nuoseklių ir išvertinę kovotojų prieš naciųmą.

Du Metai

Vakar suėjo du metai nuo Japonijos kapitaliacijos. Suėjo du metai nuo tos dienos, kada Hirohito paskelbė, jog jis vadovaujamas militarinis režimas pasiduoda.

Generolas MacArthur, faktiniasis Japonijos imperatorius, esas labai pasitenkinęs tuo, ko jis atsieki Japonijoje. Bet neseriaškia, kad Amerikos laidius yra pastenkinus. Japonijos stambioji buržuazija, Zaibatsu, nepaliesta. Japonijos viršinėnė viešpatėja turi patys šovinistinių galvalių. Tik mikroskopija dailelytė karos kriminalysti patraukta atsakomybė.

Pastaromis dienomis labai daug kalbama, kad su Japonija kuo greičiausia reikia daryti taiką. Prie taikos skubina ir Filipinų prezidentas Manuel Roxas, kurio rolopai japonų okupacijos metu daugiau negi jartina.

Matoma, kad MacArthuras užribuvavo visą mašiną. Jis ir jo artimiausi patarėjai nori separatiškai taikos. Tas nieko kito neseriaškia, kaip užastrinimą santykį su Tarybu Sajungai.

Visi MacArthuro planai ir "reformos" pagrįsti ta pamatinė mintim, kad Japonija turi būti naudingas įrankis būsimoje ekspansijoje Pacifiko plotuose.

Vakar Valstybės Sekretorius Marshall išskrido Rio de Janeiro.

Tuoj į Rio de Janeiro išskris senatorius Vandenbergas, Warren Austin ir generalas Carter.

Visi jie dalyvauja Pan-Amerikos valstybių konferencijoje ir tarsis dėl Vakarų Hemisfero apsispinklavimo.

Rio de Janeiro konferencijoje gali įvykti daug bloga. Daugiau jai dėmesio!

"Priesaika" judyje matai, kaip tarybų liudis sudėjo pažadus atstatyti sugriaudą žalį ir apginti ją laike nacių užpuolimo.

Motina—moteris, netekusi vyro ir sūnaus, neįpuolė despacijon, o kovojo iki pergalės. Ten nesimato išdumo, o vien spindi nuoši-dumas.

Tiesa, reikia daug akilumo, kad pasekti tą judi, nes jame bandoma atvaizduoti ilgas perijodas šalies gyvenimo, t. y., nuo Lenino mirties iki šių dienų ikyvkių. Kitais žodžiais nuo to laiko, kuo met J. Stalinas paėmė Tarybų Sajungos vadovybę iš savo rankų.

Patariniai pamatyti tą judi ir suprasti, kodėl Tarybų Sajungoje sugriaudatos šalies atbūdavojimais eina taip sparčiai.

Birželio 15 d., "Tribune" troko vairuotojas Lawrence Visoski, 2304 N. Avers ave., važiuodamas su troku įvažiavo į Carl Besich automobili, ties Clark ir Archer ave. Tos nelaimės pasekinėje buvo užmušta Miss Lovraine Kruegar, 919 W. 31 st. Jos minėtine reikalauja už jos mirti \$10,000, o Carl Besich, 630 W. 30 st., reikalauja už sužeidimą \$25,000.

Viso reikalaujama iš "Tribune" ir jo troko vairuotojo \$35,000.

Kalniniame sako, kad valuotojas nesilaikė jokių važiuotės taisyklės ir už tai vykdyti tojį nelaimė.

Liths Back Lash At UnAmerican Group

**Former Vice-President
Of U.S. Says It's
Time To Strike Back**

Lithuanian-American progressives backed Henry Wallace's "contempt" lashout at House unAmerican activities. He urged that the time had come to "strike back" at those who are whipping up hysteria and "thought control."

Wallace's denunciation of the committee and of President Truman's loyalty purge came in an editorial in the New Republic magazine, which he edits. He warned that continuation of these policies "will give us a police state here."

The U.S., he said, is becoming increasingly a government "of, by and for great corporations" which are misusing the powers of the Bill of Rights and the 13th, 14th and 15th amendments which were designed to protect human rights.

Among other illustrations of the current assault on civil liberties, Wallace listed the incident of a government worker who received written notice that he was being discharged.

"It states in the first paragraph that the reasons for dismissal are confidential. In the second paragraph it advises him that he is given five days to answer the charges which they won't disclose," Wallace said.

Another government worker, he said, was fired merely because he had failed to criticize the Soviet Union and an employee in a private concern was dismissed for having a copy of a Wallace speech on his desk.

"Human rights," Wallace said, "are more in peril in the U.S. today than at any time since the Civil War." Truman's loyalty order, which he described as "the domestic equivalent of the Truman doctrine" since both are designed to stop communism, will not succeed, he said, "without negating democracy."


Wallace accused the Thomas unAmerican activities committee of using "unAmerican witnesses in its fear-breeding campaign" and said that "although I respect Congress as a democratic institution, I have only contempt for the Thomas committee and its predecessors."

The former Vice President hit at the use of "congressional immunity" for the issuing of "slanderous statements" and congressionally inspired red-baiting in executive branches of government. Such acts, he said, are "too dangerous to lib-

STOCKHOLM, Sweden.—The afternoon newspaper *Expressen* linked the reported activities of so-called Estonian government-in-exile with the uncovering recently by Swedish state police of a suspected international spy ring, backed by U.S. groups.

Expressen declared it had learned about operations of the Estonians in Stockholm. Financial backing for the group comes from right-wing Estonian organizations and private citizens in the United States, the newspaper said.

Important functionaries who have the job of denazifying pro-Hitler element and alleviating economic conditions in Bavaria through an intensified work program, comes on the heels of a report received by Vilnius English Section last month revealing the capture of a Lithuanian murderer and blackmarketeer together with several other culprits who since have been turned over to Lithuanian authorities for trial.

Main aim of Lithuanian refugees in Germany and Austria at present is to secure travel rights to the United States, many of whom have already been granted this privilege.

The background of these persons has not been sifted with the result that their arrival in this country stiffens an already organized pro-nazi movement.

PLOT OF LITHUANIAN REACTIONARIES IS PROGRAM THAT CALLS FOR WAR THROUGH DISTORTION AND DECEIT

Phony Lithuanian newspaper editors and other element have written and spoken of the "tragedy of the veto" in the United Nations.

Behind this hocus-pocus distorted series of "explanations" is a powerful drive to deceive Lithuanian-Americans as to what is actually going in the UN.

It is also aimed at weakening or abolishing the veto in the UN, preliminary either to wrecking that organization or to turning it into the opposite of what it was intended to be—an instrument of peaceful collaboration of big powers.

The veto as it has been used by the Soviet Union has been an instrument of democracy, a weapon to help the forces of democracy throughout the world.

To anyone whose knowledge of the UN veto is confined to the utterly false and misleading headlines in the newspapers, this statement will come as a complete surprise. Yet it is the truth.

One has merely to look at the record.

The veto was established when the UN was founded at San Francisco. It was the United States which especially insisted on it, and correctly so.

The idea was that if every big power had a veto this would compel the big powers to arrive at mutually agreeable solutions to all questions. No one power or group of powers could gang up against anybody else. All would have to agree. This would force each power to make some concessions and compromises for a generally agreed-on, unanimous solution.

Thus, peace would be protected and strengthened.

But, cry the newspapers and Lithuanian reactionaries simultaneously with Washington officials, the veto has been "abused". The Soviet Union has used it 10 times within the past two years, they complain bitterly.

Yet, they carefully refrain from giving the ISSUES over which the Soviet Union used its veto.

If they did this, they would reveal that it is they who have been scheming to help the anti-democratic forces, while the Soviet Union has been consistently on the democratic side, including the democratic forces within the USA itself.

Here's the proof, taken from the record:

Veto 1. The Soviet Union tried to get the UN to help the peoples of Le-

banon and Syria. It urged that the UN intervene to get the French and British troops out of these lands. The other powers refused. The Soviet Union vetoed the phony milk-and-water resolution which left the outside troops there. It was fighting for the democratic independence of these countries.

Veto 2. The Soviet Union urged an immediate break with the bloody, fascist tyranny of Franco Spain. The other power hedged. They wanted a namby-pamby resolution which meant nothing in practice. The Soviet Union vetoed it. It was fighting to help the Spanish people win democracy.

Veto 3-5. All these vetoes were also on the Spanish issue. They were aimed at keeping the Spanish issue alive before the UN's Security Council, while the other powers, including our own American delegation, tried to soft-soap the fight against Spanish fascism.

Veto 6. The Soviet Union vetoed the applications of Ireland, Portugal and Transjordan—all powers with reactionary governments, the first two giving no help to the Allies ag-

ainst the Axis, and the latter a puppet. This came after the other powers refused admittance to Albania and Outer Mongolia. Another veto, together with France, was used to settle an intricate legal issue in this.

Veto 8. Russia vetoed U. S. request for commission to investigate Greek "border incidents" after Ukraine informed UN Greek Government's policies in Balkans threaten world peace. Soviet position was that Greek Government is fascist-monarchist, a fact known by the world, and that all Greek aid should come through UN, not USA alone.

Veto 9. Vetoed plan to blame Albania in dispute with Britain.

Veto 10. Vetoed scheme to whitewash Greek fascists through semi-permanent Balkan investigation of new democracies there.

This is a record of defense of democratic forces. Anyone can see that.

It is those in Washington who are acting as defenders of fascists, kings and police states, like Spain, Greece and Turkey, who should stand before the bar of American opinion.

after their B-29 was shot down in a raid on Kobe. Swordsmen hacked at their heads and then shot them.

Our business in Kobe at the time was to garner evidence relevant to such matters, and often we wondered considering the attitude of high American authorities whether any of the real criminals, Japanese in high places would ever be tried.

Figures Show Tax Break U. S. Gave Corporations

WASHINGTON (FP) — Exactly how much of a break U.S. corporations got during the first full fiscal year since World War II was spelled out in a tax collection statement issued by the Treasury Dept.

While business and profits boomed in the fiscal year 1947 (July 1, 1946 through June 30, 1947) corporation taxes went down to \$9.6 billion from the 1946 level of \$12.4 billion. A drop in the excess profits tax brought about the big difference, going from \$7.8 billion in 1946 down to \$3.5 billion in 1947.

The individual income tax gatherers took slightly more the first full peacetime year than they did in 1946, and also increased their take from excise taxes on consumer items, to which the low-income groups give as freely as the rich.

While every other major item in the tax picture rose between 1946 and 1947, the slash in the excess profits levy was enough to bring an overall drop of \$1.6 billion in Treasury receipts.

• Many controversial articles have been written in our (the Lith-American) press since the time when Mr. V. Bovinas, with his initial article, touched off the cob-webs of inactivity or semi-activity in our progressive organizations. Mainly those articles were written in the spirit of "LMS vs. LDS"; "Sports vs. Menas;" "Youth vs. Grownups."

• Some of those articles, written either by "youth" or the so-called "old fogies" appeared to be objective—endeavoring to prove one or more points with a certain degree of success, while other articles missed the point or were ad hominem arguments.

In the articles that are merely missing the point, something is proven but not precisely that which is being argued. One may try to prove the utility of sports, and in doing so, might assume that he had shown the necessity for every Lith-American and his child to become a bowler; others might say that unless all members of our progressive organizations are bitten by a golf bug the organizations will go to pot from stagnation of inactivity and, should anyone disagree with that argument, he would be taken for an "old fogey."

• On the other side of the fence, some may argue that if you ever stain your hands with a bowling ball or a golf club, you are irretrievably lost to the Lith-American progressive movement, etc.

• As to the ad hominem phase of the arguments, it is another form of missing the point. These arguments are against the opponent instead of against his or her reasons. To call an opponent a moron or other choice adjective, or even to appeal to emotion or prejudice, may be "good" debating but is never good reasoning. Assuming that such arguments are trying to bring out the truth, they are wont to take every advantage, even to the extent of opponent's character. If the opponent fails to prove an argument, they assume that it is disproved. But in reality it is merely not proved. To argue that all those who are trying to keep up the Lithuanian Language, traditions and culture alive are either "old fogies" or smacks of "Bakuzė Samanota" is not proving anything any more than to argue that all those who endeavor in sports are "Morons."

• If we mentioned "Bakuzė Samanota" objectively, we must have more than just the imagination or even a clear picture of a hut with a mossy roof; we must know that in those huts not only our parents (some of them) were born; we must know that the Lithuanian Bards were also born there. And those Bards with their "Kanklės," songs, and legends kept the Lithuanian language, traditions, art and culture alive throughout the centuries, regardless of suppression and persecution by Crusaders or the Czars of Russia.

• It is not this writer's purpose to delve deeper into the History of Lithuania and recount the plight of those born in "Bakuzė Samanota." Nor is my purpose to describe the traditional Lithuanian arts, culture or sports. It is necessary only to mention at this time that our cousins in Lithuania, after conquering insurmountable hardships of suppression, persecution and wars are now replacing their "Bakuzė Samanotas" with modern dwelling places. The typical Lithuanian traditions, language, arts and culture as well as sports go hand in hand at present. And they got that way not by arguing which is more important — sports or culture — but all put their shoulders to the wheel. All work toward the happier and free-er life.

• We, here in America, sometimes hear some Lith-American people say: "All I've seen of Lithuanian theatre here is amateurish and even absurd; therefore it is stupid to even talk about the Lithuanian culture." True, we cannot fairly say that any quality of Lithuanian culture belongs to the LMS groups because it is characteristic of a few individuals in those groups.

• The LMS, as a whole, does not necessarily truly represent the typical Lithuanian arts and culture. It is true that the Lithuanian drama, as presented by the amateur Lith-American actors is amateurish. The distinguishing attribute or quality of a term should be its difference as compared to the Lithuanian drama now flourishing in Lithuania or to the American drama as drama presented by professional actors.

• If we were to define the Lithuanian drama as presented in Lithuania by professional actors, we would

• HOLLYWOOD (FP) — Here's Morgan, doing business at the same old stand: we used to start laughing at the first sound of those words before the war, and during the past year the whole country has been let in on the delight of this excellent satirist, who was known to only a few in the past. Now the movies as well as the radio will have Henry Morgan: he has signed with Screenplays Inc., new company headed by Stanley Kramer and George Glass, to star in *So This Is New York*, from Ring Lardner's *Big Town* . . . We're laughing already. . . .

• Another notable addition to the screen's attractions is Gian-Carlo Menotti, the successful composer of opera for Broadway, who has been handed a writer-composer-director ticket by MGM . . . From France comes word that there will be a full-length biographical film of the late great Raimu. Clips from his best-known pictures (*The Baker's Wife*, *The Well-Digger's Daughter*, etc.) will be assembled with unreleased footage made for these and other films, as well as individual episodes of his life shot before his death with the idea of a screen biography some day. It will be a precious relic for the movies' historical archives. . . .

• The main Hollywood story, however, is from the stage rather than the screen. Charles Laughton in the Coronet Theater's production of Bertolt Brecht's *Galileo* (staged by Joseph Losey, with music by Hans Eisler) is the talk of the town out here, and thoroughly deserves it. A great epic play about the world-shaking struggle against the forces of darkness, this magnificent production which recap-

tures the charm and quality of the 16th-17th century theater will get a Broadway production. Filming is unlikely, however (in this country, at least) because of the unfavorable light in which the Catholic church is shown. Laughton gives the greatest and most restrained performance of his career and is admirably supported by Hugo Haas and Peter Brocco, standing out in a fine cast of 50. What a movie it would make, if that were possible! . . .

Bob Mitchum, on completion of Steinbeck's *Red Pony*, joins Loretta Young and Bill Holden in Howard Fast's *Rachel*, which was scripted by Waldo Salt. Exterior shooting starts shortly in Oregon under Norman Foster's direction . . .

• Currently running in New York, and considered one of the top shows, is the musical—*"Finians' Rainbow."* This production was hailed by the press as a fine modern, socially significant musical. So when the curtain went up on an almost bare stage, depicting a lonely scarred tree set in a rocky terrain, and actors both Negro and white gathered around and sang about their life as sharecroppers, my thought went back 10 years when I last saw socially significant drama on Broadway: "Pins and Needles," "Awake and Sing" and "Waiting for Lefty" were making long successful runs. I was ready to believe the papers. But it turned out to be another burlesque.

• A meddling old Irishman, his pretty daughter, and a very sad Leprechaun arrive on the scene, and from here on in we get a conglomeration of fantasy, pots of gold at every rainbow and one pretty fair melody, "How are Things in Glocca Marra." Once or twice the author strikes out at race prejudice. Two colored and two white children romp about the stage, asking pertinent questions, but carefully avoid touching each other.

• In the end, it's the Leprechaun who wishes upon the pot of gold and turns the barren Rainbow Valley into a rich tobacco land and fills the sharecroppers pockets with money. And the local hero stays home to marry the Irish gal and run the plantation, instead of going off on a union-organizing tour for the Merchant Marine as he intended to do in Act I. So . . . now we quietly sit back and let the Leprechauns do the work for us.

• *Notes at Random:* I see that little Iceland is the Artists' Utopia. The government pays regular salaries to its outstanding painters, sculptors, writers and composers, and grants stipends to others. Fines levied for violations of the liquor law go to a Cultural Fund . . .

• At least one individual is convinced that a World Museum will have more power towards peaceful relationships than the Atom Bomb. He believes that all nations have a common bond in Arts and Crafts, so he's starting a 50 acre World Museum project in Upstate New York where some 60 nations can exhibit and work at the Arts . . .

• The "Anniversary Song" has been kicking around for years under the title "Danube Waves," an old gypsy melody by Ivanoci . . .

CALLING EM' STRAIGHT

• The other day Bill Veeck, boss of the Cleveland Indians, declared that Jackie Robinson and Larry Doby might set the same example for the Negro in organized baseball that Joe Louis has done for him in boxing. He said that for many years white scrapers alone held heavyweight championships. "Then Louis proved," Veeck said, "that a colored boxer could reach the top of the toughest class of them all."

• Veeck was quick to sign up Doby after Dodger proxy Branch Rickey had pioneered the debut of organized baseball's first Negro player—Jackie Robinson. Veeck, though, has not real conception of how and why Negro athletes today have partially overcome Jimcrow's batters.

• Joe Louis' ring genius actually played but a tiny part in his rise to the heavyweight pinnacle. Sounds crazy. But it's clear—if you think about it.

• Louis happened to be born at exactly the right time. Had he been born 56 years previous he could never have been champion. Even had he been born 36 years earlier he probably wouldn't have made it.

• John L. Sullivan was born 56 years earlier than Joe. He was the most renowned of heavyweight champions. Sullivan, though, would never give a Negro a chance to win his title.

• A Negro was not given an opportunity to win the heavyweight laurels until nearly 20 years after John L. retired. Then, in 1908, Jack Johnson was the first colored man to become champion of the world. To become such he chased Tommy Burns half way around the world for two years. Tommy was cornered and whipped in Australia. Later Johnson was persecuted and befevilled—even imprisoned—for the courage and skill that enabled him to climb to the top.

• Heeding the wily promoter, Tex Rickard, Jack Dempsey drew the "color line" when he became champion. Tex and Jack wouldn't give Harry Wills a shot at the title during the alleged "Golden Era of Sports." Wills, a Negro, was the outstanding logical contender for a Dempsey fight.

• Wills was young enough to remember the hysterical "white hope" craze that followed Johnson's defeat of the white fighter, Jeffries. Benighted white folk throughout the country organized "white hope" tournaments. They hoped to uncover a young white fighter who would whip Johnson, restore "white supremacy" to pugilism.

• Wills, though, had never heard of a "black hope" tournament to produce a colored man to whip Dempsey. There wasn't any such stuff.

• During the "Golden Era" and the years behind it, racial opposition to Negroes was almost countrywide. The Negro was lampooned on the stage, comic papers, in popular songs. A "good" Negro was one who "knew his place." He had practically no place, not even standing room, in sports.

• Only the labor unions and scattered liberals, black and white, fought wholesale injustice toward the

great Negro population. They fought untiringly and well, though. Just as Joe Louis does in the ring. They bled, suffered jail terms, yes, died fighting during those years.

• Louis began fighting in 1932. That was the beginning of Franklin D. Roosevelt's first term. Joe won the heavyweight crown in 1937, about the time FDR set up his fair employment practices machinery demanding equal opportunity for Negroes in the workaday world.



• These were the years bringing forth the first fruits of equal recognition for the Negro in sports and elsewhere. They marked the first closing of the 30-year gap of white intolerance toward Negroes in boxing, from Jack Johnson to Joe Louis.

• For Veeck's information: It took a heap of fighting and suffering amongst fairminded Americans to win for the Louises and Robinsons the recognition of a CHANCE to get to the top.

• It has been a fight to be proud of, worth remembering while not forgetting that it hasn't yet been won by a long shot.

see that the Lithuanian drama is very much on the par or sometimes even surpassing that of America.

• A drama critic discussing Lithuanian drama might find it convenient to mention Dauguvietis of Lithuania. But in classification of Lith-American drama one must look at P. Grabauskas, J. Lazauskas, J. Judzenas, who sometimes endeavor to share the qualities of both the Lithuanian and American actors. To classify the drama further, the above mentioned players could be divided into three classes: expert players (actors), mediocre players and poor players. We have a right to expect Mr. Dauguvietis of Lithuania to be expert as that is his profession—he makes his living from it. But what about the players in the Lith-American drama? What can we expect of them when we know that they work at least 8 hours a day being just plain working people at the factory or business institution? Most time they can devote to thespian arts are mostly between 30 to 20 hours of actual preparation for a three-act play. That perhaps would be enough for Mr. Dauguvietis but it will be short of miracle if in that short period of preparation some of the Lith-Americans could turn out to be in the class of mediocre players. Even then, if they are good in characterization of a certain role, it does not imbue us to believe that they are good actors.

• So much for the thespis, which was chosen from the LMS groups as diagnostic or distinguishing in characteristics which identifies it with the LMS groups.

• Among distinguishing characteristics of the LDS is its sports activity. In sports there are also players who can be classified as experts, mediocre or poor players. And here, again, we see that the Lith-American players—be it in drama or sports—can only hope to achieve the mediocre class at best. Why, then must we have sports or the so-called culture imposed upon us?

• No reason whatsoever. We can let the cob-webs of inactivity accumulate in our organizations to the point where we will be entangled by them and go into sweet slumber, forgetting entirely that we are progressives and that we are Lith-Americans.

Employment Service

QUESTIONS AND ANSWERS ON SERVICE TO VETERANS

This is another in a series of questions and answers regarding the rights of ex-servicemen and their families, as answered by the Veterans Division, Illinois State Employment Service, 817 Exchange Ave. For further information contact that division. In this series, the ISES attempts to answer questions most frequently asked by ex-servicemen and women.

Question: My wife is in England and I desire to utilize my educational privileges under the GI Bill in attending Oxford University. Is this possible?

Answer: Yes. Many students are attending colleges and universities in various foreign countries under the GI Bill. For further information, address your request to the Veterans Administration, Vocational Rehabilitation and Education Department, Central Office, Washington, D. C.

Question: How long after discharge does a veteran have in which to file a claim for Servicemen's Readjustment Allowance?

Answer: A veteran may file a claim for Readjustment Allowance any time within two years after discharge from military or naval service, or two years after the end of the war, whichever is later.

Question: I am a veteran and would like to get a Civil Service position in a foreign country, but I do not know where to go for this information. Can you advise me what would be the quickest way of finding out opportunities in this field?

Answer: Your nearest Illinois State Employment Service office will be able to tell you of many such openings and also advise you as to how

"Communist" Is Freed Pending Appeal Action

WASHINGTON(FP)—Overruling Justice Richond Keech, the U. S. Court of Appeals has freed Carl Marzani, former State department employee, on \$5,000 bond pending action on his appeal from conviction before Keech on charges of denigrating he was a Communist.

Marzani was sentenced to serve 1 to 3 years for making the denial when questioned by security officers. He served both the State department and the Office of Strategic Services overseas during the war and won high commendation for his work.

The case against Marzani came long after he left federal employment.

you can apply for them, as well as the general requirements of these jobs.

Question: I was blinded in both eyes during service, but I want to go to college, although I know it will be difficult if I do not have someone to read material for me. Is there any way I can get a reader for my school work?

Answer: Yes. A reader service now is being provided by the Veterans Administration for blinded war veterans to permit them to attend school by having study material read to them. Those eligible for this service include all enrollees in school under the Veterans Rehabilitation Act and you should contact your VA for further details on how to receive this material.

• As progressives we are still conscious that we don't like to be living in "Bakuzes Samanotas" or in the Hoovervilles, for that matter; as Lith-Americans we assume the responsibility of retaining the Lith-American characteristics in our progressive organizations.

• As Lith-American progressives we have a purpose to organize other Lith-Americans into our organizations, whose goal is economic security as well as preservation of the traditions inherited from our parents or forefathers. They look upon us with the hope that we hold sacred our heredity and be able and willing to maintain the organizations left us by them.

• Our groups in the LMS as well as in the LDS are striving for that purpose. As humans we are bound to make mistakes in choosing the means by which to reach our goal—some may think that sports is the sole means by which to arouse masses—others take to art and culture. Still others think both are necessary. After trial and error we discover the best means. And the merits and demerits of each means should be discussed at our meetings and the solution arrived at should be put into practice immediately.

• The LMS and LDS should never be versus one another, but should work together and, if there is ever discovered that the certain activity does not seem to serve the purpose of organizing, we should try to discover what is wrong and, in co-operative spirit, remedy it.

• By individual or group prejudices we may come to careless conclusions, may make mistakes of serious consequences that may impair the progressive Lith-American movement. Collective discussions of our problems, co-operative spirit, and team-work of all our progressive organizations should be of constant importance to all of us.

• Let the boys who bear swastika of hatred and prejudice in their hearts—the ones whom we commonly call fascists—sow dissension among themselves; let them preach and practice hatred and drown themselves in that sea of hatred...

As progressives, we would do well to adopt as our slogan the phrase uttered by William Blake, who once said: "Great things are done when men and mountains meet; this is not done by jostling in the street."

INDIANAPOLIS — (FP) — More than 20 Indiana labor publications, both AFL and CIO, have defied the Taft-Hartley law provision prohibiting editorial comment on political candidate and office holders by union newspapers, CIO regional headquarters announced here.
