


IN A QUEST FOR NATIONAL SURVIVAL

An address given at the K. of L. Convention by Dr. J. J. Bielskis, Lithuanian Consul at Los Angeles, California, August 10, 1957

Many years have elapsed since my previous appearance before the Knights of Lithuania National Convention. I had the honor some 38 years ago of having been elected president of this lively organization. However, the time in that exalted position was cut short by national exigencies. I had to lead a group of militaries to Lithuania in an effort to strengthen the defenses of that young Republic. In my absence, the leadership of the organization was taken over by the vice president.

Although involved in complicated national affairs, nevertheless I followed with interest and admiration the glorious activities of the Knights of Lithuania. There were many members of the organization in important posts in the national struggle for the restoration of an independent State. They have distinguished themselves in their assignments and I consider it an honor to have had the privilege in collaborating with them. generalities of that problem. I merely wish to emphasize the particular points, the fundamentals and most essential parts of it. I am convinced that, after due consideration, you will concur with me that at this time the problem of the national survival is the most important to everyone of Lithuanian descent.

We all are fairly well acquainted with the recorded history of the repeated attempts of unfriendly neighbors to destroy the Lithuanian nation. They have used every means conceivable to them to attain their purpose, that is, to distort the Lithuanian proud history, valued language, inreference traditions, enlightening customs and high national culture, and to relegate them to oblivion. Those efforts of envious and greedy neighbors now have assumed more drastic and more deproportions. structive forms and by devious Besides suppressing means the language, religion and the love of the native country, they now are destroying the national leaders, tearing apart the families and scatttering them throughout the Siberian wilderness. Our youth is being deported into the depths of Russia and subjected to communistic and atheistic indoctrinations and russification. The invaders and occupants of Lithuania obviously are determined to make their genocidal efforts definitely effective.



However, knowing the past struggles and resistance of the Lithuanian nation, we believe that the present designs of the enemy are also bound to failure. I say we believe, yes, but it is up to all of us descendents of that old and great nation to make certain that those destructive processes will fail!

I am always glad to meet Americans, descendents of Irish, German, French or of other great nations. It is refreshing to note that although generations were born here, nevertheless they proudly admit their origin. They usually are acquainted with the history, traditions, culture of their old nation, and thereby they are better Americans. The knowledge of your own historic ancestry is of great psychological and moral value. It is uplifting to the morale in knowing that one has descended from a cultured nation which has to a large measure contributed to the creation of this great country of the United States. That knowledges strengthens their pride, brightens their vision and stimulates their enthusiasm! Judge Charles E. Wyzanski of the United States District Court of Massachusetts, speaking to a group of editorial writers, remarked: "Turning to our origins nourishes those emotions which make us receptive to spiritual influences." The

As the Knights of Lithuania organization has done in the past, I am confident that it has now also placed the question of the situation of Lithuania high on the agenda of this Convention. It is not my intention to preach or dogmatize on that subject, there is no need for that; all of you are familiar with the

late Supreme Court Justice Louis D. Brandeis, speaking to a gathering of Jewish leaders, asserted that: "To be good Americans, we must be better Jews." Now, emulating the eminent Jurist, I must state that, to be good Americans we must first be better Lithuanians! Loyalty to our own ancestors enhances the loyalty to the United States!

We are justly proud in frankly admitting that we are offsprings of the Lithuanian nation. Obviously, centuries of relentless efforts of the hostile neighbors have tarnished some of the great events and cultural achievements of the historic past of Lithuanian and its great independent State. Some sinister neighboring writers have deliberately minimized the importance of the Lithuanian role in the family of free nations. However, there are sufficient records of impartial writers and historians revealing the facts and showing the unusual virility and ability of that nation to organize, manage and defend an independent State.

Situated like on an island in a turbulent ocean, for centuries they were able to withstand the stormy siege and have safeguarded what has always been dear to them: national survival, freedom and independence. The historians give full credit to Lithuanians for saving the Western civilization from the onsloughts of the asiatic hords.

The philologists and other scholars express themselves with amazement that, inspite of all the impediments the Lithuanian nation has succeeded in preserving its ancient language. Being surrounded by Teutonic, Slavic and Scandinavian tribes and nations, and being entirely unrelated to them, and linguistically totally distinct from all of them, yet it has retained its identity as an original branch of the Indo-European language.

Our ancient dainos and raudos (folksongs and dirges or lamentations) depict the profound mentality, philosophy, customs and high culture of our ancestors. This, of course, is not our own boasting, but it is the considered conclusion of the writers and scholars of other great nations. Among the literary greats of Germany, evaluating the Lithuanian language was G. E. Lessing, who in 1759, in his "Literary Letters", wrote as follows: "I came upon some precious rarities which gave me no end of delight. These were the Lithuanian dainos or folksongs. What naive pleasantries. What charming simplicity. The frequent use of diminutives give extreme grace to the language of these songs."

Another literary great, J. C. Herder, in his work on "Voices of Nations in Songs", published in 1778, included a number of Lithuanian dainos and spoke of them in eloquent manner.

Perhaps one of the greatest of the greats in literature, Johann Wolfgang Goethe, in 1780 included some of the dainos in his writings and showed much interest and enthusiasm for the Lithuanian language.

In 1825 L. J. Rhesa had 85 dainos in his book. He wrote of them admiringly and stated that "folk poetry reveals to us a rich treasure, by means of which we may study the human spirit, be it on the shores of Greece or on the banks of the Nemunas." Rhesa also pointed out that numerous diminutives in the Lithuanian languages frequently denote exaltedness and ecstasy.

In 1745 Philip Ruhig included a number of dainos in his book entitled "Reflections of the Lithuania Language." His son Paul wrote the "Fundamentals of a Lithuanian Grammar."

As early as the nineteenth century, Wulfstan recorded in the of Lithuanian customs. It is desired that such a tender respect for the basic human relations, and such a purity of love as expressed in them, might also be found among most cultured nations everywhere."

It is said that some of the outstanding composers, such as Schumann, Chopin, Schubert and others have composed music to some of our dainos.

Another prominent writer stated: "The enthusiasm for the Lithuanian dainos among poets of other nations has remained constant. The dainos constituted a cultural monument of that nation." Still another luminary wrote: "The richest cultural heritage of the Lithuanian people is the dainos. Many variations of these peasant songs were sung thousands of years ago."

Of course, our own greats, such as Prof. Mykolas Biržiška, the late Dr. Jonas Basanavičius and others have also written much about that.

These are the documented conclusions of some of the world's literary greats in regard to the scholarly importance of the Lithuanian language and ancient culture. The unbiased and unprejudiced history of Lithuania, such as written by Prof. Henrik Paszkiewicz, Dr. V. Sruogiene and other historians, is replete with valuable information about the high culture of that nation. We can always be justly proud of being its descendents. That is our precious heritage. However, being proud of it is not enough. Our ancestors worked and fought to preserve that heritage and to pass it on to us. Now it is our sacred duty to continue that task, to safeguard the language and everything Lithuanian!

Our diplomatic and consular corps, as well as political organizations are working for the restoration of an independent Lithuanian nation. Because a nation without its own States is like a body without a heart. By the same token a State without a consolidated nation is one without a strong foundation. Therefore, now it is for us, each and everyone of us, to work, safeguard and preserve the Lithuanian national entity, integrity and unity, and proudly to pass it on to the future generations to carry on. That is the call of the national spirit and we should respect it with eagerness and sponteneity!

Our own famous philosopher Immanuel Kant wrote about the Lithuanian language with profound understanding and great admiration. Prof. Alfred Senn, the late prof. Harold Bender and many other well known philologists and scholars described in their books the scientific value and importance of that language in the research and study of the origin and migration of mankind.

Krause, in his book published in 1834, in part writes as follows: "The charming thoughts and keen sensitiveness are characteristics of the Lithuanian dainos. They possess a tenderness of sentiment all their own, a great cordiality of feeling for ties of family and fatherland. The beautifully landscaped homes of various Movie stars and other well-to-do people of Beverly Hills was also a major point of interest including the drive along Sunset Boulevard.

The following day, we planned two activities for our delegates and guests, namely: First, the Golf Tournament; second, TV program "Queen for a Day". There were hopes that one of our fairer K. of L'ers would be chosen Queen for a Day, but no such good fortune.

The post-convention activities started with a tour to Knott's Berry Farm — Ghost Town of the Wild West. Here one saw the town's general store, cracker barrels, candy jars, women's calico dresses, bonnets and all. A town of the Wild West would not be complete without the Essay Office with its large ledger of stakes for gold mining claims and various mineral rocks scattered around the dusty shelves, numerous saloons with their polished brass foot rails, and village church of Transfiguration, one of the highlights of the historic place. One building is entirely devoted to old musical instruments, some of which are over two hundred years old. The main purpose of this en-

From a little country side cafe to the present million-dollar institution was the accomplished dream of this fine family of just a few decades ago.

From there we continued on to Disneyland, a fairyland in reality. Disneyland originally was constructed for children, but it is now and adult attraction of national renown. To describe it in detail would be impossible. We were only able to enjoy part of "Alice in Wonderland", "Jungle Land", "Adventureland", "Frontierland", "Tomorrowland" and Fantasyland" due to lack of time. Inasmuch as our committee was organized in 1955 in accordance with the resolution passed at the National Convention in Newark, a broad program that can easily be adhered to by all our councils cannot be accomplished easily in two years; however, many steps in the right direction have been taken in the past year in the cultural area.

- 1. Weekly Lithuanian language classes were instituted last winter in the Newark and the Boston councils. The New York-New Jersey District at its June meeting voted to inaugurate Lithuanian language classes next autumn on the district level.
- 2. Series of 6 cultural talks-essays on different aspects of Lithuanian cultural have been furnished each council. The fourth series of talks will be sent out later this month. This cultural activity is most adhered to by majority of councils.
- We are grateful to Mrs. Eleanor Jenuss for her assistance in preparing stencils and mailing. The total coast of postage, paper and stencils, approximately \$30 was borne by your chairman and is a donation

- 5. The policy of concerts given at K. of L. convention, first in Chicago last year and then Los Angeles this year, is a very good one. Our conventions thus gain an important cultural aspect. It would be recommended that important speakers distinguished in a field of Lithuanian culture should be invited to address national conventions on an important subject. Greetings by these important people are insufficient; new and fresh ideas derived from their lectures are needed.
- 6. Many inquiries were received from various councils for lists of available Lithuanian books, dictionaries, etc., also recordings. This information was readily supplied. Information on specific ideas for plays, production, etc., was also furnished various councils.
- 7. Plans for the celebration of 500th Anniversary of St. Casimir's birth, to which the National Convention in Chicago last year delegated to the Cultural Committee, will be independently submitted and carried out by a special sub-committee, composed of Joseph Boley, chairman, Father V. Karalevičius

from the chairman.

4. Your national chairman corrected erroneous reference to the Battle of Tannenberg in a recent issue of Life Magazine. It was pointed out that this battle was won not by the Poles alone but by a combined Lithuanian-Polish army led by Vytautas the Great. This was in line with the advise of the cultural committee of correcting or objecting to errors or slurs regarding Lithuanian in papers, books, magazines, and scholarly publications.

8. The program for the Knights of Lithuanian scholarship project will be also submitted separately to this convention. This project was also delegated to the Chairman of the Cultural Committee.

In conclusion, your chairman would like to list the following observations and criticisms in the hope that the activities of this committee will be improved in the next year.

K. OF L. SCHOLARSHIP PROGRAM

In accordance with the Resolution passed at our 43rd National K. of L. Convention held in Chicago, Ill. (1956), Jack Stukas, chairman of the Lithuanian Cultural Committee presented the following Scholarship Program to the delegates at the 44th National K. of L. Convention held in Los Angeles, California (Aug. 8-11, 1957):

The Scholarship Program is intended to help a worthy and deserving Knight to obtain a college education. It should be a stimulus for young people to join our organization.

Recommendations were presented for approval based on investigation and contact with the provisional members of the temporary committee consisting of Rev. P. Cinikas (Chicago), Rev. A. Contons (Boston), Mr. L. Simutis (Chicago) and Joseph Boley (New York).

1) This Scholarship is to be given annually to one worthy and deserving K. of L'er as a grant.

2) Applicant's qualifications to be based on recommendations made by:

- a) Council President;
- b) District President;
- c) Local Pastor; and
- d) Former teacher.
- 3) Previous scholastic record.
- 4) Character reference.
- 5) Personal interview (where possible).

6) Possible examinations — College Board Entrance Exams.

Scholarship fund to start at once. Applications must be submitted by March 1st, 1958. First grant for the academic year to begin in September, 1958. Total

- a. District Cultural Committee chairmen were not selected for all districts. If they were, their names were not submitted to me. Therefore, each council in many cases had no specific regional guidance on cultural matters. Councils, furthermore, were slow or lax in most respects in furnishing your chairman with the names of the council cultural committee representatives to whom committee material could regularly be sent and who would be in constant touch ith the national chairman.
- b. Invitations to important and distinguished Lithuanian personalities to give brief talks on Lithuania at council meetings and district conventions were

scholarship of \$600.00 to be divided in half. Before each semester, \$300.00 to be paid directly to the school. In exceptional cases, the grant may be made in one lump sum. Grant to be made to a different Knight each year.

One stipulation — the applicant, if possible, is to attend a Catholic college or university. If not, a nonsectarian college or university upon the approval of the Board of Trustees. Grant may be made to a person for graduate or undergraduate work. No age limit.

Although the grant may be given to the most brilliant K. of L. member yet in some instances it may go to a student in the first half of the graduating class. Organizational activity would be an important criterion for his obtaining a scholarship along with his academic record.

Sources of Funds

- 1. Donations by philanthropic individuals and organizations (wills, etc.).
- 2. Assessment of 25c. by each K. of L. member.
- 3. Annual raffle.
- 4. Activities sponsored by individual councils, districts (such as dances, etc.).
- 5. Generous person investing \$10,000.00, and donating the annual accumulated interest to the Scholarship Fund.
- 6. L. D. S. confidential nature to be respected in the entire Scholarship program.
- Board of Trustees elected at the convention were: Jack Stukas (New Jersey), Leonard Valiukas (California) and Joseph Boley (New York).
- d. There is a noticeable lack of concerts and other cultural activities being sponsored by K. of L'ers. This area should be improved.
- e. No inquiries received from or help given to Junior Councils. At the Junior K. of L. level, cultural participation, learning Lithuanian songs and dances, etc., is especially important. A fondness for Lithuanian songs and dances, etc., acquired at this age level remains with the Knight for the rest of his life.
- f. Your chairman feels a great need for frequent committee panel discussions and seminars. These are essential to co-ordinate activities. The idea of a

not extended. This should be done. Meetings would thus become more interesting and meaningful.

c. Knights should be encouraged to subscribe to and write articles on K. of L. activities in the cultural as well as other spheres to Lithuanian Catholic periodicals. These publications would gladly either translate the article into Lithuanian or publish it in a special English section. The average Lithuanian knows too little of the contribution the K. of L. is making for the perpetuation of Lithuanianism in America and to the fight for Lithuanian freedom. regional K. of L. Committee Conference to be sponsored by the New York and New Jersey District in Newark, the weekend of January 10-11, at the Robert Treat Hotel is, therefore, warmly welcomed. We hope this conference will be well attended by K. of L'ers. Such regional conference would enable our national committees to meet frequently and accomplish considerable more work.

It has, indeed, been a pleasure for your chairman and also an honor, to have directed many cultural activities in the name of the Knights this past year.

(103), Pittsburgh, Pa. (19), Lawrence, Mass. (78), Kearny-Harrison, N. J. (90), Chicago, Ill., Gr. A. (99-24) and Amsterdam, N. Y. (100).

The only new Junior Council organized this past year was Council 12, New York, N. Y., making a total of 12 Junior Councils.

A summer camp for Juniors was investigated. Plans for a camp this year have been dropped, but camps will be set up for the summer of 1958. Seno padavimo pasakojimu, kartą Dievas savo tarnams, dorybėms, suruošęs danguje didelį pokylį. Visos dorybės ten susirinkusios nepavėluodamos.

Nusižeminimas sėdėjęs prie Dievo stalo paskutinėje vietoje; Artimo Meilė dalinusi valgius dideliais kiekiais; Kantrybė nė kiek nesiraukusi ir nemurmėjusi, patarnaujama paskutinė; o Tikėjimas ir Viltis kartu sėdėję. Kiekviena dorybė puikiai jautusis ir bepokyliaudama smagiai leidusi laiką.

Pačiame pokylio ikarštyje Artimo Meilė pastebėjusi, kad dvi dorybės atrodžiusios visai svetimos viena antrai. Ji labai nustebusi, nes iki šiol maniusi, kad jos visada kartu būnančios; dėl to ji ir susodinusi jas abi šalia viena antros. Ilgai nelaukdama, Artimo Meilė priėjusi prie šių dviejų dorybių ir jas paklaususi, ar jos esančios kada nors susitikusios. Kai jos atsakiusios, jog dar nepasižįstančios, Artimo Meilė panorėjusi jas supažindinti tardama:

— Gerume, prašau susipažinti su Dėkingumu!

Abi dorybės labai nustebusios, sužinodamos viena apie antra, ir Gerumas tada taręs Dėkingumui:

— Mes abu visada turėtume kartu būti. Deja, už patirtą gerumą žmonės neatsilygina dėkingumu. Dėl to ir mums neteko anksčiau susitikti...

Šis gražus padavimas, nors ir sustiprintomis spalvomis, alegoriškai vaizduoja gana dažną, bet liūdną reiškini žmonių gyvenime: nedėkingumą.

Vargu ar yra toks žmogus, kuris išsiverstų be kitų pagalbos. Vienas pats jis neivaliotų gyventi, nesinaudodamas kitų žmonių paslauga. Už daug ką, gaunama iš kitų, žmogus niekuomet neistengia atsilyginti, ir jo dėkingumas čia tėra lyg vienintelė kaina, mokama už gaunamą betkokią gėrybę ar vertybę: dvasinę ar medžiaginę. Visaip patiria žmogus kitų gerą širdį, tačiau už ją ir savo gera širdimi jis turi atsilyginti. yra daug mažesnis ir retesnis, negu mūsų prašymai.

Du angelai danguje dirbę maldų registracijos skyriuje. Vienas iš jų buvęs labai apkrautas darbu ir turėjęs dirbti net antnormines darbo valandas. Žmogaus dėkingumas Viešpačiui Kūrėjui yra vienas iš gražiausių religinio gyvenimo bruožų: dėkingumu Dievui žmogus išreiškia Jam savo meilę, pripažindamas Jį savo Valdovu ir visko Davėju.

Ir žmogaus dėkingumas kitam žmogui, artimam ar svetimam, yra šviesi charakterio žymė. Dėkingumas yra žmoniškumo dalis. Jis taip pat yra viena iš artimo meilės išraiškų.

šeima yra pirmoji vieta, kur dėkingumas užsimezga ir pilnai sužydi. Iš mažens neipratintas ir nenuteiktas būti dėkingas, žmogus ir vė-

lyvesniajame amžiuje nepasižymi dėkingumu. Šeimos nariai turi suprasti ir atjausti, ką jie joje gauna, ir už viską saviškiams jie turi būti dėkingi meiliu žodžiu ir mandagiu veiksmu.

Mokykla su mokytojais ir draugais vėl yra kita didelė jaunystės proga, kur jaunasis žmogus gali parodyti dėkingumą už įvairiausią pagalbą ir visokiausias paslaugas.

Pagaliau iki savo gyvenimo saulėlydžio geros širdies žmogus visur ir visada suranda progų, kuriomis jis jaučiasi ipareigotas būti dėkingas kitiems žmonėms.

Deja, yra ir nedėkingų charakterių, kurie greitai užmiršta iš kito patirtą gerą širdį, kurie tik iš kitų telaukia dėkingumo, o patys nesijaučia privalą būti dėkingi kitiems. Tokie žmonės dažniausiai esti savimyliški tipai, tegyveną žemam egoizmui, vien sau. Nedėkingumas tėra išorinis piktos ir savimyliškos širdies drabužis.

Dėkingas žmogus nesileidžia užkrečiamas kito nedėkingumu: jis visada yra pirmasis padėkoti, nė kiek nelaukdamas, kol kitas jam dėkingumą parodo.

Dėkingumas yra taurios ir kilnios širdies išraiška. Jis traukia žmogų prie žmogaus, dažnai paskatina į didelius darbus ir praskaidrina žmonių santykius.

Dėkingumu žmogus daugiau pasiekia, negu vien reikalavimu, pasipūtimu, kietu, dirbtiniu savo pranašumo ir autoriteto pabrėžimu.

A VOTE FOR THE JUNIORS?

Joseph Boley

The recent national convention saw fit to bestow upon the attending Junior members the right to cast one vote. It was said that this would give the Juniors encouragement. Besides, one vote among 90 or 100 could in no way upset the apple cart. Also, it was recalled, the Juniors were granted a similar favor at one or two previous conventions.

Before the procedure becomes a full-fledged tradition it might be well to give it a little leisurely thought between conventions and examine its virtues and weaknesses, if any.

It is heartening, of course, to have some Junior members with us at a convention. They are our pride, our joy and our hope. And when they come in the company of their parents, which is about the only safe way we can expect Juniors to travel long distances, or when they drop in as future members of the local council, it is a pleasant and comforting sight. The Juniors are our most welcome guests.

But is the right to vote any great attraction to them? To us it is an important privilege. We guard it zealously. It gives us authority to evaluate the past and to plan our course for the future. Apportioning our votes in relation to our councils' numerical strength and through our system of mandates and verifications we try to make certain that the right to vote is not in any way misused.

But can we expect the youngsters, who actually are only candidates for membership, to appreciate fully the power of the vote or the size of our favor that we so magnimously grant them? They are in no way prepared to use the vote. They have not had the opportunity to learn very much of the form or the function of the organization and are not qualified to be members of the organization's highest deliberative organ, the national convention. Granting somebody α vote is not just extending α mere social courtesy but implementing him with power which is to be used with wisdom and discretion. Important issues come up before the convention: election of officers; the setting of the annual dues; approval of reports; the decision as to the type of one or another political resolution etc. In these and other such matters we now make this Junior vote of equal importance with that of the officially elected delegate.

Again one might say, what is one vote among

And, practically, even one vote often makes a lot of difference. One single vote in the balance can mean the election of A and not B. In the case where a 2/3 majority is required a single vote can prevent some worthwhile change in the constitution, or it can equally be instrumental in introducing some detrimental alteration of our organization.

The Junior vote or votes can easily be directed, of course, by someone else's more mature judgment

voting strength of some council which already has its full compliment of votes as provided by the constitution and eventually could lead to abuses.

There is no arguing the point that our Juniors need encouragement. Those who come to the convention with their parents should be introduced to the convention and otherwise made notice of. They could be invited to express their opinion on matters that come up on the floor. They could have a little conference with the vice-president in charge of Juniors. Where there is a local or nearby council vention a party of their own and meet a half dozen of prominent delegates and those interested in Juniors. At this get-acquainted session a short discussion with them of their activities might result in mutual benefit. Ways can and ought to be found for making a fuss over them and expressing our interest in them. This might give them added strength and we might learn something in return. Careless distribution of voting privileges, however, seems to offer no benefits either to our beloved Juniors or to the organization.
