## **STATE OF ORGANIZATION REPORT**

#### Delivered by: Robert S. Boris, National President

Encouraged by the apparent success of our attempt to modernize the National Convention Sessions last year, we shall attempt to follow the same proceedure this year. Most oral reports will be elimated since they have been combined into one "State of the Organization Report." We shall therefore try, as briefly as possible, to review the highlights of those reports, which were submitted to me prior to the convention.

Complete detailed reports for each officer and committee have been reproduced and are found in this booklet for your reference. These should be thoroughly read and used to give a full report at the next meeting of your local council.

SPIRITUAL DIRECTOR. The K of L can be truly grateful to our Spiritual Director, Father J. Walter Stanievich, whose report has just been given. His wise counsel and guidance has been appreciated by all who have called His efforts to strengthen the bond of good will on him. between our organization and the clergy, who are not members, had not gone unnoticed. Despite the tremendous demands of two parishes which are under his administration, he has not failed to fulfill his duties as Spiritual Director. The revival of our Spiritual Program has been well received and appreciated. We sincerely hope this most important phase of our program will be continued and expanded in the coming year.

tions of time and funds. We tried during the past year to establish a closer bond between the Supreme Council Officers, National Committee Members and local officers by publishing a newsletter in which ideas, instructions and information were exchanged.

Close contact was maintained between myself and the National Officers of other Catholic organizations such as the Kunigų Vienybė, Susivienijimas nad the Federation. It can be announced that plans for mutual aid between the K of L and Susivienijimas have been under discussion all year and definite proposals have been made for our study by Mr. Simutis.

Great personal satisfaction was experienced by participating, as a representative of the K of L, at the Consecration of His Excellency Bishop Charles Salatka, our first American Bishop of Lithuanian descent. We organized the collection of funds to present the Bishop with a lasting gift, as a token of our good wishes and also organized a nationwide Spiritual Bouquet with which we offered to the Bishop a prayerful remembrance of our great joy.

PRESIDENT As President, I called six meetings of the Supreme Council to handle the routine business of our organization. Despite the hardships of travel, all of the meetings were well attended and productive of new ideas and plans for the future. I have attempted to discharge my duties to the best of my ability considering the restric-

Of major importance too, was the request by Bishop Vincentas Brizgys to serve on the committee being organized to undertake the erection of a Lithuanian Chapel in the National Shrine of the Immaculate Concenption in Washington, D. C.

Much time and effort was spent regarding the continual improvement of the VYTIS.

FIRST VICE-PRESIDENT Miss Helen Shields has continued to spend her inexhaustable efforts in behalf of Juniors; no amount of time, work or expense was too great wherever the K of L or especially Juniors was concerned.

Junior Rallies were held in three of our Districts this past year, namely, the New England, New York- New Jersey and the Mid-Central. Six issues of the Junior Page were published in the VYTIS during the past year. Over one thousand extra copies were printed for distribution to all Junior Councils and the Parish Schools taught by our Franciscan Sisters.

A total of five new Junior Councils were organized during the past year in Athol, Mass., Cleveland, Ohio, Detroit, (C-79) Mich.; Kearney, N.J.; and Maspeth, N.Y. Junior Members now number more than 500.

The Third Annual K of L Camp for youngsters was successfully completed last weekend. Over 50 young people attended with several participants from Dayton and Cleveland. We are especially especially grateful to Mrs. Donna Stanievich of Detroit, who supervised the camp. Also deserving of praise were Mr. John Andrulis of Cleveland Bernice Kavadaras of Worcester, and Mary Motecus and Ruth Laucius of Elizabeth who spent the entire week at camp helping in numerous ways. Mr. Faustas Strolia of Chicago was the musical director and Mrs. Donna Bunikis was in charge of arrangements.

SECOND VICE-PRESIDENT No report was received from William Grigas prior to the writing of this report, but we feel confident that the results of the Membership Drive will be available at the convention.

FINANCIAL SECRETARY Mrs. Rita Pinkus presented the following information which gives an idea of our mem-

From these statistics we can see that more emphasis must be put on recruiting new members. Ways and means of attracting and recruiting prospective members must be discovered. 1,649 copies of VYTIS are mailed out each month.

RECORDING SECRETARY Miss Ursula Yankauskas has done a remarkable job. Copies of each Supreme Council meeting's minutes were prepared and mailed to all officers soon after each meeting. A file of officers for each council as well as chairmen of all standing committees was prepared. Her help with correspondence and other matters pertaining to her office is much appreciated. LEGAL ADVISOR Mr. Konnie Savickas has been most cooperative and especially so in preparing a rough draft of a revised constitution in which all old and ambiguous phrases have been eliminated.

NEW ENGLAND DISTRICT Miss Bernice Kavadaras has reported that her District has been most active. Her efforts to reactivate dormant or weak councils has been most admirable. There are thirteen active councils and four Junior Councils in New England. A very well rounded out program of Spiritual, Cultural, Sports and other activities has put this District on top.

ILLINOIS-INDIANA DISTRICT Although no report was received prior to preparing this report from Miss Eleanore Laurin, we know that the K of L Choir of this District has been most active and had represented Lithuanians in many places and events. We trust that a report will be made available during the convention.

NEW YORK - NEW JERSEY DISTRICT No report was received from Mr. Larry Janonis. We assume that the tremendous task of preparing this convention has occupied the time and efforts of the members in this District.

MID-CENTRAL DISTRICT No report was received from Miss Mary Trainy. However we attest the District Day of Recollection and Junior Rally which was attended by more than 150 persons.

THE RITUAL COMMITTEE has reported a total of 84 degrees were presented. The Ritual Committee has also prepared the Rosary Memento Card for use by the K of L during wakes. The Committee is also investigating the possibility of having a lapel pin for members holding the first and second degree.

HONORARY MEMBERSHIP COMMITTEE has reported that two medals were presented this year. During the past year the Supreme Council has decided that from henceforth the fees for all Honorary Degree Medals will be paid for by the Supreme Council, as it is felt that any person deserving this Degree has worked sufficiently for the organization to merit this. The Supreme Council also asked to have some voice in approving the candidates who have to receive this degree.

BUILDING FUND assets are reported as \$1,297.88 by Frank Gudelis, Treasurer.

TREASURER Mr. Albert Kassel has discharged his duties with efficiency and willing cooperation. An effort is being made to coordinate all monies and funds under one central control and administration of the Treasurer. Several unfortunate incidents during recent years have necessitated this move. We strongly urge that the resolution being sponsored by the Supreme Council in this matter be approved by all the delegates.

TRUSTEES Miss Eleanore Laurin and Mr. Stanley Vaitkus have performed their duties as required.

LITHUANIAN AFFAIRS Rev. John Jutt reports a banner year for the activity of the Lithuanian Affairs Committee. A total of 4,222 bulletins were sent out to members serving on this committee. A complete report will be submitted orally.

LITHUANIAN CULTURAL COMMITTEE Mr.Jack Stukas will make an oral report during the course of the convention.

PUBLIC RELATIONS An attempt was made to organize this committee as a result of the conference held last convention. For various reasons no success was attained.

PUBLICITY Mr. Frank Vaskas and Mr. Al Manst were responsible for much publicity in the Lithuanian press.

SPORTS Mr. William Juodawlkis' report is contained in this booklet.

VYTIS Last year the Supreme Council took a number of major steps to improve the Vytis forming a "Vytis Improving Committee." As everyone is well aware the committee reccomended a change from letterpress to offset press in order to effect financial economy. The Supreme Council authorized this change and beginning with the June 1961 issue, the VYTIS was transferred to Chicago where offset press facilities were available. At that time the committee report predicted a potential saving of \$765.00. We are most pleased to announce that this estimate proved to be very conservative. The cost data shown below indicates that offset press saved us \$954.00.

These figures are comparative costs based on the cost of issuing the last ten issues of Vytis by letterpress instead of by offset.

Please bear in mind that these are not the only costs involved in printing Vytis, but are the items which are effected by the method of printing. Other expenses include: postage, salaries, misc. expenses, stationary and the cost of the Junior pages.. Total costs for publishing the Vytis in 1961-62 is \$ 3,787.03.

CONSTITUTIONAL MODERNIZATION received much attention in recent years, yet without concrete results. A recent Supreme Council meeting has entrusted the responsibility of drafting a new constitution to myself and the District Presidents. To date our Legal Advisor Konnie Savickas has rendered the most assistance in going over the old constitution and rewriting it in modern language etc. All councils are asked to make suggestions for other changes through their district president. It is hoped that a new draft will be available for everyone to consider by the end of the year.

In general, the past fiscal year appears to be one of great attainment and success. Practically all officers and committee chairmen fulfilled their duties. However, we are amazed by several instances where members of the Supreme Council and National Committee have allowed an entire year to pass without putting forth even a minimum of effort. The blame for this rests partially on the delegates who either nominated or voted for candidates whose past record of ''non-performance'' should have indicated their unwillingness to sacrifice time and work. Let's stop making a ''popularity contest'' out of our elections and look for candidates with the willingness and desire to work.

New ideas and methods must be found to increase our membership. Only from new members will fresh ideas and inspirations come. When an entire year passes with only one new or re-activated council (Council 139 - Detroit, Michigan) we feel strongly that the present pattern must be changed.

Last year we proposed that our Senior Councils adopt the drive for financial assistance to the Supreme Council. No progress has been noted along these lines, so again, we urge that our Seniors, who have shown such great love for the K of L in the past, consider this and make it one of their projects. This would help the Supreme Council to be more efficient and productive in the future.

With the Jubilee year but a few months away, we must give full support to the Jubilee Committee, which has been charged with the task of proposing ideas and suggestions for making this a great occasion with fitting ceremonies and activities.

Though our many and varied activities might present a fine picture of the K of L, and no doubt we do have much of which to be proud, there are sign of growing apathy, which causes alarm and concern. It does not require much searching to see this. Many officers are spending tremendous amounts of time and energy and find a feeble response from the rank and file members and often fellow officers. We would appreciate any ideas or suggestions to resolve this problem. Anything which will help to alleviate this situation will be of great importance to the organization.

It hardly seems possible that one year has elapsed since I was appointed Spiritual Advisor to the Supreme Council of the Knights of Lithuania. Thus, as I speak to you this morning I must say "mea culpa. . . mea maxima culpa," for it seems to me, after due consideration and examination of conscience that perhaps a great deal more could have been accomplished and more energy expended.

In the year of my stewardship, two general letters were sent to all the Lithuanian Pastors of the United States. The first one was written at the beginning of my tenure. The letter was written with the idea of introducing the Knights of Lithuania to all our Lithuanian Clergy. We were perfectly aware of the fact that many were and still are active in the in. the K of L, nevertheless we hoped that those who were unaware of our program and our aims might be acquainted with us. As a good will gesture we made the offer at the time to send a subscription of Vytis to each Rectory with our compliments. The response to the letter was not overwhelming, nevertheless there were a number of heartwarming letters of encouragement and gratitude. Even though there are no apparent results from this venture, it is hoped that good will was imparted. Maybe at some future date some new councils may be established as a result of these efforts.

The second letter which was written to the Clergy was sent out within the past month. It was sent in the form

subject matter, prepared by myself would appear in the Vytis each month. As a matter of fact, the above mentioned articles did appear in the December, January, March, April, Mayand July-August issues. At June the very outset I asked each council to report to me, as to whether this type of program would stimulate interest and would have any practicality. I also asked for any suggestions or criticisms with respect to the subject material. Thus far I have only heard from six councils, who said that they like the idea and were using the topics for discussions. Another council was using material prepared by their Chaplain. My feeling in this matter is that this program was not too successful - and I have the feeling that most of the councils did not use this or any other material. However, I still am convinced that this program can work and can be of tremendous importance to each of us The Business and Social parts of each meeting should be separated and at least ten or fifteen minutes could be devoted to practical Catholic Doctrinal discussion. In these days of specialization we simply cannot be satisfied in being just mediocre or lukewarm Catholics. If we slip in this regard believe me, the entire K of L will crumble, decay and die a quicker death than we anticipate. No amount of Patriotic Lithuanianism ne amount of convention conviviality will hold us together as that bond of Faith. And just the basic knowledge of catechism is not enough in our day and age. To continue now with the report during the fall of the year we were happy to have an informal meeting of several Supreme Council officers with the Rt. Rev. Msgr. F. Juras, President of the Kunigu Vienybe, and the Rt. Rev. Msgr. J. Balkunas. We discussed the problems of how we could have closer cooperation between the Clergy and the K of L. We feel that this meeting was of benefit to all parties concerned.

One of the high spots of mytenure of office was to work in close conjunction with the Supreme Council President to properly mark the Consecration of America's first Lithuanian Bishop. I am speaking of His Excellency Bishop Salatka, D.D., Auxiliary Bishop of Grand Rapids, Michigan, We received a rather fine response from the vast majority of Councils when we prepared a Spiritual Bouquet on the occasion of His Consecration. We also took part in the selection of a K of L gift that would be a lasting memory to Bishop Salatka. We purchased a Gold-plated Ceremonial Candleholder, an Ewer and Basin. They were all appropriately inscribed in the name of all K of L Councils throughout the United States. We also had the honor to be present at Bishop Salatka's Consecration in Grand Rapids, where we extended the best wishes and congratulations in the name of the entire membership.

Because of pressing parochial business, I have been unable to attend all the Supreme Council meetings. However, we were able to attend four of them. Since the Supreme Council President is a member of my Parish, there hasn't been a week that went by without spending some hours in discussing various phases of the organization.

Allow me to express a bit of pride in stating that the only new council that was founded during this past year took place at St. Peter's Parish in Detroit - which happens to be one of the parishes over which I have charge. We only hope that this newly founded council will continue to thrive and prosper during the coming years. To conclude my report allow me to make an observation. And that is that there has got to be a little more effort and enthusiasm displayed on the part of the membership. I sincerely believe that this enthusiasm is displayed by the members of the Supreme Council and the time and effort that they expend is truly an

of an invitation to attend our National Convention. We also invited any suggestions or constructive criticisms which the good Fathers may have had. Thus several letters were received and Dee Gratias, they were all-complimentary to the Knights of Lithuania.

I had suggested early in the year. that all Councils would devote a specific amount of every meeting to a Spiritual program. The topics or

As a member of the House, his abilities were at once recognized for he was elected to serve on a number of important committees: the Post Office and Post Roads Committee, the Post Office and Fost Roads Committee, the Labor and Eduvices Committee, the Labor and Education Committee and the powerful Rules Committee. Of the latter, he is presently the second ranking member.

During the 82nd Congress his membership on the House Rules Committee was most important for it passed Resolution No. 346 which set up a Select Committee for the investigation of communist aggression and the forced incorporation of the Baltic States into the Soviet Union. This committee of which he was a member took testimony of over 200 witnesses and recorded hundreds of exhibits at hearings held in the United States and Europe.

He thus was able to get first hand information on the ruthless and barbarous methods used by the Soviets to enslave Lithuania and the other Baltic States. The report of this Select Committee in 1955 served a most noble purpose for it gave the American people and the world a chance to understand better the Baltic States and to appreciate more fully the true nature, the unlawful tactics and the final objectives of the criminal conspiracy of world communism.

To the many Lithuanians who frequently approached him, his advice has always been generous and invaluable. To him the cause of the Lithuanians is his cause. To this cause he was and still is DEVOTED. Webster states that the word DEimplies a consecration to VOTED a purpose. Judging from the time he sacrifices to advise the Lithuanians and to speak at their gatherings, one would certainly have to say that our honored Guest has consecrated himself to the lofty and noble purpose of making the world conscious of the

atrocities committed upon the Lithuanian Nation by a cruel and ruthless Soviet.

For the past two decades, it has been customary for Congress to permit one hour's time for tribute to Lithuania on February 16, the anniversary of Lithuanian Independence Day. Each year on this occasion he has been in the forefront of those who are battling for the restoration of Lithuania's freedom. One year he himself requested the hour and each year he has addressed the august assembly of the House of Representatives outlining the infiltration, duplicity and force used by the communists to submerge Lithuania. Why has he been so dedicated to the aspirations of the Lithuanian people? Because he is convinced that the ruthlessness of tyrannical communism is the only reason why the remarkable progress made by Lithuania during the 22 years of freedom from 1918 to 1940 has been curtailed and in many cases nullified. At the present session of Congress, he is asking for the approval. of a resolution to establish a Special Committee on Captive Nations. This Committee would investigate the Communist enslavement of captive nations because the people of the world should know the history of Soviet aggression in Lithuania and the other nations behind the Iron Curtain. Also at the present session of

Congress, just recently he has introduced House Concurrent Resolution 418 which would ask Congress to condemn the false and oppressive persecution against all religions in Lithuania and in the other countries enslaved by the Soviet.

My dear Friends, I tell you we have a man here tonight who is truly dedicated to the cause of Lithuania because he is convinced that that cause is a just and righteous cause. We have a man here tonight who knows communism for what it really is and who sees the danger that lurks in it against the free nations of the world. We have a man here tonight who not only talks but also works, sacrifices his time and his energy in behalf of a country so dear to us and against which so much wrong has been done. We have a man here tonight who can without fear say and who says: "We must never forget the enslavement of Lithuania. The number one obligation of our Nation and other free nations is to keep militarily prepared or the liberty of all free people in the world is in jeopardy. In fighting for Lithuania, we are fighting for the destruction of the whole communistic system, a system which no man in his right mind can accept."

Because he has proven himself to be a staunch foe of Soviet Communism with its imminent dangers to a stable world peace, because he has ever condemned the unjust enslavement of the Lithuanian Nation by the Soviet, because believing in the righteousness of her cause he has demonstrated that Lithuania deserves the good will of all free nations, because he has proven himself to be a DEVOTED FRIEND of Lithuania, it affords me great pleasure and I deem it an unspeakable honor to present at this time, in behalf of the President and the thousands of members of the Knights of Lithuania organization this Knights of Lithuania Award Medal to that DEVOTED champion of Lithuania's freedom, an illustrious member of the House of Representatives from the grand State of Indiana, the Honorable Ray J. Madden.

"This Special Congressional Committee accomplished immeasurable results in concentrating the light of true facts exposing false communist propaganda and hidden secrets of communist methods of aggression and tyranny. Had it not been for the Lithuanian people in American, Lithuanian organizations, and the Knights of Lithuania, this Special Congressional Committee investigating communist enslavement in the Baltic States would not have been created. . .''

In the eyes of God - a thousand years are like a moment. In the history of mankind - the Egyptian dynasty or the Roman Empire, which have existed for thousands of years seem like a very long time. To us delegates to the 49th annual K of L Convention, a half century (which comparatively is a very short time) seems like a landmark - and, in truth, it is.

I say that it is a landmark, to us of the K of L, to come to an end of a half century of achievement in America - because of the unique position in which we are placed. The United States, historically speaking, is one vast melting pot - where languages, ideals, cultures are merged and fused, and the end product is what we call "America." In the 183 years of our Nation's existence, literally hundreds of tongues have been assimilated - scores of cultures were merged - and within a generation many national groups have lost their identity. And, on the course of this assimilation, hundreds of national and social fraternal organizations have become non-existant. Whether this is good or bad - only the historian of a future generation will be able to determine. It is however, with a degree of pride that we can say that the K of L have ended a half century of service to their God, their Church, their nation and their former homeland. And what is more gratifying - it not only exists today but seems to be thriving.

When the original founders of the K of L founded this Catholic organization at the turn of the century, they were faced with a complex problem. The thousands of Lithuanians who poured into this land of opportunity found themselves confused in this vast land. Whenever possible, they banded together in Colonies in the larger cities - there they maintained their faith, by building and supporting their Catholic Churches. There, then as now, they were able to hear the doctrines of

their holy faith explained in their mother tongue. The aliens who lived in smaller communities were less fortunate. For, without a stabilizing force, many lost their faith or at least it was weakened to such a degree that it no longer was able to motivate them as it should have. At this point, the K of L was organized to fill this void. It was instrumental in supplying a place for Catholic young people to meet in a familiar and friendly climate. "For God and Country" became the motto of this organization. And now, looking back almost three generations we can, with some degree of pride, say that we have rendered a unique service

> genuity to cope with the interests of our young people – and perhaps we shall have to re-evaluate our entire organizational structure to see if our aims and goals comply with the needs of the day.

> In 1913, when the Kof L was founded, the world was preparing for what was to be known as World War I - and it was indeed a terrible holocaust. Today, however we are living in a period of uneasy peace with the threat of world extinction facing each one of us. We have all seen what inroads Communism has made - we, even now, see it making apparent progress in many corners of the world. We are seeing how indifference to God and religion is sweeping over our Nation. Furthermore, with the lowering of moral standards - honesty and integrity have become passe - and the lie has become the order of the day as long as you don't get caught. Yes, in a word, our very faith is being challenged.

You, my dear delegates, are you equipped to do your share today for God and Country? As Kof L members does your Catholic faith play an active role in your lives - in your homes - your businesses? Is it so vital that it will attract others to follow your example? Is your charity toward your neighbor so great - that when you find others with a different color of skin or with a strange language - you are nevertheless willing to see Christ in them? For if we have been discriminated against, decades ago, because we were a minority, or because of our culture, our language or religion must we now reciprocate in kind? Five decades ago - the new arrivals from Lithuania on these new shores were for the most part uneducated. Lacking the opportunities which we now have, their interests were different. Today - thanks to your good parents - many of you have achieved a much higher level of education. Many of you are blessed with good professional positions. Naturally - these positions make more and di-

to our holy faith, to our land of adoption and to the land of our forefathers.

After a half century of achievement, we simply cannot rest on our past accomplishments - for if we are to exist and/or have a reason for existence, we must, even now, begin to make plans to meet the new challenges that face us today.We must face up to the fact that the coming years will also call upon our inverse demands upon you. Some of you may feel that you no longer fit in the K of L climate (in other words it is has served its purpose). However, each of us should remember - that we owe a debt and must try to repay it by volunteering our services (whatever they may be) for the cause of "God and Country."


Furthermore, the K of L may have to tailor its program to meet the



Romoje vienas lietuvis, kuriam Lietuvos dabartinė padėtis rūpi, apie Vyčius rašo: "Vyčiai nepalieka veiklos dėl mūsų kenčiančios Lietuvos. Mes lietuviai labai įvertiname Vyčių darbą ir linkime nepavargti ir nenusivilti jei pasitaikys koks išgama, kurs to Vyčių darbo neivertins."

Tokių atsiliepimų mes Vyčiai esame sulaukę gana daug netik nuo lietuvių, bet ir nuo svetimtaučių. Kodėl? Todėl, kad Vyčiai jau per 16 metų dirba ir veikia Lietuvos naudai per savo garsią Lietuvių Reikalų Komisiją. Jau per 16 metų Vyčiai gina Lietuvos reikalus ir deda visas pastangas, kad Lietuva atgautų savo tinkamą vietą tarpe laisvų ir nepriklausomų pasaulyje tautų. Kad visi gali taip atsiliepti apie Vyčius, tai nenuostabu iš šios statistikos:

- Skaičius komisijos narių padidėjo ligi 166, tai yra 2. 24 daugiau negu pernai.
- 3. Kasmet taip įvyksta, taip ir šiais metais kelineatsiuntė savo asmeniško raporto. Už tai galima sakyti, kad daugiau negu 22,363 laiškai buvo parašyta.

116-tą kuopą, kurios komisijos nariai parašė suvirš 3000 laškų. Kad visos kuopos taipveiktų, tai Lietuvos reikalai plačiau visur būtų žinomi.

- 2. New York New Jersey apskritis pasitaise, nes daug laiškų parašė negu pernai, kada žymiai nukrito. Čia daug kredito priklauso Philadelphijos 3-čiai kuopai, kurios nariai parašė 1075 laiškus.
- Mid-Central apskritis beveik trigubai padidino savo veikimą, ačiū Detroito 79-tai kuopai, kurios nariai labai interesuojasi Lietuvos reikalais.

Sveikiname tikru lietuvišku sveikinimu tas apskritis, kurios gražiai pasirodė ir linkime, kad kitos pasiryžtų daug daugiau veikimo parodyti šiame svarbiame darbe.

Pernai per seimą Irene Sankus buvo išrinkta Lietuvių Reikalų Komisijos pirmininkė. Kaipo pirmininkė ji parašė 343 laiškus, atsakymų gavo 107. Jos pareigos buvo sunkios: kalbėti nariams apie komisijos svarbą, raginti juos prisidėti prie laiškų rašymo, parašyti organizacijos vardu oficialius laiškus. Galiu liūdyti, kad ji puikiai savo pareigas atliko ir visa organizacija turėtų jai būti dėkinga už gražiai atliktą darbą. Be to ji nieko nereikalauja už savo išlaidas. Ji tą visą aukoja organizacijia. Kaipo komisijos garbės pirmininkui, man teko paruošti biuletenius, kuriuos visi nariai apturėjo ir komisijos reikalais parašiau 991 laišką bei atviruką.

Komisijos darbas yra painformuoti spaudą apie Lietuvos dabartinę sunkią padėtį, padėkoti tiems, kurie palankiai atsiliepia ir protestus iškelti prieš tuos, kurie nepalankiai atsiliepia apie Lietuvą. Kaip reaguoti ir kam rašyti, galima žinoti iš straipsnių, kurie telpa laikraščiuose, žurnaluose ir knygose. Dėkui Dievui, kad nariai susiprato ir atsiunčia mums straipsnių. Daugelis atsiuntė, bet daugiausia atsiuntė:

1. Naujos Anglijos apskritis puikiai pasirodė. Veikimas padidintas ir daug laiko praleido laiškų rašymui. Cia ypatingu būdu reikia pagirti Worcesterio

Antanas Yuknis iš Čikagos, Vincas Vyšniauskas iš Gardner, Mass. Uš jųjų darbštumą nuoširdžiai dėkoju ir lai jųjų gražus pavyzdys skatina kitus tą patį daryti.

Vėl šiais metais Vyčiai prisidėjo prie Vasario 16-sios apvaikščiojimo. Sausio mėnesyje per savo laiškus Krašto Prezidentui, Kongreso nariams, laikraščių redaktoriams, valstijų gubernatoriams, miesto majorams ir kitiems, Vyčiai prašė visų neužmiršti reikšmę vasario 16tojo visiems lietuviams ir kelti savo įtakingus balsus, kad Lietuva atgautų galutinai savo nepriklausomybę. Tas darbas atnešė daug vaisių, nes:

- 11 gubernatorių ir 16 majorų paskelbė vasario 16tą dieną kaipo Lietuvos Respublikos dieną savo miestams ir valstijoms.
- 128 kongresmanai ir 27 senatoriai pasakė kalbas apie Lietuvą ir tos visos kalbos buvo atspausdintos CONGRESSIONAL RECORD.
- 142 laikraščiai aprašė apvaikščiojimus, kurie vienur ar kitur įvyko.
- 4. Keliose parapijose Vyčiai daug prisidėjo prie tinkamų apvaikščiojimų savo miestuose.

Zodžiu, visaks buvo Vyčių daroma, kad pasaulis neužmirštų, kad Lietuva dar kenčia po Sovietais ir kad ji turi teisę gyventi nepriklausomai. Visi buvo raginami daryti viską, kas tik reikalinga, kad Lietuva atgautų savo nepriklausomybę. Daug palankumo susilaukėme, kaip antai:

- Senatorius E. L. Bartlett rašo iš Alaskos: "You may be sure that my voice will be heard loud and clear my faith in the Lithuanian people."
- Senatorius John Marshall Butler iš Maryland rašo: "As in the past you may rest assured that I shall publicize to the best of my ability the splendid example which Lithuania has been to the captive peoples of Eastern Europe and to the free peoples of the West."
- Kongresmanas Paul A. Fine iš New York rašo: "We must continue in our support and encouragement to the people of Lithuania in their struggle to regain their freedom. . We fervently hope and pray that the Lithuanian people will soon enjoy freedom in their historic homeland."
- Majoras Samuel Yorty iš Los Angeles rašo: ''I assure you that I take special pleasure in this proclamation dealing with Lithuanian independence because of the outstanding contributions those of Lithuanian extraction have made to our nation.''

Per praėjusius metus Vyčiai darė ką tik galėjo, kad pasaulis žinotų ką tai reiškia taip vadinamos Lietuvos Tragiškos Dienos, skatino Senate ir Kongrese Užsienių Reikalų Komisijas paremti ir leisti praeiti į Kongresą svarstymui 12 rezoliucijų, kurios pareikalautų, kad Sovietai išeitų iš Lietuvos ir leistų laisvus rinkimus įvykti Lietuvoje ir darė spaudimus, kad Prezidentas paskelbtų trečią savaitę liepos mėn. kaipo Pavergtųjų Tautų sa-Visuose parengimuose, kurie įvyko įvairiuose vaitę. miestuose, Vyčiai aktyviai prisidėjo ir gražiai pasirodė. Sis raportas rodė, kad Vyčiai, kaip veikė per 16 metų, toliau veikia ir pasinaudoja kiekviena proga iškelti Lietuvos bylą ir pareikalauti, kad Lietuva atgautų savo nepriklausomybę. Jie be perstojimo kreipiasi pas svetimtaučius, prašydami jųjų pagalbos ir panaudoti kokią įtekmę turi Lietuvos labui. Nėra abejonės, kad Vyčiai yra tikri, patrijotingi-lietuviai, kurie gražų tautinį darbą Lietuvos labui dirba. Už tai reikia pagirti sekančius, kurie puikiai pasirodė:

Kadangi tiek daug narių asmeniškai daug laiškų parašė, todėl šie metai yra mums rekordiniai metai. Jiems ir kitiems, kurie laiškus parašė ir kurie taip gerą pavyzdį davė visiems, mes dėkojame ir lai Dievas duoda jiems tolimesnės stiprybės taip gražiai veikti mūsų tautos naudai. Stebėtinas dalykas, kaip šis darbas atnaujina nariuose tikrą lietuvišką dvasią. Tai aišku iš laiško, kurį gavome nuo vieno nario:

''I've written to the Governors of every state asking them for proclamations on Lithuanian Independence Day. Well, the response has been terrific. ... Some people would say I'm bragging, no, just proud in the job we are doing.''

Jei yra tokių, kurie nemato svarbos komisijos darbuotės, lai klauso sekančių pasakymų:

- SIGN žurnalo redaktorius rašo: ''We depend entirely on the good will of subscribers like yourself. It takes time and effort to sit down and write a letter and we do appreciate your interest.''
- Kolumnistas Edgar Ansel Mewrer rašo: ''Several readers have written to thank me for my praise of heroic Lithuanians. I am glad for the time calls for heroism.''
- Tas pats kolumnistas savo kolumnoje (5-19-62) rašo: ''Lithuanians in various parts of our country have written to thank me for upholding Lithuania's right to freedom. I can make no sense of a 'free' world that believes passionately in giving independence to various African tribes emerging from the stone age but has no sympathy for the oppressed peoples of the Soviet Union and Red China.''

Prieš nedaugelį metų ne vieną kartą girdejome, kaip kai kurie mūsų senesnieji lietuviai peikė čia gimusį lietuvišką jaunimą, nes jam nieko tautiško nerūpėjo, rūpėjo tik geri laikai. Dabar tokių kalbų negirdime, nes esu tikras, kad visas lietuviškas pasaulis žino apie Vyčių tautinę darbuotę. Už tai mes skaitome visai ką kitą kaip antai:

- DRAUGAS savo leidinyje (8-23-61) rašo: "Lietuvos reikalų Vyčiai niekuomet neužmiršo. Neužmiršta ir dabar. Kiekvienas patrijotas lietuvis džiaugiasi ir dabartiniais jų darbais, kurie reiškiasi garsinimu Lietuvos vardo angliškoje spaudoje, atsakinėjimu į priešų šmeižtus ir padėkojimu visiems tiems, kurie gina Lietuvos nepriklausomybės bylą. Šis jų darbas yra svarbus ir reikalingas. Vyčiai, tęskite jį ir toliau."
- DRAUGAS straipsnyje apie išlaisvinimo veiksnius (1--24-62) rašo: "O kaip apie Lietuvių katalikų jaunimo Lietuvos Vyčių organizaciją, kuri yra pasirinkusi labai garbingą vaidmenį garsinti Lietuvos vardą ir jį ginti Amerikos spaudoje. Šį naudingą

Leonardas Valiukas iš 133čios kuopos, kurs parašė 625 laiškus;

- Edwardas Martin iš 79tos kuopos, kurs parašė 402 laiškus;
- 31 narys per praėjusius metus parašė virš 100 laiškų ir taip užsipelne tapti nariais taip vadinamo 100-A-YEAR klubo.

darbą ji dirba eilę metų. Tuo Vyčiai daug pasitarnauja lietuvių tautai."

Mano brangūs Vyčiai-Vytės, Lietuva, kaip ir kitos tautos šiandien kenčia todėl, kad komunizmas per stiprus buvo ir yra. Prieš visokius teisingumo ir meilės princiųs, Sovietai neteisingai užgrobė Lietuvą ir laiko jos žmones kaliniais. Vakarų tautos nemato reikalo daryti konors konkretaus, kad Lietuva atgautų savo teisingą vietą tarpe laisvų ir nepriklausomų pasaulyje tautų. Už tai mums lietuviams nereikėtų snausti, bet dar labiau dirbti ir veikti tol, kol Lietuva neatgaus savo nepriklausomybės. Pernai per Vyčių Seimą garsusis Dr. Michael S. Pap, Ko-

rie gresia pasauliui nuo komunizmo. Tarp kitko jis pabrėžė: "Mums būtinai reikia komunizmui duoti žinoti, kad tol, kol bus vienas laisvas žmogus pasaulyje, komunizmas neišloš, nes tas laisvas žmogus visuomet komunizmo tikslams bus priešingas." Čia mums geras nusistatymas. Kadangi esame lietuviai, kadangi mūsų protėviai iš to krašto buvo, kadangi lietuviškas krajas mūsų gyslese teka, mums reikėtų pasirašytu, kad tol, kol mes būsime lietuviais, komunizmas neišloš, Sovietai turės išeiti iš tos šalies, kuri taip brangi mūsų tėvams. Mes kovosime nenuilstamai, Atsiminkime, kad Leninas užėmė Rusiją tada, kada buvo

legijos profesorius, iškalbingai kalbėjo apie pavojus, ku- tik 40,000 komunistų visame pasaulyje. Sovietai užėmė Čekoslovakiją, kuri turėjo tik 100 komunistų. Mes sudarome tik mažą grupę, bet su pasišventimu, su ištikimu veikimu, kaipo Lietuvių Reikalų Komisijos nariai, mes pergalėsime priešus, mes pergalėsime komunizmą ir Lietuva vėl bus laisva. Tada bus mums ir visiems pasaulyje lietuviams garbé. Taip Dieve, padék.


