# GEGUŽĖS MOTINOS MENUO

Motinos dieną. Motinos dienos šventė yra ypatingos reikšmės ir svarbos diena. Jos minėjimas turi labai gilią prasmę. Tą dieną mes pastatome mūsų motinas į dėmesio centrą ir reiškiame joms pagarbą, meilę ir padėką. Tą dieną mes motinas iškeliame į tą ukštumą, kuri joms priklauso visuomenėje. Minėdami Motinos dieną, mes prisimename ir mūsų tėvų šalies -Lietuvos motinas, jų nueitą kryžiaus kelią praeityje ir dabar nešamą naštą raudonųjų vergovėje. Atseit, švesdami Motinos dieną prisimename tris motinas: Motiną Mariją - Dievo motiną, motiną gimdytoją ir motiną tevynę-Lietuvą. Jos visos tarp savęs turi daug daug tokių ypatybių, kurios sujaudina net žmonių kiečiausias širdis. Motina yra pradžia ir šaltinis žmoguaus gyvenimo. Motina duoda pasauliui žymius mokslininkus, kultūrininkus ir įvairių tautų genijus. # LITHUANIA'S LEGAL STATUS SINCE 1940

#### ALGIRDAS BUDRECKIS

On June 14, 1940 the Soviet Government handed an ultimatum to the Lithuanian Government demanding the formation of a pro-Soviet Government and the admission into Lithuania of an unlimited number of Soviet troops. Before the deadline of the ultimatum had expired, a force of 300,000 Red soldiers, supported by thanks and airplanes, invaded Lithuania. The Kremlin immediately set up a puppet regime under Justinas Paleckis. This puppet government, with the help of the Red Army, NKVD, and the Communist Party apparatus, handpicked a so-called "People's Diet" which immediately asked the Kremlin to incorporate Lithuania into the Soviet Union. The Supreme Soviet of the US\$R complied on August 3, 1940 and Lithuania was designated a Soviet republic. This was a classical example of outright annexation by the occupying Soviet power.

The Soviet invasion, occupation and annexation were in clear violation of treaties concluded by Soviet Russia with Lithuania: namely, the Soviet action violated the Peace Treaty of July 12, 1920, later reaffirmed by the Pact of Non-Aggression concluded September 28, 1926. On July 3, 1933, a Convention for the Definition of Aggression between Lithuania and the Soviet Union was signed. And, lastly, a Pact of Mutual Assistance was concluded on October 10, 1939.

What changes in Lithuania's international status were brought about by the Soviet military occupation? First, the obvious. Lithuania's incorporation into the USSR was duly recognized by the countries within the Soviet orbit: Latvia, Estonia, Poland, Czechoslovakia, Hungary and Rumania.

During the War, Germany, Italy, and France closed the legations of the Lithuanian Republic. The postwar governments revised this pro-Soviet act. In the postwar period Argentina and Brazil recognized the incorporation of the Baltic States and subsequent : regimes reversed this policy.

What is the attitude of the Free World community toward the recognition of the annexation of Lithuania? According to the Stimson Doctrine, adopted in 1932 by the League of Nations and accepted by the Chaco Declaration (1932), the Saavedra-Lamas Pact (1933), the Bogota Act (1948), and the United Nations Charter (1945), members of the world community are dutybound to refuse to recognize any situation. treaty, or agreement which may be brought about by means contrary to the Convent and obligation of the Pact of Paris (Kellog Pact). Nevertheless, up to the present, the decision lies with each state individually. At present, not a single government in the Free World recognizes DE JURE the annexation of Lithuania. International law does not recognize the formula of QUI TACET, CONSENTIRE VIDETUR (he who is silent seems to agree). Nonetheless, on

the subject of non-recognition of the seizure of the Baltic States, the attitude of the world community differs.

One group of countries recognizes the annexation of the Baltic States DE FACTO, but not DE JURE. This group includes Great Britain, Sweden, Switzerland, Canada and Italy.

Another group of countries, headed by the United States, does not recognize the annexation of the Baltic States either DE FACTO or DE JURE. This group, who adheres to the principle of non-recognition of annexation, also includes Germany, Brazil, Uruguay, Venezuela, Chile, Bolivia, Spain, the Vatican, Panama, Costa Rica, Thailand (Siam), Paraguay, Peru, Liberia, Portugal, Spain, Belgium, Luxembourg, Denmark, Norway, Netherlands, Greece, Ireland, Iceland, Colombia, and Argentina.

Because of their relations with the USSR, some countries that once recognized Lithuania (Yugoslavia, Finland, Austria, Iran and Mexico) remain silent. The position of Japan is also not clear. Australia and New Zealand adhere to the principle of non-recognition.

Modern international law, though not yet in possession of effective means to restore at all times a just order within the world community, excludes any possibility that an aggressor may legalize the results of his aggression by his own means. The aggressor, in this case the Soviet Union, will forever remain a mere occupant. Furthermore, the principle of non-recognition of annexation automatically imposes upon the members of the world community the duty to provide within the framework of international law ways and means of restoring world order. This duty includes thirty states that have had or still maintain relations with the representatives of the Republic of Lithuania.

The attitude of the United States has been one of absolute and uncompromising non-recognition of the Soviet annexation of Lithuania.

The automatic consequence of this refusal to recognize the illegal annexation is the continued full recognition of the legal continuity of the Lithuanian Republic and its diplomatic and consular representatives. Lithuanian diplomats and consuls still function in Great Britain, France, the Vatican, Uruguay.

### SITE OF THE CONVENTION MASS AND BRUNCH SUNDAY, AUGUST 24, 1969

The city of Elizabeth, as one of the oldest and largest cities of New Jersey, boasts of many historical spots dated back to Revolutionary War days. It can also boast of contributing much to the industrial and economic growth of the state of New Jersey, by providing a haven - and job market for numerous ethnic and immigrant groups.

Not the least of these groups is the Lithuanian Community of Elizabeth. They found welcome homes and jobs in Elizabeth, and in return, have become active in many phases of the political, economic, and cultural life of Elizabeth, as well as building a substantial community of their own. They have to their credit a large and beautiful Lithuanian church, a parish school and hall, a Lithuanian Citizens Club and associated Club Hall (Liberty Hall), a Savings and Loan Assn., numerous businesses, and most of all a closely-knit and very active Lithuanian Community.

Following are a few historical highlights relating to Lithuanians and their establishments in Elizabeth. The following history was prepared by William Senkus, of C-52.

#### LITHUANIAN PARISH

In 1878, Lithuanians in Elizabeth, N.J. began organizing and by 1893, planned a Lithuanian parish. On June 28th, 1895, Lithuanian Rev. J. Zebrys held a first Mass privately in a private home in Elizabeth. Within two months, a parish was incorporated with Rev. J. Servetka as pastor, and a church building was started at 218 Ripley Place. The Church was blessed on June 12, 1896.

In 1901, a committee and the second pastor Rev. B. Zindzius, began planning a new and larger church. In 1910, a new brick church, the present Sts. Peter & Paul's R. C. Church was blessed.

A Wayside Shrine Cross was erected in 1947, in the Church yard during the pastorate of Rev. Joseph Simonaitis. K of L'er Stanley Valatka designed and supervised the building and erection of the cross, which is a replica of a cross still standing in Lithuania.

In 1953, Rev. Michael G. Kemezis was appointed Pastor of Sts. Peter and Paul's Church, and served in that capacity until he died, in January, 1969. Following his death, the City Council of Elizabeth voted to rename Elizabeth's Isham Place, "Msgr. M. G. Kemezis Place", in his honor.

At present, the priests of the parish are Rev. Peter F. Zemeikis, Administrator; Rev. Joseph Pragulbickas and Rev. Albert J. Matulis, assistant pastors.

Assisting priests who have served Sts. Peter and Paul's Church were: Rt. Rev. Msgr. Ig. J. Kelmelis (retired), Rev. Edward Budrevicius (deceased), Rev. John Kinta, Rev. Vladas Karalevicius, Rev. John Scharnus, Rev. Vincent Svernelis, Rev. Dr. John Starkus (deceased), and Rev. Anthony P. Kasper (deceased).

#### SCHOOL HISTORY

Saints Peter and Paul School was dedicated in October, 1913. Rev. B. Zindzius' untiring efforts and sacrifice has made a dream come true, when the Sisters of Charity accepted the task of teaching the children. Rev. Joseph Simonaitis, the pastor, later welcomed the Sisters of St. Francis of Pittsburgh, Pa., to teach the children. They are presently still in charge of the school. Enrollment is over 200 students. The principal is Sr. M. Constance. CHURCH CHOIR

When the Lithuanians of Elizabeth gathered in 1895, to attend Mass at 80 Bond Street, they intoned and proudly sang their traditional hymn, "Pulkim ant kelių", and organized a choir soon thereafter.

The first Lithuanian organist and choir master was Mr. Batura. He was later replaced by Mr. John Steponavicius. Under the leadership of Anthony Radzevicius, Anthony Visminas and Raphael Juska, the choir grew in number and expanded its activities.

On January 22, 1929, the well-known composer and artist, Professor Joseph Zilevicius, became organist and choirmaster. Later he retired due to ill health and presently resides in Chicago. At present Vincent Mamaitis is organist and choir director.

LITHUANIAN LIBERTY HALL

The year 1921 marked an important organization event for the Lithuanian American people of Elizabeth for, on May 11, a Lithuanian Community center was incorporated to provide a recreation and social center. In the spring of 1924 a building program was started. The corner stone was laid with a very impressive ceremony, sparked by a parade, music, and speeches by prominent Lithuanian and fraternal and civic leaders and officials of the city. The hall was soon completed and has served as headquarters for social, sports, business, and even religious functions ever since.

In recognition of their contribution to the athletic history of the Lithuanian hall, for participating in baseball, basketball, track and bowling, the names of groups and their members, were nominated and accepted in the LITHUANIAN HALL OF FAME, ELIZ-ABETH, N.J.

LITHUANIAN SAVINGS AND LOAN ASSOCIATION

In 1913, a group of Lithuanians envisioned a dream - a plan whereby a savings institution organized under their own leadership and sponsorship could help their members and shareholders acquire systematic savings and eventual home ownership.

Joseph Akulonis was appointed assistant Secretary on October 29, 1913, and during the past 56 continuous years as a member, has held various offices in the association since 1913 and in 1963, became president succeeding the late Ignacz Budrecki.

#### SOCIETIES AND LODGES

In 1927, Elizabeth Council 52, was host to the

sponsored a track and field championship meet in Warinanco Park, Elizabeth. Elizabeth K of L-er's were prominent in this and numerous other sports activities throughout the history of the K of L.

In 1937, Council 52, was re-organized after a period of inactivity, through the efforts of the late Rt. Rev. M sgr. Michael G. Kemezis, then an assistant pastor of St. Peter & Paul's Church. Father Kemezis and a group of Lithuanian Americans travelled in 1939 to Lithuania to observe and participate in the Lithuanian Olympics. One outstanding Elizabeth member John "Shorty" Peck (Pecukaitis) was chosen as one of the American Squad of twenty to compete in the National Olympiad of Lithuania at Kaunas, Lithuania.

After twenty two years in 1949, the Knights of Lithuania Convention Delegates paraded through the streets of Elizabeth again, to a solemn High Mass in Sts. Peter and Paul's Church. A dinner attended by 350 persons at Essex House, Newark, highlighted the concluding activities of the three day 36th national convention of the Knights of Lithuania. Business sessions were held in the parish hall, and a semiformal dance and dinners were held in Lithuanian Liberty Hall.

Elizabeth Council 52, again welcomes the delegates to attend a solemn high mass of thanksgiving on Sunday, Aug. 24, at St. Peter and St. Paul's church and also to pray for our deceased members.

After Mass, breakfast will be served in the parish hall and convention pictures will be taken of the delegates and guests. Once again, the Elizabeth Knights and Ladies look forward to showing their real Lithuanian hospitality to visiting K of L'ers!

#### ŽIBUOKĖS SEXTET TO SING DURING CLOSING BANQUET

An unusual group of musicians, housewives, a secretary and a mathematician, all Lithuanian and all imbued with the love of music, will provide a

15th National Knights of Lithuania Convention. The sessions were held in the parish hall. Programs, discussions and activities took several days. After the conclave, an excursion to Lithuania was made by delegates. The group sailed on June 19, 1927, from New York, on the SS LITUANIA. Rev. Father Simonaitis, and a group of Knights and Ladies visited many historical places in Lithuania. Father Simonaitis brought back a precious stone from the town of Siluva. It is now encased as a shrine at the Lady of Siluva Altar in Sts. Peter & Paul's Church.

In June of 1930, the NY-NJ Knights of Lithuania

culture "respite" of singing, Lithuanian style, during the Closing Banquet of the Convention, on Sunday, August 24, 1969. This group, calling themselves the "Žibuoklės" Sextet, were organized about 3 years ago, and have been delighting audiences throughout the Eastern USA and Canada ever since. Soloist, musician and K of L member Louis Stukas organized the "Žibuoklės" in early 1966, to fill a need for a vocal group of this type in the Lithuanian-American community of Greater New York, and continues to direct it.

Like their namesake the "žibuokle," a violet-

like flower which appears first in early spring, often before the last trace of snow has melted, the "Žibuoklės" Sextet seemed to also save their "firsts" for early spring ... Their first public appearance, their first full record release, and, this spring, their first appearance before a strictly non-Lithuanian audience, were all Spring events!

The Sextet made its debut at the "Memories of Lithuania" Radio Hour's 25th Jubilee Concer, produced by Dr. Jack J. Stukas, at Webster Hall, New York, in April of 1966. The group was warmly received and a number of its songs were included in the "Memories of "Lithuania" Jubilee Concert Record released by Eurotone International Recording Co. They have since sung to Lithuanians and non-Lithuanians in Boston, Waterbury, Washington, D.C., Philadelphia, Wilkes-Barre, New York, Rochester, and various cities of New Jersey, as well as in Hamilton, Canada. This Spring, on May 9, the Sextet will sing at the National Secretaries' Association, New Jersey Chapter, Convention, at Union, New Jersey.

The "Zibuokles" marked their first anniversary in Spring of 1967 with the release of their first longplay record. The record, also entitled "Zibuokles" and released by Eurotone, included a pleasant collection of 14 Lithuanian and international favorites, many of which the group has sung at its various ap-, pearances.

In February, 1968, the Sextet sang at the New Jersey, Lithuanians' Banquet commemorating the 50th Anniversary of Lithuanian Independence, at the Hotel Robert Treat, Newark, and as a result, are featured on that event's memorial l.p. record, re-leased in Fall, 1968.

More recently, the group recorded a collection of traditional and new Lithuanian Hymns for another l.p. record, released also last Fall by Eurotone. The record includes hymns sung by the "Zibuokles" and by former Metropolitan Opera Star Algerd Brazis, presently of Chicago. Several of the new hymns on the recording are original compositions of the group's director Louis Stukas.

The "Žibuoklės" have achieved great popularity among Lithuanians and non-Lithuanians for their selection of repertoire as well as for their very well blended voices. The numbers they sing are melodic modern compositions as well as new arrangements of popular Lithuanian folk songs. They also do several "ŽIBUOKLĖS" and DIRECTOR

international favorites in a unique bi-lingual (English and Lithuanian) format, a feature which has proven to be very popular, especially among younger audiences. Since several of the group's members are also soloists in their own right, their concerts are enhanced by insertion of solos, duets, and trios as well as singing by the entire group.

Members of the "Žibuoklės" Sextet come from various backgrounds and callings, but are united in their love of music and singing Current members are Louis Stukas, Director, and Edna Mack, Genevieve Mazur, Aldona Pitkunigis, Ona Skurvydas, Loretta Stukas, and Brone Venckus.

arouse the interest of non-members. Getting new members active, assigning them responsibility, allowing them to grow within the organization, is one approach to attracting new members.

Present members can arouse the interest of non-members by taking the time to "Talk Up the K of L." Who would want to belong to an organization with members not interested enough to talk about their own activities? Who would join an organization not important enough to be talked about during daily conversation? No one else will promote the K of L if we do not take the time to do so ourselves. No one else cares about what happens to the K of L unless we do. No one else is concerned about the future of the K of L unless we are. No one cares to join us unless we take the time to talk about what we are doing, what we have planned for future activities, what we are all about. If we are not interested enough to talk about what is happening in the K of L, no one will be interested in us either.




