

FLAG

DAY

On June 14,1777, in the midst of the Revolutionary War, the Continental Congress passed a resolution establishing the Stars and Stripes as the flag of the thirteen American colonies which were fighting for their independence from Great Britain. In honor of that event June 14 has been for many years a day for special display of the flag, but it was not until 1949 that Congress officially designated June 14 as Flag Day. Each year it is proclaimed by the President. It is not, however, a legal holiday, except in the State of Pennsylvania.

Prior to the adoption of the stars and stripes in 1777 there had been a considerable number of colonial and regimental flags. While the pine tree was a popular design, there were numerours other symbols with appropriate slogans. One of the most striking was a rattlesnake, usually coiled and ready to strike, with the slogan "Don't Tread on Me." Since the colonies' separation from the mother country came gradually, it was only by degrees that the union flag of Great Britain was discarded. Even as late as January 1776 a flag used by American troops carried the British union jack. But the resolution adopted by the Continental Congress on June 14 in the following year specified: "that the flag of the United States be made of thirteen stripes, alternate red and white; that the union be thirteen stars, white in a blue field, representing a new constellation." Thus the first authorized flag contained stripes like our present flag. But the thirteen stars on the field of blue - the resolution did not specify their arrangement - was in the form of a circle.

In 1794, after the admission of Vermont and Kentucky to the Union, making 15 states in all, Congress adopted a second flag act providing that one new star and one new stripe be added to the flag for each new state. Interestingly, the flag which inspired Francis Scott Key to write the Star Spangled Banner was the 15 star and stripe flag. Recognizing, however, that the added stripes would soon make the flag unwieldy. Congress in 1818 established the present flag with 13 stripes, for the original 13 states, and one star for each state joining the Union, with any new star to be added to the flag on the July 4 following the admission of the new state. When Congress took this action in 1818, there were already 20 states, five - Tennessee, Ohio, Louisiana, Indiana, and Mississippi - having been admitted since 1794.

As the American nation expanded to the Pacific, each decade saw new territories admitted as fullfledged states. By 1880 there were 38. The decade of 1880 saw no additions, but in the single year 1890 five new states (and stars) were added - North and South Dakota, Montana, Washington, and Idaho. Wyoming followed in 1891, Utah in 1896, and Oklahoma in 1908.

When Arizona and New Mexico were added in 1912 and the blue field of the flag was squared with 48 stars, eight horizontal and six vertical, the flag reached a status that remained unchanged until 1959 when the addition of Alaska and Hawaii brought it to its present 50 stars - five rows of six stars and four alternating rows of five stars.

While June 14 is the official day to honor the flag, it can be displayed on all days when weather permits. Law and custom have developed various practices for the use of the flag, widely considered a symbol of the freedom America stands for, and to insure a proper respect for it. In 1905 Congress forbade use

of the flag in any registered trademark.

With two exceptions, no other flag may fly above the stars and stripes. These exceptions are a church pennant during church services conducted by naval chaplains at sea, and under a law adolpted in 1953 the United Nations flag at UN headquarters. (A.C.N.S.)



SEKMINĖS

POV. DIRKIS

Ką Sekminės ištikro reiškė mūsų tėvams ir protėviams, nesunku suprasti. Tai buvo didelis džiaugimasis vasaros grožybėmis, beaugančiu derlium ir sužaliavusiomis bei sužydusiomis pievomis. Tai buvo žalumynų šventė, kuri prasisėdavo išvakarėse ir tęsdavosi net porą dienų. Kiekvienas gyventojas bandydavo papuošti savo namus, takelius išbarstyti geltonu arba baltu směliu ir apkaišyti žaliuojančiais berželiais. Seklyčių ir klėčių arba svirnų sienos būdavo apkabinamos gražių raštų audiniais, o gyvenamos triobos bei esantieji šventųjų paveikslai buvo apkaišomi žaliuojančiomis lapuočių medžių šakelėmis, įmaišant ir žydinčių gėlių.

Mat, Sekminės lietuviui būdavo ne tik pavasario šventė, bet ir bažnytinė šventė, kuri simbolizuodavo šv. Dvasios atsiuntimą, ir kuri iš-puldavo visuomet septintame sekmadienyje po Velykų. Užtat ir tapo pavadinta Sekminėmis.

Sekminių šventėje senieji ir jaunieji traukdavo į pievas, pamiškius, paupes, laukus, kur įvykdavo vadinami "žalumynų baliai". Juose skambėdavo muzika, tautinės dainos, šokiai ir žaidimai. Kai kur net sukurdavo laužus, kad pasveikinti artėjančią vasarą.

Labai įspūdingai būdavo švenčiamos Sekminės Klaipėdos krašte, kur ta šventė buvo vadinama "Jaunimo švente". Čia jaunimas į laukus išvažiuodavo ilgomis drabynomis, apkaišytomis berželiai. Atvažiuojančių ant kalnelių laukdavo orkestrai, kurie pasveikindavo atvažiavusius. Suvažiavęs jaunimas linksmindavosi iki vėlumos.

Dideliu mastuta šventė vykdavo Kuršių kopose, Juodkrantėje, kur yra nusėta eilė kalnų, kalnelių gražiais ir būdingais vardais: Ieva, Ožis, Avis ir kt. Pagaliau Raganų papėdėje būdavo prisimenama ir tūkstantmetė liepa. Tačiau daugiausiai jaunimo suburdavo Ievos kalnas, kuris sutraukdavo tūkstančius jaunimo net iš Prūsijos. Programoje būdavo: chorai, šokiai, vaidinimai. Visa tai sudarydavo lyg kokią misteriją. Vakaro metu degdavo laužai, kuriuos kurendavo mergaitės baltai apsirengusios vaidilutėmis vadinamos. Tai buvo savotiškas įspūdis, kuris primindavo senus laikus, kuriuose gyveno karžygiai – kovotojai.

Didžioje Lietuvoje Sekminių šventėje būdavo pagerbiamos ir karvės bei piemenėliai: karves piemenėliai parvarydavo vakare gėlėmis apkaišytais ragais, o piemenėliams būdavo ruošiamos bendros puotos-vakarienė.

Šios viso iškilmės ir ceremonijos turėjo gilesnės reikšmės tiems žmonėms, kurie gyveno gražios gamtos aplinkoje.

Tikybiniu atžvilgiu Sekminės primindavo didelį įvykį, būtent: šv. Dvasios atsiuntimą.

LRKSA IŠMOKA SAVO NARIAMS SEPTINTAJĮ DI-VIDENDĄ

Lietuvių Romos Katalikų Susivienijimo Amerikoje Direktorių Tarybos nutarimu, 1969 metais kovo mėnesį nariams bus išmokėtas iš eilės septintas dividendas. Dividendus gaus nariai, kurių certifikatai yra išduoti prieš 1967 metų sausio 1 d. ir kurie buvo galėje 1968 m. lapkričio 30.

Pažymėtina, kad nedaugelis fraternalinių organizacijų moka savo nariams dividendus, o Katalikų Susivienijimas yra pirmoji lietuvių fraternalinė organizacija pradėjusi savo nariams dividendus mokėti.

Dividendų mokėjimą patikrina Susivienijimo tvir-

ta finansinė padėtis.

Taipgi pažymėtina, kad Katalikų Susivienijimas jau pavertė tradicija Kalėdų švenčių proga mokėti pinigines dovanas nariams sulaukusiems 85 ir daugiau metų amžiaus. Praeitų Kalėdų švenčių proga tokios dovanos išmokėtos 106 nariams. Tas parodo, kiek Susivienijimo narių yra susilaukusių gilios senatvės.

Katalikų Susivienijimas turi moderniškai sutvarkytus certifikatus (policies) pilnamečiams ir jaunamečiams; turi pašalpos skyrių šelpti narius ligų ir sužeidimų nelaimėse, taipgi turi Labdarybės fondą šelpti suvargusius narius, našles ir našlaičius.

Į Katalikų Susivienijimą pilnamečiais nariais priimami nuo 16 metų amžiaus, o jaunamečiais nariais gali būt įrašomi nuo gimimo dienos iki 16 metų amžiaus.

Apsidrausti galima nuo \$500.00 iki \$25,000.00. Mokesčiai yra prieinami ir mažesni už kai kurių kitų fraternalinių ir komercinės apdraudos kompanių mokesčius

nijų mokesčius.

Be to, Susivienijimas teikia šias lengvatas: aplikantams įstojimo mokesčio nereikia mokėti; už sveikatos patikrinimą – egzaminaciją, kuriemstokia yra reikalinga, centras duoda iki keturių dolerių kredito; certifikatai įeina galėn nuo įmokėjimo pirmų mokesčių ir įregistravimo centro įstaigoje ir tokio nario mirties atveju pilna apdraudos suma išmokama pašalpgaviui ar pašalpgaviams.

Certifikatai turi tris pasirinkimų vertes išmokėjimą grynais, apmokėtą apdraudą ir pratęsto termi-

no apdraudą.

Katalikų Susivienijimas turi gražių nuopelnų ne tik savišalpos srityje, bet ir tautiniais ir kultūriniais atžvilgiais. Dar carinio režimo laikais Susivienijimas kovojo už lietuvių tautos teises protestais ir memorandumais; organizavo pirmąsias lietuvių mokyklas Amerikoje ir leido reikalingus vadovėlius. Aukomis rėmė lietuvių švietimo įstaigas Amerikoje ir Lietuvoje. Ir šiais laikais Katalikų Susivienijimas nuoširdžiai remia Lietuvos išlaisvinimo akciją.

Dėl to lietuviams vertėtų pirmoje eilėje statyti Katalikų Susivienijimą jame apsidraudžiant ir čia

apdraudžiant savo šeimų narius.




WASHINGTON CONFERENCE

BALFAS ATŠVENTĖ SAVO 25 metų SIDABRINĮ JUBILIEJU

(LITHUANIAN RELIEF FUND OF AMERICA, INC.)

Lietuvių šalpos organizacija, kuri vadinasi trumpai - Balfas t.y. bendrinis Amerikos lietuvių šalpos vienetas, yra vienas iš stipriausių ir pagrindinių organizacijų. Neveltui sakoma, kad Altas, Balfas ir Lietuvių Bendruomenė jau apima visas orga-

nizacijas ir apjungia visus lietuvius JAV.

Ši organizacija buvo įsteigta prieš 25 metus t.y. 1944 m. kovo mėnesį, Chicagoje, kai Europoje dar vyko II Pas. karas ir buvo jaučiama, kad jis gali greitai pasibaigti bei prasidėti lietuvių pabėgėlių šelpimo reikalas. Todėl garbė Chicagai ir jos ano meto veikėjams, kurie tokią reikalingą organizaciją įkūrė, ją rėmė ir rūpinosi lietuvių tremtinių padėtimi Vokietijoje ir kituose kraštuose.

Vėliau į šią organizaciją stipriai įsijungė naujai atvykusieji lietuviai į JAV, papildydami savo darbu ir patirtimi Balfą ir siekdami bendrų tikslų – šalpos išplėtimo ir pagyvinimo reikalo, nes pasaulyje, o ypač Sibire, Lietuvoje, Lenkijoje, Vokietijoje ir kitur esantieji lietuviai reikalingi pašalpos, kaip karo laiko

nuskriaustieji, ligoniai, tremtiniai.

Todėl ši Balfo organizacija stipriai įleido šaknis į lietuvių visuomenę, kuri ją supranta, palaiko ir nuoširdžiai paremia šalpos vajaus metu. Tokiu būdu ji galėjo išsilaikyti jau 25 metus ir gražiu žingsniu žengia pirmyn viltimi, kad Balfas turi pagrindo būti ir toliau palaikomas, ugdomas ir finansiniai remiamas, nes vargas nemažėja, kai žmonės sensta ir yra

ištikti kitokių bėdų ir nedateklių.

Balfas tvarkosi savo statutu. Jo centras yra Brooklyne, N.Y., 105 Grand St., N.Y. 11211, o Chicagoje ir kitur turi savo Balfo skyrius. Kai kuriose vietose veikia ir apskrities valdybos, kurios yra sudarytos iš skyrių atstovų, išrinktų metiniuose skyrių atstovų susirinkimuose. Dabar Chicagoje Balfo apskrities valdybą sudaro: pirm. A. Gintneris, vicepirm. K. Bružas, Pr. Šulas ir K. Repšys, sekret. V. Baleišytė, iždin. K. Čepaitis. Kiti valdybos nariai - F. Sereičikas, A. Stankus ir Jz. Mackevičius. Balfo apskr. adresas: 3221 W. 61 St., Chicago, Ill. 60629. Apskritis turi apie 15 skyrių ir įgaliotinių.

Be to, Balfas turi ir 31 direktorių, kurie yra paskirstyti visoje Amerikoje, jų tarpe turime ir 14 direktorių Chicagoje, apylinkėse ir visoje Illinois valstybėje. Štai jų pavardės: A. Baliūnas, D. Bobelienė, Ald. Daukienė, Alb. Dzirvonas, A. Gintneris, kun. dr. F. Gureckas, V. Kasniūnas, dr. P. Kisielius, Jz. Mackevičius, V. Mankus, kun. J. Pauperas,

M. Rudienė, dr. R. Sidrys ir V. Šimkus.

Dabar Balfo CV sudaro: kun. V. Martinkus - pirm., Alb. Dzirvonas - gener. sekret., A. Senikas - iždininkas ir Jz. Bagdonas - protokolų sekretorius. Balfo reikalų vedėju yra kun. Pr. Geisčiūnas. Revizijos komisiją sudaro: M. Klimas, A. Reventas ir V. Vaitiekūnas. Balfas atšventė savo 25 m. jub. kovo 15-16 d. Chicagoje.

MINTYS APIE MŪSŲ TYLIUS DARBUS

Siame straipsnelyje bandysiu paliesti vieną, kitą mus liečiantį klausimą. Mes daugumoje rašome į "Vytį", retkarčiais ir į kitus laikraščius, kuriuos mes skaitome ir ieškome juose vytiškos dvasios straipsnių. Nors mūsų organizacijai priklauso apie šešiolika šimtų narių, mažai ką apie juos sužinome iš laikraščių. Gal mes patys kalti, kad viską nutylime ir nesistengiame duoti platesnių aprašymų iš savo veiklos. Pačiame "Drauge" skyrius "L. Vyčių Veikla' labai sumažėjo - vyčiai ir jų bičiuliai neturi nieko įdomaus paskaityti. O mums yra žinoma, kad ''Draugo'' vadovybėje - spaudos dr-joje, vyčiai turi garbingų ir didingų organizacijų pirmūnų - vadų: kun. Ad. Abromaiti, inž. A. Rudi, didi spaudos bendradarbį Stasį Piežą, garbės narius - prel. Igną Albavičių ir Leonardą Simutį. Gal toje draugijoje yra ir daugiau garbingų vyčių? Remiantis jų patariamuoju žodžiu, ''Draugo'' redakcija gal užleistų daugiau vietos vyčių straipsniams, o vyčiai daugiau paremtų ''Drauga'' finansiniai. Jei šiam tikslui trūktų lėšų, tai centro vadovybė galėtų pasvarstyti būsimame savo posėdyje ir galėtų išleisti laimėjimo bilietus bei pasiųsti juos kiekviena kuopai ir senjorų vyčių skyriams. Tikiu, kad mes šį sumanymą gausiai paremtume, nes mes nesame tokie vargšai, kad nepajėgtume nusipirkti vienos kitos bilietų knygelės. Skubiai ir šaltai pasvarstykime ir gal būsimajame seime galėsime šį darbą apvainikuoti.

Kas link centro fin. rašt. nusiskundimų bei padarytų pastabų dėl pavėluoto nario mokesčio, iš finansų raštininkės pažymėjimų "Vytyje" matosi, kad mūsų kuopų ir senjorų skyrių nariai, o ypatingai jų fin. raštininkai yra labai apsileidę. Iš paskutinio pranešimo bei paraginimo matosi, kad visoje organizacijoje pilną mokestį yra užmokėję tik trijų skyrių nariai. Taigi broliai ir sesės, vyčiai ir vytės, nejaugi mes tokie pavargėliai-beturčiai, kad negalime laiku užmokėti pilnai savo duoklės. WHY NOT THE LITHUANIANS?

On Feb. 24, while crossing 5th Avenue, I saw a large sign AEROFLOT on the East 49th Street block - and, out of curiousity, gravitated towards it.

A small artificial Christmas tree, gaily trimmed, was still in the ground floor window of the Intourist agency surrounded by posters, leaflets and other decorations. Inside, I asked if literature on Lithuania was available. "No, we do not have any", she replied, with a slight accent.

After looking over the posters and large photographs on the walls of the well-furnished modern office and picking up a few magazines and travel folders from a rack, I offered to pay her for them. There was no charge.

I could not resist remarking about one of the posters which proclaimed something about... "the moon is very far away but Moscow is closer..." and told her of something I read long ago: - Khrushchev, addressing a large assembly, proudly announced "... and in two years we will go to the moon..." A little old man timidly raised his hand, "Please, Mr. Premier, and when can we go to Vienna?"

I could not tell from the slow smile that hovered on the young lady's lips whether or not she got the point.

The editorial in the magazine "Travel To The Soviet Union, No. 10, 1968" is ironically titled 'Tourism is the Passport to Knowledge and Peace'. On page 13, an article, "Art Treasures in Soviet Museums'', features Mikaloius (their spelling) Konstantinas Ciurlionis (1875-1911) ... "Lithuanian composer and artist Ciurlionis is a unique figure in Lithuanian art. A dreamer and a romantic, a visionary and a lyric he created works of great inspiration, and beauty, kindness and humanity. His name will remain forever in the history of Lithuanian and world art". On the same page is a beautiful 6 x 8 reproduction in color of his "Fairy-Tale of Castle (1909)", Ciurlionis Art Museum. (NOTE: Funds for this museum in Kaunas were raised by Lithuanians during the period when Lithuania was independent; it was completed in 1925.)

A familiar name, Maris Liepa, appears in the story on the Bolshoi Theatre. He is also shown in three of the five color photos, performing in a leading part - that of ''Crassus'', in the ballet ''Spartacus''.

On the back cover, picturesque language describes 'Happy New Year in Moscow' under a colorful folkart type illustration of a family at the dinner table with Santa Claus - or, as the Soviets have named him, Father Frost - seated at the head, holding a glass of champagne. Masked musicians stand near the Christmas tree (I dont't know what they call it now).

Couldn't our numerous organizations and "funds"

BY SOVIET LAW LITHUANIA IS OWNED BY KREMLIN

"All Land to the People"
Bolshevik slogan of 1917

A new version of the Soviet law about 'land ownership' has been the subject of a number of articles in the press of occupied Lithuania. The new law seems to differ very little from the old

principles of ownership.

In the U.S.S.R., land belongs to the ''means of production' and therefore cannot be owned privately. The only legitimate owner of land, including the natural resources, is the Soviet State - not the ''republics of the union' of which the U.S.S.R. is composed; and not the kolkhozes or the collectivized peasantry. Thus it is not true that land belongs to those who work it, as the Soviet Constitution states it, either individually or collectively.

If, as Moscow claims it, the Lithuanian "union republic," or its government, were essentially sovereign, it would dispose of its own land. This is simply not the case. All rights of disposal cutilization of the land, for agricultural or other purposes, are reserved to the central bureaucracy in Moscow. Thus the "sovereign" union republics don't have even the theoretical right to dispose over

the land within their territories.

The status of the "union republics" explains why the Czechoslovak communist leaders, familiar with the fate of Lithuania, were so impressed by the Soviet threat to incorporate their country into the USSR. They knew that if Czechoslovakia should lose its formal sovereignty, even under a Communist system, and be incorporated into the Soviet Union, the owner of all the lands and goods of Czechoslovakia would no more be the "people of Czechoslovak Socialist Republic" but the "people of the Soviet Union", represented of course by the Moscow Party and central government. Faced with the possibility, the Czechoslovak Communist leaders chose instead to accept Soviet terms, severely reducing their program of "democratic socialism."

Thus the terrifying example of the Baltic States hangs like a Damocles sword over all of the reformist Communists. In Lithuania, Latvia and Estonia, it is not the ''working masses'' - or even the native Communists - who own the land, but Moscow's party bureaucracy. The same is true about the administration. Any attempt to assert the rights of the Baltic people to their land is immediately branded as ''localism'' and severely punished.

Karl Marx once warned about the concentration of capital and means of production in a few hands since this would lead to political oppression and exploitation. His acolytes in Moscow have embodied

that nightmare.

JUNE A MONTH OF DESTINY

June is a total month in Lithuania's last three turbulent decades. It calls forth memories of doom and despair: the Soviet aggression against Lithuania in June, 1940, and the mass deportations of Lithuanians on June 14-16, that claimed 34, 260 victims.

But it was also in June, 1941, that the Lithuanian people rose against their oppressors in spontaneous revolt and established a free government, soon to be

extinguished by the Nazi occupying power.

This year the month of June marks the middle of the Fifty-First anniversary year since the restoration of Lithuania's independence - the Year of Lithuania's Freedom Struggle. It is highly significant that this June Lithuania's oppressor, the Soviet Union, is working frantically to shore up the collapsing system of lies and oppression in Czechoslovakia, a nation that, like Lithuania, has kept its faith in freedom.

This June the Lithuanian people know that their turn will come as well, as they face the future with hope and confidence. (ELTA)

combine their talents, energy and part of their finances to publish, IN ENGLISH, an attractive illustrated magazine containing current worldwide news of our activities and personalities as well as historical data and facts to counteract misleading statements - a publication which would appeal to the general public and could be sold on newsstands...or, at least, distributed in key locations?

The nearest thing to this idea is the LITHUA-NIAN DAYS magazine, published in Hollywood, California, but it is not available on newsstands. "Darbininkas", "Vienybė", and "Laisvė" used to be among the foreign language newspapers but I haven't seen them on the stands for years.

I am all for preserving our Lithuanian language

and traditions but we do lose many opportunities for disseminating our "cause" by having programs and posters for our more important events printed exclusively in Lithuanian. Hundreds of left-over souvenir booklets from Lithuanian Day at the New York World's Fair 1964, Expo 67, Song and Dance Festivals in Chicago, Third World Lithuanian Community Congress, etc., could have been sent to certain persons, libraries, schools, newspapers, etc. throughout the world had they been printed in English. Many persons in occupied nations, including Lithuania, know English, Fewer dialogues among ourselves about things we have heard over and over again - and further expansion into the outer world would help immensely to acquaint others with our activities and aspirations.



NEWARK, NEW JERSEY
SITE OF THE 56th NATIONAL CONVENTION

Fifty doublehands of powder, one hundred barrs of lead, twenty axes, twenty Coates, ten Guns, twenty Pistols, ten kettles, ten Swords, four blankets, four barrels of beer, ten pair of breeches, fifty knives, twenty horses, eight hundred and fifty fathem of wampum, two ankors of liquers and three troopers coates'. Thus did Robert Treat and his small group of pioneers settle the Hackensack Indian claim for payment of land which now includes the City of Newark.

Even then Newark was considered ideal because of its easy access to other land areas, its 13 miles of waterfront, its rich land and favorable climate. Commerce and industry flourished; tanneries, founderies, the first paint manufacturer, textile, furniture and jewelry firms. And men. Fine men. Great men. Seth Boyden, builder of the first maleable iron foundry, the inventor of patent leather; Edward Weston, the genius who designed electrical instruments, generators, dynamos; John Wesley Hyatt, developer of celluloid - the base of today's giant plastics industry; Rev. Hannibal Goodwin who discovered flexible film, the forerunner of the motion picture industry. The list is endless and impressive.

the financial and industrial hub of the state. It is experiencing a dynamic rebirth with vast areas being transformed into educational complexes, new and expanding industrial sites and office buildings, new housing for its citizens.

At the age of "300" Newark today is truly a city on the move. Our congratulations to those who have helped make this growth possible and to those helping to make dreams for the future come true.

LITHUANIANS IN NEWARK

Lithuanian immigrants began settling in Newark in the late 19th Century. They settled, for the most part, in the "Ironbound" section, so named because it is bounded on all sides by railroad tracks and boasts of several industrial plants in the area. Here, Lithuanians, Irish, Italians, Portugese, Germans and other immigrants found employment as stonecutters, molders, machinists, hatters. They promptly proceeded to establish their own communities and form benefit societies, social clubs, language classes, and other aids to quick assimilation into the fabric of our society.

On Nov. 2, 1891, seven Newark, N.J. Americar Lithuanians gathered and organized the St. George Lithuanian Sick and Benefit Society. The Society was incorporated on Nov. 25, 1893, at Trenton, N.J. The society served a dual purpose. Through membership dues and affair proceeds, it provided insurance and death benefits for Lithuanians who could not afford or did not understand the commercial variety of insurance. Secondly, it provided a beginning for the cultural and social life of the American Lithuanian community and its members. Through the years, the Society sponsored dances, banquets, song fests and parades, and managed to keep Newark Americans of Lithuanian descent together.


On March 31, 1905, the society purchased a lot at 182 New York Ave. Shortly afterward, construction began on St. George's Hall, and on May 31, 1906, the building was completed. In 1956, the hall was modernized, and now includes a small auditorium and a large modern bar on the first floor, and a large air-conditioned ballroom, stage, and kitchen facilities on the second floor. The halls are used for various occasions, especially Lithuanian club dances, banquets, and concerts, as well as weddings, christenings, etc. St. George's will also be the site of the 56th National Knights of Lithuania Convention's Cultural Evening.

CHURCH ESTABLISHED

in 1894, a group of Lithuanians including many members of St. George's Benefit Society called a meeting to start a parish for the Lithuanians of Newark and Essex County. They named the parish Sacred Heart of Jesus. A year later it was changed to Holy Trinity.

The first parishioners were without a home or regular pastor for seven years. They held monthly services in Newark's St. Stanislaus Church and later in Our Lady of Mount Carmel Church. In 1901, the late Bishop John J. O'Commer assigned the Rev. Vaclovas Matulaitis as first pastor. Father Matulaitis purchased property at New York Ave. and Adams St., and a frame church building was erected.

In 1916, under the guidance of Rev. Joseph Dabuzinskas, plans were made for a new and larger church. In October, 1917, the corner-stone was laid in the present church at the corner of Adams and Warwick Sts. In 1962, a new and modern parish hall was built on the site of the original church.



At the time of the building of the new church, about 1000 families were enrolled in the parish. Although this number has fallen and many parishioners have moved from Newark to outlying areas, the church continues to be the place of worship for Roman Catholic Liths in Essex County, Many Lithuanians, though moved from the area, still remain active in the parish and still return weekly for Mass at Holy Trinity, thus keeping the Lithuanian Church alive.

Msgr. Ignas Kelmelis became pastor in Feb., 1922, and served in that capacity until he retired in 1968. He remains as Pastor Emeritus. Rev. John Scharnus, who was born and raised in Newark and served as an altar boy under Msgr. Kelmelis, is currently pastor. Rev. Peter Totoraitis is assistant pastor.

Holy Trinity Church boasts of the St. Cecelia Choir, directed by the parish organist Klem Bagdonavicius, a Holy Name Society, a BVM Sodality, and an Altar and Rosary Society, and several other

societies.

Newark is also home of Knights of Lithuania Council 29, founded in 1915 and active ever since in all phases of Church and Lithuanian community life. C-29 members are active parishioners of and contribute to Holy Trinity, and many also belong to the St. George Society and other organizations.

One of the more significant accomplishments of C-29 was the financing, building and erection of a beautiful Lithuanian Wayside Cross on the parish grounds.

Another of the more active groups in Lithuanian community of Newark are the Lithuanian-American Veterans and their Ladies Auxiliary. Among these groups' achievements are their regular donations of blood to the Veterans Blood Bank, the donation of an Inhalator to the Ironbound Ambulance Squad, the dedication of a plaque to the Unknown Soldier at Arlington Cemetery, and numerous charitable visits to veterans' hospitals, participation in civic projects and parades, and the like.

Newark Liths also form the core of the Lithuanian American Council (Taryba) of New Jersey, which has sponsored a series of successful events commemorating Lithuanian Independence Day, Joint Bal-

tic Nations Rallies, etc.

Newark Lithuanians, as well as those from outlying areas of New Jersey and of New York, now anxiously await the opportunity to participate in the 56th National K of L Convention, to be held in Newark.

Knights of Lithuania New York - New Jersey District Hosts to the 56th National Convention



"RUTA" ENSEMBLE CULTURAL EVENING PERFORMERS FRIDAY EVENING, AUGUST 22, 1969

To attend a social gathering of K of L'ers and not hear the familiar strains of "Kai Aš Turėjau", "Buvo Gera Gaspadinė", or other will known Lithuanian "Sing-Alongs" is indeed a rarity ... And more often than not, 'background accompaniment' to the singing is provided by one or another "Sing-Along in Lithuanian' long-play record, by the wellknown "Rūta" Lithuanian Ensemble of New Jersey.

This August, delegates and guests to the 56th National Convention will have the opportunity to enjoy IN PERSON the songs of "Ruta" during the Convention's Cultural Evening, Friday, August 22, 1969, at Newark's St. George's Lithuanian Hall.

The "Ruta" Ensemble was "born" in October, 1941 when Jack J. Stukas, director of the newlyorganized radio hour, "Echoes of Lithuania" formed a chorus as a part of his broadcast activity, naming it "Lietuvos Garsai", or the "Echoes of Lithuania" Chorus. The chorus of 35 voices, under Mr. Stukas' direction, first appeared in December, 1941, at a program honoring Antanas Smetona, president of the

Lithuanian Republic.

As World War II called away most of the young men, the chorus suffered a short period of inactivity. In 1944, it was reorganized as a 20 voice women's chorus, and renamed the "Rūta Chorus". It again began entertaining audiences in the New York-New Jersey area with Lithuanian songs. In 1945, a "Rūta" Lithuanian Folk Dance Group was also formed, as an adjunct to the Lithuanian Hour, now called the ''Memories of Lithuania' Radio Hour.

The women's chorus eventually became only a women's quartet. In 1950, under the leadership of Louis Stukas, a mixed chorus was again organized and continued singing under the name of 'Ruta''. At the same time, the dance group was united with the choir, to form the "Rūta" Lithuanian Ensemble. The Ensemble, plus the still-active quartet, appeared together as a unit in January, 1951 at the celebration of the 10th Anniversary of "Memories of Lithuania". During its existence, the dance

group of the "Rūta" Ensemble made numerous successful appearances in Lithuanian and non-Lithuanian circles, but it slipped into inactivity in 1961.

The "Ruta" Chorus, under the direction of Algirdas Kačanauskas from 1951 to the present time, has continuously grown in size, activity, and popularity. Although no longer an adjunct of "Memories of Lithuania" Radio, it appears frequently on special commemorative radio shows and/or radio-sponsored concerts. It has also appeared several times on Lithuanian TV programs and at various Lithuanian and non-Lithuanian concerts and commemorations.


"Rūta" participated in the First and Second Lithuanian Song Festivals of the USA and Canada, held in Chicago, and in several religious festivals. The chorus was significantly present at the New York World's Fair in 1964, as part of the Fair's mammoth Lithuanian Day at Singer Bowl in August, 1964, and as principal singers at several Lithuanian Day festivities in other pavilions of the Fair. As a "request performance", "Rūta" recorded a special video-tape at the RCA Pavilion, which was played on TV for the pavilion's audiences for two weeks. Most recently, "Rūta" gave most successful concerts in Wilkes-Barre, Pa. in Sept., 1968 and, under the sponsorship of K of L C-26, in Worcester, Mass., in October 1967 and again in April 1969.

The present "Rūta" Ensemble recorded its first longplay record in 1959, together with soloist Lione Jodis. Since then, they have made two best-selling "Sing Along in Lithuanian" Albums, featuring favorite Lithuanian folk songs, and a "Christmas in Lithuanian" record, which includes traditional Lithuanian and international Christmas hymns and carols. All these records will be available for purchase during

the Convention.

Although best known for their Sing-Along recordings, "Rūta" can draw from a vast repertoire of Lithuanian folk songs, recent Lithuanian compositions and opera selections, as well as many international classical and popular favorites. Thus, their concert for the K of L Convention promises to be interesting, varied and enjoyable!



St. Peter's parish in the twenties and thirties had no parochial school. Consequently, her youth attended public schools. Anthony Jurgelaitis received his early education at a Public Elementary school, and graduated in 1935 from Boston Latin high school. His first formal training at a Catholic Institution was when he metriculated at Providence College from 1935-37.


Studies for the Priesthood were pursued by him at St. Thomas College (Philosophy) at River Forest, Ill. from 1938-40 receiving a Bachelor of Arts degree. Father Antoninas completed his third year of Philosophy at St. Joseph's Priory in Somerset, Ohio.

He received his Theological training at the Pontifical Faculty of Theology in Washington, D.C. from 1941-44. In 1945 he received both Lectorate and Licentiate degrees in Sacred Theology.

June 7, 1944 he was ordained to the Priesthood by His Excellency Bishop J. M. Lemieux in Washington, D.C.

Father Jurgelaitis did not culminate his studies with his ordination to the Priesthood. However, he entered the Catholic University at Lima-Peru were he remained from 1945-48. A Doctorate of Letters were his reward for a Dissertation submitted on "A study of the Christiada by Fr. Diego de Ojeda, O. P.''

Additional studies in Philosophy were continued in So. Amer.



In September of 1949 he returned to the U.S. and was assigned to Providence College as a Professor of Spanish.

Presently, Father is Chairman of the Modern Language Department at Providence College, a position he has held for the past several years. He is active in professional language associations, and in cultural exchanges with Latin America. He was awarded the Our Lady of Guadalupe Medal for advancing the Good Neighbor Policy on College Campuses by Saint John's University, L. I., N.Y.

Our jubilarian has always manifested a keen interest in the Knights of Lithuania. He is a member of the organization since boyhood. In C-17 So. Boston he

participated in dramatics, wrote articles for the Vytis, and translated stories from English into Lithuanian. Later, he transferred his activities to C-103 in Providence, R. I. Father was Chaplain of the NED, and is a recipient our organization's Third Degree.

St. Casimir's parish and C-103 in Providence were serviced by Father Jurgelaitis during his 20 years in our city. The late Father John Vaitekunas, and our current pastor Ft. Vaclovas Martinkus have time and again availed themselves of his help in parish work on weekends. His eloquent sermons both in Lithuanian and English are food for our souls.

The members of various organizations in Providence have banded together in forming a Jubilee committee honoring him on the occasion of his silver anniversary as a priest. On June 1st, Father Jurgelaitis offered a Mass of Thanksgiving at St. Casimir's parish in Providence. Following the mass a testimonial dinner given in his honor. The following Sunday he offered another Mass of Thanksgiving for his family, relatives and friends at St. Peter's church in South Boston, Mass.

The Knights of Lithuania, and the Lithuanian Community wish to express their sincerest appreciation to Father Jurgelaitis for his numerous services to "God and Country".

REGISTRATION OF A JUNIOR COUNCIL WITH THE SUPREME COUNCIL

1. As soon as a Junior Council is organized, notification should be sent to the Supreme Council 1st Vice President.

2. Dues of \$5.00 per year for the Junior Council should be sent to the Supreme Council Financial Secretary. Dues are payable in January - if the Junior Council is organized during another month, the Supreme Council 1st Vice President will notify you of the amount to send to the Financial Secretary.

3. All Junior members are required to register with the Supreme Council. Registration cards will be sent when the Vice President is notified that a Junior Council has been organized. According to the registration cards returned, membership cards will

be issued to those members.

4. Supreme Council Vice President should be sent the following information:

(A) Name and address of person to receive copies of Vytis - there are 5 copies sent to each Junior Council.

(B) Names and addresses of Spiritual Advisor and Junior Counsellor(s).

(C) Names and addresses of Junior Council Officers. This list should be forwarded every year, as soon as possible after elections are held.

5. Counsellors should maintain contact with the Supreme Council through the Vice President, by supplying or requesting information, asking for advice or suggestions - or making same to the Vice President.



Dues have been pouring in - new members are being signed up - everyone is looking forward to the coming convention and hopefully toward reports about the prosperous growth of the Knights of Lithuania during the past year.

Only one council in the 100-member-and-over category has a fully paid membership. Congratulations to C-26 Worcester and Fin. Secy. Elena Pin-

kus.

And, neither C-36 Chicago, nor C-96 Dayton, which are the only councils in the 60 to 99 - member group, are completely paid. If that trend is any indication concerning final results, these mainstay councils will not have grown at all, and indeed, will have lost members. We hope that they come through in the clutch by getting their members paid up so that their new members really count as "new K of L'ers" rather than merely replacements for those that have not paid dues this year.

On a cheerful note, all of the other councils with more than 100 members are at least 80% paid up. There is only one council which remains completely unpaid - perhaps Council 103, Providence, R.I., can put forth a home stretch effort to sustain it-

self.

To see how your council ranks in relation to other, as far as dues payments and membership enrollments, please take the time to at least glance at the membership chart which appears in this issue of "Vytis". It will be the last record of council standings until final official figures are presented at the convention in August.

It is obvious that some cooperative efforts toward teamwork are necessary in a few councils. In order for the K of L to retain its significance within the Lithuanian communities in this country, each council must strive to hold on to its present members and unify them into a meaningful organization that can attract others.

Do not forget this year's rules governing the

dues payment and membership drives. The special Membership Drive awards will be presented to councils in each of the following categories for being the first with 100% paid-up memberships, or having the largest net gain in membership.

Awards for dues payments and membership will go to councils in each of the following categories: First Category. - 11-29 members; 2nd - 30-59 members; 3rd - 60-99 members; and, finally 100 members and over.

Individual credit for enrolling members will be earned only if the following rules and dates are observed:

TEN points were earned for each new or rejoin member enrolled from August until April 1, 1969.

FIVE points can still be gained for each new or rejoin member you enroll from that date until July 10, 1969.

Membership totals will be supplied by the National Financial Secretary according to her records from August 1, 1968, to July 10, 1969. Council awards will be presented for the greatest percentage of per capita increases based on these net gains.

As far as enrolling new members, it is already too late to obtain the TEN big points that have been offered. But until July 10th - the final date of the DUES-MEMBERSHIP DRIVES - you can still earn FIVE points for each new or rejoining member.

Because the drive for new members is based on net membership gains, only those councils that reach 100% paid-up membership become eligible for that award.



HOW WE CAN IMPROVE THE COUNCIL ACTIVITIES SECTION.

- 1) Use items about unusual happenings. Especially personal or council activity that brings out the purpose and ideals of our organization. Write your column as soon as possible after the affair while the details are still fresh in your mind. Do not write about an event that is scheduled to take place in the next few days or weeks. By the time the VYTIS is published, this event will have taken place. So report on that particular function after it has occurred or write it up in the past tense.
- 2) Use short words which will be clearly understood by everyone. Remember, easy writing makes for easy reading. Don't use the same phrase or descriptive word repeatedly. Don't hurt or degrade anyone. Read over your piece to see if it's smooth. Cross out all extra and meaningless words. Write only when you have something to say. Don't just fill up space. Stop using meaningless initials. Outside of a dozen people who know why D.S. had his eye on S.W., who cares? Our magazine is international. Use complete names and use names frequently. Everyone likes to see his or her name in print, but don't go overboard! Don't try to name all the people who were present at a picnic, party, meeting or banquet. Listing special guests is a very good idea. Don't forget that we are Lithuanians. Try to insert a few words or phrases 'Lietuviškai'.
- 3) Type your articles if at all possible double space. If you do not use a typewriter, write as legibly as possible.

Keep a carbon copy or accurate notes of your article so that items are not repeated.

- 4) We ask for news items about everyone, and not a lot about a few. Lack of space presents a problem in some issues and Council News must be cut to accommodate each council's news. Try to keep your news down to two typewritten double-spaced pages. The editors never omit an entire article, but often will condense.
- 5) Send in photos of your activities. The photos, whether printed or not, will be retained unless the sender requests a return.
- 6) All council news must reach the editors by the fifth of the month preceding the issue for which it is intended. The editors assume no obligation to return any unsolicited material. Send your material in well before the deadline. Your punctuality will give your article a better break and it will be appreciated by all concerned.
