



And so it was... a new era for the K of L, in new surroundings. Less formal, but more congenial... fewer "services", but more opportunity to "do your own thing". Perhaps it was the clear Maine air, or the quiet but breathtakingly beautiful surroundings of the Lithuanian Franciscan Monastery, or the most welcome presence of more K of L families, with children of all ages, that made this convention so refreshingly new and different. Whatever the reason, from the time of the first K of L arrivals on Sunday, Aug. 22, to the last departure on Monday, Aug. 30, the monastery gardens and buildings abounded with happy sounds, smiling faces, and evidence of a burst of new energy in the K of L.

Business sessions were better-attended than ever before (at least 85 and as many as 110 delegates and guests attended each plenary session), and more members expressed their ideas for the betterment of the organization. Numerous important resolutions were passed, both for improving organizational and for obtaining outside support from political and religious leaders for causes vital to Lithuanians.

Each mid-day, delegates paused to attend Holy Mass, celebrated or concelebrated by some of the many

members of the clergy in attendance.

Social activities boasted of formal and informal, fun-making and news-making functions. Ladies' outfits ranged from shorts to pants-suits to granny dresses to cocktail dresses, and entertainment included an outdoor lobster and clam bake and indoor ballroom and folk dancing, community singing, excellent soloists, and of course the very exciting introduction and be-medaling of Capt. Roberts Brieze, the seaman who told the world of the tragedy of Simas Kudirka.

The following pages recall the highlights of the 58th National Convention, from business and social aspects. We hope they will serve to help individuals, councils and districts plan their future programs

based on ideas and suggestions discussed during those four important days.

# STATE OF THE ORGANIZATION REPORT

The 58th National Convention of the Knights of Lithuania State of the Organization report was compiled from the annual reports of the Supreme Council Officers and Committee Chairman.

#### SPIRITUAL ADVISOR

The Knights of Lithuania is most grateful to its Spiritual Advisor, the Rev. Albert J. Contons of Brighton, Mass. for his counsel and guidance throughout the year. His report to the convention appears elsewhere in this issue. Sincerest congratulations are extended to Rev. Contons on his recent election to the post of President of the Lithuanian Priests' League, replacing the late Rev. John C. Jutt.

#### PRESIDENT

Dr. Jack J. Stukas, Newark, National President presided at Supreme Council meetings held in Newark, Pittsburgh, and Worcester, and directed national K of L activities during the year. His full report appears elsewhere in this issue. The Knights of Lithuania is appreciative to Prof. Stukas for the many hours and concentrated efforts extended for the good of the K of L.

#### FIRST VICE-PRESIDENT

Juniors Vice-President, Albert Jaritis of So. Boston, attended Supreme Council meetings in Newark and Worcester. He assisted in the Juniors' program in New England, and proposed possible contests in photography, art, and essays for Juniors. He also did some preliminary work in setting up a ritual point system for Juniors.

#### SECOND VICE-PRESIDENT

Membership Vice-President Frank Zapolis of Chicago designed a new triplicate-form membership application, which is being printed and will be described in VYTIS when available. He conducted a membership drive, whose results appear under "Official Highlights" in this issue. Of the 39 active councils, 17 had gains, 16 had losses and 6 remained the same. A net gain of 26 members was realized.

#### THIRD VICE-PRESIDENT

Seniors Vice-President Vincent Ed. Pavis of Youngstown attended one Supreme Council meeting in Pittsburgh. He reported a general lack of interest of councils in the Seniors movement, judging from the extremely poor response received from councils to his request for information on and suggestions for improvement of the Senior Councils. He none-theless urges more councils to establish Senior Councils and to require those over 35 to join, so as to leave the regular councils in the hands of younger members.

#### RECORDING SECRETARY

During her year as Recording Secretary, Nancy Kober of Great Neck, notified all officers, committee members and Honorary members of Supreme Council meetings, attended two meetings, (in Newark and Pittsburgh), and kept a record and mailed the minutes of those meetings to all parties concerned. She also compiled and mailed the official list of officers and committee chairmen, and the list of council presidents and secretaries.

#### FINANCIAL SECRETARY

Irene Rakaitis of Chicago, National Financial Secretary, reported a gain of 110 members and a loss of 84, leaving a net gain of 26, for a total membership as of Aug. 1971, of 1620. 6 councils have 100 or more members - C-7, Waterbury, C-26, Worcester, C-29, Newark, C-79, Detroit, C-96 Dayton, and C-112 Chicago. There are 39 councils, including 6 senior councils. One council, Pittsburgh Seniors, was dropped for non-payment of dues.

#### TREASURER

Stella Sankal of Cleveland attended one Supreme Council Meeting, and handled her duties with efficiency. The records of our organization were properly maintained and funds wisely invested. Her records were audited by Trustee Frank Gudelis before Convention and were made available to all interested delegates during the Convention.

#### TRUSTEES

Trustees Algerd Brazis of Chicago and Frank Gudelis of Dayton were not present at the Convention, but Mr. Gudelis traveled to Cleveland prior to the convention, where he audited the Treasurer's books, together with Honorary Member Juozas Sadauskas.

#### LEGAL ADVISOR

No report was received from National Legal Advisor, Anthony Stokna of Amsterdam, due to his illness. However, Mr. Stokna is currently handling the legalities of obtaining records and remaining monies from former Scholarship Fund Treasurer Irene Wood.



#### ILLINOIS-INDIANA DISTRICT

No report was received from Illinois-Indiana President Algerd Brazis of Chicago.

#### MID-CENTRAL DISTRICT

President Vincent Ed. Pavis of the MCD reported that the district's 23rd Annual Convention was held in Cleveland on Oct. 17, 1970. The 24th will be held in Detroit, Mich. on Oct. 9-10, 1971. The planned 1971 K of L Camp Dainava Week was cancelled due to lack of interest and support on the part of the membership, but the project will be reconsidered for 1972.

A most successful Pilgrimage to the Three Crosses Shrine, Dayton, was held Sun., June 27, 1971, and was preceded by a Lithuanian Luau at the home of Mary Lucas. Numerous other activities were sponsored by the 9 individual councils in the district.

#### NEW YORK-NEW JERSEY DISTRICT

No report was given by District President Anne Klem of Kearny. However, Miss Klem attended the Convention and served on the Nominating Committee.

#### CALIFORNIA

No report was submitted.

#### NEW ENGLAND DISTRICT

President Longinas Svelnis of So. Boston, reported that the NED has in its active council list 8 regular, 1 senior and 1 junior council. Also, C-18, Cambridge is being reactivated and will host the District's Fall Convention. The 4th Cultural Picnic is planned for Sept. 12 and the second TV Mass will be held Apr. 9, 1972 in Boston. Main efforts of the NED were concentrated on hosting the 58th National Convention.

#### VYTIS

Editor Loretta Stukas of Newark, with her staff of Anthony Yuknis, Rita Ochs, Josephine Zukas, Mary Kober, Balys Vyliaudas, Marilyn Kareiva, and Irene Sankus, published 9 issues - 7 monthly and 2 bi-monthly, since assuming their duties in Nov. 1970. Printing is done by VI VI Press, and mailing by Harper & Co., both of Chicago. \$450.00 was realized from VYTIS Christmas greetings, thus assisting with the financing of the publication. No major problems have been encountered, and members' response has been favorable. Future plans for regular columns include Letters to the Editor, Lithuanian Receipes, Editorials, and others.

#### LITHUANIAN AFFAIRS COMMITTEE

The Lithuanian Affairs Committee, as well as the entire K of L organization, suffered a tragic loss with the sudden and untimely death last June of Rev. C. Jutt, Lithuanian Affairs Committee Honorary Chairman.

Before his death, Father Jutt reported informally to the President that this had been a record year for publicity and letter writing for the Lithuanian cause, due in great part to the defection attempts of Lithuanians Simas Kudirka, the Brazinskas' and the Simokaitis'. Father also assisted the VYTIS Editor in preparing the June-July issue of VYTIS which commemorated the 25th Anniversary of the Lithuanian Affairs Committee.

At the request of the Supreme Council President, District and Councils held special masses for the soul of Father Jutt in various K of L cities. Also, the K of L year 1971-1972 was designated as the "Rev. John Jutt Memorial Year." Members are urged, as a tribute to Father Jutt, to intensify their efforts in working with this Committee.

#### LITHUANIAN CULTURAL COMMITTEE

Chairman Mary Jankowski of Worcester, concentrated her efforts in the New England District, but had mail contact with the chairmen of other Districts' and councils' Cultural Chairmen. She attended two S.C. Meetings, supplied information when requested, and assisted with cultural displays at the National Convention and the NED Cultural Picnic.



#### RITUAL COMMITTEE

The National Ritual Committee, Frank Zager of Detroit, Chairman, Rita Pinkus of Worcester and Helen (Zimmer) Skudra of Chicago, reported that 10 councils reported on their ritual activity. 18 First, 17 Second, and 7 Third Degrees were reported. 8 members were scheduled to receive the Fourth Degree during the convention but only 5 of these were present to receive the degree. The committee requested that applications for 3rd and 4the degrees give better information as the specific activities and offices for which points are awarded.

#### HONORARY MEMBERSHIP COMMITTEE

No report was submitted, but a resolution was passed to present Longinas Svelnis with Honorary Membership at the 59th National Convention.

#### PUBLIC RELATIONS COMMITTEE

Reports were received from Juozas Sadauskas of Cleveland and Susan Boroskas of Brockton. Mr. Sadauskas publicized the K of L activities of Cleveland and the MCD, as well as several S.C. meetings, widely in the Lithuanian press. Mrs. Boroskas concentrated her efforts mainly on getting an appreciation of Lithuanian culture and knowledge of Lithuanian activities across to the younger genera-





tion of Liths and to non-Liths in the NED, by spreading English language books and pamphlets about Lithuania, and by exhibits and radio coverage.

Mention must also be made of excellent publicity work done by A. Skirius of California, V. Samaska of Chicago, F. Vaskas of Newark and H. Kulber of New York.

#### SCHOLARSHIP FUND

Chairman Dr. Jack J. Stukas of Newark met with committee members Gerald Zager (Detroit) and Walter Svekla (Philadelphia) during the convention to select 3 recipients of the 1971 award. The winners are introduced elsewhere in this issue. Dr. Stukas also reported that no final report has been received from former treasurer Irene Wood of Amsterdam. Mr. Zager presented a financial report of the Fund for the past year.

#### LITHUANIAN CATHOLIC RELIGIOUS AID

Rev. Raila thanked the K of L for it's past support and donations of \$278 received to date from the organization. He further asked councils and districts to become more active in assisting the LCRA's work, morally and financially.

Father Raila also strongly urged that more efforts be concentrated on seeking out new leaders


from the ranks of the youth.

#### SPIRITUAL ADVISOR'S REPORT 1970 - 1971



Dear Delegates and Guests:

It has been a source of satisfaction to have the privilege of serving as Supreme Council Spiritual

Advisor during the past year.

As a result of the Chicago convention in August of 1970, I prepared an article entitled RELIGIOUS FREEDOM IN LITHUANIA - SOVIET MYTH. This article was published in the Boston Pilot, Vytis, and Garsas. We arranged with Immaculata Press to print 10,000 copies in leaflet form. These were circulated through various K. of L. Councils and others. It proved most useful in many ways: distribution to the members of the Boston Priests' Senate, Lithuanian Priests' League, National Convention of the General Women's Clubs in Pittsburgh (900 copies).

I am most grateful to all who helped in circulating these leaflets.

During the past year I attended Supreme Council meetings in Chicago (post convention), Newark in November, New England District Conventions in Athol (Sept.) and Brockton (May), convention planning meeting of the New England District in Maironis Park, etc.

In the aftermath of the Simas Kudirka incident I wrote letters concerning this matter in the name of the K. of L. to the Boston Herald, President Nixon, Senators Kennedy and Brooke, Secretaries of State and Transportation and introduced an appropriate resolution in the Boston Priests' Senate, which unanimously passed it.

It was with the deepest regret that I learned of the untimely and tragic death of Father John Jutt. Unfortunately, I was in Europe with a student travel-study tour June 26 - August 5 and was unable to attend the funeral service.

May God bless all of you who are so devoted to the ideals and work of the Knights of Lithuania!



(Summaries of reports of other national officers national committee chairmen are given separately, as has been done in previous years. and therefore are not herewith included).

As President, I again spoke at numerous social, cultural and political affairs during the year. I sent numerous letters and telegrams in the name of the K of L, seeking political aid for the Brazinskas', Simas Kudirka and Simokaitis' occurrences. addition, I organized a prayer campagn for Mr. Kudirka, with masses sponsored by the K of L in various cities throughout the country. This campaign received considerable publicity in the local American press. The cooperation of all K of L'ers in this prayer campaign is deeply appreciated.

A recording (1/p) of the Papal Mass and ceremonies of the Blessing of the Lithuanian Chapel in Rome, in 1970, is now in production and will soon be released by Eurotone Records. It is being done in the name of the K of L, without cost to our organization. However we must distribute as many as possible to help the company at least recoup its costs. It will sell for \$5.00, with quantity discounts

available.

I called, and participated in Supreme Council meetings: Nov. 8, 1970 in Newark, N.J.; Mar. 28, 1971 in Pittsburgh, Pa., and June 27, 1971 in

# NATIONAL PRESIDENT'S **ACTIVITIES** 1970 - 1971

Shrewsbury, Mass. (Maironis Park). Formulated agendas for the meetings, and handled all correspondence and action on matters discussed and voted on.

In this connection, your President is unhappy over the fact, that many Supreme Council officers and National Committee Chairmen do not participate in SC meetings, nor do they submit reports as requested. In the future, similar to the Amerikos Lietuviu Bendruomene organization, SC officers should be concentrated in one District or area to make frequent and fruitful meetings possible, or SC officers from faraway areas should be reimbursed in full for their transportation expenses. However, there is no excuse for the non-submission of required reports.

From July 15 to 30, your President led an unofficial K of L tour, sponsored by the Jersey Shore Travel Agency, to 3 Scandinavian countries.

Our group comprised 10 people.

I have agreed to organize, and assume responsibility, for a 15 or 17 day trip, approved by the SC, to be sponsored by the K of L, to 5 South American countries: Venezuela, Colombia, Argentina, Uruquay and Brazil. Cost per person, approx. \$800. Through 5 joint programs (concertfolk dance fetes), one in each country to be visited, K of L'ers participating would be able to meet local Lithuanian youth and possibly start an international K of L movement. The trip would take place in late June or early July, 1972.

In July, of this year, with great sadness I attended the funeral of Rev. J. Jutt, who for 25 years of hard work on his Lithuanian Affairs Committee, endeared himself to all of us and was an inspiration and a beacon of light to us. I appreciate the various Districts sponsoring memorial masses for the repose of his soul, in accordance with my

request.

And finally, I am still seeking active cooperation with other major Lithuanian organizations in this country, by the K of L, especially the Bendruomene and Altas, for only in unity with all, shall we find strength in our work and activities for God and Country.

# ROBERTS M. BRIEZE

14th RECIPIENT OF THE FRIEND OF LITHUANIA AWARD

Now named ''The Rev. John C. Jutt - Jutkevičius 'Award Medal

Following is the text of talk given by National President Dr. Jack J. Stukas, in awarding the Gold Medal to Mr. Brieze, during the Closing Banquet of the 58th National Convention of the Knights of Lithuania, on Sunday, Aug. 29, 1971, at the Franciscan Monastery, Kennebunkport, Maine.

Mr. Toastmaster, Your Excellency, Bishop Brizgys, Vicar General, Reverend Fathers, General, Knights and Ladies of Lithuania ...

This afternoon, our organization is honored and privileged to pay due respect to a modern "Paul Revere." We all recall from our American history the midnight ride of Paul Revere, who rode through the entire night, arousing his countrymen that the British were coming ...

Our esteemed guest, ROBERTS M. BRIEZE, last November 23rd, similarly called the attention of the American nation and the entire world as well, to the tragic story of a Lithuanian seaman, Simas Kudirka, who had jumped from a Soviet ship and sought asylum on an American coast guard cutter, the "Vigilant", in American territorial waters, was severely beaten by Russian seamen on the American ship and in an unconscious state, returned to . the Soviet vessel in an American lifeboat. Surely Our Lady of Liberty. whose statue has stood for many years in New York harbor and represents America's promise and will to be a haven for all those who flee oppression and discrimination, must have covered her eyes in shame that

shouted the incident in rightful indignation to the world, Simas Kudirka and his great sacrifice would not have been made known. Yes, Mr. Brieze, you were the Paul Revere of America last year. telling the whole world of the injustice rendered Simas Kudirka, and of the tragedy of the Baltic peoples of Latvia, Estonia and Lithuania, who lost their freedom and independence after World War II to the Soviets, whose armies occupied their lands and to this very day refuse to return freedom and independence to them.

I don't think that Mr. Brieze realized, that in alerting the world to the Simas Kudirka tragedy, that he would call the attention of all nations to the plight of the Baltic States formerly sovereign member states of the League of Nations prior to World War II, whose people were decimated, tortured, exiled and incarcerated when the

cupied them in 1940. Almost every newspaper and every radio station in the Free World last November carried an account of the Kudirka incident, and at the same time, recalled the unhappy fate of the Balts.

Just a few weeks ago, the free world was again reminded of the Simas Kudirka incident and the denial of liberties to the Baltic peoples by the Russians, when an account of his trial in Vilnius was somehow, albeit miraculously released ...

Asked whether he considered himself guilty, Simas Kudirka answered: "I do not consider myself guilty, since I did not betray my homeland, Lithuania. I do not consider Russia, called the Soviet Union, my homeland." In the trial, Kudirka reflected on the waves of Lithuanians that went with their young to the concentration camps, and how the death of Stalin saved his people from physical extermination. He continued: "Now we are destined to die a much slower death' - assimilation. However, we don't want to die. For 10 years our brothers in the woods, the Lithuanian partisans, fought for Lithuanian freedom and 50,000 of them were lost." Simas Kudirka stated further: "A new young generation has grown up, which intends to take the same road as their fathers." Before sentencing, Kudirka declared that he was a devout Catholic and wished to have a priest to give him the last rites of the Catholic Church. He had but one request: "THAT YOU GRANT MY HOME-LAND LITHUANIA INDEPEN-DENCE." Fortunately, he was not sentenced to death but to 10 years who like Paul Revere, Communist Russian forces oc- labor in a strict regime camp

In 1950, on August 4th, about 100 Baltic refugees, seeking a new homeland, undertook the dangerous venture of crossing the mighty and forboding Atlantic in this vessel. It took them 25 days to cross the Atlantic and they were held six months by our Immigration authorities in Boston.

However, in recognition of this spectacular voyage to freedom in America, by a special act of the United States Congress. the Baltic refugees were given the right to remain and live in the United States. Since 1951, Mr. Brieze and his family have lived in Fairhaven, Massachusetts. As an able and experienced seaman. Mr. Brieze now has two fishing vessels and is President of the New Bedford Seafood Producers Association.

Such is the background of the man the Knights of Lithuania honor today. A man who knows what it is to lose his homeland, his family and his freedom. No wonder, then, that Mr. Brieze alerted the world to what happened to Simas Kudirka and to American ideals on that fateful day last November. We all know some of the details of this unfortunate incident which were published by a special congressional committee which investigated it. I am sure you will want to hear the story in a few minutes from Mr. Brieze himself who witnessed this sordid affair.

# FREEDOM and DIVINE PROVIDENCE

by Msgr. William Cuneen, V.G.

Sermon delivered by Msgr. William Cuneen, V.G., Representative of the Bishop of Portland, during the Convention Closing Mass, Sunday, Aug. 29, 1971.

"Blessed are they who suffer persecution for justice sake, for theirs is the kingdom of heaven. Blessed are you when men reproach you, and persecute you, and, speaking falsely, say all manner of evil against you, for my sake. Rejoice and exult because your reward is great in heaven." Matt. V 10-12.

"If the world hates you, know that it has hated me before you... No servant is greater than his master. If they have persecuted me they will persecute you also... these things I have spoken to you that you may not be scandalized." John XV 18, 20, 21, XVI 1.

In your native land of Lithuania you would not be able to gather in peace and tranquility this day to join Christ as He offers Himself through the human instruments of myself and the priests who will celebrate this Mass with me. I bring you greetings of Bishop Gerety and Auxiliary Bishop O'Leary. As a Vicar General of this diocese of Portland, I officially represent the diocese within whose territory your priests have found a home.

When I was assigned to this honor I asked the priests here at St. Anthony's to give me information about Lithuania. Loss of independence negatively affected Lithuanian research and publication in the West. For the past 2 weeks I was on vacation and had ample opportunity to read a book of 259 pages entitled, "Lithuania Under the Soviets - Portrait of a Nation 1940-1965." After an opening chapter on Lithuania from the closing years of the twelfth century up to World War I, I read of your nation's struggle for independence between the two World Wars, and the history of foreign occupation and subjugation by Russia, then by Germany under Hitler, and then again by Russian Communism which is enduring unto this day. What happens to a nation's cultural and ethnic heritage when it be-comes absorbed into a nation like Russia, whose language it does not speak, whose political system is abhorrent to its people, whose traditions are alien? The tragedy of Lithuania caught in a pincer between Hitler's Germany and Stalin's Russia, your nation's struggle to retain independence first from Russia and then from Germany - this was the message of this book. It made an overhelming impression on me and evoked a deep admiration for the heroism of the Lithuanian people, Naturally, as a priest, I

read and re-read the chapter on "Soviet Policy Toward Religion" in your native land. Since both Nazism and Communism as political philosophies are based on the theory that the state is absolute, they have to deny the existence of God and strive to destroy belief in Him in human beings, and force religion to cease among its leading people by preventing them from fulfilling their duties to God. Read the Declaration of Independence of the Founding Fathers of this land which you have adopted and in which you have found refuge from Communist tyranny. A brief review of that will point out that they too believed that your rights come from God and not from the state.

Roman Catholocism is the traditional religion of Lithuania. It has deep historical roots commands strong, almost universal support. In 1939 Pope Pius XII called Lithuania the outpost of Catholicism in North Europe. In 1940, 94% of all ethnic Lithuanians were Catholic. In 1940 there were 2 archdioceses and 4 dioceses with 3 archbishops, 9 bishops, 1439 priests, 708 churches and four seminaries. So from June 1940 to June, 1941, the first Soviet occupation, Moscow used all of its powers to destroy the Church: 1. Church property was confiscated, church funds likewise, so the Church lost all property, capital, and sources of income. 2. Religious education of youth was banned. Thue Church was isolated from public life, hoping adults would "forget their religion." Persons seen in Church were threatened, Holy days abolished, Christmas and Easter made work days and those failing to report for work were punished,

seminaries were closed. Why deceive young men, who, when they became priests would have nothing to do? They hoped that priests would abandon vocations and take secular jobs, but none were converted. Priests were condemned as "enemies of the people", exploiters of the working class." Destroy priests at any price! Spy on them!

During the second Russian occupation in 1957, there was a mass deportation of clergy. Bishop Vincentas Borisevicius was arrested and condemned to death. Two other Bishops were deported to labor camps; churches were closed; seminaries were

reduced to to one with 25 students.

A period of intense attack began in 1957 bringing with it anti-religious propaganda, war on the clergy. obstacles to worship, and formal restraints on religious practices carried out by police methods. Atheistic propaganda flourished, During 1960, 80,000 lectures were given by 779 groups. Concentrating on youth, schools of atheism were founded. Youth cannot be helped by the Church, for Church attendance is a crime. At home? If parents act, children are taken from them by court decision and entrusted to state institutions. Either declare yourself an atheist or lose your job and face reprisals. They paganized religious feasts by destroying their religious character. Thus, Easter became a spring festival; Pentecost a day celebrating the shepherd and his herds; St. John's Day a summer solstice festival. When no substitute for a feast day can be found, festivities are arranged and young people are required to attend and thus are prevented from attending church. To offset the ceremonial effect of baptism, confirmarriage and funerals, civil rites have confirmation, substituted for religious ones. Well known Marian shrines are either destroyed or priests are barred from visiting them, pilgrims are intimidated and discouraged, roads are blocked, transportation refused, visitors are searched and arrested.

Churches that remain open as of now, are state property and must be rented by the parishes with rents extremely high. Since parishioners had to pay these rents, these were increased 3 and 4 times hoping the faithful would tire of this burden. Although

there is a war against the clergy, the campaign against religion has not produced the desired results. People still hold on to their "superstitions." Pushed off the mountain, the Church descended to the valleys and continues its work. Even Moscow has found that Lithuanians are still quite religious and conscientiously attend church on holy days. So - a campaign of clander against the clergy: accuse them of all sorts of crimes, and the clergy have no opportunity to defend themselves.

Police methods are used in the following ways: communication with the Vatican is discouraged, Bishops deported, the Church is administered to the last detail by the Commissar for Affairs of the Cult which specifies when and how long church bells can ring. No priest can fulfill his duties or occupy any position without permission of this Commissary. Clergy cannot teach catechism to children. Priests cannot visit sick in hospitals. There are no religious publications in Lithuania today.

Ergo, the importance of basic truths in our

USA Declaration of Independence.

The Declaration of Independence is very cornerstone of our Democracy. We cannot take the Declaration and its far reaching implications for granted. It is the foundation of all American life. Academic freedom to peddle all sorts of doctrines is a cloak under which subversive agents work. I am free to sell good food, but I am not free to sell poisoned food. Guard against use of freedom to destroy freedom.

If we neglect the Declaration of Independence, the Constitution, and the Bill of Rights, human liberties which all of us cherish, will be lost. Bound up as they are with the truth repeatedly recognized in the Declaration - that the rights of each of us come from God and that no state can take them from us - we feel safe in accepting the rights but forgetting the source of these rights

171 years ago, our Founding Fathers adopte a charter recognized as one of the noblest documen of all time. They based its authority on Almighty God. Four times they referred to God. Members of Congress were even more explicit. For them the idea of God had to be integrated with everything if men were not to forget that their rights, liberties, and life itself come from God. Human rights come from Source of all rights, not out of thin air. This can be accounted for only by the acceptance of the teaching of divine revelation in the Holy Scriptures of the Old and New Testament held in common by the Jewish religion of the synagogue and all of Christianity - Protestant, Greek Orthodox, and Catholic. Nowhere but in that teaching is such a doctrine to be found. The very words "inalienable rights" used in the Declaration of Independence to characterize life, liberty, and the pursuit happiness, are meaningless unless they refer to the divine origin of these rights. From the Judeo-Christian view of man these rights flow; form any other view, and no rights flow. Undermining this religious foundation of our national life prepares the way for the advent of the totalitarian omnipotent



state. Marx, Stalin, Hitler - they knew this and built

their systems on it.

Marx expressed himself in regard to the nature and rights of human being this way in his "Das Kapital": "The democratic concept of man is false because it is Judeo-Christian. The democratic concept holds that each man is a sovereign being. This is the illusion, dream, and postulate of Judeo-Christianity."

Hitler said, "To the Judeo-Christian doctrine of the infinite significance of the human soul, I oppose with icy clarity the saving doctrine of the nothingness and insignificance of the human being." This explains why all these totalitarian systems

imprison rabbis, ministers, and priests.

"When in the course of human events, it becomes necessary for one people to dissolve the political bonds, which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and Nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation". This statement emphasizes the fact that Natural Law depends on God.

"We hold these truths to be self evident, that all men are created equal, that they are endowed by their Creator with certain unalienable rights, that among these are Life, Liberty and the Pursuit of Happiness." They did not want Americans in generations ahead to forget that human rights come from the Source of all rights, and not out of thin air. This doctrine had come down through long centuries. Jews, for thousands of years, had kept alive the sublime concept that he derives his rights from his Creator, and therefore, he has the solemn obligation to each of his fellow men in whom he should see a child of God.

"To secure these rights, governments were instituted among men, deriving their just powers from the consent of the governed." Governments exist for men; not vice-versa as Communists say. God made man a social being, ergo - society. For society, law is necessary. "Whenever government becomes destructive of these ends, it is the right of the people to alter or abolish it." Toward the end of the document, they appealed "to the Supreme Judge of the world" for the rectitude of their intentions.

It closes thus: "And for the support of this Declaration, with a firm reliance of the protection of Divine Providence, we mutually pledge to each other our lives, our fortunes, and our sacred honor."

Your great contribution for this country would be to make known your own country's experience under Soviet Communism. Communists in this country have been working to scuttle the Declaration of Independence. They see that most Americans are taking the Declaration for granted and forget it. Academic freedom is not license. I am free to sell good oysters but not bad ones.



## REZOLIUCIJOS

## RESOLUTIONS

The following resolutions were all approved by the convention delegates.

WHEREAS, despite proclamations in some quarters there have been statements about communism softening in its policies, factual evidences reveal that idealogically and practically the denaturalization, dechristianization and dehumanization processes, both in private and public life continue with unabated persistency in Lithuania and all communist occupied countries; and

WHEREAS, as of the present moment the Most Reverend Bishop Julius Steponavičius of the diocese of Vilnius, Lithuania has been stripped of his official position merely for his refusal to ordain two seminarians into priesthood, because they were found to have been infiltrators of the communist

conspiracy; and

The Most Reverend Bishop Vincent Sladkevičius of Kaišedoris diocese forbidden to perform his duties because he was consecrated Bishop without the permission of the communist party; and

Father Anthony Seškevičius at this very moment is serving a one-year prison sentence in Lithuania

for the simple crime of teaching Catechism to school-age children; and

WHEREAS, in our own day with the whole world as witness a Lithuanian Seaman, SIMAS KUDIRKA, was seized by communist sailors while seeking asylum aboard the U. S. Vigilant and at this very moment is incarcerated for a period of ten years in a communist prison;

BE IT RESOLVED, that the KNIGHTS OF LITHUANIA convening at its 58th National Convention in Kennebunkport, Maine, August 26-29, 1971 unites with Lithuanians all over the world, individuals and organizations, in strongly protesting to the whole world against the above-mentioned inhuman and immoral atrocities committed by the godless communist regime against all communist-subjugated peoples and especially our own Lithuania and Lithuanians; and with the same urgency we appeal to the President of our United States of America, the Congress of the United States, the American Catholic Bishops' Conference and to the members of the United Nations, particularly to those members who have recently obtained freedom and self-rule from the shacles of colonialism with full voice in the family of nations, to extend their utmost efforts that these injustices be rectified and the freedom of LITHUANIA ad all subjugated nations be restored.

WHEREAS, on November 23, 1970, a Lithuanian Seaman, SIMAS KUDIRKA, serving on a Soviet vessel, sought asylum aboard the United States Coast Guard ship, the SS Vigilant, and contrary to all American precedent, Soviet sailors were permitted to board an American vessel in American waters, seize and brutally beat him on the SS Vigilant and forcibly take him back to the Soviet ship and to Soviet-occupied Lithuania, where he is now serving a ten-year term in a communist labor camp for the "crime" of having sought freedom in free American territory.

We, the KNIGHTS OF LITHUANIA, meeting at the Franciscan Monastery, in Kennebunkport, Maine, at our 58th National Convention, August 25-29, 1971, as AMERICANS of Lithuanian descent, express our grief and confusion over the United States officers' disgraceful abandonment of American policy and tradition in permitting this most un-American action and thus contributing to the subsequent incarcera-

tion of one of our Lithuanian people and the harasment of his family;

WE, FURTHERMORE, firmly petition the President of the United States and the Congress of the United States, not merely to state words of protest to the Soviet Union over this illegal infraction of international procedure, but to use their official powers to extend every positive means to have SIMAS KUDIRKA and his immediate family brought to the United States, where, at the rist of his very life, he sought refuge.

FURTHER, we, as Americans deeply believe that by such action our own confidence in and respect for basic American principles will be refreshed; and the image of the United States, as the citadel of

freedom for all men, will be restored in the eyes of all subjugated nations of the world.

\* \* \* \* \*

WHEREAS, Attorney Anthony Oswald Shallna of Boston was recognized by the United States Department in 1939 as Consul of Free Lithuania, whose Exequatur was in full force and effect until his death, June 19 1971, at the age of 77; and

WHEREAS, during his lifetime he devoted his energies in behalf of Lithuania's independence, and WHEREAS, among his written works his booklet "Adjudication of Thaddeus Kosciuszko's Wills"

provided documentary proof of Kosciuszko's Lithuanian ancestry; and

WHEREAS, for many years, during his legal secretary's tenure of office in the Knights of Lithuania organization, he kindly allowed his office to be a depository of the K of L files and practically K of L headquarters, and

WHEREAS, he had ties of friendship with Tevas Mykolas Norkunas, founder of the Knights of

Lithuania, and

WHEREAS, in the early stages of the Lithuanian Affairs Committee, he gave aid and advice in the

practical realization of this important sphere of activity, and

WHEREAS, Honorable Shallna was a true friend of the organization and its purposes, BE IT RESOLVED that the Knights of Lithuania, convened at Kennebunkport, Maine for its 58th National Convention, pay a deep tribute to ANTHONY OSWALD SHALLNA for all his acts and deeds and wish to send a copy of this tribute to his widow, Attorney Susanne P. Shallna.

RESOLVED, that the Knights of Lithuania Supreme Ritual Committee review the system of awarding points toward meriting degrees of members on a more equitable basis for work done.

BE IT RESOLVED that the Knights of Lithuania elect or appoint a committee to investigate the possibility of erecting a plaque on the site of the school in downtown Manhattan where Dr. Karolis Kuršius -Curtis, a Lithuanian, was the first teacher in 1657, in what was then Niew Amsterdam.

NUTARTA, kad Lietuvos Vyčiai vieną kartą metuose organizuotų ir vadovautų skaitlingiems pulkams maldininkų vykti į Washingtoną Tautinėje Marijos Šventovėje įkurtą Šiluvos Koplyčią - Lietuvos Globėjos ir Užtarytojos garbei.

REZOLIUCIJA, kad būtų pakeltas į Garbės Narystę per ateinantį seimą, LONGINAS ŠVELNIS, 17-tos kuopos sendraugių ir Naujosios Anglijos apskrities pirmininkas, pagal rezoliuciją paremtą Naujosios Anglijos apskrities, priimta.

Kadangi Lietuvos Vyčiai savo seime 1970 metais nutarė įvairiais galimais būdais remti Lietuviu Katalikų Religinės Šalpos veiklą, todėl šis seimas nurodo kad Lietuvos Vyčių kuopos, apskritys, ir Centro Valdyba, bendraujant su savo dvasios vadais, pasirūpintų organizavimu ir veikla Lietuvių Katalikų Religinės Šalpos Rėmėjų skyrių pagal L.K.R.S. Rėmėjų statutą, kuriam pritarė Kunigų Vienybės Seimas.

NUTARTA, kad Lietuvos Vyčiai steigia LIETUVIŲ KALBOS IŠLAIKYMO KOMISIJĄ, kuri kuopoms siunčia paraginimus ir nurodymus kaip puoselėti lietuvių kalbos vartojimą. Komisija panaudoja šiam tikslui organą "Vytį" ir kitas prieinamas priemones žadinti geresnį kalbos pažinimą ir tikslesnį jos

1. Lietuvos Vyčiai kur galima savo susirinkimus ir posėdžius praveda lietuviškai.

2. Lietuvos Vyčiai remia visus lietuviškus institutus įvairiuose universitetuose ir ragina savo narius

3. Lietuvos Vyčiai remia visus lietuviškus parengimus, kurie duoda progos pasidžiaugti lietuviškais

meno kūriniais.

4. Lietuvos Vyčiai kur galima dalyvauja lituviškose pamaldose ir ragina savo klebonus bažnytinėse apeigose naudotis lietuvių kalba.

5. Lietuvos Vyčių kuopos ir apskritys steigia lietuvių kalbos kursus arba kalbos studijų ratelius.

BE IT RESOLVED, that the Supreme Council pay the transportation expenses of all elected Supreme Council members and National Committee Chairmen who attend the Supreme Council meetings outside their immediate localities, with the following restrictions: That no member be reimbursed for more than two meetings per year, and that each trip reimbursement not exceed \$100.

While we mourn the loss of our great leader, Rev. John C. Jutt, BE IT RESOLVED, that as a fitting memorial to him, we intensify all our efforts and energies in the furthering of the work of the Lithuanian Affairs Committee.

BE IT RESOLVED that the Friend of Lithuania' Award, presented at the National Knights of Lithuania Convention to a prominent figure who has befriended the Lithuanian Cause during the preceding year, hereafter be called the REV. JOHN C. JUTT - JUTKEVICIUS MEDAL., To honor the great man who initiated the award.

WHEREAS, there has been established an Associate Membership in the Knights of Lithuania for non-Lithuanian Catholic spouses, and

WHEREAS it is timely to formulate guidelines for local councils in granting proper recognition for services performed other than through our established ritual program,

BE IT RESOLVED, that a study committee of three be selected at this convention to determine the

rights, responsibilities and methods of acknowledging services of Associate Members.

BE IT FURTHER RESOLVED, that the recommended guidelines be formulated in time for approval at the 59th National Convention.

BE IT RESOLVED, that the members of the 58th National Convention acknowledge with gratitude and appreciation the untiring efforts of the Presidium members, the Sgts-at-Arms, and the members of the Convention Committees.

BE IT RESOLVED, that the members of the Knights of Lithuania assembled at the Franciscan Monastery in Kennebunkport, Me. for their 58th National Convention, hereby express their gratitude to the outgoing officers of the Supreme Council for their dilligence in performing their K of L duties during the past term.

RESOLVED, that the members of the Knights of Lithuania assembled at the Franciscan Monastery in Kennebunkport, Me. for their 58th National Convention, Aug. 26-29, 1971, hereby express their heartfelt appreciation and thanks to the Franciscan Fathers for their gracious courtesy and complete cooperation in extending the beautiful facilities of the Monastery to the delegates and guests, and supporting our activities with their prayers.

#### 1972 CONVENTION

No formal bids were received for hosting the 59th National Convention in 1972. Therefore, the Convention Delegates formally asked the Mid-Central District to consider either hosting the Convention as a District, or asking one or more of its councils to host it, inasmuch as all other Districts have hosted at least one National Convention during the past 4 years. Officers of the Mid-Central District agreed to bring this matter before their District Annual Convention to be held Oct. 9-10 in Detroit and to report on the outcome immediately thereafter to the Supreme Council. If the Mid-Central District cannot find a suitable host, the Supreme Council will select a site and host.

#### PRESS AND TV COVERAGE OF CONVENTION

Well before the 58th National Convention opened, the public was being made aware of its coming ... especially along the Eastern Seaboard. Various American newspapers in Hartford, Conn., Boston, Mass., Portland, Maine, and even Cleveland, Ohio carried advance publicity, as did members of the Lithuanian press, namely DRAUGAS, DARBININKAS. GARSAS, DIRVA, and others. During the convention, MR. ED. WINSTON of the Portland Press Herald was a familiar sight, covering several of the sessions as well as the closing Mass and Banquet. Thanks to Mr. Winston and MR. JOHN M. LOVELL also of the Herald, a lengthy story of the Award to Mr. Brieze appeared the morning after the Convention, in the Press Herald. The story was also released to United Press International and Associated Press, and thus made its way into the Boston Globe, the New Bedford Standard-Times, the New York Times, the Amsterdam Evening Recorder, and others.








#### FOURTH DEGREE AWARDED TO DESERVING MEMBERS

Within the last two months, the Knights of Lithuania lost three of its outstanding leaders, who were called to their eternal reward.



#### ... ON THE FUTURE OF THE K OF L JUNIORS

Youngsters should be included as much as possible in a council's regular activities, so that they'd feel a part of the whole. But they should also be given a chance to have separate activities, where they can enjoy activities of their own. For this to succeed, the K of L must look for dedicated counselors in its midst.

The best way to make juniors enjoy regular council projects is to assign them special tasks to perform or specific parts of the projects to carry out on their own.

Energetic activities are needed to keep younger members interested, and Lithuanian folk dancing, singing and crafts answer that need well, provided equally energetic counsellors from the ranks of older members are willing to sacrifice time to teach, etc.

Children are imitators... we must give them something good to imitate. Thus, if we make the K of L something attractive and familiar to our children, they will grow up wanting to become members.

Each council should decide on the kind and extent of Junios activity it should have, and what age groups it should aim at, recognizing that the future of every council depends on the incorporation of more young blood.

#### ... on RITUAL REQUIREMENTS AND REVISIONS

Degrees are earned on K of L activities or Lithuanian and religious activities done under the auspices of the K of L, but not for Lithuanian activity in other organizations.

All K of L Ritual degrees, including the First and Second, represent important steps upward in the organization, and as such, should be presented in a solemn and dignified manner, at special council or district meetings or gatherings.

Council Ritual Chairmen have been very lax in reporting the bestowing of the First and Second degrees. As a result, members eligible for higher degrees frequently encounter difficulty getting National approval for those degrees, due to a lack of adequate records.

To encourage more Junior activity, the points awarded for Junior Counseling should be greatly increased.

It was recommended that the Ritual Committee revise and standardize the questions used in 2nd and 3rd degree examinations to make them more relevant.

#### ... on THE RIGHTS AND PRIVILEGES OF ASSOCIATE MEMBERS

Now that our constitution allows for Associate Members, we should not treat them as second-rate citizens, but rather grant them appropriate privileges and opportunities of membership.

The USA does not allow a foreign-born citizen to be elected President. By this precedent, it is appropriate that the K of L likewise rule against non-Liths (Associate Members) holding a presidency in the organization, but should allow them to hold other offices.

Associate members who work actively for the K of L should be granted some form of Ritual degrees or other recognition.

Numerous other Lithuanian organizations have benefited greatly from allowing non-Lithuanian spouses membership - full or limited - and the K of L likewise stands to gain from the entrance of full families, even when the mother or father is not of Lithuanian heritage.

#### ... on K OF L PARTICIPATION IN LITHUANIAN AFFAIRS AND POLITICS

The Lithuanian Affairs Committee of the K of L must be the eyes, ears, and voice of the K of L in political matters. It must keep the public aware of the Lithuanian cause through newspaper articles, letters to key people in government, and the like, and also by thanking all who publicize or befriend Lithuanian causes.

Public Relations work on a smaller level must not be ignored either. Local papers are always anxious to hear of local citizens' activities, so K of L-ers are urged to report their attendance at conventions, and send copies of important resolutions to their local papers, as well as to their congressmen, senators, etc.

Many young people are anxious to do papers on Lithuanian life, art, folk music, etc., but frequently complain that organizations are hesitant to help them. When we hear of such students, we should show an interest in them, introduce them to books, pamphlets on Lithuania and its arts and crafts, and offer general assistance, so as to further interest them in working for our causes.

Introducing ourselves to people of other nationalities as Lithuanians and members of the Knights of Lithuania can reap many rewards, in new friendships, and in more publicity for the name of Lithuania, for such introductions invariably lead to questions about ''where is it,'' etc., and provide an excellent forum for telling of Lithuania's plight, and interesting others in our culture.

#### Hellos - introductions - greetings - welcomes began to be exchanged as early as Sunday, Aug. 22, as the first Convention guests and hosts arrived to enjoy the beauties of the Franciscan Monastery and the many activities planned by the New England District. But after a few warm "Labas's", hosts and guests went their separate ways, temporarily, to prepare for the rest of the week. For the first time, even


