KNIGHTS OF LITHUANIA

64th NATIONAL CONVENTION



The Knights of Lithuania Organization if alive, healthy and growing!!! A great amount of excellent work has been contributed by your Supreme Council.

SPIRITUAL ADVISOR — Rev. Anthony Jurgelaitis, O.P.

Our Spiritual Advisor, Rev. Anthony Jurgelaitis, wrote a series of religious articles for "Vytis" publication, served as Chairman of the Constitutional Revision Committee, coordinator of the 64th National Convention Committee (C-103), visited and participated in various District and Local Council events, composed a K of L "Wake Ritual", compiled guidelines on National Convention planning, submitted proposals for a Priest Member ritual, prepared the Convention Liturgical Booklet, arranged Themes I and III for the Convention and attended all the Supreme Council meetings.

PRESIDENT - Anthony M. Miner

Arranged agendas for all four Supreme Council meetings and chaired three of them. Represented the Supreme Council in person whenever possible and arranged for other Supreme Council members to represent the Supreme Council, or sent greetings by mail.

He also maintained close contact with other Lithuanian Organizations, appointed K of L representatives to the Baltic Human Rights Rally, arranged for the making of a new Supreme Council flag, served as coordinator of the K of L Manual, presented 2 workshops on "Lithuanian in Massachusetts", maintained close contact and consultation with other Supreme Council Officers, carried out the decrees of the Supreme Council and the 63rd National Convention, submitted suggestions for the Constitutional Revision and presented resolutions for the 64th National Convention consideration.

FIRST VICE-PRESIDENT — Ann Marie Kassel

Attended all Supreme Council meetings, submitted monthly articles to "Vytis", communicated with members, distributed materials, selected "National Conventionship" recipients, served as K of L representative to ALTAS convention and Baltic Human Rights Rally. Mrs. Kassel also organized Junior Council 36-112 and served as their Counselor. She also worked at establishing Junior Councils in other areas. We now have 10 Junior Councils.

SECOND VICE-PRESIDENT — Philip Skabeikis

Attended three Supreme Council meetings, assisted new K of L Councils, continued his attempts to revive, found new councils, carried on much correspondence, related to membership and K of L activity, submitted several articles to "Vytis", and conducted Membership Drive.

THIRD VICE-PRESIDENT — Joseph J. White

Attended four Supreme Council meetings, contacted all Senior Councils offering assistance, and participated in various Church, K of L and Lithuanian events in his area. Mr. White reports that we have 6 Senior Councils with a total of 231 members. No Senior Council exists in the Mid-Atlantic District.

RECORDING SECRETARY — Ann H. Bender

Attended all Supreme Council meetings. She sent, meeting notices and minutes of the meetings to all Supreme Council members, Honorary members and Past Presidents. She also took care of all correspondence as requested by the Supreme Council and for the President, and compiled a list of Council Officers.



TRUSTEES — Charles Machutas and Vytautas Radzivanas

Charles Machutas attended three meetings. Vytautas attended two meetings. Both examined the books in Washington and found them to be in order. They also compiled an inventory list of K of L property. They are searching for a site for the 65th National Convention.

LEGAL ADVISOR - Att'y Anthony J. Young

Attended three Supreme Council meetings, obtained a release from the Internal Revenue Service waiving a penalty for the late filing of Form 990, and is currently attempting to gain a Tax Exempt status for the K of L which the Post Office will accept and then grant a Bulk Mailing Permit. Mr. Young also encloses a check in the amount of \$700.00 to sponsor the reprinting of the "Our Lady of Siluva" Booklet.

"VYTIS" EDITOR — Loretta Stukas

Attended three Supreme Council meetings, and served as guest speaker and showed slides of Lithuania at Kearney, Washington, Newark and Mid-Atlantic District meetings. Ten issues of "Vytis" have been published and the old schedule of June-July, August-September, and October issues has been resumed. Two new staff members Philip and Marian Skabeikis have been added. The Christmas Ad Campaign netted over \$1100.00. There is a dire need for additional Lithuanian language articles.

CULTURAL CHAIRMAN — Aldona Ryan

Attended three Supreme Council meetings and sent frequent articles to "Vytis", sent "Amber Web" to all councils for each month, sent Straw Ornament Instructions to all councils, distributed book allotment money to all four Districts and sold and distributed 40 copies of "Forty Years of Darkness". She also gave a lecture on Lithuania to the Sidney, Ohio Rotary Club, and engaged in more activities than can be mentioned here. Please read her report in detail.

RITUAL CHAIRMAN - Bertha Janus

Attended two Supreme Council meetings, sent resumes of Ritual system, revised forms and Rites to all Councils. The Ritual Committee conferred 139 First Degrees, 61 Second Degrees, 20 Third Degrees and 15 Fourth Degrees to be conferred during this Convention.

Scholarship award to Rosemary Klatt was paid in two installments. Scholarship reminders were sent to all Councils, outlining the requirements. Many applications have been received.

HONORARY MEMBERSHIP — Eleanore Laurin

Honorary membership to be bestowed upon Larry Janonis at this Convention. A Resolution naming several candidates will be presented to this Convention. Honorary Membership procedures and guidelines have been submitted for inclusion in the revised Manual and have been printed in the "Vytis".

SPECIAL TRUSTEE REPORT — Eleanore Laurin

In order to maintain our Corporate and Not for Profit Corporate status, Eleanore Laurin as a resident of Illinois and a special Trustee filed an annual report with the State of Illinois.

YOUTH COORDINATOR — Mary Margaret Panavas

Contacted World Lithuanian Youth Association in December but received no response. She attended one local meeting in Detroit. Wrote to the Association again on August 1st.

LITHUANIAN LANGUAGE COMMITTEE — Joseph Boley

A meeting was held in Chicago last Fall, but nothing came of it. There seems to be a lack of volunteers. This lack of interest apparently reflects the attitude of the K of L. In the future, perhaps interest in the Lithuanian language will awaken, and Lithuanian articles will appear more often in the "Vytis".

ARCHIVES AND MICROFILMING COMMITTEE — Longinas Svelnis

Attended three Supreme Council meetings, participated in the revision of the constitution, represented the K of L at the "Black Days of June" services at St. Peter's church, attended the N.E.D. conventions and stressed the importance of archives material. He has obtained some material for the archives and will display copies of it during this convention. He urges the microfilming of council histories and requests all types of council records. He still needs 1922 and 1923 "Vytis" issues. He concludes with the false statement that the President is not interested in the Archives Committee and does not recognize its Chairman. In reality, however, all Supreme Council members know that his reports were solicited, presented at Supreme Council meetings and duly recorded in the minutes of the meeting.

ILLINOIS-INDIANA DISTRICT

Reports quarterly business meetings preceded by Board of Directors' meetings, a membership drive, more efficient operation of the K of L Building, 2 very active Junior councils, a flourishing K of L Choir, active public relations with a District bulletin. The activities included "Memories of Lithuania" Dinner Dance, St. Casimir's and K of L Day observances, Memorial Mass, Golf outing and participation in Captive Nations' Day parade, special Lithuanian language committee meeting, Nativity BVM Parish anniversary, and Mid-West Bowling Tournament. It has a total of 7 councils, 425 members.





MID-ATLANTIC DISTRICT

Reports 18 councils and 4 Junior Councils. The total membership is 777. It held 3 District conventions and 6 Executive Board meetings, publishes a bulletin and is active in Lithuanian Affairs and Public Relations. It has sponsored a Testimonial Dinner Dance honoring Loretta Stukas, a bus trip to Washington, D.C. to visit the Lithuanian Legation, the Franciscan Monastery and the Our Lady of Siluva Chapel for Mass. Two councils sponsored buses to the Lithuanian Day in Lakewood Park, Pa. The President recommends concentrated efforts to organize additional councils in Penn.

NEW ENGLAND DISTRICT

Reports 2 conventions, an annual TV Mass, an annual Cultural Festival, St. Casimir's Day observance, a Holy Hour, a Family picnic and a Spiritual Retreat.

In summary, we have had another active and successful year. Please pay particular attention to the recommendations made by the Officers and Committee Chairmen. This report is but a summary. Please read the individual reports carefully for all the details of the work performed.

As requested by the Supreme Council President, I submit the following proposals to further and make more effective the office of the Supreme Council Spiritual Advisor:

A. Revitalize the Spiritual Committees on Supreme Council, District and Council levels for better service to the members.


B. Establish closer working relations with all Spiritual Advisors.

C. Cooperate with the II Vice President in a Membership Drive to attract more priests as members, possibly including more religious Sisters. D. Develop in detail a concept of "DIEVUI" - DIENA or "FOR GOD" - DAY, to be arranged on local Council levels on which members from 2 or 3 nearby Councils would gather for a day of talks, conferences and other spiritual activities under the direction of the Supreme Council Spiritual Advisor. The purpose of these "For God" Days would be to foster the American - Lithuanian Catholic Spirit.

E. Implement the proposal made to the Supreme Council that the entire membership of the Knights of Lithuania take note of the death of a fellow member. According to the proposal, Council Presidents would be required to inform the Supreme Council President of the death of a member immediately, so that a message of condolences could be sent to the family. The Supreme Council would then arrange for a Month's Mind Mass to be said and a Mass Card would be sent to the family by the Supreme Council Spiritual Advisor announcing the celebration of the Mass.

NATIONAL PRESIDENT'S ACTIVITIES

1976 - 1977

During the past year I have adhered to the principle of recognizing every communication and issue which came to my attention. Every matter received proper attention and appropriate action was taken.

In the fulfillment of the President's duties, I engaged in the following activities —

a. arranged the agendas for four Supreme Council meetings, in Boston, Scranton, Providence and Washington.

b. chaired three of the meetings.

- c. represented the Supreme Council at the 60th Anniversary Dinner-Dance of Council 26; The February 16 observance in Worcester; the Council 142 presentation of Dr. Jurgela's book at the Army and Navy Club in Washington; the testimonial for Loretta Stukas, and the May Mid-Atlantic District convention.
- d. represented the Supreme Council and served as Master of Ceremonies at the New England District St. Casimir's Day observance.
- e. conducted two workshops on "Lithuanians in Massachusetts" for the Massachusetts Ethnic Heritage Conferences at Holy Cross College in Worcester.

f. arranged with Vice-President Kassel for K of L representation at the ALTAS and the Federation conventions in Chicago.

g. sent written greetings on those occasions when personal K of L representation was impossible. h. maintained close contact with other Lithuanian organizations.

i. appointed Vice-President Ann Marie Kassel as K of L representative to the Baltic Human Rights Rally meetings in Chicago.

j. appointed Grazina Vaskelis as K of L representative to the Baltic Human Rights Rally, when the meetings were shifted to Detroit.

k. submitted a large number of suggestions for the revisions of the Constitution.

l. held frequent consultations with various Supreme Council members.

m. sent an annual memo to all councils.

n. presented radio speeches for Lithuanian Independence Day.

o. served as Vice-President of Worcester County Organization for Ethnic Affairs.

p. arranged for the making of a new Supreme Council flag.

q. served as coordinator of the K of L Manual which is now ready for editing and printing.

r. ordered new K of L pins.

s. carried out all of the actions decreed by the Supreme Council and the Convention.

Perhaps the best news of the year is that we have been enriched by the addition of three new Councils. Welcome Councils 46, 143 and 144. Welcome also to the two new Junior Councils - Council 36-112 and Council 142.

This year the Supreme Council emphasized the completion of on-going projects, the revisions of the Constitution, the completion of the K of L Manual and the completion of the Cultural Hand-book. Satisfactory progress was made in each case.

One of the prime perennial problems is that of Communication. Telephone calls, letters and announcements in the "Vytis" are often ignored. Reports are sent in late or not at all. Officers' Rosters are not forwarded to the Recording Secretary and requests for information are completely disregarded. It is essential for the efficiency of the organization that

good communications be maintained.

It seems advisable to establish a policy whereby the President would be authorized to visit each K of L District at least once each year. This would permit a better opportunity for the exchange of ideas and would foster a clearer understanding of the situation in each area.

In conclusion, I wish to express my most sincere thanks to all the dedicated Supreme Council members who worked so diligently and harmoniously for the good of the organization. Thanks also to all of the K of L members for their unstinting support. It has been a distinct pleasure to work with you and for you.

I also express my heartfelt appreciation to the Districts, Councils and individual members who expressed their consideration and friendship in the form of Masses, prayers and greetings during my rather lengthy illness.

PRESENTATION OF THE FATHER JUTT "FRIEND OF LITHUANIA" AWARD

TO ALFRED FRIENDLY, JR.

Accord.

Each year, or less frequently, during the National Convention, the Knights of Lithuania honors a prominent non-Lithuanian who has distinguished himself with his work in Lithuania's behalf or interest. This year, the recipient of this "REV. JOHN C. JUTT FRIEND OF LITHUANIA" Award was ALFRED FRIENDLY, JR., journalist and presently Deputy Staff Director for the Congressional "Helsinki Commission". Mr. Friendly was presented the Gold Medal Award by Lithuanian Affairs Chairman Rev. Casimir Pugevicius. Following are the remarks of Rev. Pugevicius in presenting the medal, during the Convention Banquet.

Friendly, Jr., served as correspondent for Newsweek Magazine in Chicago and Rome. Between 1966 and 1971, he served as correspondent for the New York Times in Indonesia, West Africa, the Mediterranean and the Balkans.

From 1972 to 1974, Mr. Friendly was counsel for the Senate Subcommittee on Intergovernmental Relations. From June, 1974 until July, 1976, he was Moscow Bureau Chief for Newsweek Magazine.

Since September, 1976, Mr. Friendly has been serving as Deputy Staff Director for the United States Congressional Commission on Security and Cooperation in Europe, popularly known as the Helsinki Commission, since its primary task is to monitor compliance with the Helsinki Final

The Lithuanian community of the United States has never reconciled itself to Basket One provisions of the Helsinki Final Act, since we see in its provisions a DE FACTO recognition of the Soviet occupation of the Baltic states: a 1970's version of the Munich pact, buying a chimeral peace at the price of the liberty of small nations powerless to defend themselves.

However, Mr. Friendly had nothing to do with the writing or signing of the Helsinki Final Act. It was only after the signing of the Helsinki Final Act that he was engaged as Deputy Staff Director for the U.S. Congressional Commission on Security and Cooperation in Europe. It is the task of this commission to see whether the provisions of the Helsinki Accord are being adhered to.

One redeeming aspect of the Helsinki Final Act was its Basket Three provisions: those dealing with human rights. In this respect, the Congressional Committee on European Security and Peace has done considerable work. As deputy chief of staff for the Commission, Alfred Friendly, Jr. has been called the heart and soul of the Commission. He is one of those people who takes his job seriously.

Under Mr. Friendly's leadership and with his prodding, the Commission has held hearings during the past several months to gather data on the violation of human rights by signers of the Helsinki Final Act.

In this way, Mr. Friendly has made it possible for the present plight of the people of Lithuania to be entered into the record. The Congressional Committee which Mr. Friendly serves as Deputy Chief of Staff has invited and received testimony from Dr. Kazys Bobelis, President of the Lithuanian American Council, of which the Knights of Lithuania is a member organization. The Committee has also heard directly from the Knights of Lithuania through member Joseph Simanis on the

issue of human rights in Lithuania. It has also received and entered into the record written testimony from the Lithuanian Community, U.S.A., and from the Lithuanian Human Rights Commission a report on the violation of human rights in the area of religious freedom, which was researched and drafted by the Lithuanian Affairs Committee of the Knights of Lithuania.

In all this, Mr. Friendly has never shown any favoritism to the Lithuanian cause. If anything, it still remains for us to convince the Commission which he serves, that the simple cause of national selfdetermination for Lithuania IS a human right, and deserves attention at Belgrade.

Be that as it may, Mr. Friendly, by doing his job conscientiously and with a heart, has done much to further the cause of human rights for the people of Lithuania, and he has therefore been named by your Lithuanian Affairs Committee to receive the 1977 Friend of Lithuania medal. I ask this assemblage to ratify that action by standing ovation!

REMARKS OF
ALFRED FRIENDLY, JR.
TO THE
KNIGHTS OF LITHUANIA
PROVIDENCE, RHODE ISLAND
AUGUST 20, 1977

It is a very great honor for me to accept your award, but it is also a very great responsibility. I am not sure that I am equal to either.

I do have several friends in Lithuania, and even a few Lithuanian friends in America. Nothing could be easier than making such friends. In one weekend in Vilnius about a year and a half ago, my wife and I met men and women whose hospitality and good humor were so ready and so unstrained that the memory of their friendship will always be with us.

But to be a Friend of Lithuania with a capital F - imposes obligations that go beyond sentimental recollections. It obliges me to remember people I do not know and to honor a cause I can only share at a great remove. In a way those few days I did actually spend in Vilnius make the job easier. For I will always remember the grey Volga sedan with the five men in it who watched my wife and me everywhere we went. And I will always remember the nervous amusement of our friends in Vilnius who thought it was a great honor to have so many KGB agents obliged to give up their Saturday and Sunday to trail us to a farmer's market and a sculptor's studio. I will also remember that those

same friends were called in by the KGB - after my wife and I had gone back to Moscow - to be interrogated about their conversations with the dangerous American journalist.

But my experience with what is called "Soviet reality" in Lithuania was brief and was cushioned by my privileged position as a foreigner there. To be truly a Friend of Lithuania, one must share on a daily and vulnerable basis the reality of Lithuanians themselves. I do not think that is possible for an American to do, not even for Americans - like yourselves - who have close ties to Lithuania.

None of us can really know what it is like to be, for instance, a contributor to the Chronicle of the Catholic Church in Lithuania. We can read that courageous publication or, like Rev. Pugevicius and Professor Landsbergis, translate and disseminate the copies of it which make their way to America. But secure in our freedom to read what we like and publish what we want others to read, we can only remotely feel the dedication of Sergei Kovalev or of Nijole Sadunaite to the freedom of thought

and expression we take for granted.

Nor, I think, can any of us know what it means to pay the consequences of having suspect friends. Vytautas Bogushes and six of his classmates were made to pay the price of such a friendship. About this time last year they were informed that they had been expelled from their senior class in Vienuolis High School because although they were never told this openly - they had been friends with Viktoras Petkus. Petkus is a Catholic activist, a man who has already served 14 years in prison for his commitment to Lithuania, a member of the Lithuanian group to defend the Helsinki accord. Being his friend is pretext enough to earn a boy expulsion from school.

In truth, in the Soviet Union today, the wrong kind of friendships can ruin you. And how can we - in a society built on trust, prospering on a foundation of political and social confidence - understand what it is to fear the offer of friendship? How can we know the anxiety, the strain of not knowing whom to trust?

We can only experience that agony indirectly. We can know, in the abstract, what fear does to a whole people: it reduces them to silence. But can you really imagine what a country sounds like when its people dare not speak? I remember walking in Moscow, on a main street, with an artist friend who made me stop and listen. "Listen to what?" I said. "There is no noise". "Exactly", he replied. "Listen to how quiet and empty it is with no one on the street talking. to anyone else. Listen to the silence".

Out of that silence, fortunately, we now hear voices. Sometimes they are eloquent; often they are so angry that their message is hard for us - consumers of the soft sell - to accept. But over and over again, those voices are saying one thing: we want to be free.

The fascinating thing to anyone who hears those voices and who knows some of the people who are expressing themselves in what is called dissent in the Soviet Union is that by speaking out, those people have made themselves free. They may be in prison, or in camp, or in psychiatric hospitals because their refusal to conform makes them dangerous, but they are, in fact, free. They have liberated themselves from fear.

They have set a contagious example in their own society. Few of them, however, think of themselves as liberators. I have one good friend - a middle-aged lady who has given help to countless political prisoners at great risk to herself and her family - who never thought for a moment that what she was doing could change the society in which she lived. She testified to the Helsinki Commission last June, and when a Commissioner asked her how she found the courage to go on, she replied, "If you want to keep your selfrespect, these are the things you do". Later, to a journalist in Washington, she explained that she and her friends in the Soviet Union express their freedom - at the risk of freedom - for what she called "the comfort of our souls".

I do not think we can truly comprehend that kind of commitment. We certainly cannot grasp it if we put it into narrow categories. It is not Lithuanian nationalism alone. It is not devout religious beliefonly. It is a broad and generous friendship for all those who want to be free, who want to express their freedom and who will pay the price - in a situation where conformity is the law and freedom a crime - of being true to conscience.

All those people - not just in Lithuania, not just in the Soviet Union, not just in the Communist world - are the true friends you and I would like to have and to be. At dinners in Moscow and in Vilnius, it is a custom to drink to such friends, and especially to the ones who cannot be at the table. The custom is of long-standing, so familiar that the toast that is offered is known very simply as the second toast of the evening.

It is meant to honor the free men and women who have lost their freedom - sometimes their lives - because their consciences made them criminals in the eyes of an intolerant state. I can think of many such people tonight, names you know and names you have never heard of, names of the living and of the dead.

All of them are committed to the freedom that some of them, who are from Lithuania, expressed in terms of their own country. All of them are truly friends of Lithuania. I would like to propose that to them we drink, in friendship, Toast Number Two.

Following are the remarks made by Walter Svekla, National Scholarship Committee Chairman, in presenting the 1977 CANON KEMEŽIS SCHOLARSHIP AWARD.

> Your Excellency, Reverend Clergy, Distinguished Guests, Honored Knights and Friends:

The Knights of Lithuania Scholarship Fund was established years ago to assist deserving members with financial help in getting their undergraduate or graduate degree. By deserving, we mean those members who have worked very actively within the K of L organization and their own parishes, and who typify the K of L concept of what a Lithuanian-American young man or woman should be. He or she should be a credit to our motto

"For God and Country!"

I would like to separate this year's Scholarship Award presentation into three parts, dealing with the past, the present, and the future.

For the past, I would like to read a letter sent to the Scholarship Committee by last year's K of L Scholarship recipient, Rosemarie Klatt of Council 36, Chicago:

"I am most grateful to the Knights of Lithuania for the scholarship award which I was awarded at the 63rd National Knights of Lithuania Convention Banquet (Dayton, Ohio) in August. Although I am most grateful for the most generous award, at the same time I feel quite honored to have been chosen as the recipient of such an award. Ačiū Labai!

"Words can only begin to express my sincere expressions of thanks and gratitude. In my heart, thoughts and deeds, I promise to continue to show my worthiness of this award.

"Hopefully, this award given to me will encourage and motivate other members to become more active in the Knights of Lithuania and in the promotion of everything that is Lithuanian.

"This enumeration of activities will, hopefully, encourage you as it is to let you know that I have not curtailed or lost interest in Lithuanian activities or involvements since my scholarship award.

"I still remain an active member of the Knights of Lithuania organization. I have recently received my second degree, and I am the Financial Secretary of my council (36) for the second consecutive year. I still belong to the Lithuanian dance group which is quite active. I have joined the Lithuanian Club at school, of which I was the news correspondent and I have also participated in a Lithuanian operetta for the second time this year since the time of my award..."

In another letter she had written: "Just as there is always room for Jello, there is ALWAYS room for the K of L! As always, I remain dedicated to the cause".

Rosemarie's letter shows what the K of L Scholarship Program is all about and it could not have been put in better words. Her activities represent the "profit" that was realized by last year's investment (K of L Scholarship Award of \$1,000) and the Scholarship Committee is certain that this investment will continue to pay "interest" far into the future. Once again, we congratulate Rosemarie for her K of L activity and wish her continued success throughout her life.

For the present, I would like to state that the Scholarship Committee was beseiged this year by a large number of qualified applicants. We wish we could have given them all an award but this is impossible. This year's K of L Scholarship recipients will each receive an award of \$500 given in two installments.



This year's recipients deserved their awards and the Committee felt we made a good decision, but our generosity this year has put a strain on our monetary reserve to the point that we will need a substantial amount of scholarship donations within the next year so that we can make a comparable award next year. To be honest, if these donations are not forthcoming we will have to curtail our awards and all our past good work and public relations generated by our Scholarship Program will be lost.



ORGANIZATIONAL PANEL

THE KNIGHTS OF LITHUANIA, TOMORROW AND BEYOND

The 64th National Convention Sessions were highlighted by three "themes", or panel discussions: cultural, religious and organizational. The Saturday afternoon "theme" was concerned with the future of the K of L, as the title of this section indicates. Three panelists participated in the presentation under the leadership of Father Anthony Jurgelaitis, O.P.

Dr. Algirdas Budreckis foresaw future K of L activity as a force revitalizing our Lithuanian parishes, reviving and maintaining the Lithuanian Catholic spirit. If our parishes fail, the K of L would be among those who would suffer most. His proposals included the expansion of celebration of traditional Lithuanian Holydays, erection of Lithuanian wayside crosses where none exist, the formation of K of L choirs to sing at Lithuanian religious services, closer cooperation with local pastors in promoting annual (or more frequent) Lithuanian parish homecoming Sundays on which all Lithuanians in the area would return to their ethnic parish for celebration of a Lithuanian language liturgy, a dinner or some other appropriate event.

In his second statement he foresaw the Knights of Lithuania fostering their Lithuanian heritage by blending traditional Lithuanian customs with new elements of present day culture. Implementation of this vision would be brought about by a new zeal for the study of the Lithuanian language, by research, collection of materials and publication of articles and even books on the history and achievements of Lithuanians in our parishes and K of L councils.

He proposed a revival of Lithuanian arts and crafts by talented K of L'ers and others, who would be encouraged to present Lithuanian themes and motifs in painting, music, weaving, wood-carving and so forth through modern media. In a final point, this panelist saw the Knights of Lithuania transforming routine monthly meetings into recreational, cultural experiences with ongoing developmental programs, limiting the time for the necessary council business to a minimum.

The second speaker was Marian Skabeikis who directed her gaze upon the future of VYTIS. She foresaw a greater utilization of VYTIS as a Public Relations "arm" of our organization, a broadening of the scope of our "house organ" to encompass the attractions of a general cultural magazine. With more non-member subscribers the VYTIS would reach out to a wider readership and extend our influence "For God and Country" amongst readers eager to learn more about Lithuania. Marian Skabeikis further

envisioned the coming years as a period in which the Supreme Council would lay the groundwork for a workable Public Relations operation, would draft policies and guidelines, establishing a network of input sources and outlets for news releases and current interest articles, and finally, the "training" of council correspondents to become "reporters" of the accomplishments of newsworthy K of L'ers and of K of L events.

Father Casimir Pugevicius, the third panel member, peered into the future and noted a concerted and stronger effort in recruiting a younger age group for membership in our organization. He pointed out that originally the K of L was established as a youth organization. When it ceases to be a youth organization, it cannot claim to be the organization which the founder envisioned. Recruitment of younger members could concentrate on children of present members or seek younger members among those with a growing interest in their ethnic heritage. Father Pugevicius' final point noted that what is happening in Lithuania today is awakening among our membership a deeper sense of responsibility for assuming a greater role in the struggle for human rights and religious freedom and national self-determination. Right thinking K of L'ers see more clearly than ever before that the Knights of Lithuania is not a "beer and pretzels outfit", but a determined, active, responsible organization supporting those Lithuanians in Lithuania "from 8 to 80 years old" who are standing up to be counted "For God and Country". As more and more Knights of Lithuania ask themselves "What did you do?" for Nijolė Sadūnaitė, for Petras Pliumpa-Pliura, for Sergei Kovalev, they will realize how much more needs to be done and will become zealous to do more and more, "to want a piece of the action".

As each speaker terminated one point of his or her presentation, the Convention delegates and guests were asked to check off one of the following "reactions": Strongly approve, Approve, Disapprove on a specially prepared tally sheet. Space was provided for brief comments for those who wished to explain their "reaction". A very brief discussion from the floor followed. The "reaction" sheets numbering 117 in all are being tabulated and analyzed. The results will be announced in a future issue of VYTIS.

According to Father Jurgelaitis, who made a quick review of the "reaction" sheets: "We have an interesting cross-section of K of L thinking on several important matters. These will provide a basis for future K of L planning by the Supreme Council".



HONORARY MEMBERSHIP AWARDED

Another very worthy member was elevated to Honorary Membership, the highest honor the organization can pay a member, during the Convention Banquet. The award was presented by Honorary Membership Committee Secretary Phyllis Grendal to LARRY JANONIS, Mid-Atlantic District President and frequent Convention Presidium Chairman, of C-12, Manhattan, N.Y. The members of the Knights of Lithuania extend warmest congratulations to Larry, and thanks for his many contributions to the Knights.

CONVENTION PUBLICITY

The 1977 Convention Coordinating Committee began planning Publicity for the 64th Convention early in the year. Previous Conventions had discussed having a "Press Box", which was to function during the Convention, writing up stories and issuing releases. In past years the host council provided a monthly column in the VYTIS to inform the members of Convention plans. Usually, someone was found to write articles for the Lithuanian newspapers. All this did not seem to be enough for the C-103 convention planners.

After much discussion they hammered out a new plan, which called for a wider and more frequent coverage of the Convention preparations and events.

John Stoskus assumed the duties of keeping K of L members informed through his monthly "Convention Rap" column. Father A. Jurgelaitis, O.P. was requested to implement other items of the publicity master plan.

First of all, letters were sent out to all councils requesting the name of their local daily newspaper. As soon as the lists of council delegates and alternates reached convention headquarters, news releases were prepared and sent out to the local council area newspapers with information about the Knights of Lithuania and the local council participation in the Convention.

About two weeks before the Convention, general news releases were sent out to Providence and Rhode Island papers.

The 64th National Convention was most fortunate in enlisting the generous, tireless and experienced services of Tom Holleran, correspondent of the PAWTUCKET TIMES and zealous supporter of Lithuanian activities in Providence, who not only wrote up and distributed the news releases, but also, through his professional contacts arranged for TV and photographic news coverage of the major Convention events.

From his report we get an accurate picture of the results. First releases went to 23 Rhode Island newspapers; special briefer notices were sent out to 17 radio stations and the 4 local TV News Directors; arrangements were made for the "WELCOME, K of l" outdoor sign on one of the busiest streets in Pawtucket; arrangement of the participation of the K of L in the Channel 12, WPRI-TV program "Front and Center" in which a seven minute segment was obtained for a showing on Saturday, August 20th at around noontime. Convention General Chairman Birute Stoskus, Cultural Evening Hostess Helen Seraichekas and Father A. Jurgelaitis, Convention Coordinator, were guests on this program which featured news about the Knights of Lithuania, and cultural items about Lithuanian national costumes (both ladies were Lithuanian national dress), about Lithuanian amber and about Lithuanian crosses. Fr.

Jurgelaitis spoke about Lithuania's struggle for human rights and the value of the "Chronicles" as documentation of the persecution of the Lithuanian people for their religious beliefs.

Tom Holleran, also, contacted the other Providence TV Station, WJAR-TV, Channel 10, for coverage of the March for Human Rights from the hotel to the church on Sunday morning.

As soon as elections were over, a follow-up news release was prepared and sent out to 35 out of state newspapers, announcing the names of the new officers of the Supreme Council.

In terms of newspaper space our 64th Convention received we have the following: PAWTUCKET TIMES 102 inches; Providence JOURNAL BULLETIN 38½ inches; the diocesan PROVIDENCE VISITOR 24 inches. In all, local Convention news coverage amounted to almost an entire page of a newspaper.


The UPI — United Press International — which is a wire news service, picked up the notice of the Convention and sent it out to all its hundred and more affiliates.

In addition to the above English coverage, a news release in Lithuanian was sent out to DRAUGAS, DARBININKAS and GARSAS, and, also, to Lithuanian Radio Programs all over the United States.

To insure complete photographic coverage of the Convention amateur photographer Ray Fields was enlisted to provide photos for the VYTIS.

The 1977 Convention was memorable in many ways, and it must be said that the far reaching and successful publicity effort helped to make it so.

The warmest K of L thanks goes out to Tom Holleran and Ray Fields and to all the news media for their assistance in spreading the word about the Convention and all K of L activities.

Culturally, Aldona Ryan, C-96, Dayton, National Cultural Chairman, Faustas Strolia, C-36, Chicago, K of L Choir Director, and Philip Skabeikis, C-110, Maspeth, National 2nd Vice President, presented an excellent discussion of the origins, meaning, and beauty of Lithuanian culture, entitled "The Treasures of your Lithuanian Cultural Heritage". By popular demand, these discussions will be printed in their entirety in a future issue also.

To look into the organization's future, the organizational theme was carried out by a panel entitled "The Knights of Lithuania Faces the Future, Tomorrow and Beyond", with panelists Rev. Casimir Pugevicius, C-29, Newark, National Lithuanian Affairs Chairman, Marian Skabeikis, C-110, Maspeth, past National First Vice-President, and Dr. Algirdas Budreckis, C-17, So. Boston, Mass., who "peered into the future" and suggested innovative proposals.

REZOLIUCIJOS

WHEREAS the policy of the United States Government and the governments of the leading countries of the free world continues to be one of non-recognition of the illegal annexation of the Baltic countries of Lithuania, Latvia and Estonia,

BE IT RESOLVED that the Knights of Lithuania urge the United States government to draw attention to the denial of self-determination of these countries as it addresses the problem of human rights in the United Nations and other international meetings, particularly at the Belgrade conference review of compliance.

BE IT FURTHER RESOLVED that the Knights of Lithuania urge the United States Government to accord proper respect toward Lithuania as a diplomatically recognized country, in its procedures. This would involve rejection of Russian orthography in spelling of Lithuanian place names. It would also involve establishing intellegence efforts in the State Department and elsewhere aimed at following events in Lithuania as separate from the Soviet Union.

WHEREAS the Committee on Security and Cooperation in Europe (The Helsinki Commission) has made a long-term commitment to work for the cause of human rights in Eastern Europe.

BE IT RESOLVED that the Knights of Lithuania, gathered at their 64th National Convention in Providence, R.I., August 17 - 20, 1977 commend the Committee on Security and Cooperation for their positive position on human rights.

BE IT FURTHER RESOLVED that the Knights of Lithuania commend the attention given to human rights, not only in Lithuania, Latvia and Estonia, the Ukraine, Byelorussia, Georgia and others whose people have relatives abroad to speak in their behalf, but also to other suppressed peoples such as the Crimean Tartars who are too often forgotten.

BE IT FURTHER RESOLVED that the Knights of Lithuania urge the Committee not to separate the issue of National self-determination from the question of human rights.

RESOLUTIONS

WHEREAS President of the United States Jimmy Carter has consistently demonstrated a positive stand on human rights, in word by his public addresses and in deed by signing the National Proclamation for Captive Nations Week, and

WHEREAS the people of occupied Lithuania have expressed their great appreciation of this stand, and

WHEREAS one of the basic concerns of the Knights of Lithuania is the implementation of Human Rights which include national self-determination, in Lithuania

BE IT RESOLVED that the delegates to the 64th National Convention of the Knights of Lithuania, August 20, 1977 at Providence, R.I., representing 2500 members from all parts of the United States, gratefully commend and strongly support President Carter's expressed support on Human Rights.

BE IT FURTHER RESOLVED that the Knights of Lithuania urge Mr. Carter to continue to use his position as a preeminent world leader to promote the cause of justice and freedom for all peoples in world community.

WHEREAS the Catholic Bishops of the United States, meeting in Chicago, May 4, 1977, issued a statement decrying the suppression of religion in Lithuania and Eastern Europe generally,

BE IT RESOLVED that the Knights of Lithuania, an American Catholic organization with 2500 members, communicate to the Bishops through Archbishop Joseph Bernardin, and through local ordinaries, their appreciation of the Knights of Lithuania for the Bishops' statement, and urge that appropriate steps be taken to follow up on the statement.

WHEREAS the Council on Foreign Relations, a nongovernmental but prestigious advisory body, has chosen as its President Winston Lord, and

WHEREAS Winston Lord is quoted in the press as having called Aleksander Solzhenitsyn "just about a Fascist",

BE IT RESOLVED that the Knights of Lithuania seriously object to the choice on the basis of his poor judgement as demonstrated in this instance.

WHEREAS the Lithuanian Marian Fathers have successfully initiated proceedings in Rome that may one day result in the canonization of Archbishop George Matulaitis, and

WHEREAS the prayers and intercession of this Servant of God are most needful for the preservation of the Faith in Lithuania,

BE IT RESOLVED at the 64th National Convention of the Knights of Lithuania in Providence, R.I., that as an organization and as individual members, the Knights of Lithuania support and promote the process of Beatification and Canonization through prayer and other assistance.

BE IT RESOLVED that a Committee of three members be selected to prepare a new Lithuanian version of the Constitution incorporating the revisions adopted by the 64th National Convention, and

That Father Thomas Ziuraitis, O.P. and Joseph Boley, Honorary Member, be invited to serve on this committee.

WHEREAS organizational costs continue to increase and the 1977-78 year brings a probable increase in the cost of both VYTIS publication and postage,

BE IT THEREFORE RESOLVED that National Membership dues be increased to \$8.00 annually for a single individual or couple after the first year, \$12.00 for a couple in the first year and \$4.00 for the family's non-subscribing member. This dues structure would, of course be subject to the usual quarterly pro-rated reduction.

BE IT RESOLVED that the Supreme Council Ritual Committee notify candidates for the Fourth Degree, or Council Ritual Chairmen, of the acceptance or denial of the Fourth Degree qualifications prior to Convention time.

BE IT RESOLVED that for 1977-1978 not more than three regularly scheduled Supreme Council meetings be held between Conventions.

BE IT RESOLVED, that the Knights of Lithuania Cultural Fund, established by resolution of the 60th National Convention, be allocated the sum of \$1,000.

BE IT RESOLVED that the Supreme Council Cultural Committee allocate \$100 per District for the express purpose of placing books and records in public or university libraries, and that requests for such funds be made to the Supreme Council Cultural Chairman through the local District Cultural Chairman.

WHEREAS it has been traditional to invite representatives of major organizations to our Convention, and

WHEREAS, in recent years this has not been consistently done,

BE IT RESOLVED that the Supreme Council Secretary be required to issue such invitations three months before the opening of our National Convention, other invitations to be allowed.

WHEREAS the ideals of the Knights of Lithuania are best served when adequate time at every council meeting is provided for religion, Lithuanian culture and language, and Lithuanian Affairs projects,

BE IT RESOLVED that local council officers give highest priority to the preparation and presentation of such informational programs.

RECOMMENDATION. These programs should take at least thirty minutes.

WHEREAS it is fitting that the entire Knights of Lithuania organization join in prayer for a deceased member and in expressing condolences to the family of the deceased member through the Supreme Council Officers

BE IT RESOLVED that each council secretary immediately inform the President of the Knights of Lithuania of the death of a council member;

That the President send a message of sympathy and condolences to the family of the member, announcing that a Month's Mind Mass would be offered for the soul of the member;

That the Supreme Council Spiritual Advisor be requested to offer the Mass and send a Mass Card to the bereaved family.

BE IT RESOLVED that a Committee of three members be selected whose responsibility it shall be to prepare for publication the KNIGHTS OF LITHUANIA LEADERSHIP MANUAL.

RECOMMENDATION. The following guidelines are recommended to the Committee.

- 1. Adopt a unified style for the various sections.
- 2. Adopt the standard 8½ by 11 format.
- 3. Submit the MANUAL for printing.
- 4. Provide at cost 200 three ring binders with Knights of Lithuania insignia.
- 5. Distribute the MANUALS as fellows:

Two copies to each Council President One copy to each Spiritual Advisor One copy to each Supreme Council Officer and Committee Chairman Two copies to each District President

6. Have 300 copies printed.

WHEREAS there are irregularities in the manner in which Ritual Degrees are conferred on Spiritual Advisors and Priest members,

BE IT RESOLVED that the Supreme Council Ritual Committee amend its rules to incorporate the following:

A. Spiritual Advisors who have been members for twelve months qualify for reception of the Second Degree.

B. Spiritual Advisors who have been Second Degree members for three years qualify for the reception

of the Third Degree.

C. Spiritual Advisors who have been Third Degree members for four years qualify for the reception of the Fourth Degree.

Priest members who are not Spiritual Advisors qualify for the higher degrees as follows:

- A. Second Degree to be granted after twelve months as members.
- B. Third Degree to be granted after four years as Second Degree member.
- C. Fourth Degree to be granted after six years as Third Degree member.

Since our organization has been remiss in conferring of degrees, it is further submitted that the Supreme. Council allow the conferral of the highest degree merited, skipping over the intermediate degrees, where this procedure is warranted.

This means, for instance, that a Spiritual Adviso who has been serving for eight years would be granted the Fourth Degree immediately. Any priest member who has been in good standing for eleven years would immediately be granted the Fourth Degree.

BE IT RESOLVED that the Knights of Lithuania Christian Wake Service prepared by the Supreme Council Spiritual Advisor and approved by Bishop Louis E. Gelineau, Bishop of Providence, be adopted as the official Knights of Lithuania Christian Wake Service, and

That the Supreme Council order the printing and distribution of the Wake Service to all local Councils.

Dear Rev. Pugevicius:

Thank you very much for sending me the recent resolution of the Knights of Lithuania on the linkage between human rights and the right of national selfdetermination.

The Commission recognized the connection between the two subject headings — separate in the Final Act — in the hearings it held April 27 and 28, 1977. In preparing its report on implementation, however, the Commission elected to concentrate its discussion of human rights compliance around Principle VII, leaving Principle VIII temporarily aside.

The Belgrade Conference, however, will include a review of all the Principles, one by one, and will afford an opportunity to discuss the issues of self-determination, especially for the Baltic states, in the context of Principles VII and VIII. You can be assured that the Commission will recommend a thorough discussion of the matter as a human rights question.

ON THE RELIGIOUS SIDE

The 64th National Convention opened officially with Holy Mass at noon at Saint Casimir's Church. The altar of Sacrifice was simply yet tastefully decorated, and banners proclaimed the intention of the Mass: "Come, Holy Spirit".

Father Vaclovas Martinkus, C-103 Spiritual Advisor, was main celebrant. Concelebrants were Fr. C. Pugevicius, Fr. V. Kriščiunevičius and Fr. A. Jur-

gelaitis, O.P., who also gave the homily.

Before the Mass there was a brief hymn rehearsal conducted by Faustas Strolia. A specially prepared Lithuanian "missalette" made it easier for all to participate in the liturgy. Three new Lithuanian hymns were rehearsed and sung during the daily Masses. Using well known English hymn melodies, the Supreme Council Spiritual Advisor composed new words to make up hymns particularly appropriate for the Knights of Lithuania.

In his homily Fr. Jurgelaitis set the spiritual tone for the Convention by explaining what "Come, Holy Spirit" should mean to the Knights of Lithuania, namely, that we Knights believe in God's Power, that we are to be open to the Wisdom of God, that all our

efforts ought to be based on love.

"Nemanykime, kad Šventoji Dvasia veikia tiktai bažnyčiose arba tiktai šventuose dalykuose. Šventoji Dvasia veikia visur. Šventoji Dvasia veikia ir mūsų Seime!"

He proclaimed this year's Convention motto: "Mūsų Lietuva laukia Jūsų kovos, Jūsų aukų dėl žmogaus teisių". — "Our Lithuania awaits your sacrifice, your struggles for human rights", which all delegates were to see imprinted on two huge yellow banners in the Convention Hall when the official

business sessions began later that afternoon.

On Friday, Holy Mass was concelebrated at the hôtel, rather appropriately in a room called "Angell-Street". Father Casimir Pugevicius, Lithuanian Affairs Chairman, preached the homily. This Mass was a special Mass found in the new Sacramentary: "For Persecuted Peoples". The Rev. Deacon John Prusaitis assisted the concelebrants.


The Religious Theme, as part of the Convention Program, was presented by Deacon John Prusaitis, a recent graduate CUM LAUDE of the "Angelicum" university in Rome. Deacon John is a member of the Knights of Lithuania C-1 Brockton. He gave a well-prepared conference on "The World has no conscience, have you?"

The speaker carefully pointed out that everyone does have a conscience, but that there is a huge amount of confusion and ignorance concerning the part conscience must play in the daily life of all people. He explained that even when people do not know God, or even deny Him, they still have to obey conscience which is really a silent voice of God. Confusion of conscience comes about when people try to become a law unto themselves, whether from culpable ignorance or from pride, a refusal to obey some particular law of God. He made a special point that emotions and feelings must be set aside when forming one's conscience, because emotions obscure right thinking and right willing.

A question and answer period followed. Fr. A.

Jurgelaitis was discussion facilitator.

After the Mass all Spiritual Advisors and priests present held a Luncheon Meeting at which K of L problems and projects were discussed. Present were



During the Friday afternoon session, the Very Rev. Joseph Dambrauskas, MIC, Provincial of the Lithuanian Marian Fathers, addressed the Convention. He spoke about the beatification of Archbishop George Matulaitis, MIC, who was the reorganizer of the Marian Fathers and whose reputation for heroic sanctity is growing year by year. His excellent talk was an inspiration for the Knights of Lithuania and a stimulus to share in the efforts to have Archbishop Matulaitis raised to the honors of Sainthood in the Church.

On Saturday, Holy Mass was again concelebrated at the Marriott Hotel. Father C. Pugevicius was chief concelebrant and homilist.

After the Mass there took place a unique ceremony. The newly adopted K of L Christian Wake Service composed by the Supreme Council Spiritual Advisor and approved by the Most Reverend Louis E. Gelineau, Bishop of Providence, was used as a commemoration of all deceased K of L members. The Supreme Council President and the District Presidents, representing all the members placed white flowers at the foot of the cross which was set up beside the Pascal Candle to the left of the altar. It was truly a devotional moment as all the delegates and guests repeated the Response: "Priimk juos i savo Karalyste ir apdovanok juos savo gailestinga meile". — "Receive them into your Kingdom and grant them your merciful love".

quet was the Most Reverend Louis E. Gelineau, Bishop of Providence. His warm and pleasant remarks indicated how impressed he was with the work and activities of the Knights of Lithuania, and also, his own personal concern as a member of the Hierarchy for our persecuted bretheren in Lithuania.

Presiding at the concelebrated closing Mass of the Convention on Sunday at Saint Casimir's Church was the Most Reverend Kenneth A. Angell, Auxiliary Bishop of Providence. Chief Concelebrant was the Supreme Council Spiritual Advisor, Fr. Jurgelaitis, O.P. Other concelebrants were Father C. Pugevičius and Father V. Kriščiunevičius.

In his homily, Bishop Angell described how communication was a divine action and is eternal in the Most Holy Trinity. He went on to show how creation and revelation are external communications and that the Holy Spirit was the ultimate Communicator of God's Will to men. He pointed out that since we are made to the image of God, we, too, share in the ability to communicate. We communicate vertically with God Himself through prayer and horizontally with each other through love of neighbor. He urged the Knights of Lithuania to emphasize both means of communication.

Father Jurgelaitis' remarks at the close of the Mass picked up the Bishop's theme and specifically applied it to our organization. He suggested that all officers and members of the Knights of Lithuania make "prompt communications" a special project for the coming year, so that K of L activities for God and Country would be more effective and far-reaching.

A collection for Lithuanian Catholic Religious Aid was taken up at the Mass and almost \$400 was contributed by the delegates and guests and the parishioners of St. Casimir's Church.

PADRIKOS MINTYS

Neseniai pasibaigė 64-tasis vyčių seimas. Pirmą sykį dalyvavusiam tokiame sambūryje teko išgyventi vieną kitą nepamirštamą įspūdį. Pradedant šv. Mišiomis, giesmėmis ir malda, buvo galima pajusti rimtį, su kuria teko svarstyti opius klausimus ir nustatyti gaires ateičiai. Čia nenoriu kalbėti apie seimo tvarkingą bei sklandžią eigą ir įdomius posėdžius, tik noriu pasidalinti kai kuriais maloniais seimo

ispūdžiais.

Šimtai įvairaus amžiaus atstovų suplaukė į metinį vyčių seimą. Susidarė įspūdis, kad čia susirinko ne eilinė gatvės minia, bet tvarkinga išmintingų, pajėgių, susipratusių lietuvių rinktinė. Suvažiavusių tarpe buvo matyti pagyvenusių, gal ir senstelėjančių vyčių. Kai kurie juo labiau silpnos sveikatos, pakėlė nemažą ilgos kelionės vargą. 

NATIONAL TRUSTEE DANIEL AVERKA, COUNCIL 17 SENIORS



K OF L CONSTITUTION REVISION PROJECT

The long-overdue project of updating and revising the Knights of Lithuania Constitution was brought one step closer to completion during the 64th National Convention. The proposed changes, as listed in the May, 1977 issue of VYTIS were passed on, one by one. All but one were approved. The item not accepted was the addition of a new section, section 6., to Article VII. This item is listed on page 17 of the May VYTIS. Specifically, it reads:

"6. Members who willfully violate Catholic standards of moral behavior or who consistently


fail to observe the regulations of the organization shall be requested to resign from the organization upon recommendation of the Council Spiritual Advisor and the unanimous vote of the local Council officers".

The item was omitted because the delegates felt that the subject of this addition is already covered in other parts of the constitution and need not be reiterated.

The last step in this project is the translation of the new constitution into Lithuanian and the printing of the English and Lithuanian versions for distribution to all members.

The Knights of Lithuania are indeed grateful to Rev. A. Jurgelaitis, O.P. and to all his assistants for smooth execution of this important and time-consuming task. Unitl the new constitutions are printed, we suggest that all members keep and refer to the Proposed Revisions, as printed in the May issue of VYTIS, pages 15-18.



KNIGHTS OF LITHUANIA NATIONAL CONVENTION — 1977

Over forty Juniors from Amsterdam, Brockton, Boston, Chicago, Maspeth and Providence gathered in Providence, Rhode Island for the Knights of Lithuania 64th National Convention.

The earlybirds attended a pool party at the Marriott Hotel. Some of the Juniors from Providence wore old-fashioned bathing suits. The group from Maspeth showed up with "Hug a Junior Today" tee shirts.

The convention officially opened on Thursday with Mass at St. Casimir's Church with all the delegates and guests in attendance. A luncheon followed in the church hall. Later, the Juniors led by Paul Stoskas, took a walking tour of Providence. The highlight of this tour was Benefit Street. This street between 1756 and 1758 was widened for "the common benefit" of all. Many of the original houses stand today. Other sights along our path were Roger William's Spring, the Cathedral of St. John, the Old Court and State House, and Brown University. All of these buildings have historical, architectural, political, and religious significance. The tour included a slide show of Providence and its founder, Roger Williams. In the evening, the Juniors watched "Kaimo Vestuves".

On Friday there was a trip to Newport. The first stop was "The Breakers", summer cottage of the multi-millionaire Cornelius Vanderbilt. Everyone took a tour of

this Italian Renaissance style mansion. These activities were sponsored by the Rhode Island Lithuanian Bicentennial Committee. After a ten mile drive along the coast, lunch was served at the home of Mrs. Coughlin, President of this Committee. After lunch, swimming at Newport Beach was on the agenda. In the evening, the Juniors took a cruise with the rest of the convention on Narragansett Bay.

Saturday was a day of business. The Juniors' session was called to order at 9:15 AM with a prayer by Fr. Anthony Jurgelaitis. Nominations were accepted for a chairman and Secretary. Elected were Marcy Krecioch, C-103 and Bill Sidtis C-110, respectively.

The first order of business was a talk by Fr. Jurgelaitis. Father spoke about our Lithuanianism and how we should always be proud of it. He likened the K of L Juniors, Regulars and Seniors to the Olympic runners who must pass that torch of light and energy from one runner to another. Next on the agenda was a talk from Walter Svekla of the Scholarship Fund. He explained its purpose with explanations of eligibility and the

CULTURAL EVENING

What might loosely be called "Lithuanian theater" was last seen at a National Convention in 1973 at Brockton. Indeed, the traditional Cultural Evening of the 64th National Convention brought back some fond memories.

Convention delegates and guests were packed into St. Casimir's Rev. John A. Vaitekunas Hall on Thursday evening. The program was entitled "Kaimo Vestuvės", A Village Wedding. The usual cultural fare of folk song and dance were there, but they were packaged in a completely unique way.

The Boston Lithuanian Ethnographic Ensemble was founded in 1974 by a group of Lithuanian young people who simply enjoyed singing and learning about the origin of song. They officially became the "Ensemble" in 1976. Since then, their aim has been to painstakingly research Lithuanian folk customs and musical folk lore and to present them in authentic reenactments of scenes from Lithuanian life. With fewer than ten performances to their credit, this group is still in its infancy, yet to their credit, the 22 young people participating brought a style and maturity to their presentation that was refreshing.

As the title leads one to believe, a village wedding was depicted between one Onute Mikšyte and Jonas Kunča. By means of clever dialogue woven between folk songs sung "village style" or a capella without accompaniment or direction, all the folk customs attendant to a Lithuanian wedding were enacted.

There was the Piršlys, or matchmaker, making all arrangements as smoothly as today's politicians might. The inviter, Kvieslys, cordially exhorted the audience to attend the nuptials. We saw the poignant hair combing and braiding ceremony on the eve of the wedding, the antics of the guest at the "reception", the mock lynching of the piršlys when the

bargain is feigned faulty, and the final exchange of the rue - wreath for the married woman's headdress, and the tearful fairwell of the young couple.

Most remarkable, was that although some of the dialogue might not have been understood by all, nor the folk songs, some as old as the "sutartine" may not have been recalled, everything seemed so natural, so familiar, as if striking some common chord in all the


