


Archbishop Charles A. Salatka blesses his faithful after Installation at Oklahoma City. (Story - p. 3)



# CHARLES A. SALATKA, ARCHBISHOP OF OKLAHOMA CITY

Dec. 15, 1977, was a day of excitement and reverence for the Catholics of greater Oklahoma City, Oklahoma, for on that day, they welcomed and installed their newly-appointed Archbishop, the second in their history. For Lithuanian Americans in Oklahoma City and elsewhere, and especially for members of the Knights of Lithuania, this was also a proud day of historic significance, for the new Archbishop, CHARLES A. SA-LATKA, is "one of their own", an American, born of Lithuanian parents and raised in the Lithuanian tradition. He is also an Honorary Member of the Knights of Lithuania.

When Charles A. Salatka was consecrated Bishop in 1961, he became the first American born Lithuanian Bishop in the United States. (Bishop V. Brizgys of Chicago was born and consecrated Bishop in Lithuania, Bishop Martinkus of Cicero, now at the Vatican, was consecrated Bishop later). Now he holds the added distinction of being the first - and only - Lithuanian American Archbishop in the USA.

The new Archbishop's life of hardship, joy, achievement and service is summarized beautifully in the following excerpt from the "Sooner Catholic", Oklahoma City, Dec. 11, 1977. We quote:

#### ARCHBISHOP SALATKA

#### A PORTRAIT OF THE MAN AND THE BISHOP

Charles Alexander Salatka was born in Grand Rapids, Michigan on Feb. 26, 1918. He was the third of five children born to Charles Anthony and Mary Balun Salatka. The parents were immigrants from Lithuania. They had come to America about the beginning of the 20th century.

The Salatka family lived out a typically American story. They retained, in good part, their Lithuanian heritage. Their neighborhood was populated by fellow Lithuanian-Americans. Their parish, Sts. Peter and Paul, was a national Lithuanian parish. At the same time that the Salatkas treasured their past, they felt another attraction — to be integrated into American life.

The life of the Salatkas family centered around the parish church. The children — Mary, Joseph, Charles, Elda, and John — were baptized, entered into the life of Catholic worship, received their formal elementary education, and participated in an endless round of parish-sponsored activities at Sts. Peter and Paul Church.

The Salatka family was far from affluent. Mr. Salatka earned the family support as a veneer sander in Grand Rapids furniture factories. Added to the task of coping with a wholly different culture was the Great Depression which afflicted the economy during the elder Salatka's prime working years.

Charles ("Chuck" to his family and friends) attended elementary school at Sts. Peter and Paul. During the first years, he was under tutelage of the Dominican Sisters and in the upper elementary grades was taught by the Sisters of St. Francis of the Providence of God.

Chuck Salatka made his decision to enter the diocesan seminary following eighth grade graduation. He attended St. Joseph's Seminary in Grand Rapids during his high school and college years. For theological studies he traveled to Catholic University in Washington, D.C. While there he earned a master's degree.

February 24, 1945 was a very big day for the Salatka family — Charles was ordained a priest. His

first appointment was to the faculty of the Grand Rapids seminary. Then Bishop Francis Haas sent Father Salatka to Rome to seek a degree in canon law. In 1948, he received a licentiate from the Institute of Civil and Canon Law.

The next decade and a half were predictable years for the bright, hard working canon lawyer. Father Salatka joined the Grand Rapids' chancery office staff upon his return from Rome. In 1950, he was given the additional assignment of pastor at the small rural church of St. Michael at Coopersville. By 1954, he was named vice chancellor. In 1961 he became Bishop Allen Babcock's vicar general.

Pope John XXIII appointed Charles Salatka auxiliary bishop of Grand Rapids on Dec. 9, 1961. He was consecrated a bishop on March 6, 1962. At the

same time that he became auxiliary of Grand Rapids. Bishop Salatka also assumed responsibility as pastor of a large urban parish, St. James in Grand Rapids.

On Jan. 10, 1968, the 49-year-old auxiliary of Grand Rapids was appointed Bishop of Marquette, Michigan by Pope Paul VI. He was installed in that office on March 25, 1968.

Almost a decade later, even as he was deeply and satisfyingly involved in his work as chief pastor of the Marquette Diocese, life took a completely unexpected turn for Bishop Salatka. Pope Paul VI asked him to transfer to the Archdiocese of Oklahoma City. Announcement of the appointment was made on Oct. 11, 1977.

#### INSTALLATION

To show their esteem of the man and his office of Bishop, the Knights of Lithuania elevated Bishop Charles Salatka to Honorary Membership in Detroit in 1962. To demonstrate his own esteem for the Knights of Lithuania, Archbishop Salatka invited Knights of Lithuania National President Anthony Miner to attend the Installation to Archbishop, and its associated dinner

and reception on Dec. 15, 1977 in Oklahoma City.

Mr. Miner attended, and had the distinction of being one of the few lay people included in the dinner at the Hilton Inn Northwest before the Installation, and sat with the Archbishop's family during the Installation at the Cathedral of Our Lady of Perpetual Help. Thus he was also privileged to receive Communion from the Archbishop

before the general Communion service.

At the Archbishop's request, the Installation Ceremony was simple and reverent, although attended by Cardinal Deardon of Detroit, over 50 Bishops, hundreds of priests, and a mass of laity. Three local TV stations and many newspapers covered the event.


In his sermon, Archbishop Salatka said, quoting from St Augustine, "For you I am a Bishop, but with you, I am a Christian. The first is an offer to accept. The second is grace. One is a danger, the other is a guardian". He also said that his ministry to the flock would be three-fold - as a teacher, priest, and shepherd. "...As a teacher, I will proclaim the work of God patiently, consistently, and faithfully". His priestly function would be to "sustain and provide you the Sacraments". As a shepherd, his duty will be to "watch over you lovingly, to protect and to guide you".

After the Mass and Installation, there was a general reception at the Connor Center, where Anthony Miner presented the Archbishop with a token gift from the Knights of Lithuania, a replica of the painting of Our Lady of Vilnius, done in bits of amber and inscribed with the Knights of Lithuania name and the date. The Archbishop was very pleased with the gift. No other presentations were made.

It is noteworthy that the "Sooner Catholic", official organ of the Archdiocese of Oklahoma City, devoted the better part of an issueand the "Oklahoma Journal" dedicated an entire section - to Arch-

Salatka. Both bishop papers dwelled heavily on the Salatka family and their retention and appreciation of their Lithuanian heritage. The Journal also included a full page to a discussion of Lithuanian customs, the plight of Lithuania today, and the religiosity of the Lithuanian people, and quoted two other local priests, Rev. John Petuskey and Rev. James Mickus, also of Lithuanian descent, in a discussion of Lithuania.

Oklahoma City is indeed fortunate to have this holy, intelligent, diligent man as their Shepherd.

On behalf of all members of the Knights of Lithuania, we thank Archbishop Salatka for the rare opportunity to participate in such a historic event. We extend to him our sincerest congratulations on this high appointment and our fervent prayers for his continued success in the service of God. AD MULTOS ANNOS!

# A BITTER-SWEET ANNIVERSARY FOR LITHUANIANS

On February 16, 1978, Lithuanian Communities throughout the Free World will celebrate the 60th Anniversary of Lithuanian Independence. The question has sometimes been posed as to the reason for celebrating the "Independence" of a country which is no longer, in fact, free. Independence, in the most widely accepted sense, represents the freedom of a nation to

determine its own destiny in the tide of world affairs. In a deeper, and more meaningful sense to us, perhaps, independence is a freedom of spirit, a movement in the hearts of men which transcends the political sphere, and reaches the very core of existence.

This spirit of independence exists in those believers in Lithuania today who are willing to risk everything, so that the truth can be made known. The words of the 28th issue of the CHRONICLE OF THE CATHOLIC CHURCH IN LITHUANIA reflect that special freedom. As we plan our local commemorations, it would serve us well to remember the daily struggle of those in Lithuania to-day who work to maintain that freedom of conscience which is the true meaning of independence.



# LITHUANIAN CHRONICLE CALLS FOR SUPPORT OF THE "CHURCH OF THE CATACOMBS"

"The Catholic Church of Lithuania is working in two ways: publicly and secretly", reports the CHRONICLE OF THE CATHOLIC CHURCH IN LITHUANIA.

The CHRONICLE is itself a clandestine newsletter published at great risk by members of the Lithuanian Catholic underground, and smuggled out to the free world. The latest issue has just reached this country. Dated June 29, 1977, it is the twenty-eighth issue in over five years, appearing despite elaborate efforts of the KGB to crush it. "Forced to operate entirely underground", the CHRONICLE reports, "are religious orders of men and women, young men secretly preparing for the priesthood, almost all teachers and various officials, who are afraid to be seen in church receiving the sacraments, lest they suffer for it.

"A good number of the priests even with official work permits are forced to function in catacomb fashion", the CHRONICLE continues, "preparing children for First Communion and Confirmation, visiting the sick in hospitals where the medical staff will not admit them, and witnessing the marriages of people with state jobs.

"The Catholic Church is functioning exclusively underground or semi-underground in wide areas of the Soviet Union. It can function because it ignores the restrictions imposed by the atheists. Such work is difficult, because it is



persecuted more vigorously by the atheists. However, it is difficult to suppress when it is properly organized".

"The Church operating legitimately out in the open can be annihilated at any moment by the atheists, who can close down the churches and arrest the bishops and priests. However, it is very difficult for them to overcome the 'Church of the Catacombs', since they cannot keep up with its activities.

"The Church of the Catacombs does not interfere with the Church operating overtly, it does not try to undermine its authority or to divide it, but tries in every way possible to complement its work...

"The government is quite displeased by activities of the Church of the Catacombs, because it cannot control them. While the overtly operating Church has certain privileges, the Church of the Catacombs is persecuted. Priests and religious working covertly are termed agents of the

Vatican or foreign spies.

"The very ones who make such accusations know they are not true. The Church of the Catacombs is not preparing any uprising, or revolt against the Soviet system...

"A serious pastoral error was committed by not preparing the bishops, priests and faithful of Lithuania in time juridically or pastorally for pastoral work in catacomb conditions.

"The more freedom of religion

increases, the less significance will the Church of the Catacombs have. The greater the persecution, the more will the Church be forced to burrow more deeply into the catacombs, and the greater will be its importance.

"With these facts in mind, we trust that our brother Lithuanians abroad, and the bishops and faithful of the whole world will help us to preserve the Catholic Faith, by their prayers and sacrifices; and that by all means at their disposal, they will defend us against persecution".

"We hope that they will make the best possible use of Catholic media of information, and media in the hands of other people of good will. We hope that they will make every effort to see that the hierarchy of the Catholic Church assists not only the Church operating on the surface in Lithuania, but also the Church working under catacomb conditions".

# LITHUANIA'S FRIENDS... AND THE STRUGGLE FOR HUMAN RIGHTS

The spirit of independence will not be extinguished in the hearts of those denied their just freedom and basic rights as long as there are statesmen in the free world willing to take a firm stand AGAINST the forces effecting those denials. During the recent meeting in Belgrade, Yugoslavia, called to discuss the Helsinki Final Act, many Americans rose up to affirm their commitment to the Human Rights provisions of the Act, and to demand the right of self-determination for all peoples, including Lithuania and the other Baltic States.

One such notable American was Sen. Robert Dole. We print his remarks, made in Belgrade on Nov. 25, 1977, as an outstanding example of the commitment of the American people to the right of Lithuania and other captive nations to their rights and independence, and a fitting tribute to the 60th Anniversary of Lithuania's Declaration of Independence, which we celebrate February 16, 1978.



#### Mr. Chairman:

I wish to extend my gratitude to the Government of Yugoslavia for the excellent job they have done in hosting this historic meeting. Although my duties in the Senate of the United States have prevented me from spending as much time here in Belgrade as I would have liked, I, along with my colleagues in the Congress, have followed these proceedings very closely and with great interest. The Chairman of my delegation, Ambassador Goldberg, has articulated the views of our Government and our people on many occasions during this meeting in a frank and fortright manner. He has expressed the particular concerns of our country that the human rights provisions of the Helsinki Final Act be implemented and observed. In doing so, he speaks for all Americans.

My delegation, however, is not only concerned with the human rights provisions of the Final Act. We are dedicated to the fulfillment of all its provisions. Quite frankly, great doubts were expressed by many Americans about the Final Act at the time it was signed in 'August of '1975. It was not all some Americans wanted and more than others cared for. President Ford was criticized for his participation at Helsinki and the Final Act was a matter of some contention in last year's presidential election. I do know this very well, since I was his running mate.

To his credit, President Carter not only continued, but personally strengthened America's commitment to implement the Final Act. Just last week, Vice President Mondale reaffirmed this resolve. American commitment to the implementation of the Final Act is across the board, it is strong, it is bipartisan.

Mr. Chairman, I am sure that whatever is accomplished here will be the result of compromise and cooperation. It is significant, however, to note that whatever the end results, there has been a review of the Final Act and there is a consensus for additional meetings. This, in itself, is progress — painfully slow as it may be.

#### POLITICS OF HUMAN RIGHTS

Without a doubt, is is popular, politically speaking, to pursue the quest for human rights. In most cases, it is also highly appropriate. Some, of course, would have you believe they discovered the dignity of man, while others are quick to condemn but slow to self-examine.

Ambassador Goldberg and other United States delegates have been specific and to the point. They have properly stated our case. Therefore, it is not my purpose to confront, or posture, or pound anyone over the head. Specific "human rights" cases which have been called to my attention have been passed on

to appropriate officials. I shall hope for expeditious handling and favorable disposition. My delegation does not seek to confront but to cooperate and we do not seek to confuse but to clarify and not to weaken but to strengthen.

#### A NATION OF IMMIGRANTS

We are a nation of immigrants, people who have come from all over the world to participate in the promise of America. Most of our population come from European backgrounds. They have cultural and ethnic identity with most of the participating states in this meeting. They actively maintain their interest in their heritage and in their former homelands.

They express their interest through associations and organizations throughout America. For example, I have met with representatives of organizations such as the National Confederation of American Ethnic Groups, The Czechoslovak National Council of America, The Congress of Russian Americans, The Polish American Congress, The Hungarian Organization in North America, The Ukrainian National Association and The Joint Baltic American National Committee — and many others. They have expressed their concern not only about the human rights provisions of Basket III and Principle VII, but also about the right of self-determination of all peoples.

It is a fact that the United States has never recognized the Soviet incorporation of Lithuania, Latvia and Estonia and U.S. official policy of nonrecognition was not affected by the results of the European Security Conference. This long-standing principle is the policy of the United States and is supported by the Congress of the United States.

I cite these groups and their concerns not to be provocative or confrontational. I merely wish to clarify and explain the reasons for the strong concerns of my delegation and my government in the field of human rights. There is — in my opinion — a


direct connection between the public perceptions of the integrity of the Helsinki process and the ability of governments in the West to carry on the process of detente. Public trials of political dissidents, for example, could have a profound impact on pending or subsequent bilateral and multilateral agreements. Most members of the Congress of the United States believe, in my opinion, that human rights cannot be subordinated to development, cooperation and security.

Our basic goal is to promote genuine understanding and relaxation of tensions between the participating states, greater respect for human rights, freedom of religion and self-determination of all peoples. We view CSCE as an important step toward achieving these objectives. We also understand that ours is not a perfect system — that we too have our own problems and failings — but we are making efforts to do better, and we will continue our work toward full implementation of all the provisions of the Final Act in our own country.

#### AMERICAN PROPOSAL

Finally, it is in this spirit that the American delegation, with the support of other delegations, will put forward a proposal which will, among other things, recognize the importance of the CSCE process and its continuation. The proposal will resolve to implement unilaterally the relevant provisions of the Final Act relating to human rights and fundamental freedoms and to ensure their implementation bilaterally and within the context of the CSCE and other multilateral fora.

December 10 is Human Rights Day, anniversary of the U.N. General Assembly's adoption of the universal declaration of human rights in 1948. My it serve to remind all nations of how far we have come and the distance yet to travel as we strive for future cooperation and security in Europe.

Vienoje priešseiminėje "Vyčio" laidoje, AAJ jautė reikalą paraginti vyčius metiniame seime bent iš dalies, t.y. bent 10% kalbėti lietuviškai. AAJ pateikė žiupsnį vienažodžių lietuviškų išsireiškimų, pavyzdžių ir trumpų, progai tinkančių, sakinių. Gaila, maža buvo kreipta dėmesio į šį nuoširdų pasiūlymą. Seimo dalyviai prašovė pro taikinį, lyg jo visai nebūtų buvę. Mieli broliai ir sesės, laikas pabusti ir sukrusti!

Manau, visi sutiksime, kad tautinei sąmonei išlaikyti, kalba yra neatstojamas ir nepakeičiamas veiksnys. Kalba yra tautos gyvybė, jos širdis ir siela. Be savos kalbos tauta vysta, džiūsta ir ilgainiui miršta.

Kai kurie vaikai jau silpnai kalba tėvų kalba, o vaikaičiai jau beveik visiškai yra užmiršę senelių palikimą. Jeigu šioje apgailėtinoje padėtyje nieko nedarysimė ir leisime gyvenimo raidai toliau ta

kryptimi vystytis, lietuvių kalba ir lietuvybė Amerikoje bus žuvusi.

Lietuvių tautinis išsilaikymas Amerikoje yra mūsų rankose. Jis yra tampriai susijęs su mūsų nuoširdžiu noru ir tvirtu ryžtu kalbėti lietuviškai. Kalbėjimas yra vienintelė išeitis. Turime daugiau kalbėti lietuviškai savo namuose, draugiškuose susitikimuose ir vyčių susirinkimuose. Juo dažniau ir daugiau kalbėsime, juo lengviau, gražiau ir taisyklingiau kalbėsime. Jau laikas mesti į šalį tuščius, nepagrįstus pasiteisinimus dėl nekalbėjimo, kaip tai: per sunku, kiti juoksis, čia Amerika, o ne Lietuva. Pastarasis gal skaudžiausias atsikirtimas. Atsiprašau, bet tikrai koktu išgirsti "dypukų" vaikus besiteisinančius "I am an American!"

Jeigu užmiršome tėvų kalbą, turime rimtai pradėti mokytis ir ryžtis bent kiek pramokti. Pati pažanga pareis nuo pasiryžimo kalbėti. Kalbėkime, kad ir netaisyklingai, su anglicizmais ir kitomis svetimybėmis, bet kalbėkime. Bandykime kalbėti tarpusavyje šeimose, susirinkimuose, pubūviuose ir vakaronėse. Maži vaikučiai išmoksta kalbėti pamėgdžiodami tėvus. Iš karto jie nesugeba aiškiai ištarti žodžių ir tiksliai išreikšti savo noru, tačiau ilgainiui išmoksta. Jeigu nemokame pasakyti lietuviškai, kad "boisas išrunino į strytą" arba ⁴aš tų šiūšų nelaikinu", iš pradžių taip ir sakykime. Atidžiai klausydami ir priimdami pataisymus, išmoksime sakyti, kad "Vaikas išbėgo į gatvę". Užuot sakę "nelaikinu tų šiūšų", sakysime "Man tie batukai nepatinka'. Gal skaitėte A. Barono "Lietuva mano", kur jo "dypukai"



tariasi grįžti į savo gimtinę, bet pramato vargo su naujai įsigyta manta:

"Matai, tėvyne, mes dar sugrįšim, Graži tu, mano brangi Lietuva Tik kaip parvešim ten erkandišen, Porčių, ir sofą, ir šaldytuvą?'

Kai kur vyčių kuopos remia vakarinius lituanistinius kursus suaugusiems. Kol kas jie stropiai lankomi. Sveikintinas ir remtinas reiškinys. Kad tik dvasia nepalūžtų ir jėgos nenusilptų. Visai nemokančiam kalbos, vardininkai, kilmininkai, daiktavardžiai, būdvardžiai, prieveiksmiai ir kitoki galai gali pakirsti ir uoliausią pasiryžimą. Gal geriau būtų pasekti Berlitzo mokymo pavyzdžiu? Ši mokykla remiasi dėsniu, kad galima svetimą kalbą išmokti trumpu laiku, klausant ir kartojant žodžius. Taip, kaip vaikai išmoksta iš tėvų. Būtų drąsus bandymas: čia stalas, čia kėdė, čia ranka, galva. akis. Akys yra mėlynos. Plaukai juodi. Popierius baltas ir t.t. Juo veikiau įtraukiamas mokinys į žodžių tarimą ir kartojimą, juo geriau.

Teigiama, kad pakanka 500-800 žodžių paprastam susikalbėjimui. Taigi, tikslas nėra neatsiekiamas.

#### HISTORY OF SYRACUSE

**PARTII** 

The history of Syracuse continues... The name "Syracuse" was chosen from Syracuse, Sicily because of the similarity between the two cities. Italian and Roman names must have been a favorite with the early settlers as a number of towns carry the names such as: Marcellus, Camillus, Cicero, Manlius, Pompey, Fabius, and Rome, to name a few.

Syracuse has many nicknames - Canal Town, Salt City, The Hub, Central City, etc. The most pupular is Salt City. This name is known the world over. In fact, the mascot of the Syracuse University athletic teams is dressed as an Indian brave and is called the Saltine Warrior.



In the early years of Syracuse, salt was the main industry. As competition from other areas increased, its market began to decrease. However, a chemist by the name of William Cogswell, saw the potential of blending two of Syracuse's most abundant deposits, the thick layer of salt and limestone, into an essential chemical called soda ash.

This was the beginning of Solvay Process Company which today is a part of Allied Chemical. Soda ash is the basic and most widely used alkali for industrial application. Its largest single use is in the manufacture of glass. Other uses are textiles, pulp and paper, metallic alloys, soap and soap powders, adhesives and ceramic ware.

Another product of Solvay Process with which most of you are familiar is Arm and Hammer Baking Soda.



Other inventions by Syracuse people were many. John Montague developed a machine to remove shells from rice and coffee beans. Charles Lipe invented a two-speed gear for bicycles which was to become a prototype for the early automobile transmission. Today Brown-Lipe-Chapin is a division of General Motors. Alexander Brown, who had over 150 patents to his credit developed a typewriter that was so easy to use that L. C. Smith left the gun industry to produce the typewriter.

Because of the chance meeting of Herbert Franklin and John Wilkinson, the Franklin automobile became a reality. Until it closed in 1934, Franklin made the country's only air-cooled passenger car engine.

Carrier Corporation started in New Jersey but moved to Syracuse to the vacant Franklin complex in 1937. Here it grew by leaps and bounds and is today a world giant in the air-conditioning field. Syracuse China is another name most people have heard. The Syracuse China line is a by-word around the world. James Pass who ran Onondaga Pottery, developed the first porcelain insulators for electric wire.

Crouse-Hinds Company grew over the years because of far-sighted management. Their first products were switches, switch-boards and panelboards. Next came trolley car headlights, automobile lights, searchlights, arc lamps and airport lighting. They produced the lighting system for the Panama Canal and recently the new lighting for the Statue of Liberty.

Crouse-Hinds greatest achievement was the development of the traffic light system. The first installation was in Houston, Texas in 1921.



Another kind of light is the candle. Syracuse still has four of the largest candle companies in the United States. Most of your church candles are made in Syracuse.

For the students of "liquid amber", Syracuse is a first class classroom. At one time we had a dozen breweries working hard to quench the thirst of the people. Today we have just two - Schlitz and Millers' - and they produce about 15 million barrels a year. Hopefully that will be sufficient for all of the thirsty K of L Conventioneers in August.

#### A.A. KUN. POVILAS JUKNEVIČIUS

Spalio 30 d. Chicagoje staiga mirė kan. Povilas Juknevičius, o lapkričio 2 d. - Vėlinėse - buvo iškilmingai palaidotas Šv. Kazimiero liet. kapuose. Marijos Nekalto Prasidėjimo bažnyčioje laidotuvių pamaldose dalyvavo Chicagos arkv. kard. John Cody, vysk. Alfred Abramovich, vysk. Vincentas Brizgys, lietuviai kunigai ir pilna bažnyčia tikinčiųjų. Kun. Povilas, kuris mėgo liturgiją, būtų patenkintas savo laidotuvių gražumu. O jos tikrai buvo gražios!

#### TRIJŲ TĖVYNIŲ KUNIGAS

Kun. Povilas gimė Latvijoje, mokėsi ir jaunystę praleido Lietuvoje, o dirbo ir mirė - Amerikoje.

Jis gimė 1904 m. vasario 11 d. Glemzinų k., Lucinos aps. Latvijoje, lietuviškoje šeimoje, bet visa aplinka buvo kalbiškai mišri. Todėl jis nuo mažens, be lietuvių, dar mokėjo latvių, lenkų ir rusų kalbas. Tėveliams persikėlus iš Latvijos į Lietuvą - Panevėžį, - Povilas čia lankė gimnaziją. Vėliau įstojo į Kauno kunigų seminariją, kurią baigė 1930 m. ir tais metais buvo įšventintas į kunigus. Dešimt metų (1930-1940) ėjo vikaro pareigas Ukmergėje ir Vandžiogaloje. Okupacijų metais (1940-1944) Kaune ėjo Šv. Luko ligoninės ir III gimnazijos kapeliono pareigas ir vadovavo savo įsteigtam Kurčių ir nebylių institutui. Rūpinosi Kauno kunigų seminarijos ekonominiu išlaikymu, kas karo ir okupacijos metais nebuvo lengva.

1944 m. pasitraukęs į Vokietiją Fellbach'e, prie Stutgart'o miesto, buvo lietuvių stovyklos kapelionas. Lietuviams vyskupams, su Amerikos lietuvių finansine pagalba, įsteigus religinėms knygoms leisti leidyklą - "LUX" - kun. Povilas buvo šios leidyklos vedėjas. Taip pat Skaučių Seserijos dvasies vadas. Vokietijoje iš Lietuvos



pasitraukęs Kauno arkivyskupas Juozapas Skvireckas kun. Povilą pagerbė garbės kanauninko titulu.

1949 m. atvykęs į Ameriką apsistojo Peoria, Ill., kur vietos kat. ligoninėje ėjo kapeliono asistento pareigas. Iš ten po kelių metų persikėlė į Chicagą - Marijos Nekalto Prasidėjimo liet. parapiją, kurioje darbavosi kaip vikaras, o vėliau kaip pensininkas iki savo staigios mirties.

#### BAŽNYČIOS KUNIGAS

Kun. Povilo kunigiškajį gyvenimą galima būtų aptarti šiais keliais žodžiais: jis buvo bažnyčios kunigas. Mylėjo jis bažnyčia, jos pamaldas, jos liturgiją ir melstis joje. Bažnyčios liturgija - buvo mylimiausioji jo pokalbių tema. Jis ja visada sielojosi, diskutavo, rašė vyskupams, ir liturginius leidinius rėmė finansiškai. Sielojosi liturginių tekstų vertimu į lietuvių kalbą. Visas jo dėmesys, kaip kunigo,

daugiausia koncentravosi bažnyčioje. Už bažnyčios ribų - visuomeniniu darbu domėjosi tik tiek, kiek
būtinai reikėjo. Bet ir ten dirbo
daugiausia kunigo darbą būdamas
dvasios vadovu. Buvo jis ir Lietuvos Vyčių Brighton Parko kuopos
dvasios vadu. Už jo nuoširdžias
maldas ir darbus Vyčių organizacijoje - Vyčiai jį pagerbė 4-tuoju
organizacijos laipsniu.

Šį žemiškąjį gyvenimą jis praėjo

tyliai ir kukliai.

Pagerbė jį vyskupas ir vyčiai, o aname gyvenime, tikime, jį pagerbs gerasis Dievas savo amžinąja meile ir amžinąja ramybe. Šv. Kazimiero kapuose, po vysk. V. Brizgio paskutinės maldos ir prel. D. Mozerio padėkos žodžio, laidotuvių dalyviai sugiedojo jam tradicinį "Viešpaties angelą". O toliau... amžinąją giesmę jam giedos kapinių medžiai savo ošimu...

#### IN MEMORY OF FATHER PAUL

Rev. Paul Juknevicius of beloved memory, cherished friend and Spiritual Director of Council 36 of the K of L passed away unexpectedly in Chicago on October 30th, 1977. The Resurrection Mass took place on Nov. 2nd - All Souls Day - at Immaculate Conception Church and Father was laid to rest in St. Casimir Lithuanian Cemetery. Participating in the funeral services were - Cardinal John Cody, archbishop of Chicago, Bishop Alfred Abramovich, and Bishop Vincent Brizgys. Many Lithuanian priests and an impressively large group of the faithful also attended. Father would indeed have been pleased with the beauty of the Ceremonies which were arranged by the pastor Msgr. D. Mozeris.

#### A PRIEST OF 3 COUNTRIES

Father Paul was born in Latvia of Lithuanian parents, was ordained in Lithuania in 1930, and died in the U.S.A. in 1977. Until 1944 Father served in various priestly capacities in Lithuania. With the outbreak of war Father continued his ministry in Germany. For his work with the press, youth, and Lithuanians, archbishop Joseph Skvireckas (in exile) bestowed upon him the henorary title of Canon (kanauninkas in Lithuanian). In 1949 Father found himself on American shores. Within a few years Father located himself at Immaculate Conception Parish where he worked until his retirement. Even as a retired priest he helped in the parish and worked with the K of L.

#### A PRIEST OF GOD

Father Paul's life could be summed up in a few words: he was a priest of God. He loved his church and he loved the liturgy. Father Paul gave his attention to strictly religious affairs. In this sense, Father Paul faithfully served the needs of the Knights of Lithuania in Chicagoland and especially in Brighton Park. The Knights always had a special place in Father Paul's heart. He is

responsible in great part for Council 36's constant rise in activity and number since he joined. In recognition of his prayers and efforts, Father attained the honor of fourth degree Knighthood.

Father Paul's passing leaves the Chicago K of L saddened. May he rest in peace!







NEW JERSEY-ITES AT THE BALTIC RALLY. E. Raudys, A. Bruzenas, E. Stankunas.


