Could a porch light have been substituted the night a girl was being beaten and raped in a suburb and blinds were pulled and ears were deaf to her screams because people feared getting involved? And she died in the blackness of the night.

Could the torch have illuminated a child's life by the giving of extra time to help him when he fell behind in his studies? Or did he just flounder and drown in a sea of darkness through the cracks of the system, never to surface again?

How many people yearning to be free are imprisoned in darkened cells, victims of "policy", "procedure", and "politics"? When will a torch lead them to our shores?

How many lifes of the elderly will be thrown a way of light with a visit, a letter or a phone call from family and friends? Or will they live out their lives in the shadows of their solitary existence.

The Statue of Liberty was never meant to physically be everywhere in this nation with her lamp. With each individual who came here, it was their duty to create their own personal torch that would burn within and shed light to every part of this land. These lights are there.


Some of our national treasures can be seen in the comforting hands and words of a nurse who helps lessen our fear and pain when we are alone, in the middle of the night, during a hospital stay; it can be heard in the comforting words of a police officer trying to calm a lost and frightened child. They are seen in the gleam of a parent's eyes when their child graduates from college or high school.

The Statue of Liberty holds a promise to welcome the world to her shores, comfort the tired, befried the poor and offer hope to the homeless. But she herself cannot do these things. She is only a 151-foot statue carved out of copper.

All 235 million of us Americans are the only ones who can give Lady Liberty life...and meaning. We must remember this. Let us help Liberty's light shine bright!

FACING THE CHALLENGE OF RESPONSIBILITY

You and I are very fortunate people. We have nice churches in which we can worship. Halls to use for our social events. These were all made possible by our parents and grandparents who came from Lithuania, on the most part poor, uneducated immigrants. They saved their pennies, nickles, dimes and quarters and they built our beautiful churches, rectories, schools, convents, halls and clubs. They were proud of their Lithuania nationality and they wanted to continue on their heritage and pass it onto their children and grandchildren. They worked hard and made many sacrifices to maintain these buildings by placing their pennies, nickles, dimes and quarters in the collection basket each Sunday. Church and participation in the Lithuanian community was very important to them.

You and I are the recipients of these beautiful churches, rectories, schools, convents, halls and clubs. We are the inheritors. As with any inheritance comes responsibility. We are now responsible for the maintenance and the upkeep of the buildings. We must assist in every possible way. We cannot leave it up to our parents and grandparents because they have gone onto their eternal reward. *We own this to our parents!*

If the parish is small and the works falls on a few people then we must go out and search for more Lithuanians to assist us in our duties. We all are disciples. We must spread and share our Lithuanianism with other Lithuanians. Sometimes it only takes a few kind words, while other times it may take a few visits. Most Lithuanian people are proud of their nationality. Most will mix with other Lithuanians if given the right opportunity. It is up to you and me to present them with the right opportunity. strongly that if we are to keep our Lithuanian churches open, we need people and we need participation.

The sacrifice you must make may be more than you care to make, but it will be far less than what our parents made. Conditions today are much more lucrative than they were fifty or more years ago. We are unable to do so much more than our parents were able to do. Therefore, extra work and sacrifice would not hurt us. We could do much more for the cause without suffering ill effects.

The Lithuanian parish situation is much more serious than most Lithuanians care to believe. In some cases it is very grave. Some churches have had to close. Others are in depressed neighborhoods and are on the verge of closing because of poor support. There are some who do not have Lithuanian pastors. Really there aren't many churches which can be classified as well off financially and attendance wise.

There are many Lithuanian priests who are associated with non-Lithuanian parishes. If approached properly some would probably transfer to Lithuanian parishes. If you know of a priest who would transfer please contact me and I will put him in contact with the right people.

And, we should never forget the need for vocations. Pray that more of our young people will respond to the Lord's Call.

In this year of the Lithuanian Christianity Jubilee how better can we celebrate than by developing and strengthing our Lithuanian parishes in the United States. Let us put our Lithuanian pride and determination to work and show others that the Vyciai are workers. Let us show them that we are one big family not always happy — but we are a family because we love each other and we care for each other.

There are many Lithuanians out there who belong to non-Lithuanian parishes. These are the ones we must talk to and use our best salesmanship. Emphasize

WHAT I WOULD TELL A PROSPECTIVE MEMBER ABOUT THE KNIGHTS OF LITHUANIA

The Knights of Lithuania means a great deal to me. In my case, pride in my Lithuanian origin, deep faith in the Catholic religion, devotion to Mary, were instilled in me from babyhood by my beloved parents. Thus, when the K of L was reorganized in Amsterdam in 1950, I was the most anxious to join.

To approach a prospective member, you have to be positive, eager enthusiastic and knowledgable about the K of L. Stress the three prime qualifications ... Catholic ... American...and of Lithuanian ancestry. If one is seeking identification of oneself, join the K of L where all members have the same background.

When I see that someone shows an interest in the Knights of Lithuania, my approach always is, "Would you like to join the K of L?" If the response is "YES", then I follow up with, "To become a members you must be a Catholic, American of Lithuanian extraction, or if married, your spouse has to be of Lithuanian heritage, that is, if you are of another ethnic origin." If the reply is affirmative, I then note the many alluring aspects....that we are a national organization...our activities in the fields of culture, Lithuanian Affairs and Public Relations...being delegates at the national and district conventions. I mention the activities at our monthly meetings which include most informative cultural sessions and our spiritual advisor's inspiring comments on religion, news about Lithuania, showing of slides, etc. Of course, the meetings are concluded with refreshments and socializing.

I then advise the prospective member that upon joining the K of L, the Vytis, an excellent monthly magazine, would be mailed to him or her. The magazine is a means of acquainting one with the doings of other councils with feature articles on religion the Lithuanian language, customs, recipes, Lithunaians in the news, and special articles by our national spiritual advisor and other officers.

Next, I refer to the scholarship awards. Any active member, preparing to enter college, may apply for this award. Our Scholarship Committee examines all applications and the winners are named at the national convention.

I stress the importance of getting involved in the activities of the organization and the point system in receiving grades. Attend the conven-4 tions as a delegate or guest. You will meet members from all over the country. The sessions are very informative and the evening social activities are always most enjoyable and relaxing.

THE CHURCH IN LITHUANIA

In 1984, a Christmas celebration was being arranged in the yard of Alytus. Even though it was not the first, the affair displeased the city government. Vice Chairman Laukiene of the Alytus City Executive Committee, shouted at Father Pranas Raciunas. "The Soviet government is mighty. We have the means, we'll take care of you!" In the end, the government officials agreed to allow the Christmas celebration to be arranged in church.

On the day appointed for the holidays, all kinds of obstacles were thrown up to the pupils of the City of Alytus. Various affairs were arranged in school, the pupils were kept in school until evening. They were warned not to attend the celebration being organized in church. In spite of the interference, several thousand children and youth gathered. No small number of them went to confession and received Holy Communion.

During the affair itself, a few teachers were sent from each school to spy on their own pupils, Security personnel and militia in civilian dress stood guard in the churchyard from the beginning of the affair to its end.

On February 14, 1985, the Administrative Committee of the Executive Committee of the Alytus City Council of workers' Deputies: Chairpersons Mrs. B. Butviliene, Secretary Mrs. J. Leliene, Members Mrs. J. Smilcicaç. and Mrs. A. Petraitiene and A. Ivanauskas, after considering Administrative Case No. 124 in open session, determined that Father Antanas Grazulis, son of Antanas, on December 15 or 18, 1984 (illegible, although in reality it happened on December 26), arranged in the churchyard of Alytus a Christmas celebration for preschoolers, the result of which was to arouse consternation and disturb the public order. In this way, they disobeyed the order of the Presidium of the Supreme Soviet of the Lithuanian SSR, of May 12, 1966. In accordance with the Regulations for Assessing and Collecting Administrative Fines confirmed by order of the Presidium of the Supreme Soviet of the Lithuanian SSR, January 19, 1962, it is the decision of the Commission to assess Father Antanas Grazulis, son of Antanas, an administrative fine of 50 rubles.

Since the last Supreme Council Executive Board Meeting, (March 15, 1986) the New England District held its Spring Convention on April 27, 1986. It was hosted by C-103, Providence, RI. The convention was opened with the celebration of Holy Mass by Rev. Isadorius Gedvilla, pastor of St. Casimir's, Providence and also Spiritual Advisor for the New England District. The business session followed: 125 delegates and guests attended. There were eight clergy attending. This was a good sign of the cooperation of the clergy with the district. A holy half-hour was held to close the convention.

At the Benediction Service a Fourth Degree was presented to **Rev. William Wolkavitch**, C-27 Two third degrees were also presented.

One of the resolutions passed at the Convention was to allow the New England District to make a presentation at the 73rd National Convention to host the 75th National Convention (1988) with the host city being Boston, MA.

Guest speaker at our Spring Convention was Mrs. Marion Skabeikis of the Lithuanian Catholic Relief Fund. She spoke on the subject of prisoners of conscience. The Knights of Lithuania and other Lithuanians, she said, should take a more active part in writing to prisoners of conscience and to our legislative persons urging them to pressure the USSR to free these prisoners of conscience.

At the Spring Convention the District also observed Founder's Day — April 24.



Our district has been working on the committee for the 600th anniversary of the Christianization of Lithuania celebration. The date for the Massacusetts and Rhode Island celebration will be October 4, 1987. It will be held at the Cathedral of the Holy Cross, Boston, MA. Cardinal Bernard Law is to con-celebrate the Mass with a banquet to follow the Mass. The location for the banquet is yet to be selected. Many of the Connecticut councils are also busy with plans for the 600th anniversary of the Christianization of Lithuania. Their celebration is set for May 17, 1987 at St. Joseph's Cathedral in

Hartford, CT. The district wants its members to give support to both dates and make the celebration successful ventures by their attendance and to let the world know there is a place known as Lithuania and that it exists even though it is under the bondage of the USSR. Many other events will be held throughout the year. The schedule will be issued in the near future.



Gyvuokim, Dirbkim, Nepasiduokim!

This year of 1986 is special to all of us in the Mid-Atlantic District. It was three score and ten years ago, in the year 1916, that the Knights of Lithuania councils which were organized in the New York - New Jessey area, decided it would be beneficial for them and good for the organization to band together into a district. and so, three years after the founding of the Knights of Lithuania organization, the New York - New Jersey district came into being.

Officers were elected, by-laws were written and the councils in that area met quarterly to discuss ways and means to strengthen their activities, individually as councils and collectively as a district.

In 1941, Council 3 in Philadelphia was reactivated and was invited to join the New York - New Jersey district. It became one of the districts more active members: More than two decades passed before some Council 3 members began expressing a desire to change the name of the district, since then, it could truly be a part of the district. The motion was submitted to many district conventions, but repeatedly defeated. But persistance paid off and in 1972 we got a new name MAD ---Mid-Atlantic District. There were 11 councils making up the district at that time.

How can I recall a history of 70 years in a few pages? There is bound to be something or somebody of importance omitted. for that - mea culpa! Let's just present a few highlights which have enriched MAD's history.

From its inception in 1916 to World War II, the district flourished. A district choir was organized, drama groups were formed. In 1916 we read in the Vytis "Pagyrimo nusipelnė mūsų vyčiai, kad šoka vien tik dorus šokius ir žaidžia gražius lietuviškus žaidimus".

The district, in various ways aided Lithuania to gain and establish her independence. Did you know that Philadelphia's Council 3 had various money-raising affairs, the profits of which were sent to, the then, President of Lithuania A. Stulginskis to support the army.? The district also had a flourishing sports program in baseball, basketball and bowling. George Blecka from Great Neck, send us some clippings from the 1930's basketball seasons, with headlines such as: "Transfiguration at peak of form". "Transfiguration Lithuanian Champs of New York-New Jersey, Conn 1936-1937 record Won 46, Lost 6!"

Tourists to Lithuania, occupied by the Soviet Union, and the underground papers published there inform that there is no alleviation for Catholics under the new Gorbachev rule. We received in Chicago two issues of the underground newspaper "Ausra" (The Dawn). In No. 48, a former prisoner Liudvikas Simutis reveals how his father in 1941 together with 72 other Lithuanians was murdered in the Rainiai woods. His face was smashed, his eye gourged, his tongue extracted and bound with string, his hands and legs burned by boiling liquid. This forced his son Liudvikas to become a freedom fighter. He was caught, suffered a lot in slave labor camps. When he finished his term of punishment and returned to Lithuania his life as a former prisoner was extremely difficult and he received some help from Fr. Alfonsas Svarinskas, who at the present is being jailed for defending the rights of the people and for

In the same issue of that underground newspaper Fr. Rokas Pusonas published another letter describing how he, when he decided to begin studies for the priesthood, was terrorized by the secret police who wanted to make an informer of him. This is just one case of many; the KGB uses most nefarious means to recruit informers among candidates for the priesthood. Those who refuse in many instances are prevented by the police from beginning studies in the priests' seminary. Some of them sign a promise to cooperate and later when they are ordained, renounce any ties with the Soviet intelligence as Fr. Puzonas did.

The same underground newspaper, "Ausra", published the memoirs of prisoner of conscience Vladas Lapienis. He was suspected of taking part in producing and distributing the underground publication, "The Chronicle of the Catholic Church in Lithuania". He had to freeze in extremely cold rooms. The KGB ripped a crucifix from his neck, he underwent severe interrogations, repeatedly was placed in solitary confinement, was threatened with placement in a psychiatric ward, his food rations were very meager.

In another issue (No. 49) of the same underground newspaper, "Ausra", an excerpt is given of the last will of a very famous Lithuanian writer, Antanas Vienuolis. He expressed the desire that on his simple monument, a stone, a cross be carved. The Soviet authorities did not permit this cross on his monument, disregarding the fact that the writer died as a good Catholic, made his confession and Fr. P. Rauda administered the last rites.

"The Chicago Catholic" did a very important service for the oppressed Catholics under soviet rule: it published the names and addresses of some prisoners of conscience asking that letters be written to them and to their families. This is not only a consolation for them but pressure also on Soviet authorities to alleviate their situation. Our oppressed brothers under the atheistic yoke of communism need our prayers. We also have to publicize their plight and in this way to organize the pressure of public opinion against religious persecution.

Tried on January 17-18, 1985 in Vilnius along with Fr. Matulionis for participating in a religious procession. Sentenced to 2 years general regime camp under Art. 201-1. Blocked from higher education for religious and national beliefs. Release in November 1986. Place of detention unknown.

GUIDELINES FOR CORRESPONDING WITH LITHUANIAN PRISONERS OF CONSCIENCE AND THEIR FAMILIES

1. Write regularly.

2. Letters can be written in any language: Lithuanian, English, etc. In your first letter, ask which language is preferred.

3. Letters should convey personal greetings and messages of good-will. Discuss day-to-day activitites and topics of mutual interest, such as occupation, hobbies, friends. Send photographs of your family printing each person's name and date of birth on the back. Write about places you have visited and your impressions. Numberyour letters, Letter #1, #2, etc. Date your letters also.

4. Inquire about birthdays, anniversaries, etc. and send cards to celebrate these events. Cards should also be sent for the religious holidays such as Christmas, Easter.

5. In general, letters should not be political. Mention no group affiliation.

6. Soviet postal regulations prohibit the enclosure of the following items destined for the USSR: postage stamps, Soviet currency, recording tapes, medicines, vitamins, chewing gum, thread, motion picture film.

7. For addressing the envelope, use the following procedure:

USSR

Name of Republic/ Lithuania, etc. Name of City,/& zip code, if known Street Address/Name, number and apartment number \$3.60 carries with it an indemnity of \$27.97. As the postal regulation points out you are entitled to the indemnity if the letter is lost regardless of the value, or lack of value of the contents. The return receipt costs \$.70 air mail and is returned to the sender signed by the addressee, upon receipt of the letter by the addressee. Therefore, a $\frac{1}{2}$ ounce of regular air mail letter will cost \$4.74.

FOLLOW UP

1. If, within 30 days, neither the return receipt nor the letter/with a stamp indicating the reason for nondelivery/is returned, form #542 "Inquiry About a Registered Article" should be filed at the local post office. If, in response to the inquiry, the postal service indicates that the letter has not been accounted for, you are entitled to the full indemnity and should file form #2855 "Application for Indemnity" to receive it. If no answer is received to the inquiry within six months of filing, fileform #2855 for indemnity anyway.

2. Be sure to answer all letters received from Lithuanian prisoners and their families promptly. If no response is forthcoming, continue to write, since your first letter might not be delivered.

3. If, in the course of correspondence, requests are received for material or financial assistance, before answering please check with Lithuanian Catholic Religious Aid, 351 Highland Blvd., Brooklyn, NY 11207, Tel. 212/647-2434, for help in evaluating the situation at

Letters to prisoners and their families should be sent via registered air mail with an air mail advice of delivery card/return receipt/requested. At the time of posting, you will receive a receipt which should be kept. Air mail postage is .44 per each $\frac{1}{2}$ ounce. The registry fee of

4. To help Lithuanian Information Center document the flow of mail to Lithuanian prisoners and their families, send returned letters or receipts and the replies to inquiries by postal authorities to LIC. Copies of letters of more than routine interest should be forwarded to the LIC office.







LITHUANIAN DEVELOPS NEW SCIENTIFIC TECHNIQUE

According to the "General Electric News" Schenectady, N.Y. area, a General Electric scientist has developed an improved technique for producing highly magnified photographs of proteins, the complex compounds that aid digestion, help ward off disease, allow blood to carry oxygen and perform numerous other vital body functions. With this technique, the scientist has employed an electron microscope to make detailed photographs of several important proteins, including IgG, an antibody involved in the body's defense against infection.

The improved technique was developed by Dr. EGIDIJUS E. UŽGIRIS, a physicist at the Research and Development Center, who is working to better understand biomolecular interactions.

Dr. Užgiris expects that his research will aid in understanding DNA, the master chemical of heredity, and how it is regulated by protein binding.

HARVEST CUSTOMS

PRAPIOVOS


(Taken from Encyclopedia Lituanica) (Edited by Regina Gerutis Kot)

The harvest began with appropiate customs called prapiovos. For the rye harvest, the entire family, including the very oldest, would go out, taking bread, salt and water. After praying and making the sign of the cross, the master of the house would gather the first handful of ripe rye and cut it with his sickle. In later times rye was harvested by scythe.

Hay-making began with the head of the house cutting the first swath, after he had prayed and wished the movers health, good weather amd a heavy dew. The first bunch of flax was gathered by the oldest woman, the farmer's wife, or a recognized village songstress.

The termination of work, like its commencement, was surrounded with ceremonial actions and with festive celebration. Especially colorful were the Pabaigtuves, marking the completion of the rye harvest. Prior to World War I, in some regions a small section of highgrade rye would be left standing. In southeastern Lithuania (Dzukija) the women would carefully weed this section, and bury some bread and salt in the center as an offering to the earth, while they devoutly recited, Earth, you gave to me, and so I give to you, (Zemele, tu man davei, tai ir as tau duodu). In other areas of Lithuania bread was cast into the standing rye and the harvest continued, until it was recovered. The workers

a wisp of the uncut rye. It was an honor to cut the last sheaf. Only later, in southern Lithuania, the woman who bound the last sheaf was named "the old woman". Care was taken to make the last sheaf bigger and to bind it so as to suggest a woman, called "the old woman of the rye (rugiu boba). From this, a wreath was woven for the lady of the house, and a sash for the master. Upon completion of the rye harvest all would let out a cheer, proclaiming that this field was done. The girls would then sit to weave a wreath of rye and bluebottle. After World War I other flowers began to be incorporated. The wreath was carried by the woman who cut the final sheaf, or sometimes by the best songstress. The sash was carried by one of the men. Singing light-hearted songs, mostly about rye and work, and bearing the last shock, the harvesters would make their way home, where the mistress would meet them at the door with bread, salt

and a beverage, treating the shock like a honored guest. The lady of the house was then crowned with the wreath, and the master was girded with the sash.

The final shock was given a place of honor at table like the first. The celebration would then begin in earnest, complete with vigorous singing, in the hopes of a rich harvest the following year.



The Periodical Rooms will house magazines printed in both Lithuanian and English. The Museum's collection dates back to the 19th Century. These have been completed and we are in the process of relocating and organizing the material within these rooms.

The Gift Shop display cases have been remodeled and painted. The new 200 square foot shop opened in April. It is a major distributor of Lithuanian books and memorabilia.

The new Children's Museum and workshop will have 1500 square feet of space. The Children's Museum will emphasize educational activities in order for the young people and


It it with great pleasure that I bring you a status report of the Balzekas Museum's remodeling program and anticipated needs.

The proposed budget for the renovation and remodeling of the new museum building and exhibit hall is estimated at \$1,000,000. The first year, \$500.000 will be needed, and \$250,000 in each of the two successive years.

The renovation will be accomplished in three stages. The first phase gives priority to the main exhibit hall, Art Gallery, Library, Children's Museum, Women's Guild Room, Gift Shop and meeting rooms. The official opening was planned for June 22, 1986.

The second stage will include the development of banquet facilities, and educational spaces, such as workshop areas and lecture facilities.

The third stage will provide performing arts facilities and gourmet Lithuanian dining.





After invading Latvia, Lithuania and Estonia, the Soviets, on June 14, 1941, began mass deportations of Balts to Siberia. Baltic Americans observe this date with rallies and demonstrations in support of freedom for these countries.

The U.S. does not recognize the Soviet annexation of Latvia, Lithuania, and Estonia and has expressed concern over human rights violations in the region.

The Baltic leaders presented President Reagan with the Baltic Freedom Award.

FINALLY, A LITHUANIAN RESTAURANT IN BOSTON

Back in March the Lithuanlan American Community of the Greater Boston area was shocked and dismayed when the South Boston Lithuanian Citizens Club license was revoked indefinitely. In actuality, the ABC Commission merely prohibited the issuance of *alcoholic* beverages to the public at large. The Lith Club is still serving the Lithuanian Community culturally, socially and civicly. Traditional observances, concerts and commemorations are still held in the spacious second and third floor halls. The Lithuanian Folk Dance Ensemble "Sambūris" still meets Monday nights to rehearse. No, the "Club" is not closed!

Since the beginning of the year we should add another dimension to the "Club's" activities; it also functions gastronomically. Yes, finally a Lithuanian cuisine restaurant in Boston! It is called LITHUANIAN KIT-CHEN, it serves simple, basic Lithuanian food: kugelis, barščiai, kopustų sriuba, koldunai, potatoe pancakes, kielbasi with Lithuanian sweet sauerkraut, and other favorites that mom or grandma used to prepared on a black wrought-iron stove. Cellar the Lithuanian Kitchen serves Lithuanian-style home cooking on Saturdays and Sundays, between 11 a.m. and 10 p.m. Take out orders will also be prepared upon request. How did this come about?


Eleven years ago, seaman JONAS STANKUS was a communications expert on a Soviet Lithuanian fishing ship docked in Belon, France. He jumped ship, took a midnight train to Paris and made his way to the American Embassy. After an arduous ordeal he was granted political asylum and through the help of the Lithuanian organizations came to the USA. Last fall, Jonas Stankus opened the LITHUANIAN KITCHEN in the South Boston Lithuanian Citizen's Club, 268 W. Broadway, South Boston. Come Saturday or Sunday and the Club's elevator operator will transport you to the basement and you'll be in the homey confines of the Lithuanian Kitchen. It even has a Lithuanian jukebox featuring such classics as the "Lithuanian Ruddy Valli" Antanas Sabaniauskas. In addition to traditional fare, Jonas Stankus stated that he was: "also experimenting. I enjoy making fancy desserts based on old ideas." As a specialty Stankus bakes baumkuchenas (a fir-tree shaped cake with real egg glaze) for weddings and anniversaries. As John would say: "SKANAUS APETITO!"



Jonas became involved in food preparation. He worked in New York City's Serendipity restaurant. Moving to Boston he got a job in Anthony's Pier 4 and later worked at the famous Montillio's bakery in Quincy. He also worked at Kilus' Lithuanian bakery in Brockton.

Guest speaker was the Los Angeles born Frank Lubin, the coach of Lithuanian basketball team which won the European basketball championship in 1939. He started in sports while in high school. He then played basketball with Pasadena Majors, Olympic Club, Universal Pictures, 20th Century Fox and Wickland O'Neil. In 1936 Frank was captain of the US basketball team that won the Gold Medal at the Berlin Olympics. In 1938, Lubin and his US Lithuanian basketball team were victorious in the Lithuanian National Olympiad. During the Los Angeles Olympics in 1984, Lubin as a member of the Spirit Team spoke to various organizations and schools to promote the ideals of the Olympics.

Frank Lubin is married to Mary Agnes, an American of Irish descent. She learned to speak Lithuanian during their visits in Lithuania. Since about three-fourths of our council members are American born, a lecture about Lithuanian symbols and emblems seemed appropriate.

Robert Novak showed and wxplained the following: The Lithuanian flag of yellow symbolizing fruits of life; green, life and red, the blood shed in protection of the fatherland, was adopted in 1918. Those colors were also used in woven fabrics. In the 15th century the Knight and Gediminas Columns on a red background was the flag.

The state flower was rūta, a sturdy plant with little yellow flowers. Songs were written and rūta was used in Lithuanian ceremonial weddings.

The Gediminas Columns, depicting gates to a city, were used on coins, shields and seals in the 13th century.

Mention was made of the double cross used on shields and military medals.

To me, the sculpture of "Vargo Mokykla" was always touching. Here is a mother teaching her child to read while working at her spinning wheel. The dog at her feet was their guard to warn them of the approaching Russian gendarmes. Instantly, the books were hidden. If found, they were punished by exile as a criminal in possession of Lithuanian print. Under these difficult circumstances, Lithuanians managed to be 58 percent literate while their imposed rulers were 34 percent literate.

The Madonna of the Gates of Dawn in Vilnius, the sign of live religion, Catholicism, is visited even today by pilgrims.

Candidates for K of L membership were introduced: Edward Antanaitis, his son Paul and John Skirius, Ph.D., professor at UCLA. They were welcomed by enthusiastic applause.
