



I am submitting to the delegates of the 73rd National Convention a condensed report of all Officers, District Presidents, and Committee Chairmen for the 1985-86 term. The full officer reports are available for your taking.

#### **Spiritual Advisor**

As per usual Father Anthony Jurgelaitis did an excellent job. He attended 2 Supreme Council meetings and missed the 3rd becasue he was hospitalized.

He worked on a new missal for our Conventions. It will be much improved over our old missal. He offered Masses for all of our dearly departed Knights. He participated in doings with the New England District and the Providence council.

#### President

President Frank Petrauskas organized and presided at 3 meetings of the Supreme Council. He spoke at many District and Council affairs. He spoke in all four Districts.

Frank worked with Attorney Saulius Kuprys to correct the K of L tax exempt status with the Internal Revenue Service. He accepted the resignation of Alexander Domanskis

Saulius has been doing a good job on our tax exempt status with the Internal Revenue Service both for the K of L and the K of L Foundation.

#### **Vytis Editor**

#### Lithuanian Affairs Committee

WHEREAS Karl Linnas, an American citizen of Estonian descent, has undergone investigation for alleged Nazi war crimes by the U.S. Department of Justice, Office of Special Investigations (OSI), and has been stripped of his citizenship, and

WHEREAS the OSI has relied upon less-thanconvincing information provided by the Soviet KGB during his trial without full benefit of American due process, and

WHEREAS Karl Linnas faces deportation to Soviet-occupied Estonia as early as October 7, 1986, in violation of the U.S. non-recognition of Soviet illegal occupation of the Baltic States; therefore,

The Third Vice President is in charge of the Juniors, tries to expand their activities and organize new Junior branches." 

Pre-Convention Activity: Tour of Allentown-Wednesday, August 6th

On Wednesday, early arrivals to the National Convention took a bus tour of Allentown and his immediate surrounding area. The host of the bus tour was C-63 member and Allentown resident, Bob Klova. He arrived at the hotel with a "spanking" new bus and a most gracious chauffeur—George.

We were informed that Allentown was settled in the early 1700's by English, Scotch, Irish and German immigrants. Central and East Europeans settled in Allentown after World War II. Allentown and the Lehigh Valley are not known for its quantity of Lithuanian immigrants - only its quality. It was originally an agricultural community focusing on potatoes. There is still quite a bit of farming done in the area. We particularly noticed fields of sunflowers on our tour.

Allentown has a multi-service industry base. Mack Truck has a large plant there. The Bull Dog tack pin included in our courtesy bags came from them.

Touring Knights noticed the beautifully manicured lawns of the city parks. In fact, our longtime French "Ami de Lituanie", Vic Mathieu of C-103, Providence, said he did not see one lawn in Allentown that needed mowing. Bob Klova, our Allentown informant told us that Allentown had been blessed with a generous civicminded philanthropist - Gen. Trexler. The General donated the interest on certain investments to maintain the city park system. This interest amounts to nearly \$ one million annually.

The highlight of our tour of Allentown was a tour of Stroh Brewery - the home of Stroh, Schlitz and Schaefer beers. It is the third largest brewery in the nation. The grounds cover over 149 acres of land which are watched over and protected by the Statue of the Patron Saint of Brewers, King Gambrinas. His Statue is mounted near the building entrance in order to better maintain his vigil and welcome all visitors to Stroh.

Our Stroh hostess, Bernadette, took us through the brewery explaining Stroh's pride in their method of "firebrewing" in copper kettles which produces a more natural home-brewed taste. The kettles are maintained at 2000 degrees. Stroh performs approximately 250 quality tests on samples to insure its consumers get their values worth.

At the end of the tour we were received in the Strohaus to sample some of the brew. Everyone enjoyed the taste-testing.

From this vastly automated atmosphere we travelled to the Haines Mill Museum. This old-fashioned grist mill dates to the 18th century, explained Lehigh Historical Society's representative, Susan Dominick. However, the mill's current machinery apparatus is early 20th century. The mill had produced grain primarily for animal feed or heavier flour products such as pretzels. Susan demonstrated the workings of the mill's grain scales by attempting to weigh Larry Svelnis and Andrew Rogers.

We left the mill and continued along the avenues of Allentown. Bob Klova told us that Allentown possessed some fine medical doctors. Allentown's medical center performs the 2nd largest number of heart transplants in the nation.

At Stroh Brewery they had served us samples, when we arrived at the Fish Hatchery we discovered we were going to "treat" the fish. We all were supplied with small bags of food for the fish. Despite the fact that we all fed them,

they were still hungry. Sabina Klatt and Fran Petkus thought they had not fed the poor fish in weeks because the fish jumped with super exhileration at the single drop of food into the water. The hatchery was established in 1883 and was one of the main suppliers of fish for eastern Pennsylvania. It currently is the home for young brook, brown and rainbow trout fingerlings received from state hatcheries. They are raised in Allentown until they reach maturity.

Before our tour ended we stopped at Allentown's esquisite rosegardens. The gazebos and blossoms added a touch of romantic nostalgia to our trip.

Our tour concluded with a verbal guide to wining and dining in Allentown by our guide, Bob Klova.

#### **Ethnicity - Bonus** or Hinderance

Fr. William Wolkovitch, Spiritual Advisor of C-27 Norwood, MA, and also the author-to-be of the Knights of Lithuania History, presented to the first session of the National Convention a treatise entitled, "Ethnicity - Bonus or Hinderance?"

In the 1980's, noted Fr. Wolkovitch, there signs of ethnicity all around us. Ethnicity receives attention from politicians seeking "ethnic" votes. In the private and community sectors of our community, lectures, books, newsletfers often focus on ethnic groups and the history of their immigration to America. And most profoundly ethnicity greatly touches our religious life. Fr. Wolkovitch noted this fact by mentioning that in New England there are 18 Lithuanian parishes, and in Pennsylvania there are 40.

Although ethnicity is very commonly spoken about, it is difficult to define. What causes one to develop a feeling of separateness from others, and a sense of belonging to one particular group. In a review of ethnicity, Fr. Wolkovitch stated that there are objective and subjective elements. Objective elements which people often use to identify ethnicity are 1) dress; 2) food; 3) customs; 4) religion; 5) residence; 6) language and 7) biological makeup.

Although these factors are frequently used, they are not absolute and essential in the assignment of ethnicity. Many ethnic groups have emigrated to the United States. As succeeding generations become further removed from their particular country of origin, such objective factors do not always distinguish ethnicity.


Among the subjective aspects of ethnicity, Fr. Wolkovitch mentioned awareness, acceptance and expression. The majority of people possess some sense of ethnicity. However the degree of their ethnic awareness varies greatly. Even within individual persons the quality of ethnic awareness changes during their lifespan. At first one may merely have a sense of separateness. This can lead to inquiry about what makes one different, and then we might often invest time and effort to learn about our roots. Later one may often develop serious appreciation and active involvement. One's /acceptance of his ethnicity is also a factor. One must deliberately and consciously choose to be Lithuanian, or whatever ethnicity one purports to be. · How does one express the acceptance of one's ethnicity? The awareness of one's ethnicity? Expression is another subjective element of ethnicity. The wearing of ethnic insignias, involvement in ethnic organizations, the ethnic decoration of our homes are all exam-

ples of ethnicity expression. The activity of the line of longtime, hardcore members of the Knights of Lithuania is also an expression of ethnicity.

Such a sense of ethnicity appears to be of worthwhile value and a value to cherish. However, ethnicity can also prove ugly through misuse...in the arrogant belief that one ethnic group is superior to all others. This leads to mistrust, prejudice and hatred.

The origin of most American ethnic parishes were plagued with misunderstandings and rivalries. In South Africa today, much violence and maiming exist because of ethnic tribal rivalries. Today America'a melting-pot image has been mostly replaced with one of a multi-colored tapestry. Ethnic pluralism can be beneficial if used maturely.

Expression of one's ethnicity should never interfere with one's higher duty to the Gospel command of neighborly love and concern. A wholesome appreciation of one's heritage should make a person more sensitive to ethnic differences. In conclusion, Fr. Wolkovitch challenged the members of the Knights of Lithuania as followers of Christ, to assess their experience of ethnicity. Has it been a bonus or a hinderance? Have we, individually, or as a group been guilty of committing some of the evils of ethnicity, or also, have had such evils committed against us?


then properly outfitted with a tri-color Lithuanian beret for the occasion.







On Friday, Holy Mass was held in the hotel. The sacrifice of the Mass was offered for the suffering church in Lithuania. The principal celebrant was Fr. Anthony Jurgelaitis, our National Spiritual Advisor. Concelebrating with him were Fr. Albin Janiunas, H.M., Fr. Louis Zaremba, Fr. Albert Contons, Fr. John Mikaljunas, Fr. William Wolkovich, and Fr. John Rikteraitis. Srs. Alverna and Francesca served as our reader and organist.

In his homily, Fr. Jurgelaitis focused on the mysterious ways our Lord often does things and our commitment to serve the Lord without question. Yes, it is difficult to understand God's reasoning for permitting some of the atrocious evils that surround us, explained Father. We often wonder about the Lord's reasoning when we look at our own Lithuanian people who have suffered so much. We don't know how long or how much more they will have to suffer. Yet, our lives continue; their lives continue. We don't understand the reason for their suffering. Somehow, in expression of our faith, we submit to God's will. And today, at this Mass, we offer their sufferings, their sacrifices, their persecution and our lives, ourselves and our prayers so that we all can grow in strength, and remain faithful to the Lord. We pray to the Holy Spirit that during this year of "faith consciousness" that he help make our faith more real, and allow us never to forget the committment we made to God in our baptism.

This Mass was also in observance of St. Dominic's feastday. Fr. Jurgelaitis cited circumstances from St. Dominic's life to illustrate the zeal needed to serve God. Throughout his life, St. Dominic had a dream, explained Father. It was to give his life for the missions. He wanted to travel to various sections of Europe, to bring the Good News, the Word of God to others, as he had to the


Albigenses. St. Dominic was never able physically to realize this dream. He had to remain behind to tend the concerns of his own immediate community. He was needed there, and although he wished to go and travel, he submitted to the Lord's will and remained behind. He sent his followers to those remote parts of Europe, including regions near Lithuania, to spread the glory of God's word.

The effects of St. Dominic's missionary zeal were felt through the work of his followers - even in Lithuania. We find in the words of Gediminas, in a letter to the Pope, a request for the Pope to send him men of the Franciscan, and of the DOMINICAN orders to preach to the Lithuanian people. Perhaps Gediminas thought, as Mindaugas thought, that by becoming Christian, he could repel the hordes of Teutonic Knights from overcoming Lithuania.

St. Dominic felt duty bound to the Lord's command to help his fellow man. We, too, are bound to pray for our brothers and sisters in Lithuania, and throughout the world. One way we can help them is through prayer. We can also help them by letting others know about their plight and encouraging other people to pray. Letter writing helps. Through our efforts, a few years ago, the bishops of the United States proclaimed a day of prayer for Lithuania in all American dioceses. We have to, we must, continue to work on their. behalf. We must give them the moral support they need. Our efforts are felt; the Lord has let the Lithuanian people know that they are not alone. And they do know. This has been directly expressed in the Chronicle.

Each Chronicle that comes to our country is really a gift from Catholic Lithuania. It is a precious spiritual gift—a gift of their example of living the faith in the face of adversity. The words they use to defend the Lord, the words school children use in rebuttal to school authorities who harass them, the words of prayer written from prisoners of conscience are "gems of faith" and illustrate an example of baptismal living. They are evidence of the faith consciousness that our brothers and sisters in Lithuania possess.

### Saturday, August 9 Holy Mass Observed Memory Of Deceased Members Of The Knights Of Lithuania

On Saturday, Holy Mass took place at Noon at the hotel. It honored the deceased members of the Knights of Lithuania.

Fr. Anthony Jurgelaitis served as principal celebrant. He was assisted by Fr. Albin Janiunas, H.M., (Spiritual Advisor, C-78, Lawrence, MA) and Fr. John Mikaljunas (Spiritual Advisor, C-72, Binghamton, NY). Sister \_\_\_\_\_ of the Sisters of St. Casimir, read the scriptural passages for the day's liturgy.

"How many Vyciu have we prayed for during the years since our organization was established in 1913?", asked Fr. Jurgelaitis, wonderingly, "..From the very first one to the most last, the most recent."

There have been many, but our united prayer, at this Mass, explained Father, will be extensive and effective enough to reach every single one of them.

Lithuanians have traditionally fostered respect of the dead. This part of our religious heritage extends back to our pagan beginnings. Our people, our grandparents have long observed many customs and devotions which relate to the deceased. One of the best possible ways to remember those who have died, however, is by offering the Sacrifice of the Holy Mass for their intentions. It is a tremendous sacrifice because it is Jesus Christ who is the victim - the gift that we offer to God, the Father.

We can be assured that some of our departed Knights of Lithuania are definitely and firmly with God, the Almighty, in Heaven. Others may remain "close" to Him in Purgatory. They are there until they attain full purity, the necessary qualification for entrance to Heaven. The factor explains the urgency of our prayers at mass today-to help them achieve full purity.

Fr. Jurgelaitis spoke to us regarding our feelings of sadness when a person dies and of the the effect memories of our departed have upon us. During the course of the year, Father commented that he had said over 65 special Masses for individual departed Knights. And always, when information is provided, he sends letters of sympathy to family members. A tremendous comfort and consolation to all of us and to individual families in these moments of sadness is that in the reality of our faith, these individuals are not dead - they are alive with Christ, with God. Their physical departure from this earth is a reality, but spiritually, they will never be gone, never forgotten.

The death of friends and family members can become a beauty and a joy when we pray on their behalf. Our act of charity on their half is both blessed and pleasing to God. Spiritual grace is bestowed upon us from Our Lord in Heaven for these acts. At this Mass today, a spirit of unity binds us all - Our Lord, our deceased and ourselves.

As our Knightly congregation paused to reflect on the spiritual lesson presented to us by Father, the names of those Knights that had died during the past year were mentioned individually.

On August 7th, as the convention activities of the 73rd National Knights of. Lithuania Convention began, a schedule of events for Juniors was posted in the lobby. - 1. During regular council meetings, a junior should be given/assigned a task or responsibility to perform. This activity could be related to a scheduled Lithuanian affairs activity (writing letters) or cultural presentation.
- 2. The regular councils should present more cultural activities and invite the Juniors to participate. A slide presentation on someone's trip to Lithuania would be enjoyed by Juniors.
- 3. Lithuanian language should be used more at meetings. It would be relatively easy to initiate the use of simple words and phrases. If more adults spoke Lithuanian, the Juniors might catch on also.
- 4. When possible we should do school projects on Lithuania and Lithuanians.



#### **"Personal Commitment**

These words taken from a prayer smuggled out of Lithuania explain the theme of the Convention's first panel. Fr. Anthony Jurgelaitis, O.P., our national spiritual advisor served as the panel coordinator.

In this year of "faith consciousness" Father said we should take some time to be a little thoughtful, to look inside and around ourselves, and to reflect on God's presence around us. What is happening in our country, our city, our state, in our town, in our schools...? Are we expressing our Christian faith vividly, vitally and vibrantly?

In the first half of the panel, Fr. Jurgelaitis presented the "catastrophes" found in today's world. Nancy Pawasauskas Miro, C-141, played the role of the devil's advocate - presenting several news items which indicate a changing sense of values in our society.

... "Explosive growth of pornography aided by courtroom decisions" (Dateline: Washington, DC):

A draft report of the Justice Department's commission on pornography shows a direct relationship between actions by the federal government and the explosive growth in pornography and obscenity in the nation. The massive report which runs to well over 1,000 pages notes that it was not until the 1950's that

Judy Brown, President of ALL, commented, "This decision not only rules against preborn babies, it also rules against women. The Court has clearly said it does not care about either potential victims of abortion — the baby or the mother. It is ensuring the new paramount right of doctors to exploit abortion on demand... People should realize that it is the doctors who do not want the woman with a 'crisis pregnancy' to know the nature of abortion or about the possible alternatives. People should know it is the doctors that do not want to protect the baby - even after liability. The Supreme Court has abdicated. It has abandoned its charge responsibility to the citizens of this country...

for. By looking at it, by reading about it, by becoming concerned and aware. Many people go through life not seeing problems, not doing anything to correct problems. That is not living the faith or being conscious.

... "Cardinal John Krol says the Supreme Court has expressed judicial hostility to all religions"

•On June 11 in a homily given by Cardinal John Krol of Philadelphia, the Cardinal stated that the Supreme Court had departed in some of its

decisions from the constitutional principle prohibiting the establishment of religion, and instead expressed judicial hostility to all religions. He said that Catholics, in addition to criticizing the secular humanism of the Court should examine our own consciousness regarding being sufficiently alert in claiming our rights. Krol also charged that the Court was ridiculous in asserting that observing a 'minute of silence' in public schools would amount to the establishment of religion. What religion can be established by a moment of silence?

Responding to these news items, Fr. Jurgelaitis said that although we have been taught to respect the Supreme Court, the 'law of the land', certainly when we find out that the Court is judicially hostile to people's rights something must be done. They are sort of teaching that religion doesn't count.

How do Catholics act in Lithuania? For them, those laws that touch upon conscious are to be disregarded - as a matter of conscience. They risk going to jail, labor camps, or psychiatric wards. True believers stand firm in their faith and state, "Let God take care of my career...if they don't let me go to the university, or tech school."

Do you see the relationship? Do you see that we, American-Lithuanians, must also join in a proper understanding of law. There comes a moment, when we must examine our consciousness, as Cardinal Krol mentioned, and make a decision through the eyes of faith...could we not write a letter, or could we not speak out. We must always be on the alert to the 'catastrophes' that are around us.

After a few comments from the floor, Fr. Jurgelaitis noted that presently President Reagan is replacing some judges on the Supreme Court. It is critical that we now face our responsibilities as citizens inspired by faith in God and our knowledge of truth, to influence the President's choice. By letter writing, by words, by example or whatever means, we must strive to ensure that the Supreme Court be a matter of right, not just legality. This is a catastrophe staring us in the face. ... "Anti-Catholicism as rooted in Church opposition to contraception" (Dateline: Washington)

There are many groups who are anti-Catholic, as stated by Fr. Richard Roach, at a February 9th Catholic League gathering in St. Paul, MN. One root of these groups being hatred of Christ — antipathy toward Christ; another being the Church's condemnation of contraception and related matters. In his talk, Fr. Roach emphasized that anti-Catholicism is helped greatly by ignorance of nominal Catholics. Two truths are needed to dispel that ignorance. First, an understanding of church authority and an understanding of why contraception is wrong.

Vatican II documents are essential for the understanding of Church authority. A great source of confusion develops when certain theologians assert that only solemnly defined teachings bind. Actually both solemnly defined and ordinary universal teachings of the Church constitute the one deposit of our faith.

Fr. Jurgelaitis stressed that there is a need to look at the teachings of the Catholic Church through the eyes of faith. Objections to the Church's teachings on contraception is a catastrophe, a prevalent problem in our lifetime. And how should we react to those that criticize our beliefs? Communists and atheists in Lithuania hate the Christians, the believers, throughout the Soviet Union. That, too is a catastrophe. We both must stand firm in our Church's beliefs and pray that the Lord gives us strength to see things as He sees them.

... "Pope John Paul II-Yes; Fr. Charles E. Curran-No" (Dateline: Rochester, NY) has contradicted Church doctrine on premarital sex, masturbation, contraception, abortion, homosexuality, divorce, euthanasia and invitro fertilization. The ad called upon all Catholics to express their solidarity with the actions taken by Pope John Paul II to restore doctrine and discipline in the Catholic Church...

One Catholic University theology professor, William May, who called the Vatican's action tragic in many ways, but necessary, said that in a sense, Fr. Curran is correct about being in the mainstream. There are many theologians that hold these same positions, but this factor doesn't make these views right. Curran's emphasis on the views of the 'majority' of the Church are irrelevant. Catholic theologians who stress majority opinions should consider the consequences of 'piety by plebiscite'.

In the situation of Fr. Curran or other dissenting theologians, we are placed in a very touchy situation. It is not our position to ascribe guilt. The real factor here is dissent with the teachings of the Catholic Church. The ordinary, everyday teaching of the Church, that which has been propounded and explused in the documents of Vatican Council and inspired by the Holy Spirit, is what we are ordered and enacted to follow. In theology, they seek out the absolute things to believe. Those which might be considered secondary are discarded. But as Catholics, we are bound to follow the whole doctrine of the Church, not just the absolutes, but also the teachings of the Pope, Cardinals and Bishops. This, too, represents a catastrophe. We must look at it and pray about it. We must seek to realize that God knows best. We cannot tell God what to do or what to teach us. Truth is not a question of majority vote. God cares for us in loving ways, caring ways, but not always telling ways. Where do we look for the final answer? In faith. Faith says that the church is the teacher. That is an attitude that can strengthen us when we are faced with a decision about following or not following, supporting, or not supporting church teachings.


So stated a recent large advertisement in the **Rochester Democrat Chronicle** - March 23, 1986, by a group of concerned Roman Catholics in Rochester. The ad went on to state since his 1968 dissent from 'humanae', Fr. Curran has repeatedly undermined Catholic teachings on faith. In his writings and lectures, he "The studies of U.S. textbooks downplaying the role of religion" (Dateline: Washington, DC)

The role of religion in American life, past and present, is largely omitted in today's school textbooks according to three recent studies. All three studies concurred that U.S. history and social science textbooks, from 1st grade through 12th grade, treat religion by simply excluding it, or by brief and simplistic reference....If students grow up ignorant of the role of religion, religious faith and religious freedom in American life than we will have badly failed them. The absence of any mention of religion in school is as bad as giving too much emphasis to one religion or another. We are the most religious country in the modern world. But reference to this fact does not appear in our textbooks. The bottom line is that many students are graduating from high school with a distorted view of American history and are ignorant about issues of religious freedom.

Fr. Jurgelaitis posed a question to the convention, "How many of your children, grandchildren go to school? Public school?" He asked if we were aware of what is happening. Neglect, lack of concern is an attitude which has become a worldwide catastrophe. People may not reject God to the point of being atheist, but they will come to a point where it doesn't matter. This is a catastrophe!

How do we face it! Through an awareness of our faith. When the time and opportunity presents itself in our community, we must act to return facts about religious freedom and religions role in American history to the schools of our country. Over the years we have seen freedom of religion progress toward freedom for non-religion. That non-religion seems to dominate. It's something to fight — with the weapons of faith and with the weapons of God. ... "The power of television-what thinking people have to say about that medium"

Our panel had many clippings about the effects of television upon us — providing a fascinating glimpse of people's thoughts regardings its effects. Nancy Miro commented that from her pile of clippings she concluded that it was impossible to find a child development expert who would wave compliments in televisions' directions. About the best thing they would say is that TV is a mixed blessing. Although parents develop guilt feelings about the amount of time their children spend watching TV, they also will state that TV is a convenient babysitter. Teachers are concerned about the effects of TV watching: noting that we are producing a lack of interest for reading; yet what about Sesame Street? Most Americans would not admit that Americans, on the



Casimir Yanish, C-74, expressed his

average, spend more than 7 hours a day watching TV.

In 1975, the U.S Catholic Conference issued a statement that TV is the single, most formative influence shaping American lives, attitudes and values. TV molds the intelligence and character of youth, far more than schools or parents.

Would a good solution to this problem be to do without TV totally? that is what we asked. Looking through the eyes of faith, what would be the answer to this question? TV is a mixed blessing...it can be a blessing...it can be a curse. We can see the catastrophe that faces us. But if we pledge to follow our 'faith consciousness', to be aware of over indulgence, and unknowing temptations, we should suffer less from the ill-effects of TV.

What is going on around you? I'm sure you now see some of the catastrophes that face us daily!

#### **PERSONAL COMMITMENT**

The upcoming Jubilee of Lithuania's Christianization has served as the theme through out this panel. We think of the years 1251-1387-1413. The baptism of Lithuania is reflected in these important dates. How many of us remember the exact date of our baptism? Very few. But, for us, in our own lives, baptism is a million times more important than our birth dates. It really is — WHY? We can enjoy our physical life for 70, 80, maybe a 105 years, but WE ARE **BAPTIZED FOR ETERNITY.** After our birth, we may have the responsibility to keep our physical body together until God calls us but what is more important is what God does for us in baptism. He adopts us as His children. He calls us brother, sister... friend. This is ever so important. Likewise as important is our response to baptism. What is the response of baptism? It is a challenge, a challenge to say - I renounce Satan and everything he stands for. At baptism we made a vow, a sacred promise... the first of several that occasionally follow in a lifetime. Others include the sacred promise of

matrimony, a vow to religious life — the priesthood. Although we made this vow through others, through our godparents we are expected to be conscious and conscientous about it. Baptism is really a challenge in us to help make our faith grow, to do all we can to cooperate with God. We must strive to make our baptism as complete, as meaningful as possible throughout our lives. Baptism does not merely touch our physical life, but reaches into life hereafter. It is of extreme importance. It is a big, big project. We know that we cannot increase faith in ourselves just as we cannot increase charity in ourselves. These are gifts of God. God has to give the increase as He gave the gift. But...we can help. That was God's plan. How do we help? By making a personal and spontaneous commitment to the Lord. If we deny our commitment, or forget it, there is no way to helping our faith grow. But when we do... we will be surprised at the things to come.

Let's look at the shape of some of the commitments that are possible in our lives. There is no absolute order to when or where Our Lord will challenge us to fulfill our commitment to him, but when we are asked we must do so with a positive readiness.

Taking a cue from our Lithuanian-American Christian heritage we are asked to respond to the Lithuanian bishops' proposals for preparing for Lithuanian's Christianity Jubilee. For the first year, 1985, they proposed a year of the "Good News". They suggested to Lithuanian Catholics, and beyond them, to us, to get to know the "Good News", the Bible, the word of God. We were urged to read it day by day, week by week, as a constant step in order to grow.

Non-Catholic Christians have accused us, and with good reason, of not knowing the scriptures. Protestants outshine us in their love for the Bible. Recently I saw a sermon on T.V. The preacher was at the pulpit; he had a Bible in his hand. The individual in charge of the camera took a shot at the audience. He slowly screened by those listeners. Everyone had a Bible, an open Bible, in his or her hands...following the readings, checking as the preacher instructed them to go the Chapter 51,

verse, psalm, etc. Is there something to be learned by us from this? What do you see in **your** churches? In regards to a Bible? We have a missalette. We know that the proper thing to do is to listen carefully to the Word of God. But it might help to follow along. Are we making an effort to take hold of the "Good News" of the Lord? Or could we all study the Word of God more attentively.

How many of us have a Bible in our homes? Almost a perfect 100%. But is your Bible, a well-thumbed Bible? Should I get to know the Bible a little better? No one will deny that we shouldn't. Ignorance of Scripture is ignorance of Christ. One of the fathers of the Church once said that. If we do not possess a well thumbed Bible could it be true that we also do not know Christ that well? We should ask the Holy Spirit to move us, to prompt us to become more acquainted with the "good news", the work of God. Another question. What percentage would you give yourself in the knowledge of faith? 90%? 70%? 99%? An honest answer to this question should flush our cheeks with a touch of flame. Why am I so ignorant in the faith? you might ask yourself. Am I too

lazy? Is the power of T.V. more powerful than the revealed Word of God? I am going along O.K. Why is it impor-. tant that I become more knowledgeable? Answers to these questions might reveal that sometimes we put our pride before the Lord. If we do not take the time to read, we are not using a gift we have been given. So what, we answer. I don't need more faith, more knowledge. This is how we get ourselves into blind alleys. One cannot explicate oneself. If you don't read, if you don't make an effort to obtain a Bible, a religious book, to learn your religion...how would you get to know faith better and to love it? Simple knowledge of our faith is not sufficient. We must learn to love it and to live it. You cannot love a person unless you know him. Unless you know the Scriptures, unless you have some further growing knowledge you cannot really know and love Christ. Try it, you'll like it. It's your own faith consciousness.

Perhaps we don't say the Rosary too often to praise the Blessed Mother, for the conversion of Russia. It could mean the liberation of all the occupied and persecuted countries. But if we did try, if we did pray the Rosary a few times...then we might begin to see a

kind of little reward. This goes along with faith. Perhaps we will begin to like saying the Rosary, and the more we like it, the more we will love it. All of us are aware that breathing is a sign of life. If a person ceases breathing, one tries to revive the person with CPR. Your breath becomes the breath that maintains life within<sup>®</sup> that individual. Likewise, prayer is the breath of faith that is in us. We said we are baptized, we said we have the faith and we do. As people of God we should pray as regularly as we breathe. The more frequent, the more thoughtful prayer is something that comes from a personal commitment. This is the year to think about this, and to ask the Holy Spirit to give us the courage to become personally committed to God. Prayer of petition is a beautiful thing. God loves our prayers of petition.

But prayers of petition are not the only kind of prayer. We should not limit our vision. The eyes of faith tell you that there is also a prayer to praise God. Glory be to God! That's a prayer. Praise Now thank thee all our God! It's a tremendous beautiful feeling and a very faithful feeling to pray or sing such thoughts. And is it not more beautiful and more effective to pray, "Lord, give the Lord! That's a prayer. There is also a prayer of gratitude. Thank the Lord!

him; Lord give her; Lord grant them" than to pray, "Lord, gimme this, gimme that"? When we forget our own particular needs and pray for others, we do as Jesus did, as Jesus does for us. Frequently, after Sunday sermons, when time permits, Fr. Jurgelaitis mentioned that he asks the congregation who he is addressing - How do you pray? How do you live from Sunday to Sunday? The reason is, to ask, do we pray only on Sunday, not on Monday, Tuesday, Wednesday... There is a necessity to praise God, to thank God any time, any day. Something should be done about the in-between days, even though we worship God principally on Sundays.

We must think about attitude, about commitment - those personal and private. And also, we must think about what commitments the Knights of Lithuania can make in relationship to this year of conscious and conscientous faith that we are actively participating

What commitments can we do together in a group. During this panel we tried to arouse our commitment as individuals, to help us learn to live according to the Holy Gospel. We have stressed prayer. Bishop Baltakis and the Central Committee for the Anniversary of Lithuania's Christianization also stress prayer. We must ask the Lord to give life to our persecuted brothers and

sisters in Lithuania. We must not just do things on a material plane, such as the exhibits, the books, the plays, the poems, etc. Our efforts in promoting the sale of the medallion are helping the cause, but we must go beyond this.

Things on a spiritual plane are much more valuable. We must ask the Holy Spirit to make it possible for us to have the courage, the strength to commit ourselves to spend a definite length of time, at each meeting until at least the end of the Jubilee Year of 1987, to commit ourselves to some spiritual and/or religious topics of discussion or prayer. If we set our minds to it, we will be able to have good results.

Following this discussion on being aware of our faith comments were taken from the floor. Individuals talked about the catastrophes that they saw in their own communities. We expanded further on the Church's response to these catastrophes throughout history. The complexity of faith awareness was well demonstrated. And we realized there is no easy answer. When we deal with issues of everyday life, with issues affecting our role in the Church it is very difficult to judge right from wrong. We must therefore strive to get to know God better, to become more informed, so that we can love the Lord and his love can shine through us and especially on our brothers and sisters in Lithuania.

At this time, we were also given another surprise. The Medallic Art Company presented us with four, specially made, no charge, medallions in pewter.

One of these madallions will go to Mr. Kasuba, who designed the medallion. Two, of the others, Loretta Stukas presented at the first session of the National Convention to Bishop Baltakis, and to Mr. Jonas Kavaliunas-the Chairman' of the Central Committee for Lithuania's Christianity Jubilee.



1986 Friend of Lithuania Award Congressman Don Ritter

The Knights of Lithuania express its gratitude to a special friend

Congressman Ritter, the Knights of Lithuania are grateful to have a friend such as you. Your cause is My cause!

Prior to presenting Congressman Don Ritter with the 1986 Knights of Lithuania "Friend of Lithuania" Award, National Lithuanian Affairs Committee Chairperson, Nancy Pawasauskas Miro, spoke regarding the efforts Congressman Ritter has demonstrated on behalf of Lithuania.

The primary goal of the Knights of Lithuania Lithuanian Affairs Committee is heighten the awareness of Lithuania's struggle for freedom. This task is almost overwhelming except when we receive help from our friends. We expect help from our friends. We expect help from our Lithuanian brethren but when help comes from our non-Lithuanian friends, it becomes very special.

We have such a friend in Congressman Don Ritter of Pennsylvania, who has been selected to receive the 1986 Rev. John C. Jutt Friend of Lithuania Award. He joins the select group of past recipients who have also distinguished themselves with outstanding service to the Lithuanian cause. Congressman Ritter is currently serving his 4th term in the United States House of Representatives. He represents Pennsylvania's 15th Congressional District, the Lehigh Valley. His district is the state's 3rd largest metropolitan region and includes

Allentown, Bethlehem and Easton. One of the few congressmen with a scientific background and the only one at the doctorate level Congressman Ritter makes good use of his background in various congressional committees concerned with science and technology, agriculture, energy and others.

But one of his most notable areas of expertise and activity is in the area of human rights and the cause of freedom and self esteem for communist-enslaved nations. The soul member of Congress who has had extensive exposure to Soviet society from the inside, he and his wife, Edie, lived for a year in Moscow. He speaks fluent Russian and has served as an exchange scientist at the Vyklov Institute of the Soviet Academy of Science. This has given him a lasting interest in U.S.-Soviet relations and a committment to human rights. Congressman Ritter is the ranking republican on the Commission for Security and Cooperation in Europe, better known as the Helsinki Commission which monitors the performance of Soviet bloc governments in human rights' areas. Congressman Ritter is also co-chairman of the Ad Hoc Committee on the Baltic States and Ukraine. As an activist in the cause, of human rights,

Congressman Ritter has especially endeared himself to the Lithuanians of this nation and to the local area. His remarks supporting Lithuania's right to self-determination appear frequently in the *Congressional Record*, as do his appeals to his fellow congressmen to support human rights causes. He is also a regular visitor and frequent speaker at local Lithuanian events—especially at commemorations of Lithuania Independence Day and the Terrible Days of June.

We are indeed grateful to have a friend such as **Don Ritter** in our court and we are honored that he has agreed to accept the well-earned honor to be our **1986 Friend of Lithuania**. We have a very special gift to present to Congressman Ritter this evening. As you know, our Lithuanian Christianity Jubilee Commemorative Medallions are available. We have had two of them framed for Congressman Ritter. They are positioned to illustrate both the observe and reverse sides of the medallion.

Congressman Ritter, on behalf of the Knights of Lithuania, I present to you the 1986 Rev. John C. Jutt "Friend of Lithuania" Award.


Greetings, Knights of Allentown and the Lehigh Valley, and all Knights of Lithuania gathered here this evening,

(Congressman Ritter asks an individual to pass him a table decoration consisting of a glass decanter holding a candle).

This light that burns in this glass is like the flame that burns symbollically, like the one of the great lady who stands in New York's harbor, rejuvenated and renovated by efforts such as yours. It is like the flame that burns in the hearts of Lithuanian-Americans and Lithuanians all over the world. It is the flame of freedom.

I accept this award on behalf of the citizens of the Lehigh Valley, who have supported my efforts in Congress and the kind of efforts that you are familiar with on behalf of human rights. So many of my constituents in the Lehigh Valley have had similar experiences to yours. They are the Ukranian-, Americans, they are the Slovak-Americans, the Hungarian-Americans, the Polish-Americans, the German-Americans, the Chinese-Americans, and lately the Southeast Asian-Americans and yes, even some Afghan-Americans. Without them, without you, this award is not possible. So again, I say...aciu, aciu, aciu, labai aciu.

It was just last week that again we



rang out from the halls of the Kremlin...from *Pravda*, which in Russian means truth, but in reality means exactly the opposite.

This is what *Pravda* reported on June 7, 1986:

"...Today, maybe President Reagan has the wrong name, or maybe his advisors have not explained to him that Lithuania, Latvia and Estonia are, of their own free will, an inalienable part of the Soviet Union and not oppressed people as they might appear, to the U.S. President from his California ranch."

Allow me to repeat Pravda's key statement - that Lithuania, Latvia and Estonia are of their own free will an inalienable part of the Soviet Union and not oppressed peoples. Ladies and gentlemen, we are struggling not only against totalitarian rule that is perhaps the most powerful military machine the world has ever known but also one that masks the truth. This statement from Pravda is a purposeful distortion of objective reality. Black is white, evil is good, terror is the people's democracy. The actual truth is, I don't have to tell you, that Lithuania and the rest of the Baltic states are not of their own free will a part of the Soviet Union. Lithuania has a rich and independent heritage dating back to 1253 when Mindaugas was recognized as the first Christian king of Lithuania by Pope Innocent IV. For almost 500 years, part of which was spent in an alliance with Poland, this tradition continued. However, when most of present day ethnic Lithuania was seceded into Russia in 1795, and through various occupations by the Russians and the Germans in years to come, Lithuanian's have fought to secure their rightful independence and self-determination. That fight continues until this very day, in fact this very moment. While Lithuanians achieved their goal in 1918, it was painfully taken away again, by the Soviets, in 1940. This was after the infamous, then secret, Molotov-Ribbentrop Pact was agreed to by Hitler and Stalin. Hitler and Stalin...,those moral twins, how similar Marxism and Communism, how well they reflect the total institutional pressure of human spirit, how skilled, ideological and justified mass torture reflect terror and execution; how unparalled in human history the concentration camp, the death camp, the gulag.

As we all know, through the ensuing World War and the peace time which has followed, peace came to the rest of the world, but peace in Lithuania was never to come again. Lithuania has not been able to achieve her rightful independence. It is that hope for independence, for greater independence, for some independence at all for the hope to see the yellow, green and red once again fly freely in the skies of Lithuania...that we gather here this evening. We come together committed

celebrated Helsinki Human Rights Day. This year was the 11th anniversary of the signing of the faithful Helsinki Accords. While I and many of my colleagues rose on the floor of the house of Representatives to express our. solidarity with you and so many other

to a cause, committed to one another, committed in opposition to Soviet domination and brutality, a brutality that has continued in Lithuania now, for 40 years, for 40 long years. I think of when it all began...on that fateful night—June 14, 1941—a night engraved in the memory of, I am sure, many of you who are here today. Soviet troops forced more than 15,000 Baltic men, women and children, kicking and screaming, into railroad cattle cars and sent them off to uncertain fate, often death, in far off, in inhospitable Siberia. These were the leaders, the writers, the poets, the artists, the professionals, the business people, and their children. During the next 10 years, the Soviets eliminated more than 600,000 Baltic citizens—more than 10% of the total population of these nations. We saw the beginning of the Soviets' real aim to create a Lithuanian cast in the image of the Soviet Union. The actions taken by Soviet authorities were critical in achieving this goal to wipe out and clear the slate of all vestiges of Lithuanian independence, religion and culture.



At first, as I have already mentioned, the Soviets used deportations to the far reaches of Siberia and Gulag Archipalago. They used outright murder to achieve their goal. The method later changed to a more subtle, but yet intensive, russification campaign. Churches were closed, Christian education was stifled, Lithuanians were denied freedom of the press, citizens were prohibited from assembling together freely. Books and papers printed in the west were strictly forbidden into Lithuania in an attempt to break the Lithuanian people and erase all vestiges of their culture. Add to this a huge, Soviet directed influx of Russians and the manipulation of all schools, newspapers, radio and television by Soviet propagandists and we see the totality of the situation. However Lithuanians have vigorously resisted the stifling of their uniqueness and will not crumble to the dominance of Russian jargon and the Soviet state. The nationalization of Lithuania's industries, the collectivization of its agriculture and the sovietization of its economy have stripped Lithuania of its rightful heritage.

Yet the strong voice of Lithuanian-Americans, people like yourselves, will not allow the stripping away of that "core" Lithuanian culture and heritage.

Our last U.S. census, reported that there are over 800,000 ethnic Lithuanians living in the United States. That reminds us and encourages us that the Lithuanian heritage will not be trampled under by the Soviet boot and that the Lithuanian people are determined as ever to re-establish greater independence for Lithuania. Yes, perhaps somewhere in the distance, will come that ultimate dream of an independent, free Lithuania.

Our U.S. policy must be committed to achieving that goal. During my tenure in Congress, as the ranking Republican member on the house side of the Commission for Security and Cooperation in Europe, otherwise known as the Helsinki Commission, as co-chairman of the Ad Hoc Committee on the Baltic States and Ukraine, I have along with my collegues, steadfastly worked to bring the plight of oppressed Lithuanian people and others living under Soviet domination to the light of the American public. An example of the kind of work we're doing through the work of the Congressional Helsinki Commission, and our most recent conference in Berne, where Ambassador Michael Novack made our case, and the case of hundreds of persecuted peoples living within the Eastern wall,...made that case clear to Soviet authorities. As you might know, over 100 families were reunited and people were allowed to emigrate after that meeting. It's small...but its something.

Through the Ad Hoc Committee we've been working to see that the U.S. policy of non-recognition remains intact. As you know the U.S. has refused to legitimatize Soviet control of the Baltic states and has continued to maintain diplomatic relations with representatives of the independent republics of Estonia, Latvia and Lithuania. A few years ago we ran into a flap. The State Department was making maps and the Baltic states were not represented on those maps. We took the case to the State Department and reversed that policy.

Recently the U.S. Department of State announced that several U.S. government officials were planning to participate in the Chatauqua Conference - the Eisenhower Institute Conference on U.S.-Soviet relations, a journey in diplomacy. It is scheduled for September 15-19. What has troubled me about this meeting is that it is taking place in the Soviet occupied country of Latvia. While the American Latvian community has okayed the trip, there still remains the question as to whether such a visit could be considered "defacto" recognition of Soviet control of the Baltic states. To thwart this perception, I, along with my colleagues on the Ad Hoc Committee, have sent a letter to Secretary of State Shultz to explain his position and to issue an official protest decrying the Soviet occupation of these countries-something that in all the years since World War II has never been done.

In our own Lehigh Valley, we plan a Peace and Freedom Day Rally which is scheduled for Wednesday, August 27th in the front of the Bethlehem Plaza Mall. Our rally will be attended by hundreds of members of the various Lehigh Valley ethnic communities and will stress the importance of peace with freedom. This is something sorely lacking in the so-called 'mainstream' peace movement. I look forward to seeing as many of you there as can make it. We can start something new here in the Lehigh Valley—a new movement for peace and freedom...freedom and peace. Those of Baltic heritage know there is no real peace in Lithuania. They, and you, know that fear, oppression, torture, enslavement deny real

peace. They know that today real peace in Lithuania, or anywhere in the Soviet Union, for that matter, is forbidden. There is no peace in slavery. No, there is no actual fighting between armies, just a war led by the elite against its people.

Through rememberances like Baltic Freedom Day, Helsinki Human Rights Day and special protests on behalf of special Baltic citizens like Kaisa Randpere, the 3-year old Estonian girl who is being held as a political hostage by the Soviets, and Mart Niklus, the Estonian human rights activist...and so many other Baltic activists we can do something. Priests in Lithuania now find themselves put in prison because of their beliefs—Fr. Tamkevicius, Fr. Svarinskas, Fr. Matulionis. Their only crime is to believe in God, to care for their flock. Is that peace? Is the state

which conducts a war against people who believe in God at peace? No. We, and my colleagues, will try, in the face of great odds, in the face of an American people which finds difficulty in filtering through to the reality of the Soviet state and what it seems to export, not only to its satellies to the west of Russia, but to national entities in its own borders and to national entities far beyond its borders, stretching to Asia, to Africa, to Central America. We will continue to keep the light of freedom alive on behalf of Lithuania and others. The prospects for peace in this world only exist if peace is combined with freedom. And that is extraordinarily difficult.

Prospects for peace will remain alive as long as some nation exists whose

main entity is freedom itself. The key to bringing freedom to the Baltic people and others who share their fate-lies in your determination. It lies in your determination and the determination of free peoples who understand the struggle for peace with freedom. No elected official, such as myself, can raise the consciousness of the nation without the enthusiastic support of concerned, involved, and active citizens like you: Let me say that the dedication which comes from your hearts gives me heart to join you, and to lead you. Your cause is my cause. It is the cause of the people of the Lehigh Valley, of America, and indeed of all humanity.

Thank you for this award. I am proud to be selected as the Friend of Lithuania for 1986. I will cherish it for as long as I live.
