



WE LEFT OUR HEARTS IN KANSAS CITY

To many of us, gathered at the 73th convention in Allentown, Pa, it was a mild shock, when Council 150 invited us to come to Kansas City, Kansas for the 74th Convention. We had to admit that we did not know too much about the place. Visions of the Wizard of Oz, Judy Garland, Toto and great open plains raced through our minds. Council 150 must really be brave to undertake this formidable task. Some councils, the so-called "experts" at arranging conventions, must have had some doubts. Our baby, Council 150, only three years old and already arranging a convention. Many of us older councils acted like worried moms. Boy, did our baby surprise us!

At the Kansas City airport we were greeted by a large LABAS sign which brought a sentimental feeling to our hearts. Again at the hotel entrance the marquee proclaimed "Welcome Knights of Lithuania"! What a warm reception. Even the thermometer stood at 97 degrees and it was only 10 a.m.

Those of us who had arrived earlier were treated to various tours. There was much to learn about this area. For me, it was especially meaningful. When I arrived in the States in 1949 Harry S Truman was president. And now, here I am visiting his homestead in Independence, Missouri and placing a flower on his grave. I often thank Harry for producing a daughter like Margaret, who is a great writer and whose mystery novels are a real treat to me.

The opening Mass was offered by spiritual advisor Rev. Anthony Jurgelaitis at the beautiful church of St. Mary's — St. Anthony on Thursday July 30; The convention motto was taken from the writings of Blessed George Matulaitis: "Seek God, bring His Spirit to all things"! The first session was opened with the presentation of the colors and a prayer by Father Jurgelaitis. A special prayer was offered for our deceased members especially Larry Janonis and Irene Sankus who were terribly missed at this first convention without them. They both were exemplary presidium members. Today their places were taken by chairman Algirdas Budreckis and co-chairmen Frances Petkus and Jonas

Adomėnas. Secretaries were Rita Pinkus and Ann Bender.

Eugene Ashley, chairman of the convention welcomed us and Frank Petrauskas our ever popular president gave his "State of the Organization" report. Loretta Stukas, Clemencine Miller and Victor Matthau shared their experiences with us from the 600th Christianity jubilee in Rome.

At the second session, our treasurer Teresa Trainis informed us of the organization's financial situation. Mary Kincius and Vincent Gray performed their duties as trustees.

Loretta Stukas, K. of L. Foundation chairman gave her report. The Foundation was started in 1984 and at present has \$35,000. Each council should try to contribute at least \$100 to it. Next year when we are celebrating our 75th Anniversary it would be nice to see \$75,000 in the foundation. Loretta also announced the winners of the essay contest: 1. Sabina Klatt, Chicago, Ill; 2. Mary Sazecki, Forest City, PA; 3) Ernie Suktus, Chicago, Ill.; Honorable mention was given to Mary Lucas.

A religious panel was presented by Father Anthony Jurgelaitis. He spoke on our personal responsibility after the Christianization Jubilee.

Mass before the second session was held at the beautiful St. John the Baptist Church. Here we were shocked to see the walls decorated with a few swastikas. Later we discovered that when the church was build they simbolized "the welfare of an individual or thing".

At the third session, Larry Švelnis, Archives Committee Chairman gave a lengthy discussion about the state of our organization's official flag. We need a new one desperately and it has to be authentic, Larry told us. It was decided to form a committee and try to get a flag by the 75th convention.

The afternoon panel was presented by Dr. Victor Stankus of Cleveland, Ohio, a very active member of the community and in various Lithuanian organizations. He spoke about the OSI and the Lithuanian holocaust. He told us that Lithuania supported the allies during World War II and that Lithuania was the only country to boycott the German efforts to enlist men to the SS. He explained how we, as an organizatrion and as individuals can help the victims of the OSI persecution.

In our resolutions: we thanked Pope John Paul II for his kindness to the Lithuanians while in Rome; also we thanked Father Joseph Dambrauskas, MIC for his efforts in the beatification of Blessed George. Msgr. Al Bartkus, Archbishop P. Marcinkus and Msgr. A. Bačkis also got our AČIŲ LABAI!

At the Saturday morning session Junior Vice President Marytė Lepera introduced us to the younger part of our organization. She recited a poem (Marytė is the unofficial poet laureate of the K. of L.) describing the activities of the Juniors at the convention. Frances Rauba of Shenandoah, PA donated \$2000 towards sending a junior to the Lithuanian Youth Congress which will take place in Australia in December. Two juniors were selected, namely, Rita Zakarka of Chicago and Rima Hartvigas of Amsterdam, NY.

Amber Keenan of New York presented a plaque to President Petrauskas in memory of her grandfather Peter Zupko who had recently passed away. The Junior program ended with the youngsters singing "Mažiukas traukinukas" (A little train). A big ačiū labai must be given to Marytė Lepera for her dilligent work with our *atžalynas*.

Our popular president Frank Petrauskas was reelected for a 3rd term. We were happy to have Dr. Jack J. Stukas back again in the Lithuanian Affairs committee. (The rest of the board can be found on the inside front cover of the issue).



Yours truly, had a sneak preview of a summary of the book. It is beautifully written in an easy to read style. It will appear in 1988. The book is in English with a summary in Lithuanian by Dr. A. Budreckis. Good job Father William!

It was decided to hold our diamond 75th convention in Washington DC It will be hosted by the Supreme Council and the chairman will be Helen Shields. Chicago has invited us in 1989.

At the Saturday banquet Clemencine Miller of the Scholarship Committe presented Alice Karklas Memorial Scholarships to: Judith Ann Rekstenis, Amsterdam, N.Y. — \$1900.00, and \$1000 each to Kenneth Jasowicz, Amsterdam, N.Y. and Barbara Mickūnas, Philadelphia, PA.

Honorary membership was conferred to Msgr. Algimantas Bartkus, Rector of the Pontifical College in Rome, founder of the Anthracite Council 144. It is the highest honor given by the K. of L.

Sunday, at the closing Mass, fourth degrees were awarded to Vincent Gray, Cleveland; John

Knights of Lithuania 74th National Convention State of the Organization Report

As presented by Frank Petrauskas, National President July 30, 1987

I am submitting to the delegates of the 74th National convention a condensed report of all Officers, District Presidents and Committee Chairmen for the 1986 - 87 term. The full officer reports are available for your taking. Please take one of each and take them back to your local council so they will be available to your membership.

Spiritual Advisor

Father Anthony Jurgelaitis attended all Supreme Council meetings. He assisted in the planning of this convention and among other things he will chair a panel during the Convention. Also due to a scarcity of Lithuanian priests, Father will be called upon to handle more religious proceedings.

Father Anthony remembered all of our deceased members in his Masses.

President

President Frank Petrauskas organized and presided at 4 meetings of the Supreme Council. He attended and spoke at many council and district affairs. He participated in the 600th Anniversary Celebration at Hartford and at Newark. He also participated in Lithuanian Day at Moosic, Pennsylvania, Lithuanian Day at Auriesville Shrine, N.Y., and "Day of Prayer" at the Shrine of Our Lady of Czestochowa, Doylestown, Pennsylvania.

Frank sent letters of greetings to other Lithuanian

organizations when important meetings or conventions were scheduled. He sent out a general letter to all councils and districts and many letters to various individuals.

Frank arranged to have a nice portrait of Archbishop George painted and presented to Pope John Paul II dur ing our 600th Anniversary Celebration in Rome. He requested Dr. Jack Stukas to make the presentation.

First Vice President

The first Vice President's new title now is "Special Assistant" to the President. Dr. Algirdas Budreckis has just been that. He has been most helpful to your President. He has translated a number of letters into Lithuanian and he even translated a letter into Italian.

13. Was involved with a heavy volume of correspondence this past year. Much of it concerened the 600th Anniversary. Now comes our 75th Anniversary as an organization.





PRE CONVENTION TOURS

President Harry S. Truman Museum Tour Wednesday July 29, 1987

On Wednesday, two excellent tours were simultaneously offered — the Heart of America and the Harry S. Truman — both of which were very tempting.

For those who elected to go on the Harry S. Truman tour, an airconditioned bus was ready to transport us to the Independence Square Courthouse where Harry S. Truman began his political

career as a judge. For a few minutes a stop was made in front of the Truman home, where the President resided from his marriage to Bess Wallace Truman in 1919 until their deaths. Visitors to Harry S. Truman library & Museum can, among many other options, visit the Oval Office with President Truman himself narrating the tour. The building houses millions of presidential documents relating to the Truman administration. The building also contains private offices where, while President, Truman met

such notables as John F. Kennedy, Lyndon B. Johnson, Jimmy Carter and Hubert Humphrey. President and Mrs. Truman are both buried just outside of his private office. Upon visiting their graves, one gets the eerie feeling that the President will speak to everyone from his office. We toured the Marshal's Home and Jail Museum which housed such notorious prisoners as Frank James (brother of Jesse). This building provided a home for the county marshal, together with an attached 12 cell jail, with two foot

thick limestone walls which is preserved as it existed during the Civil War. The tour included a brief stop at the Vaile Mansion, once owned by Harvey Vaile of Independence, which is said to be one of the best examples of Victorian architecture in the United States. In 1897, the Vaile home became a private sanitorium, then a nursing home and later a tourist attraction. The conclusion of the tour brought the group to the RLDS Auditorium of the Reorganized church of Jesus Christ of Latter Day Saints (Mormons), which was very inspiring. This building was constructed to house the church's conferences and administrative offices. It can seat approximately 6,000 and is also the home of one of the best organs in the country. A half hour organ recital was most relaxing to all.

The Heart of America Tour Wednesday July 29, 1987

The delegates who chose the Heart of America Tour, also in an air-conditioned bus. First of all we were given a few vital statistics of Kansas City. It is an unique city since it is both in the States of Kansas and Missouri. It has more fountains than any other city in the world except Rome and has more miles of boulevards than Paris. Kansas City is proud of such notables as Lewis & Clark, J. C. Nichols, who created the nation's first shopping center, Harry S. Truman and Hallmark. The bus took the delegates through the downtown area past the restored historical buildings, the financial district, the stockyards and the convention center. A brief stop was made at the Liberty Memorial not only to view the skyline but also to go through the WWI Museum with its weapons, uniforms and other momorabilia. The bus driver drove into the underground caves where numerous warehouses are located. Westport, another restored area was also on our route. It is a collection of stores, restaurants and courtyards. Claiming to be a shopper's paradise, Kansas City boasts of still another shopping center, the Country Club Plaza. The buildings are modeled after the sister city, Seville in Spain. The 14-block district with its shops, restaurants and fountains is, in essence, an outdoor museum. We saw many mansions owned by such millionaires as Prendergast, H. & R. Block, Russell Stove and others. The millionaire's row is known as Mission Hills, the most elite residential area of all. We paused for a cold drink and a quick view of Crown Center which is a "city within a city". It is privately financed and covers 85 acres. Besides the show, there are two luxury hotels, condominiums, as well as major offices of Hallmark Cards. the waterfalls are also very spectacular. We found this tour to be extremely informative as well as interesting.

Rev. Anthony Jurgelaitis

On Thursday at the stroke of twelve noon, or a minute or few thereafter, the participants of the Kansas City Convention intoned the *Pulkim ant kelių* as the celeb-Father Anthony Jurgelaitis, O.P., Supreme Council Spiritual Advisor, approached the altar of St. Mary's - St. Anthony's Church, where Father Raymond Davern is pastor, to begin the Sacrifice of the Mass, invoking the guidance of the Holy Spirit upon the delegates and the labors of the Knights of Lithuania National Convention.

After the readings by volunteer lectors, the celebrant preached

the homily.

"Another year, another convention, another milestone," he began, "this time the farthest West the K. of L. has gone. Our goals, our ideals remain unchanged — Dievui ir Tėvynei, but we are meeting during the Lithuanian Christianity Jubilee. When Mindaugas, his family and his court received Baptism in 1251, he was gifted with Faith, Hope and Charity as well as the Gifts of the Holy Spirit which accompany Baptism. They, the original Christian Lithuanians were blessed with the Gifts of Wisdom, Understanding, Counsel, Piety, Fortitude and the Fear of the Lord to help them become more perfect Christians. Even though Mindaugas seems to have fallen away from his promises, Christianity perdured here and there in Lithuania: the Faith was never extinguished.

These gifts were a wonderful manifestation of God's generosity, which enable us, also, to believe and love more perfectly and

to become more responsive to the working of the Holy Spirit in our lives. So, the challenge of the Jubilee is to become more familiar with them, and more open to them. The challenge is met by praying for them, simply, asking God, which is not too difficult to

Music for the hymns sung during the Mass was played by Mr. David Sachen, one of the foremost organists in the nation.

Aiding the persecuted

At mid-day on Friday the Mass for persecuted peoples was celebrated at Saint John the Baptist Church, where Monsignor John Horvat is pastor. Celebrant and Homilist of this Mass was Father

Jurgelaitis.

He pointed out that the history of the new born Church in Lithuania shows periods of stress and struggle and recounts moments of grandeur and grief. From the very beginning the Knights of the Cross and the Knights of the Sword placed all kinds of obstacles to the peaceful growth of the Church. The Reformation confused the people and was a cause of divisions in the Faith. The Russian Tzarist regime not only strove to russify the language, but also to pressure the Lithuanian Catholics to adopt Russian Orthodox worship. And in our own times atheistic communism of the Soviet Union is attempting to undermine and destroy the traditions of the Catholic Faith of five centuries duration. The relentless persecutions and oppression of the past fifty years urges us to go to the aid of the 'Lithuanian people, to pick up the weapons they provide, namely prayer and fidelity to Jesus Christ. That is why we pray for our persecuted brothers and sisters in their homeland.

"As we pray for them, let's learn from them how to be heroes of the Faith. Let's learn how precious that 600 year old Faith really is. Let's learn to see, as they see, that God is at work even in these terrible trials, and that God is our strength as He is theirs." Father Anthony ended.

Remembering the departed

On Saturday the delegates and guests of the Convention returned to Saint Anthony's — Saint Mary's Church for the annual Mass for deceased members of the K. of L. There was a sizable increase in the congregation, since most of the delegates had arrived. The customary hymns were sung with devotion and musical assurance.

Principal celebrant was Monsignor Algimantas Bartkus, who was to be raised to Honorary Membership that evening and concelebrant was the Spiritual Advisor of the Knights of Lithuania, Father Jurgelaitis, who also preached the homily:

"It is good to pray for the dead," he started, "and it is a noble act for the Knights of Lithuania to maintain the brotherly, sisterly bonds that tied them together over the 74 years since its inception. Saturday of Convention week has become a sacred moment. We do not pray only for those who have died during the past year, but for all who have died in the organization. And as a matter of fact, when one member is called by the Lord and a Requiem Mass is said at the request of the Supreme Council for his or her soul, all deceased members are included. This bond of remembrance through prayer will continue as long as the K. of L. shall exist.'

During the Prayer of the Faithful delegates from the various Councils took turns in announcing the names of the deceased members for whom the Mass was being offered.

The Presentation of the Offertory Gifts was truly in keeping with the spirit of the Lithuanian Christianity Jubilee. Gift bearers were in Lithuanian native dress and brought foreward the official Christianity Jubilee medallion, a large commemorative medal of Archbishop George... Blessed George... Matulaitis, beatified by the Holy Father in June, a wayside cross, a rue plant, and the bread and wine for the Sacrifice.


His Excellency, Bishop Forest, greeted the congregation in the name of Archbishop Ignatius Strecker and the local Pastor.

The above mentioned specifically religious aspects of the Convention manifest a great deal of preparation and planning, as well as skillful coordination by the Host council under the leadership of Gene Ashley and his team. For these efforts, which demonstrate exceptional K. of L. Spirit, all Knights of Lithuania are enduringly grateful.

And finally, one activity, not mentioned in this report — The Religion Panel held on Friday — will be presented in a future issue of *The Knight* — *Vytis*.

We are thankful...

Sunday. the Masses at St. Mary's - St. Anthony's Church are celebrated at eight and eleven A.M. Thus, the Knights of Lithuania could have the beautiful church from nine to ten thirty. And what happened? It became the Lithuanian church for the day, reminding the older Lithuanians of Kansas City of yesteryear, when there was a Lithuanian church there. The church was well packed for this



occasion, as many local Lithuanians gathered for the closing Mass of the Convention, which was said in Lithuanian.

The parish choir *Rambynas* from Omaha was present in full force with a special program of hymns for this important occasion. It seemed that the entire congregation joined in the singing. Among the soloists were Al Brazis and Marytė Juzenas. Con-

celebrants of the Mass "in thanksgiving" were Monsignor Al. Bartkus and Father Jurgelaitis.

Preceding the Mass the Fourth Degree was conferred upon threeworthy candidates. The prayers were said in both English and Lithuanian, so that all could understand the significance of this Degree, through which the candidates rededicated themselves after many years of faithful service for "God and Country" in furthering the ideals of the Knights of Lithuania.

In the homily, Father Jurgelaitis stressed the importance of a proper celebration of the Lithuanian Christianity Jubilee year 1987 - 88. The bottom line of this celebration is not to be the three years of preparation, nor the pilgrimage to Rome, but rather a deeper knowledge and grasp of just what our Baptism means to us, what it ought to mean.

The advice given to the pilgrims at Rome by Pope John Paul was: "Be worthy of Christ!" and "Be God's people in the world!" It is clear that if we celebrate Lithuania's Baptism and boast of it, we must be what we

claim to be — followers of Christ. Personal responsibility — "P.R." is the watchword. During this year the Christian conscious of his Baptism can't help but resolve to grow in the Faith, and do the deeds Baptism requires as a matter of personal responsibility.

If the Delegates noticed that no mention was made thus far of the Papal Blessing upon the Convention, the explanation came just after the Homily. The document from the Holy Father came early enough, but it was misplaced. The convention hosts spent hours attempting to find it; it was discovered only after the Mass and entrusted to the National Spiritual Advisor. What was not read

at the Mass, is quoted here:

"His Holiness Pope John Paul II has been informed that the Knights of Lithuania will hold their 74th National Convention on July 29 - August 2, 1987 in Kansas City. He sends his greetings of grace and peace in Our Lord Jesus Christ to those taking part and assures them of his prayerful remembrance.

During this present Marian Year, the Holy Father commends the Knights and their families to the maternal intercession of the Blessed Virgin Mary and in the love of Jesus her Son he gladly imparts the requested Apostolic Blessing."

WHEREAS this treaty partitioned Poland and Lithuania between Germany and Soviet Union; and

WHEREAS the Soviet Union, in conjunction with this treaty issued Public Order No. 001223 which directed the liquidation and operative liquidation of up to 750,000 people in Lithuania, including American, British, Zionist, patriotic Jewish organization personnel, and other segments of the population in Lithuania; and

of the Soviet Union of its collaboration with Nazi Germany and the guilt of the Soviet Union of committing

Nazi war crimes;

BE IT RESOLVED by the Knights of Lithuania at their 74th National Convention held in Kansas City, Kansas that the Supreme Council of the Knights of Lithuania write to U.S. Attorney General Edwin Meese, President Ronald Reagan and the Senate and House of Representatives Majority and Minority Leaders to:

1. Express the Knights of Lithuania belief that no persons based on alleged discrepancies of his/her immigration application to the United States, be deported to the Soviet Union because of likely execution by Soviet

officials, i.e. Federanko.

2. Request that proceedings be initiated to try people now residing in the United States, who had collaborated with the Soviets in that time period of Soviet-Nazi collaboration (1939 - 1941) for their Nazi war crimes (this being in compliance with the Holtzman Amendment)

BE IT FURTHER RESOLVES that the Supreme Council of the Knights of Lithuania advise all District and Council Presidents to similarly write to the abovementioned individuals and their respective Congressional representatives regarding these issues.

19. Resolution

WHEREAS the right to life, liberty and the pursuit of happiness is a sacrosanct principle of the American heritage, and

WHEREAS abortion is a deed directly in contradiction

to that heritage

BE IT RESOLVED that the 74th National Knights of Lithuania Convention meeting in Kansas City, Kansas, reaffirm its opposition to legalized abortion and be it further resolved that the Convention express its strong support for the legislation proposed by President Ronald Reagan denying government funds to agencies counseling for or providing abortions.

BE IT FURTHER RESOLVES that members write

to the White House supporting this legislation.

20. Resolution

BE IT RESOLVED that the Knights of Lithuania 74th National convention approve the condidacy for elevation to Honorary Membership during the 75th National Convention in 1988 of a faithful, tireless, over half a century diligent member Konstant A. Savickus of Council 5, Chicago, Ill.

WHEREAS, cassette, tapes for VCR viewing were also made available and have been distributed throughou the world, in the hope that the cassetters may find their way into occupied Lithuania and give these people encouragement and hope in their struggle for freedom and human rights and

WHEREAS by the efforts and dedication of Rep. Lafayette to the cause of a free Lithunia that he may be of inspiration to others, to emulate, his achievements in having every February 16 known throught all of our 50

States as "Lithuanian Independence Day.

BE IT RESOLVES that the Knights of Lithuana Convention held in Kansas City, Kansas, recognize Rep. René M. Lafayette for what he has done for Lithuania in so short a time and wish him luck in his young political career.


