Are you a Sailboat, a Dolphin or a Sandpiper? Reflections on the 78th Knights of Lithuania National Convention

One of the greatest scientists was asked if he were the world's greatest. He replied, "No, I am only different!" The same could be said about our Knights of Lithuania conventions, each is different and unique in itself. This time, from the hustle and bustle of large cities, we chose the tranquil beauty of St. Petersburg Beach, Florida at the huge TradeWinds Hotel with its labyrinths of corridors and rooms named "Floridian" things or animals. Hence, a popular question was asked when inquiring about one's room - "Are you a dolphin, penguin or a sailboat"? This was our site August 1-4, 1991 with an attendance of approximately 300 members and guests. Each day, our registration girls, Ann Marie Kassel, Terry Strolia and Marytė Sepikas greeted all delegates giving them a beautiful tote bag inscribed with Knights of Lithuania and its emblem which was included in the registration packet.

As Msgr. Bartkus so aptly put it: "A convention is a check up time for an organization". It is a time to reflect what we have done in the past and to reflect on our future goals. Somehow this was a bitter sweet time. Al Zakarka, convention chairman, chose this lovely site and then his Maker called him. As we gather for this convention, we know Al is watching over our accomplishments.

As is custom, a short National Executive Board meeting preceded the convention. We all felt a trifle bit sad that our president Anne Wargo stepped down. After reading her State of the Organization Report at the first plenary session, a bouquet of flowers was presented to her for her accomplishments.

Opening Mass was at the nearby St. John's Church. Transportation Committee consisting of Anthony Kober and John Mickunas recruited everyone to the buses going and

returning from church. Mass was concelebrated by Msgr. Bartkus from Rome and Rev. John Contons from So. Boston, MA. The readings were done by Robert Boris in English and ApolonijaZiausys in Lithuanian. In his homily, Msgr. Bartkus thanked us for our support of the Lithuanian Pontifical, College in Rome. Next year 20 seminarians are expected from Lithuania and our help is needed more than ever before.

The first plenary session started in the afternoon with the roll call of officers and the State of the Organization Report read by outgoing Pres. Wargo. The following presidium was approved: CHAIRMAN: Fran Petkus; CO-CHAIRMEN: Evelyn Ozelis and Frank Petrauskas; PARLIAMENTAR-IAN: Peter Paul Zansitis; SECRETARIES: Mary Kincius and Helen Meizis. GREETINGS COMMITTEE: Marytė Sepikas, Irene Senken, Mary Shalins, Debbie Martin and Kenneth Rudmin. RESOLUTIONS COMMITTEE: Vin-

cent Boris, Terry Strolia, Glen Perutis, Mary Juzenas, Fr. Contons. MANDATE COMMITTEE: Alma Torre, Dolores Jonaitis, Sophia Zukas, Eleanor Arnauskas and Anne Cheplick. Anthony Gudonis, president of local council 147 welcomed and wished us a fruitful convention.

On Thursday evening, we traveled again by buses to the Lithuanian Club where a pleasant surprise awaited us. A young talented singer from Lithuania, Emira Dervinytė entertained us very briefly. Emira is currently studying at the Pontifical Institute of Sacred Music in Rome. Her able accompanist was Faustas Strolia. No K of L convention would be complete without Joe Thomas from New York especially his "Joe, Joe Don't Get Married". We were also entertained by a few K of L'rs, i.e., Ed Antanaitis, Iggy Walles and Anthony Kober. Dancing continued until the buses decided to return to the hotel.

It was truly a miracle that most of us managed to attend the 8:30 Mass the next morning in the hotel. Friday was perhaps the busiest day of the convention. The morning session had an excellent youth panel entitled, "Knights of Lithuania looking to the Future". Moderator was John Baltrus and his panel consisted of all females: Donna Juraitis, Barbara Mickunas, Marytė Sepikas, Irene Gecas and Elena Mikalauskas. In the audience there were three and four generation Lithuanians who shared with us their opinions and ideas. When the panel came to an end, we were reminded that "If you Win over a Junior, you will have a Knight".

Our K of L Honorary Member Robert Boris shared with us his ideas and accomplishments regarding Aid to Lithuania. We were shown a video tape of the Detroit K of L council loading a container of World Medical Relief supplies for shipment to Lithuania. (The particular container shown

arrived in Lithuania two days prior Bloody Sunday in January). What a sharp contrast between the loading in Detroit and unloading in Lithuania. In the U.S., most modern hydraulic lifts are used whereas in Lithuania, muscles and perspiration were the unloading components. At the end of the tape, Sister Albina Pajauskaitė, head of Caritas and a group of doctors in Lithuania, resounded with a hearty "Ačių labai mielieji Vyčiai!" Since the 1990 convention in Pittsburgh, the K of L have sent over a million dollars worth of medical supplies to Lithuania.

The afternoon session was also devoted to the youth of Lithuania. Moderator was Jack Stukas. Sister Helen Ivanauskas and William Hough acted as panelists. Sister Helen spoke about a new organization, S.O.S. Vaikai whose purpose is to help the orphans in Lithuania. When Sister was in Lithuania, she was only shown "the better ones". They were

> stark, dehumanizing, medieval death camps. Sister showed us a tape of the torture chambers for its innocent victims. Babies were shown in straight jackets, plaster falling, broken rest room facilities, etc., etc. To watch this film brought tears in many of our eyes. William Hough spoke about his visit to Lithuania. He first heard of our plight by reading A. Kučas book, "Lithuanians in America". He stated that we Lithuanians are not doing enough to regain independence for Lithuania. Many nations are on our side and do not recognize Lithuania's illegal annexation to the Soviet Union. France and Switzerland did not return to the Soviets the money which was deposited by independent Lithuania in their banks. We must buttonhole our congressmen. Many of them do not know what bills other

congressmen are working on. It seems our government wants to put Lithuania in a closet, like one would do with a cat and mouse and then let them work it out themselves. At the end of the panel, Jack Stukas remarked, "Let's find a nice Lithuanian girl for Bill and make him an associate member".

Friday evening again there was a treat in store for us. "Audra", a dance group consisting of 20 adults all over age fifty performed. Algerd Brazis of Metropolitan Opera fame and his 87 appearances with the Lithuanian Opera of Chicago impressed us with his beautiful baritone voice. Al dedicated the song "Kur bakūže samanota" to Dalia Bulvicius, much to her surprise. Last but not least, there was Ona Jamaikiene of Palm Beach Opera fame. Her solos and duets with Al were received with thunderous ovations. The able accompanists were Al's wife Aldona Brazis from C-112 Chicago and Louis Stukas from C-153 Treasure Coast. After Helen Shields and the Lithuanians who a few days ago were murdered at the border crossing in Lithuania. A minute of silence was observed for all. A busy day followed. Second Vice President Sabina Henson showed off her Juniors. They had a separate program visiting exhibits, museums and having a sand building contest on the beach. Aušros Vartai and Trakai were among the winners.

Nominations and elections followed. Unchallenged Frances Petkus of C-98 Dayton, Ohio became our President. The list of officers elected are listed on the Front Inside Cover of Vytis. Stanley Vaitkus, Honorary Membership Chairman presented Aldona Ryan's name from C-96 Dayton, OH for next year's consideration to the Honorary Membership. There were two bids for the 1992 convention site. Marytė Sepikas invited all to come out to C-133 of Los Angeles, CA and Anne Wargo invited all to Allentown, PA wherein C-144 Anthracite will act as hosts. A vote was taken and Allentown will be our next convention site. We do hope that C-133 Los Angeles will invite us again in 1993.

On Saturday evening, the banquet was held in the large banquet room at the hotel. Newly elected National Executive Board marched in and took their seats at the dais. Master of Ceremonies was Walter Svekla of C-3 Philadelphia who punctured his eloquent style remarks with humor. A good MC must be sincere, be honest and be seated which all applied to Walter!

Various scholarships numbering in the thousands of dollars were presented to our deserving youth by Clemencine Miller, Scholarship Secretary & Treasurer of C-141 Bridgeport. Their names are listed under an article entitled Canon Fabijonas Kemežis Scholarship Awards in this issue.

The Friend of Lithuanian Award was presented by Rita





FRIEND OF LITHUANIA AWARD Presented to WILLIAM HOUGH, III

The FRIEND OF LITHUANIA AWARD is one of the highest honors awarded by the Knights of Lithuania organization and was initiated by Rev. John Jutt many years ago. The purpose of this award is to give recognition to a non-Lithuanian person who has distinguished himself by working for Lithuania. This year's recipient is WILLIAM HOUGH, III, a 1985 cum laude graduate of New York Law School. He has authored the "Annexation of the Baltic States and its effect on the Development of Law Prohibiting Forcible Seizure of Territory" for publication. Mr. Hough has been active in Baltic affairs in his capacity as advisor and consultant to the Baltic Federation of Canada, the Lithuanian-American community, the American Latvian Association, the Estonian American National Council and the Joint Baltic American Committee. Mr. Hough was requested by Pres. Landsbergis to advise the Lithuanian government with respect to various legal matters. He has drafted various memoranda and has given testimony before the Congressional Helsinki Commission on the Baltic Crisis and testimony before the Senate Foreign Relations Committee regarding Soviet Disunion. He organized New York visits of Estonian, Latvian and Lithuanian government officials in July of 1990. Mr. Hough has also assisted Ms. Jeri Laber of Helsinki



Watch to establish contacts in the Baltic States in Jan. of 1991 and assisted Lithuanian Catholic Religious Aid in establishing a training program for Lithuanian ophthalmologist at New York Eye & Ear Hospital. He is currently acting as legal advisor to the Popular Fronts and Independence Movements in Estonia, Latvia and Lithuania.

We, the Knights of Lithuania, hope that Mr. Hough will continue to help Lithuania in her path to democracy and freedom and give public and moral support whenever possible. The Knights of Lithuania members are very proud to present this Award to Mr. William Hough, an outstanding individual! Our heartfelt thanks goes out to him for all his untiring efforts on behalf of Lithuania.

THE KNIGHTS OF LITHUANIA LOOKING TOWARDS THE FUTURE

Friday morning's panel at the 78th National Convention was a candid exchange of ideas between the panel's members about what they believe the K of L has to do to attract new members in the coming years. The panel was comprised of Marytė Sepikas (Los Angeles), Donna Juraitis (Chicago), Barbara Mickunas (Philadelphia), Elena Mikalauskas (Dayton), Irene Gecas (Dayton) and the moderator was John Baltrus (Pittsburgh). The average age of the panelists was approximately 30 years old, but combined, they had almost 75 years of experience in the K of L.

The panel concentrated its discussion on three areas of importance: how to attract new members, how to keep the members who join, and how to integrate the junior members into the regular councils once they become older.

The first topic of how to attract new members was discussed by Marytė Sepikas and John Baltrus. Marytė joined the Los Angeles council a few years ago and since that time has been instrumental in increasing the size of her council from eight to approximately 80 members. Marytė did this by placing one line advertisements in local church bulletins and newspapers saying, "If you are Lithuanian, please call Marytė" and then listing her phone number. She has also promoted the K of L by using Vytis. She constantly carries a copy with her and shows it to prospective members. She encourages people to initially subscribe without having to immediately join the council.

John Baltrus agreed that publicity is the key to recruiting new members. Many of our councils are located in large cities where there is a constant influx of potentially new members. However, we rarely go outside our tight Lithuanian communities to publicize our organizations. He gave the example of several inquiries he received about the K of L from simply having a letter to the editor published in the local newspaper.

Finally, Maryte stressed the informality of meetings that attracts members to her council and makes them want to meet often. Most of their meetings are held in members' homes where social functions are highlighted in addition to regular K of L business. She feels that members want to interact on a personal level and enjoy the relaxed atmosphere of home meetings and social gatherings.

Donna Juraitis and Barbara Mickunas discussed ways for keeping younger members interested in the K of L. They offered constructive criticism to improve council meetings and keep members coming back. They stressed that council meetings should be a place for all members to interact on an equal basis. Members who have been very active in the K of L should not use the meetings to boast about their accomplishments at the expense of other members who may not have as much time to dedicate to K of L causes.

Next, they tackled the topic of boring and unproductive meetings. They believe that one of the main obstacles to more productive and quicker council meetings is that members simply do not know the rules of the organization or the council president is lax in enforcing them. Since each council was issued a new copy of the K of L manual at this year's convention, they suggested that sections of the manual be published in the VYTIS so that all members, especially new

ones, might become more familiar with the K of L structure and rules. They also suggested that if your council president is not familiar with the rules and makes no effort to enforce them, it may be time for a change in leadership.

Donna and Barbara emphasized that change and new blood is important to keeping any organization alive. We have several councils who have not had a change in leadership for quite some time and their meetings have become dull rather than crisp and fresh with new ideas. It was pointed out that sometimes it is difficult to recruit new officers. However, it was theorized that this may be because no one wants to enter a new job cold. It was suggested that current officers involve newer members of their councils to assist them in their duties. That way these people will be more willing to accept a new position once present officers decide to step down.

Finally, Barbara and Donna emphasized that we should not be afraid of change. We should make an effort to include new activities in which younger people will want to participate and to include new ideas in traditional activities. Just because something has been done the same way for many years doesn't mean it can not work even better with a few changes. You should find that the younger members are willing to compromise and still accept several of the old traditions, but the older members should think of how much they would feel welcome if they were trying to join a group whose activities were only geared to younger members.

A look at the K of L from the perspective of junior members was given by Elena Mikalauskas and Irene Gecas, junior advisors for both Dayton council and Mid-Central District. Many of their opinions were gathered directly from their junior members. They pointed out that it is important for youth to participate in activities which they find to be fun. Many of these are not traditional council activities on the senior level, but daily activities popular with the youth and in which a K of L atmosphere can be created.

Elena and Irena stated that the youth would like to be represented by the older members and have input into decisions affecting them. The younger members will be expected to make mistakes, but they can share in the knowledge and wisdom of older members if it is kindly offered. The youth, of course, would also be expected to show respect to older members as well. Again they emphasize that they like informal meetings and ones in which an activity is planned. They would like to have control over some finances if they assisted in raising funds.

Next, they discussed to what extent juniors can find time to participate in K of L activities. The youth should be encouraged to make time to participate and their parents should encourage them to do so as well. This will be easier if they see their activities in the K of L as fun. Some parents of ethnically-mixed marriages, which are becoming the norm these days, may be hesitant to have them participate in only Lithuanian activities. Perhaps a day should be set aside periodically so that the youth may discuss the importance of other heritages to which they belong.

It was felt that the K of L Scholarship Fund is an important program for our organization. This is where some of our future leaders will come from. It should be supported by all councils whether they have eligible candidates or not. The recipients of scholarships in return should be required to show some commitment to the K of L in the future. This should be stated explicitly on the application although it is realized that there is no way to force participation. Recipients might also be asked to report on their college activities and progress to their degree. We should realize that the participation of collegiate members may decrease considerably due to their studies, but we should encourage them to become active again once they have graduated.

It is important for the Lithuanian youth to build friendships. It is the junior advisor's duty to involve them in activities through which they can build friendships. The advisors should keep parents informed of youth activities and ask them for support. They should encourage the Lithuanian heritage among the youth and the Catholic faith as well. Advisors should not be afraid to set down the rules. They should be persistent in recruiting new members and encourage current youth to aid in recruiting members. Remember that if you win over a Junior, you will have a Knight!

There were many other ideas regarding the K of L that were expressed during this panel. It is hoped that the summary above will enlighten current members as to what they should do to start recruiting and retaining younger members. In brief, we should publicize, harmonize and rejuvenize. Of course, we will have those who will say that it can not be done, especially this way. These are the people that are suffocating our organization. It is the duty of every member to follow these suggestions so that we insure the future of the K of L. The members of the panel offer unmistakable proof that these tactics do work.


Rev. Clergy, Sisters, Distinguished Guests and Fellow Knights:

Third - Janet S. Domalakas, C-144 Anthracite, PA has been active with the Knights for 12 years. She began as a member of the dance group, became a





KNIGHTS OF LITHUANIA 78th NATINAL CONVENTION STATE OF THE ORGANIZATION REPORT

Presented by Anne Klizas Wargo, National President - August 1, 1991

In accordance with Article XI, Section 2 of the Knights of Lithuania Constitution, I submit to the delegates of the 78th annual convention, the National Executive Board's Annual Report. I have condensed all reports submitted to me before the convention. Fuller reports have been provided by all officers. I urge you to take a set home and share the contents with your council.

SPIRITUAL ADVISOR

The Knights of Lithuania organization is most grateful to its Spiritual Advisor, Rev. Joseph Anderlonis for his counsel and guidance this past year. He continues to offer a monthly Mass for all the deceased Knights of Lithuania members. He remembers all names submitted to him in his prayers each month. He hosted the National Executive Board meeting in Philadelphia in October and attended the March meeting in New Haven, CT. Parish duties, as well as his participation in a Special Day of Prayer at Our Lady of Czestochowa Shrine in Doylestown, PA for Lithuanians prevented him from attending the June meeting in Detroit. He has been active in a number of efforts on behalf of Lithuania's drive for independence. He was pleased to have arranged a discussion meeting with the late Senator John Heinz (R-PA) and a group of leaders of the Lithuanian Community on Feb. 4, 1991. He has supported numerous letter-writing campaigns to officials in Washington. Father Anderlonis has encouraged participation in various religious and cultural activities which demonstrates support for Lithuania.

PRESIDENT

Anna Klizas Wargo organized and presided at three meetings of the National Executive Board in Philadelphia, New Haven and Detroit. She continued her letter-writing to Congress and to Pres. Bush. She attended two hearings of the Helsinki Commission in Washington, DC, one in January where the Vice President of Lithuania, Bronius Kuzmickas and Vice Presidents of Latvia and Estonia and Attorney William Hough testified. In May, she attended the hearing when Lithuanian President Vytautas Landsbergis and Prime Ministers of Latvia and Estonia testified. She represented the Knights of Lithuania at a reception for President Landsbergis and presented him with a copy of the K of L History book. She sent a telegram to Archbishop Marcinkus wishing him well on his retirement and thanking him for all he did for the Knights of Lithuania, especially during the celebrations in Rome on St. Casimir's 500th anniversary and the Christianization Jubilee of 600 years of Lithuanian Christianity. Congratulations with a \$50.00 gift were sent to Bishop Deksnys on his Golden Jubilee. She attended C-36's Chicago and C-29's Newark 75th Jubilees. She answered all correspondence and forwarded requests to the proper officers.

FIRST VICE PRESIDENT

Frances Petkus attended all three National Executive Board meetings. Frances worked hard on completing the Knights of Lithuania Manual and this will be completed and distributed to National officers and council presidents at the convention. She also has continued her letter-writing campaign. Frances is also her council's president and is active on the district level.

SECOND VICE PRESIDENT

Mary Kincius attended all National Executive Board meetings. She cooperated with the First Vice President in updating the Manual. She wrote an article for VYTIS to stimulate more interest in the Knights of Lithuania and spearheaded a membership campaign. She sent Membership dues schedules to all Presidents. She sent packets to all leads given to her for new councils. She wrote letters and phoned councils who were thinking of disbanding. Mary also has been active in her local council.

THIRD VICE PRESIDENT

Sabina Henson attended meetings in Philadelphia and Detroit. She was unable to attend the March meeting due to the death of her mother. She wrote articles for VYTIS and DRAUGAS. Sabina sold Vytis T Shirts for the Juniors Special Fund. She sent out the "Junior Jewels" newsletter each month to junior councils. Sabina has done an excellent job on this newsletter and is to be commended for this. Two new junior councils were formed in 1991 - Bridgeport, CT C-141 and Hudson-Mohawk C-136. She contacted Vytautas Kamentas about the Youth Congress to be held in South America on Dec. 18, 1991 to Jan. 8, 1992. An essay "What Activities in the Knights of Lithuania have he/she been Involved" was used to select a candidate. She represented the Knights of Lithuania when President and Mrs. Landsbergis were in Chicago. She has encouraged all councils to form a junior council.

RECORDING SECRETARY

Robert A. Martin, Jr. attended all National Executive Board meetings. Minutes were recorded efficiently and sent to all Supreme Council and Honorary members. He handled all requests given to him by the President in a timely manner. He updated all officer's lists and forwarded to National Executive Board members.

FINANCIAL SECRETARY

Ann Cheplick attended two meetings. She reported a total membership of 4,662. Delinquent notices were sent to councils whose members did not pay dues.

TREASURER

Frank Peterson attended all National Executive Board

meetings and handled his duties efficiently and responsibly. His complete report will be presented at this convention.

TRUSTEES

Edward Barkowski and William Kolicius attended all Supreme Council meetings. They have audited the Treasurer's report and found it in order. Before the closing of this convention, they will audit all Knights of Lithuania Funds -K of L Foundation, St. Casimir Guild, Medical Aid Fund, Scholarship Fund, the Vytis interest held by Vytis Editor from certificates donated by K. Savickus, and the Financial Secretary's

records. They audited the Archives Room in Putnam, CT. They have sent letters to Councils to host the 1992 convention. Ed Barkowski assisted the First Vice President in the editing of the K of L Manual. Bill Kolicius represented the Knights of Lithuania at the Vlikas Convention in Cleveland. Both trustees were dedicated to the tasks their office required.

LEGAL ADVISOR

Saulius Kuprys prepared an information report to the Internal Revenue Service in Philadelphia as required by law. The return was completed in consultation with Treasurer Frank Peterson. He has maintained contact with the attorney representing the co-executor of the estate of Helen Shields. At the request of Vytis Editor, he provided the Lithuanian Foundation with the K of L Federal ID number, since the Vytis magazine received a \$500.00 grant from the Foundation and the Foundation was requesting ID numbers from all recipients to comply with IRS requirements. He prepared a summary as to the Corporate Structure of the K of L Foundation for the Manual.

VYTIS EDITOR

Mary Kober attended all National Executive Board meetings. She reported the Christmas Ad Campaign did not do as well as Christmas of 1989 and requested the members give more Well-Wishers ads at \$10.00. Mary appreciates the good work done by council news editor, Helen Chesko, Food Editor Stella Matulonis and Dalia Bulvicius. She maintains a computer list of all members and takes care of all changes of address, death notices and new members. Ten issues are published yearly and she asks for comments, good or bad, from readers.

ARCHIVES COMMITTEE

Longinas Svelnis made three trips to Putnam, CT. He attended ALKA board meeting and two New England District meetings. The Archives Committee reviewed the scrap

> book of Honorary Member Alexander Aleksis and recommends to retain it as is. They also reviewed material from Honorary Member Antanas Mazeika and found typed material from our Founder Honorary Member Mykolas Norkunas which was sent to Honorary Member Ignas Sakalas dated April 1950 giving details of the founding of the Knights of Lithuania.

CULTURAL COMMITTEE

Regina Kot attended one National Executive Board meeting. She replied to all requests

and mailed out six cultural readings to District chairpersons to be sent to councils in their districts. She wrote one article for Vytis.She hosted a Lithuanian Christmas Program on Radio Station WCSS.

HONORARY MEMBERSHIP

Stanley Vaitkus reported Honorary Membership Eleanore Laurin presented Msgr. Jouzas Prunskis the Honorary medal at the "Memories of Lithuania" banquet in Chicago Feb. 2, 1991. Two outstanding members, Helen Shields and Marcella Alexis, died during this year. The committee have voted and will submit two names from the Honorary Membership as replacements for the Amber and Mid Atlantic Districts. Letters were sent out by Secretary Phyllis Grendal to update proposed members for Honorary Membership. Honorary membership consists of 34 living members, 3 Bishops, 5 Priests, 16 men and 10 ladies.

LITHUANIAN AFFAIRS COMMITTEE

Due to the untimely death of Chairman Albert Zakarka, his daughter Rita completed her father's term of office. Rita



has written letters, attended a seminar in Washington on Lithuanian Affairs and has filled the office diligently and faithfully.

LITHUANIAN LANGUAGE

Apolonija Ziausys attended all Executive Board meetings. She assisted at the annual pilgrimage for the suffering Church in Lithuania. She hosted a young Lithuanian doctor from Vilnius. Polly and her husband, Ed, have obtained donations of medical equipment from Amsterdam Memorial Hospital and either delivered the equipment themselves or arranged for shipment to LCRA in Brooklyn. In January she hosted another doctor from Kaunas, Dr. Sigitas Dumčius. He was sent to the U.S. by Caritas to learn how hospitals in the U.S. are operated. She and her husband made the necessary arrangements for him to be received at Amsterdam Memorial Hospital. The hospital again donated additional supplies. She has continued letter writing to Pres. Bush and Congress. She obtained Lithuanian cassettes for people who wanted to learn the language. She translated and wrote letters when requested. Polly is to be commended for the work she has done to obtain medical supplies for Lithuania and for all she has done for the Lithuanian cause.

PUBLIC RELATIONS

Dalia Bulvicius attended all Supreme Council meetings and reported these for Lithuanian publications. She gave a report of the Pittsburgh Convention on the Lithuanian Radio Program and wrote the convention news with photos for Lithuanian publications and Vytis. She edited and translated items sent to her for Darbininkas. She wrote articles for the Knights of Lithuania "Aid to Lithuania" campaign and wrote letters to the Editor of the New York Times and the National Geographic.

RITUAL COMMITTEE

Rita Pinkus reported that in 1991, 20 councils gave 40 First Degrees, 34 Second Degrees, 81 Third Degrees. Sixteen Fourth Degrees are to be given at this convention.

LITHUANIAN CATHOLIC RELIGIOUS AID

Florence Zaleskas reported that she did not have a special fund campaign due to the inception of the Medical Relief Fund for Lithuania chaired by Robert Boris.

AID TO LITHUANIA COMMITTEE

Robert Boris reported 429 donations were received as of June 30 totalling \$43,309.00. Two containers and an emergency air shipment after "Bloody Sunday" were shipped at a cost of \$24,169.59. Total weight shipped was 34,269 lbs. with an assessed value of \$1,005,341.00. Thanks to Sister Alverna, OSF, Pittsburgh, the Rosary Crusade is a great success. The Rosary is recited for Lithuania every 15 minutes by 387 people. Robert Boris notes that of almost 5,000 members, only 393 donations have been received and many of those were not from individuals. He asks all members to contribute even a small donation. We must continue this project. Robert is to be commended for all he has done for this very worthy cause.

SCHOLARSHIP COMMITTEE

William Piacentini reported approximately 50 requests were received this year and all were answered. The annual fund-raising appeal was down from last year. Less than half the councils responded and the amount of \$2,375.00 is \$800.00 less than last year. The need for financial support is greater than ever due to the rising cost of college. The Committee considers each candidate carefully to insure that donations are properly expended.

ST. CASIMIR'S COLLEGE - ROME

Robert Boris attended three National Executive Board meetings. He represented both the Knights of Lithuania and St. Casimir's Guild at a meeting called by Bishop Baltakis in December. The balance in the Guild presently is \$12,527.13. In September, twenty seminarians will be sent to the college from Lithuania. It is important that we continue our contributions to the Guild.

KNIGHTS OF LITHUANIA FOUNDATION, INC.

Pres. Loretta Stukas reports the Foundation currently has over \$56,000. in capital. About \$7,000. will be available in interest this year for use in Knights of Lithuania and other Lithuanian causes. Donation of a note came from the estates of the late Helen Shields and Peter Kasilonis and from C-40 East St. Louis which disbanded but donated their treasury to the Foundation. Considerable donations were also made to the Foundation in memory of Helen Shields. Donations are needed from councils and individuals on a regular basis to guarantee tax exempt status of the Foundation. Only the accrued interest is used for various cultural and religious projects of the Knights. Disbursements will go this year to the presentation of the Alice Karklius Scholarship, funded by a \$25,000. donation from Ben Karklius in memory of his late wife, essay contest winners funded by a \$10,000 donation by Msgr. Juozas Prunskis and any other Lithuanian causes to be selected during the Foundations annual meeting Aug. 2. Last year the Foundation donated \$2,000 to the Container Fund.

The Foundation mourns the deaths of Directors Helen Shields and Albert Zakarka and regrets the resignation of Director Nancy Miro Mourkakos. Temporary replacements were appointed to continue the work of the Secretary and Treasurer, and permanent directors will be appointed at the annual meeting after approval by the National Executive Board.

AMBER DISTRICT

Pres. John Mickunas attended all meetings. Three District meetings were held. The District has remained stable with eleven councils and a slight increase in membership. The yearly raffle was successful. The Amber District regrets the loss of Helen Shields. Her leadership and vast knowledge of the Knights of Lithuania will be sorely missed. The new District flag was blessed in church during the St. Casimir Day celebration by Spiritual Advisor Rev. Matthew Jarasunas at Our Lady of Siluva Church in Maizeville, PA. A donation of \$500. will again be given to the Medical Aid Fund at this convention. The Amber District has been involved in many Lithuanian cultural projects and Lithuanian Affairs Projects this past year. The District is currently planning to attend the 25th Anniversary celebration of Our Lady of Siluva Chapel in Washington, DC on Oct. 13.

MID AMERICA DISTRICT

Pres. Algerd Brazis reported the District held four meetings. The District was represented at C-36's 75th Anniversary in Chicago. It was also represented at the Draugas yearly banquet, Dirva banquet, Pres. Landsbergis luncheon at the Balzekas Museum and the Marian High School rally for Pres. Landsbergis. They met him at the airport and had a representative at the private luncheon and private conference. They were represented at the Song Festival and Lithuanian Opera and also at the closing Mass with Cardinal Bernadyn in

Immaculate Conception Church. The Fourth of July picnic had a good representation from all councils. The profit from the Memories of Lithuania amounting to \$2,000 was presented to Charge d'Affaires Stanley Lozoraitis for the Lithuanian Legation. MID ATLANTIC DISTRICT

Pres. John Baltrus attended all Supreme Council meetings. There are 8 regular and one junior council in the District. Two meetings are held yearly. Donations were given to the VYTIS Christmas Ad campaign, Medical Aid to Lithuania, Scholarship Fund and St. Casimir's Guild. Dear President Bush:

We, the Knights of Lithuania, being met at our 78th National Convention in the city of St. Petersburg Beach, Florida on August 2, 1991, wish to express our consensus extreme displeasure with your recent action in offering Most Favored Nation trade status to the Soviet Union. That this action was announced on the very date that the Soviet Moscow-controlled elite troops furthered their program of violent intimidation and provocation with the apparent execution of six Lithuanian customs guards.

Our organization represents over five thousand second and third generation Americans of Lithuanian descent. We maintain a high regard for our heritage both as Americans and as ethnic Lithuanians. We know and appreciate current Lithuanian aspirations toward a freely elected fully independent government. We know also from personal contacts of the continued depredations and violence to the Lithuanian people by the present foreign occupying forces.

We have been heartened by your many words of support for the Lithuanian nation and the non-recognition of Soviet annexation of Lithuanian territory. We recognize that both you and your predecessors have been unstinting in their verbal support. Unfortunately, too often actions give lie to the words. We strongly urge your favorable consideration or various actions now being considered within the legislative branch. These range from de-facto recognition of Lithuania to the provision of substantive technical assistance to the Baltic Nations.

WHEREAS the future of the Knights of Lithuania rests in the hands of our young people, and

WHEREAS junior Knights of Lithuania councils are not to be found in all geographic areas,

BE IT RESOLVED that Member-at-Large status be established for Juniors.

WHEREAS the minutes of the National Convention are the official record of all convention business, and

WHEREAS several items of business are traditionally conducted after the official close of business at the Convention banquet, specifically presentation of the Friend of Lithuania Award, Honorary Membership and Scholarship Awards,

BE IT RESOLVED that the National Convention minutes be replaced by National Convention Proceedings, which will be the formal documentation of business meeting minutes, and all awards and presentations.

BE IT RESOLVED that the 78th National Convention of the Knights of Lithuania extend our heartfelt thanks to the St. Petersburg Lithuanian Club for the hospitality shown to us during this convention.

WHEREAS the local Lithuanian residents of St. Petersburg Beach, Florida have made a significant addition to the ambience of our 78th National Convention by displaying Lithuanian historical memorabilia and cultural artifacts,

BE IT RESOLVED that the Knights of Lithuania here assembled in National Convention express our sincere appreciation and gratitude for providing this most interesting exhibit.


