# FROM YOUR EDITOR


You had to be there to soak in the convention experience of Detroit '95 - but just in case you weren't, here's our 82nd National Convention Issue as the next best thing.

# Xnights of Lithuania National President's Meetings in Lithuania

During October 1994, I attended the Lithuanian American Congress. Dr. Bobelis, Chairman of the Committee on Foreign Affairs of the Republic of Lithuania, created a commission comprised of Lithuanians abroad and members of the Lithuanian Parliament for the purpose of informing Lithuania's emigrants. In January 1995, I received a letter of invitation from Dr. Bobelis, inviting the Knights of Lithuania to be a member of this joint commission.

The commission has been formed to coordinate and inform humanitarian, scholarly and cultural activities, to recommend changes in obtaining dual citizenship and other information. After volumes of correspondence to the Supreme Council, it was their decision on March 25 to send me as the Knights of Lithuania representative.

Finalization was made to depart from Chicago on Friday, May 26 through June 6.

I arrived in Vilnius on Saturday, May 27 and immediately had to speak and think in Lithuanian, since all conversations would be conducted only in Lithuanian.

A formal invitation had been issued to attend a reception with the "Seimo Pirminikas", Speaker of the House, C. Jursenas, at the Hotel Draugyste where we were staying as guests of the Republic of Lithuania. We were then individually introduced with a brief resume of our organization's background. Mr. Jursenas greeted us and thanked us for coming. There were representatives of Bendroumene from the U.S., Canada, Australia, Germany, South America (Lith. World Youth

Pres.), Moscow, Siberia and two Altas representatives from Cleveland and Washington, DC.

Monday, May 29, we were chauffered to the Parliament for meetings that began at 10 a.m. and ended at 5 p.m. with a break for lunch.

We exchanged greetings with members from the Parliament, and as we were to divide into groups, there was an upheaval. The president of Bendroumene cited irregularities commission. Finally, World Community and US Bendroumene met in agreement with Seimas representatives. Two groups were formed; one for dual citizenship and another for humanitarian, political, scholarly and cultural. The latter was my committee. After lunch, we met with a briefing on this commission which was expected to be ratified during the afternoon. Instead, it went into committee and was detained. We were then informe commission would not be working for awhile, but we could offer advise and ask questions on various issues of citizenship and could not vote.

Mrs. Danute of the Lithuania Immigration was a thorough individual who did not bend with the wind until much clarification. Dr. Valdas Petrauskas, an MD who favors working in Parliament because "it pays more than medicine" was not in favor of dual citizenship. At times the discussions became as heated as the temperature (90 degrees with no AC or even fans). I recorded six cassettes of conversations. They are much like our congressmen and senators, but with less finesse.

I came prepared with history books and VYTIS copies. I left the copies with Prof. Landsbergis along with my official K of L business card. I gave a copy of our history book to Mr.

Markauskas of the Seimas. He was the representative on the citizenship commission. Another copy was given to Victor Petkus, a political dissident, who was an observer with us.

While taking a ten minute break on Wednesday afternoon, I spoke with Mr. Beliauskas, former President of World Community. He knows the K of L very well, but kept insisting we are only a Catholic organization. I spent the next half hour giving him an understanding of the Knights, what we have done and what we can do.

On Wednesday, May 31, we were invited to attend a formal reception at 7 p.m. at the request of the Prime Minister, A. Slezevicius. Once again, we were introduced with a brief resume of our organization. It was very informative and we did ask many questions about the borders of Lithuania. Belorussia joined forces with Russia and at these borders comes contraband - and many unanswered questions.

The commission on dual citizenship was finalized during the following morning's session. After lunch, our commission was called to attend the Seimas, for it was going to be presented for ratification. Prof. Vytautas Landsbergis was against ratifying our commission because he claimed it was done last year with Bendroumene. With that, Dr. Bobelis said that Bendroumene did not represent all Lithuanians. And then he introduced me to the Parliament. We were ratified with a 66 to 11 vote.

Friday's schedule included a meeting with the President at 11 am for a briefing on the recommendations presented on dual citizenship. He said all Lithuanians should have citizenship, but documents had to be turned over to the legal dept. for clarification and constitutionality. If all went well, it would be sent to the Parliament Sept. 5.

We received engraved individual invitations from Pres. Brazauskas to luncheon with him at the Draugyste Hotel. It was very elegant, while everyone extended their greetings. I chose to be the last speaker, since I did not want him to forget the K of L. These appearances were televised. The K of L was mentioned in two newspapers. During the second week, I was interviewed by Europos Lietuvi, giving a full report on our history and activities.

My first Sunday Mass was a two hour high mass at the Cathedral of Vilnius. People stand to receive the Eucharist given by only priests or deacons. They are coming into this century.

Ventured to Klaipeda to visit relatives who live in a compact but clean apartment building. The hallways and elevators, however, are similar to our housing authorities' - dirt and druggies laying around.

Spent a few rainy days in Klaipeda. Went to the botanical gardens in Kretinga, part of the estate of the Amber Museum. Attended Mass at St. Anthony's in Kretinga. The Franciscans regained most of their land and hope to be able to use it for the good of the people. The church was packed with people of all ages.

Visited relatives on the farm in Silute. At 75 yrs. old, they still farm a small bit of land to

He has continued to offer a monthly Mass for the deceased members of the Knights of Lithuania, whose names are submitted to him periodically. Father has provided advise and counsel to K of L members, and especially the Supreme Council members. Father has hosted the Supreme Council meeting in October with the able assistance of Council 3-Philadelphia. He continues to be our best friend.

Evelyn Ozelis, organized four meetings and presided over three. Meetings were held in Philadelphia, Worcester, and two in Detroit. The host councils for these meetings were most gracious, and very accomodating. There has been much correspondence from various organizations, and Knights of Lithuania members. It has become a tradition that there are some activities to give the early bird conventioneers "local flavor" before the main convention Detroit '95 was no exception. We offered two.

One group of 40 members traveled to Frankenmuth (a Bayarian town in northern Michigan) where we admired this small beautiful town. This summer the town is celebrating its 150th jubilee. We were happy to find our Lithuanian tri-color there. By the entrance to the store there are Christmas greetings in 200 languages. We found our Lithuanian "Linksmu Kaledu" there also.

All you can eat chicken dinner at the Bavarian Inn was topped by a serenading accordianist in

traditional garb - short leather pants with suspenders and hats adorned with feathers. We saw the number 150 in honor of the jubilee of the town made out of sand near a little castle. A scene of wooden statues depicted the Pied Piper of Hamlin legend. We checked out bake shops and wines and beers from around the world to take home to the hotel.

For a second group, nearly a dozen conventioneers carpooled to World Medical Relief, Inc. offices in Detroit to join in helping to sort and pack containers with various needed medical supplies and instruments. These are shipped to medical facilities abroad as well as homeless shelters in the metro Detroit area.

Here, K of L conventioneers got to witness first hand participation in the massive humanitarian assistance program of Aid To Lithuania, Inc. which has resulted in 11 containers (each the size of a trailer truck) delivered to hospitals, orphanages,

clinics, schools and even a church in Lithuania in 1994-1995.

At present, 54 IBM computers were being packed and made ready to be shipped out to Lithuania. It is hard physical work, and those who never observed this labor of love will be able to appreciate it more fully. It is hard to imagine how dedicated these people are and what great work "Aid to Lithuania is accomplishing".

# A BRIEF SPIRITUAL RETREAT by Mirga Diane Bablin

The opening convention Mass was held at the Sts. Cyril and Methodius Seminary on Thursday, August 10. Three loaded school busses made the thirty minute trek to the Polish/Lithuanian seminary where many priests studied earlier in this century. The day was a typically hot and humid one, as was most of our summer, and many of our Knights were grumbling and cranky on the trip there.

Once we arrived at the beautiful grounds, located in Orchard Lake, Michigan, we walked to St. Mary's Chapel, a beautiful and spacious church and marched behind the priests and flag bearers. Those of us who liked to sing formed a choir group near the accompanist.

Mass was celebrated by Rev. Dr. Joseph Anderlonis, our National Spiritual Advisor, with Rev. Gintaras Grusas, Secretary General of the Bishops' Conference of Lithuania and Rev. J. Walter Stanievich, former pastor of St. Anthony's Parish and former National Spiritual Advisor. The opening Mass was said for the intentions of the Knights of Lithuania.

Father Anderlonis' homily offered us some food for spiritual thought. He praised the K of L's dedication to helping both our own country and Lithuania. He cited the Knights motto, "For God and Country" and posed the question, "How do we work for God?"

He said each of us has a divine purpose for our existence and has an eternal destiny. We must give witness to the Lord, Jesus and live His values. Religion can be handled two ways, he added, begrudgingly or enthusiastically. We can work for God in practical ways by our enthusiasm and joy which has a ripple effect like a pebble thrown into water to uplift others.

Somehow the mood was more pleasant on the trip back to Novi where the business of our convention was to begin. The grumbling over the heat and the bumpy school bus ride was replaced by delegates chatting and singing.

# FIRST PLENARY SESSION

Following the presentation of colors, Supreme Council President, Evelyn Özelis called the meeting to order. Rev. Joseph Anderlonis opened the meeting with a prayer followed by the singing of the American and Lithuanian National Anthems and the Vyciu Hymnas. Agnes Mickunas, National Recording Secretary presented the roll call of the Supreme Council Officers. Lawrence Hofner, C-102 President welcomed the Knights to Detroit followed by Tim Baibek, Convention Chairman.

(MAD), Frank Bunikis (MCD) and John Skricki (NED); Resolutions Committee - Vincent Boris (Chairman), Frank Petrauskas, Theresa Strolia and Sr. Helen Ivanauskas; Mandate Committee - Rita Sussko, (Chair), Consuela Karchefsky, Georgiana Macke, Agnes Mickunas and Mary Beth Slakis; Greetings Committee - Robert Martin, Jr. (Chairman), Mirga Bablin, Nellie Bayoris Romanas and Isabel Peterson; Bertha Stoskus and Lillian Petravicius reviewed minutes from the last convention; Peter Zansitis reviewed parliamentary procedure.

President Evelyn Ozelis gave reports on the State of the Organization along with a report on her official trip to Lithuania.

A budget proposal for 1995-1996 was presented by Treasurer, Edward Barkowski followed by a personal greeting from Kestutis Jecius of the Lithuanian Scouts Association. Mr. Jecius presented President Ozelis a cassette of Lithuanian Scouting Songs and booklet.

Longinas Svelnis, Chairman of the Archives Committee, was congratulated for celebrating his 82nd birthday. He noted he was "as old as the Knights of Lithuania". The session ended with additional greetings, mandate report and a prayer.

# SECOND PLENARY SESSION

The convention provided an early Mass celebrated by Father Anderlonis. Sessions began with resolutions and a personal greeting by Michael

Aburius, President of the Lithuanian National Guard.

"The Re-emergence of the Catholic Faith in Lithuania" was the topic discussed by guest speakers, Sr. Igne Marijosyte and Father Gintaras Grusas, who were introduced by Tom Bruzga.

Sister Igne, Provincial of the Lithuanian Sisters of the Immaculate Conception, gave us a summary of what's been happening during the past five years in Lithuania. "There has been a re-emergence of faith, with an incredible movement of the laity, " she said. The six dioceses formed Catechetical centers, but lack

books and materials. A creation of 'Catholic Schools' began in Siulai, plus 'Catholic classes' have started in the homerooms of public schools. Another re-emergence since WWII is the Catholic press, with seven publications now in Lithuania.

Although assistance is received from other European nations, needs are still profound. The government expects the Catholic schools to receive aid from the West, while Vilnius Univ. summer institute is preparing teachers in religious instruction.

Many nuns took secular jobs as nurses, cooks, etc., during communism and lived in groups of 2-3. Now they must learn to re-adjust to community living, although they still fear that one may be an "infiltrator".

With freedom of religion also came an onslaught of other religious and cultish groups, from the Mormons to Hari Krishnas. Since people are eager to learn what they had been shielded from, these other groups are making inroads too.

Sr. Igne asked for continued support both financially through K of L supported groups and to LCRA. She also urged keeping the network of communications open, seeking English teachers in Lithuania and prayers.

Fr. Gintaras Grusas, General Secretary of the Lith. Bishop's Conference, residing in Vilnius, noted in his speech that faith never died in Lithuania. Citing the famous Hill of Crosses as an expression of Lithuania's faith, he noted that faith was moving "from a defensive posture" to a personal experience.

Fr. Grusas stressed the tensions existing in the Lithuanian Seimas, attacking the Church in the field of returning church properties. In Vilnius, for example, most priests do not have a rectory and live with relatives or in apartments.

Even if church property is returned, he noted, buildings are in severe disrepair and costs are skyrocketing. "\$40,000 was required to authorize the dig for restoration of property," he said. Plus the LDDP wants to equate cultist groups with traditional religions. Catholics are helping the other traditional Christian religions to retain rights. Although Lithuania boasts 76% Catholics, like America, church attendance is dropping with only 41% of the people believing in a personal God.

Fr. Grusas urged support of seminarians and the St. Casimir College in Rome. He also accented some of the positive. With a severe shortage of priests, the Church is creating three seminaries in Lithuania. New methods, such as radio and TV are being used to teach the masses. The New and Old Testaments of the Bible are being translated into Lithuanian for the first time. Pre Cana preparation for marriage conferences are being set up to help curb the high divorce rate. Food kitchens and support groups are being formed to enable the people to help themselves. A "not for profit" store was opened in Vilnius as a way to help finance a parish.

Questions were taken from the delegates. Most important, he ended, was to continue praying for positive change in Lithuania.

The session concluded with additional greetings, resolutions and mandate report. Luncheons were provided with special meetings for members of Aid to Lithuania, Inc. and K of L Foundation, Inc.

# THIRD PLENARY SESSION

Friday afternoon's session opened with a prayer by Fr. Anderlonis.

HM Robert Boris, Chairman of Aid to Lithuania, Inc. followed with a report. Bob noted that in 1990, four containers were shipped to Lithuania. During the past year, eleven containers were shipped, almost three times the amount shipped only 5 years ago. A container is the equivalent of a trailer truck size and each, according to Bob, costs approximately \$4,000.00 to ship. Although most of the items shipped are medical supplies, recently Mercy International Health donated 54 IBM computers that Bob will ship to Catholic schools in Lithuania. However, there are no printers with these and he is seeking to find a donor.

Bob had also been given 150,000 vials of Hepititis B vaccine valued at a half million dollars, which is despirately needed in Lithuania. However, this medicine must be sent via air, since there is a shelf life and it must be refrigerated. Bob was seeking the \$2,000 needed to ship it properly.

Aid to Lithuania, Inc. (ATL) realized a profit of almost \$8,000 from its 2nd Annual George Perles Golf Invitational.

ATL decided to sponsor a container to be shipped in October with clothes and Christmas gifts for orphans in the Utena area. Distribution will be supervised by the Srs. of St. Francis from Pittsburgh, now working in Utena. Bob thanked members for their continued support.

John Baltrus and Peter Zansitis then presented the Trustees report which included a bid from C-1, Brockton, MA for the 1996 National Convention. The Trustees also updated a list of the Supreme Council's equipment.

Vincent Boris read resolutions that were voted by the delegates which included a monetary grant of \$3,500 to offset administrative expenses for Aid to Lithuania, Inc. (See pg. 28)

Father Antanas Saulaitis, S..J., was the featured speaker during this session. He spoke on Lithuania today and offered an interesting example of how both a Lithuanian mother and father on separate occasions asked the priest to baptize their son. "It was a case of the parents not trusting each other," he added. Fr. Saulaitis informed us the European Bishops were discussing the huge influx of the "new age" movement (from Hari Krishna to Paganism) in former communist countries from former East Germany to Estonia. He said a system of education would be the best way to combat it. He then passed out an interesting questionnaire, a true-false test to help us understand that "voluntary aid means building bridges". The "test" included sections on

characteristics, cultures, Soviet heritage and ethnic matters and it helped us understand Lithuania today.

HM Loretta Stukas, of the Honorary Membership Committee presented Frank Petrauskas and Faustas Strolia for Honarary Membership who were voted unanimously.

The session concluded with additional resolutions including donations to Draugas, Darbininkas, Dirba and St. Casimir's Guild. A moment of silence was observed for past HM's Jack Sharkey and Jonas Valauskas. A prayer closed the meeting.

# FOURTH PLENARY SESSION

His Excellency, Paul A. Baltakis, OFM, Bishop for Spiritual assistance for Lithuanians residing outside of Lithuania greeted the delegates on Saturday morning's session. He informed us the that 7 deacons and 6 priests were recently ordained at the Lithuanian Pontifical College in Rome.

Bishop Baltakis said the College will continue to be a home for priests and students until Lithuania can prepare priests sufficiently to prepare others. Currently, there are 20 priests studying at the University to receive theological degrees. Stressing how badly Lithuania needs priests, the Bishop added that Lithuanian seminaries are not yet properly prepared for priests. "The mission is more important than before;" he stressed and desired to make the College at Rome better known.

One particular project at the Pontifical College in Rome is to update its library. It's being revamped and will have two floors which will hold a capacity of 15-20,000 books, including a section that concerns Lithuania. \$10,000 in pledges have been received for this purpose, he added.

Five new computers and a Volkswagon van were recently donated to the College. The Bishop thanked Ann Wargo and the St. Casimir Guild for the vestment fund donations and made an appeal for more K of L'ers to become benefactors.

New membership awards were then presented by 2nd VP, Robert Martin, Jr. He gave a special award to Elsie Kosmisky for helping organize C-156, Shanokin, PA with 21 new members. Council awards for councils under 75: 1st place C-19, 2nd - C-102, 3rd-C-153; 75-150 1st (tie) C-7 and C-141, 2nd-C-79;151 or over- 1st C-112, 2nd C-26, 3rd C-144. 1st place for individuals went to Maryte Sepikas, C-133; 2nd Albert Lesutis and a 3-way tie for 3rd of Clem Miller and Patricia Silk, C-141; Doris Spirmunas, C-7.

Fourth Degree candidates were presented by Ann Marie Kassel. (See pg. 25); HM Loretta Stukas gave the K of L Foundation report that included financial status, investments and specific projects such as the donation of "Learning English" books to the Priests Seminary in Kaunas. She also announced the essay contest winners (See pgs. 22-23).

Monsignor Algimantas Bartkus, Rector of the Pontifical Lithuanian College of St. Casimir in Rome, gave an address and thanked Anne Wargo and the St. Casimir's Guild for the \$10,000 check presented for the vestment fund. (See pg. 39)

He said the Knights of Lithuania are the backbone of Catholic support in Lithuania and noted that presently "Eastern Europeans are like sheep without a pastor."

Msgr. Barkus said there are 300,000 Lithuanian exiles in the former Soviet republics such as Poland, Hungary, Russia and Siberia. Most have no Lithuanian priests. The Monsignor will be flying to Siberia to assess the situation there. He said we should not forget those still forced to live in exile.

The convention site for 1996 was voted to be held in Brockton, MA for the second week in August. Chairman will be Veronica Bizinkauskas Cote of Council 1.

Resolutions, additional greetings and a mandate report concluded business. A prayer and singing of the Vyciu Hymnas followed.

survive. Chickens are a delicacy. They milk two cows to sell it to the co-op. Many like them lost their money in the banks, unless they saved American dollars. My cousin was able to pay for his cataract operation in Vilnius with the \$150. he had saved for four years.

Both sets of relatives live on opposite ends of Silute. They all remarked about children going hungry and dirty, parents without jobs who somehow find money to drink...a high rate of alcoholism, an outrageous situation.

On Sunday afternoon, I attended "Sekmines" in Rietava. A young priest, who had just been ordained the day before, blessed us as parishioners clapped. The beautiful choir sang from the opera, "Nabucco". Outside, candy was being sold as a tradition of Sekmines - pure sugar. A car was stolen that was parked next to ours, disasterous and heartbreaking.

Fruit carts along the main streets sell bananas to kiwis, but bananas are purchased for their cheaper price and higher nutrition. Some crazy drivers in new Mercedes, Volvos, Fords, Chevys and many used cars are seen on the streets which came as a surprise. I visited a supermarket, "Iki" whose shelves were stocked, but people seemed to look and not buy. Looking over the entire scene, I saw some progress, but only time and new elections will make a change.

Managed to get home via Newark, NJ. Thanks for the opportunity to get acquainted with Parliament, the political structure and the education.



# **RESOLUTIONS - NUTARIMAI**

# **CHANGES TO CONSTITUTION:**

# DISALLOWANCE OF PROXIES

WHEREAS the Knights of Lithuania is a non-profit Illinois corporation duly organized and operated under the laws of said state, and;

WHEREAS it has been established that under the statutes of the State of Illinois not-for-profit corporations are permitted to utilize proxies at membership meetings, and that the said statute further permits organizations to limit and disallow the utilization of such proxies, and;

WHEREAS it has been determined that the utilization of proxies is not conducive to the orderly and effective conduct of Knights of Lithuania meetings, and;

**WHEREAS** the requirements for prior approval by the Supreme Council and publication in VYTIS have been duly accomplished,

**BE IT RESOLVED** that the Constitution of the Knights of Lithuania (as revised and approved in 1994) be amended to add a paragraph to Article XIV to read as follows:

"10. Proxies may not be utilized at membership meetings."

# ACCEPTANCE OF NON-LITHUANIAN SPIRI-TUAL ADVISORS AS MEMBERS

WHEREAS several Councils and Districts of the Knights of Lithuania have experienced difficulties in securing a Lithuanian priest or member of a religious order to serve as Spiritual Advisor, and;

WHEREAS the constitution does not require that the Spiritual Advisor be of Lithuanian extraction, but only that he be the pastor or appointed assistant at the associated parish or as approved by the National Spiritual Advisor; and,

WHEREAS increasingly the accepted Spiritual Advisor is not of Lithuanian extraction and despite this official and very intimate relationship with the Council, the non-Lithuanian Spiritual Advisor cannot be fully integrated into the organization as a member,

BE IT RESOLVED that Article V, Section 1.b. of the Constitution of the Knights of Lithuania be amended to read:

"... be of Lithuanian extraction or the spouse of a member in good standing of the Knights of Lithuania, or be an approved, although non-Lithuanian, Spiritual Advisor of a Council.

**BE IT ALSO RESOLVED** that the first sentence of Article V, Section 2.c. be amended to read:

"An associate member may be a non-Lithuanian Catholic spouse of a member in good standing of the Knights of Lithuania or be a non-Lithuanian priest or ordained deacon serving as a Spiritual Advisor of a Council."

# **GENERAL:**

# **BUDGET ACCEPTANCE**

BE IT RESOLVED that the budget for 1995-1996 as submitted by the Supreme Council Treasurer be accepted as a guideline for the Supreme Council and with the understanding that a 5-person panel will be appointed by the Supreme Council President to review the overall funding levels and devise an approach to attain a balanced budget if feasible.

# K OF L REPRESENTATION ON CAMP DAINAVA BOARD

WHEREAS the Knights of Lithuania from its inception has been affiliated with the Lithuanian Roman Catholic Federation of America, a national

umbrella organization which is a corporate affiliate of the United States Catholic Conference; and,

WHEREAS the Lithuanian Roman Catholic Federation organized the Lithuanian Roman Catholic Federation Youth Camp "DAINAVA" in 1955 for the purpose of promoting religious and cultural activities among Lithuanian American Catholics and particularly young people; and,

WHEREAS the Board of Camp Dainava has representatives from Catholic organizations active in the United States, it is deemed mutually beneficial for the Knights of Lithuania, the largest lay Catholic Lithuanian organization in the United States, to be officially represented on the Board of Camp Dainava,

BE IT RESOLVED that we delegates to the 82nd National Convention of the Knights of Lithuania authorize the Supreme Council of the Knights of Lithuania to designate a representative to the Board of Camp Dainava, and, that upon the appropriate changes having been made in the by-laws of the said Camp Dainava, such representation be appointed thereafter on an annual basis by the Supreme Council.

BE IT FURTHER RESOLVED that the designated representative report annually to the Supreme Council and the National Convention on the activities and status of the Lithuanian Roman Catholic Federation Youth Camp "Dainava."

# **CHANGE IN IRS STATUS**

\*

WHEREAS the Knights of Lithuania, an Illinois not-for-profit corporation, currently has an exemption from the Internal Revenue Service under Section 501(c)(7) which primarily applies to a sport's league and/or a recreational organization; and,

WHEREAS it has been determined that the current activities of the organization are more accurately described under Section 501(c)(4) of the Internal Revenue Code as an organization engaged in social and civic activities for the public welfare; and,

WHEREAS it having been established by the Supreme Council that, for the good order of the

organization a change is its status should be sought in accordance with the above, the organizational legal counsel was instructed to proceed to take all necessary legal, technical and administrative steps to obtain a reclassification of the Knights of Lithuania as a Section 301(c)(4) organization.

BE IT RESOLVED that the we delegates to the 82nd National Convention of the Knights of Lithuania here assembled at the Novi Hilton Hotel, Novi, Michigan, hereby confirm the action of the Supreme Council and authorize the expenditure of such funds as are required to effect said reclassification.

WHEREAS in response to this invitation, the Supreme Council at their March meeting in Worcester Mass. did select the Supreme Council President to serve as such a delegate to the Commission meeting in Vilnius between May 28 and June 2 of this year; and the full report of this meeting has been submitted to this convention,

beneficial for the Republic of Lithuania and for our organization.





# THREE PERSPECTIVES OF LITHUANIAN FOLK CULTURE

It has become customary at our conventions to experience in sight and sound, in prose and poetry, or in participation and performance some aspect of Lithuanian culture. It is a tribute to the richness of our culture that offerings can extend from the beauty of operatic arias and classical musicianship (Washington '88; Chicago '94) to the plaintive re-enactment of folk stories by Lithuanian Summer Camp youth (Worcester '93).

In Detroit '95, new dimensions were introduced. First, came traditional folk dances aptly and ably performed by youth from Dayton, Ohio. A new dimension derived from the fact that only some of the dancers were of Lithuanian extraction; one was Latvian; most boasted of a mix of ethnic backgrounds; all were at least third generation Americans. One could not have surmised that fact from their dress or demeanor. All seemed to fully and equally enjoy the dancing. Their ease of movement and precision in the choreography could only have been achieved through hours of preparation and practice. Yet, a sense of spontaneity and frivolity permeated the performance to make it all the more enjoyable by the audience which indeed was captivated by the dancers.

The most captivating aspect of the Dancers from Dayton was the diversity of their ethnic backgrounds. We, Lithuanians have long boasted that the folk songs and dances were the jewels of our rich heritage. Too often, we have treated them just as such precious jewels - to be enjoyed in our own private vaults and put on display only as in a museum. But then "Vejelis" proved that folk

dances are not diminished in the least by sharing. Rather, by sharing, cultural appreciation is expanded and its longevity extended well beyond the immigrant generations.

After a short video tour of Lithuania, a second unique cultural perspective on Lithuanian folk life was seen This was short film of Lithuanian-American life in the 1920's. Unfortunately, it reflected many of the "flaws" of non-professional film production - overloud background clatter, stilted dialogue, choppy transitions between scenes, etc. It was produced by a prosperous Detroiter of Lithuanian extraction. based on an incident related by her grandmother concerning the days of Prohibition in Detroit.

It was a time when many Lithuanian immigrants those of other ethnic groups) found (and "bootlegging" or production of "bathtub gin" as the most accessible means of livelihood. At the time many women, widowed early in life by the untimely death of hard-working spouses, found that keeping boarders (usually newly arrived immigrants), allowing gambling in the dining room in the evening (from which the house could extract a percentage of the wagers) and "selling" home-produced liquor provided sufficient income to maintain the home and raise several children. The story concerned an incident where the woman was able to provide an

emergency resupply of booze to a local "blind pig". Later, she successfully hides her stash from agents of the "Purple Gang," a notorious Detroit mafia group that controlled alcohol trafficking.

Despite its shortfalls, this video won some critical acclaim and was shown at the Detroit Institute of Arts. For many of the delegates, it was nostalgic; a few similar tales were related later during the post-event socials. It may not have been a flattering depiction of Lithuanian life in the States; but it was valid for a small segment of early immigrant urban life.

Finally came the *piece d'resistance* - a video translation of a major motion picture produced in

Lithuania in the mid 1960's "Velnių Nuoteka" or "The Devil's Bride". The film won high critical acclaim (and several prizes). Based on a folk tale about a crafty miller who makes a deal with the "devil" to exchange the hand of his daughter (when she comes of marriageable age) in return for manually powering his mill. The story is mostly set at that critical time when the beautiful daughter has fallen in love with the local "hunk" but

faces the fulfillment of the father's earlier promise to the devil. The father, desiring his daughter's happiness, devises a plan to outwit the devil. He substitutes, for his daughter, a shrewish hag who so nags and discomforts the devil during the pre-wedding negotiations that the devil soon cancels the bargain and forswears his requirement to marry the daughter. After more mischief engendered by the devil, the story ends with the happy couple married and riding off into the sunset.

"Velnių Nuoteka" is set as a period piece (18th or 19th century ??) but is presented in the form of a light rock opera a la Clockwork Orange or Jesus Christ, Superstar. Elements of allegory can be viewed and interpreted in many ways. The film was the basis for long analytical discussions whenever shown in Lithuania. Imagine, the college kids, who saw this movie when it first came out, had lived their entire life and formative years under the Soviets and official atheism. Yet, on the screen was a marriage being performed by a priest and in another scene the miller and his daughter earnestly

pray to God for help and salvation against a background of "decadent Western rock" music.

As a Lithuanian folk-tale, the story presented stereotypical characters. The "devil" in Lithuanian folk tales is not the malevolent embodiment of evil so much as an impish mischief-maker. The miller is a wise and crafty Lithuanian peasant, who can get the best of any bargain. The daughter is the sweet virginal Lithuanian maiden. Her suitor is a typical Lithuanian "hunk" - handsome and vain but sturdy and brave.

The action which at first seems so incredible begins to make sense only within the context of the Lithuanian folk-tale genre. One prime example is

provided by the Devil - He is ensnared by the miller's net and after being outwitted by the miller spends time in the attic of the mill, propelling the rod that turns the millstone. The devil keeps his bargain, but it doesn't stop him from creating mischief particularly in preventing the would-be suitor from seeing the miller's daughter - bridges collapse, wheels come off the carriage, a collaborator is convinced by the

devil to steal the horses during the wedding ceremony so that the vows are not taken, etc.

Which brings us to the other example - why would a man abandon his beloved right at the point of taking the vows of marriage in order to pursue horse-thieves? But understanding Lithuanian folk wisdom, it is the essential aspect of a man to support his wife and family. If he has no means of support, then he has no right to take a wife. Therefore, it is logical that upon losing his horses, he would first attempt to recover them, regaining his ability to support a wife, before continuing with the ceremony.

Thus, through subtle inferences and allegorical action, the film offers a moral lesson in values. It is all the more surprising that it was produced in the darkest years of the Soviet period. To that extent it came as a reaffirmation of a statement made earlier by one of our featured speakers at the convention, Fr. Gintaras Grušas. He reminded us that throughout the long period of Soviet domination, Lithuanians had never lost their faith.

# GLEN E. HAYDON - 1995 FRIEND OF LITHUANIA

All the nominees for the "Friend of Lithuania Award" were suggested on the basis of their involvement with humanitarian aid to Lithuania as she recovers from the long half century of Soviet domination. The 1995 selectee is distinguished by not only what he has already done, but by an even greater potential that will evolve from the concept and groundwork already laid.

It was 40 years ago that the first "Friend of Lithuania" was named at the Knights of Lithuania Annual Convention Banquet by Father John Jutt, after whom the award is now named. Born in this country, he carried into all aspects of his life a very deep and vibrant love of his Lithuanian heritage and the land of his forefathers. The immediate post-World War II years, when most of the world was still rejoicing in the long awaited peace, Fr. Jutt recognized that there was no joy in our ancestral homeland. Communists were back in power and backed up by the occupying Soviet Red Army. The Lithuanian people were again subjected to the Stalinist program of genocide through deportation and Russification. The exhausted Western Allied raised no official protest.

Lithuania was born under his leadership to bring the situation in Lithuania to public attention though letters, Op-Ed pieces, demonstrations, etc. He soon noted that the cause of Lithuanian freedom attracted support and compassion from a number of influential and well placed non-Lithuanians. Fr. Jutt developed and implemented a proposal to recognize the efforts of these non-Lithuanians by

Christian charity. Each shared with us a concern for the plight of the Lithuanian people and manifested concern with action.

Lithuania reclaimed its independence in 1990 and the Lithuanian Affairs Committee has shifted its concerns to the problems and frustrations of Fr. Jutt was convinced that Lithuanian Americans could not complacently stand by in the face of this Western apathy to Soviet terror. His voice rang out clearly and convincingly - Lithuania would not be forgotten nor would the conscience of the West be allowed to be ignore the plight of the brave Lithuanian people. Thus, in 1946 the Lithuanian Affairs Committee of the Knights of reconstruction. Many of the previous techniques of public outreach and legislative lobbying are being employed to support aid in overcoming 50 years of Soviet suppression and depredation. Once again, we have found a tremendous amount of support from non-Lithuanians, who have freely and unstintingly given their time, talents and expertise to help Lithuania overcome the dark decades and prepare to enter the bright new millennium. Which brings us to today as I present to you a man whose personal credentials have entitled him to be designated as a Fellow of the American College of Healthcare In 1990, he began by Executives inquiries on the status of health care in Lithuania, if there was a need for outside help and what might be done.

Glen Haydon is the President of Mercy International Health Services a subsidiary of a Michigan based non-profit Healthcare system sponsored by the Sisters of Mercy Regional Community of Detroit. He serves as an educator and advisor to governments, religious congregations and individual hospitals, specializing in the areas of privatization, strategic planning. marketing. operations improvement, structuring of hospitals and health care systems. He has worked in Africa. Micronesia, Melanesia, the Middle East, Central and South America and Eastern Europe. Prior to coming to Mercy International, he had been involved with medical relief work for the International Committee of the Red Cross, disaster relief work for the United States government and the United Nations and has served as executive director of the American Red Cross.

Had we been in a position to search and hire someone for a long-term healthcare improvement project, I doubt that we could have found someone better qualified. I know that neither we nor Lithuania would been able to afford his services. Yet, providentially, he came to us and without recompense has worked these past five years with great effectiveness.

He began his involvement with detailed interviews of doctors from Lithuania visiting in the Detroit area. In this early period, he developed the concept of establishing a Catholic Hospital with modem technology and US standards in health care as well as physical infrastructure. In 1992, he made his first visit to Lithuania to gain first hand knowledge of the situation. In addition to visiting several health care facilities, he met with the Minister of Health as well as Cardinal Sladkevicius to assess their willingness to support the project. Both reflected reservations and demurred from enthusiastic full support.

Having seen the hospitals, Glen was convinced of the need and recognized the lack of enthusiasm from government and Church leaders as coming from factors other than nonrecognition of the need for improvement in healthcare. Undaunted, he has persevered in refining the concept, developing a plan for implementation and laying groundwork for the eventual funding of the project. Subsequent visits

to Lithuania were successful in gaining both official government and church endorsement of the project.

By obtaining a grant from the Emily George Foundation, Mr. Haydon conducted a seminar on healthcare systems for senior members of the Lithuanian Ministry of Health in October of 1993. It was at that time the Government was developing their first post-Soviet overall plan for organizing Lithuanian healthcare. There can be no doubt that the subsequently promulgated blueprint for Lithuanian healthcare was influenced by this seminar.

Additionally, Mr. Haydon now sits on the Advisory Board for Aid to Lithuania, Inc, and has become involved in furthering the efforts of that program. as well. Thus, in many ways, Mr. Glen Haydon has demonstrated a real concern for the welfare of Lithuania devoting much time, talent and effort to a most significant project to aid Lithuania. I am most gratified to name him "Friend" and present him as our 1995 Friend of Lithuania - Glen E. Haydon.

## September Dates to Remember:

- Feast of the Nativity of Mary, also called "ŠILINĖ" in Lithuania. The feast is closely associated with Our Lady of Šiluva. It marks the beginning of an eight day atlaida at Šiluva, which is the major religious festival in Lithuania; it attracts faithful by the 10,000's. The Nativity of Mary has been celebrated by the Eastern Church much longer than in the Western (Roman) Church. It was incorporated into the Latin liturgy at the end of the seventh century by Pope Sergius I. In the nineteenth century, its date was used to fix December 8 as the day for the Feast of the Immaculate Conception.
- Sept 12 Feast of the Holy Name of Mary. Following normal Jewish practice, a newborn babe was named within the octave of birth, thus the feast of the Holy Name of Mary was inserted into the Church calendar within the octave of the feast of the Nativity. Observance of the feast had began in Spain in 1513. In 1683, Pope Innocent XI extended the feast to the whole Church in thanksgiving to our Lady for the victory of John Sobieski, King of Poland and Grand Prince of Lithuania, over the Turks who were besieging Vienna and threatening the West.
- Sept 15 Feast of the Seven Sorrows of the B. V. Mary. The third great Marian feast in this month commemorates the sufferings of Mary and of the Church. Depiction of the Sorrowful Mother is very popular in Lithuanian folk art.
- Sept. 23 Commemorative day in Lithuania, on which attention is drawn to the Holocaust in Lithuania. Over 90% of the Jewish population of Lithuania (in 1939 they constituted 17% of the overall population) were killed at the hands of the Nazis.

## In October:

Oct 2

Feast of the Guardian Angels. In the Old Testament, it is recorded: "I am sending My angel to go before thee and guard thee on thy way, and lead thee to the place I have made ready for thee." Our Guardian Angel is commissioned to protect and defend us always against the cunning enemies of our soul and all adversities, so that we may reach the promised land of everlasting life. As our faithful companion, we owe our angel our gratitude; as a pure spirit enjoying the vision of God in heaven, we owe our veneration.

Oct 4

Feast of St. Francis of Assisi, one of the greatest saints. He took the Gospel quite literally and followed Christ as closely as possible. He had several followers to whom he gave his rule but more importantly imbued them with his spirit. Thus was born one of the world's greatest religious Orders, the Friars Minor. Then, with St. Clare, he founded a counterpart Order for women. Lastly, came the "Third Order of Penance" which was to include lay people. Francis of Assisi died on October 3, 1226 and was canonized by Gregory IX less than two years later.

Oct 9

"Discoverer's Day" - a National Holiday in the US commemorating the valiant explorers that discovered and opened up the New World and Continents. Expanded from the simple observance of Columbus Day, it is also transferred from the traditional Oct. 12., the date on which in 1492 he first set foot on the territory of the "New World."

Oct 11

On this date in 1962, the Vatican II Council began. Among the major accomplishments of this Council was the revision of the Liturgy with the introduction of the use of the vernacular in the Mass and other Sacraments. The Council ended on Dec 8, 1965.
