

Knights of Lithuania 83rd National Convention State of the Organization Report presented by Evelyn Ozelis, National President - August 8, 1996

In accordance with Article XI of the Knights of Lithuania Constitution, I submit to the Delegates of the 83rd National Convention, the National Executive Board's Annual Report. Wherein, all reports have been submitted and combined before the National Convention. It is important to note that this is but a summary of the work done by your Executive Board. The officers have provided reports of their activities. You are urged to take home a set of these reports, read them, thoroughly and share the contents with your council members.

Spiritual Advisor, Dr. Joseph Anderlonis, S.T.D., has attended all Supreme Council meetings, except the Chicago meeting in June. His priestly and pastoral duties prevented his presence. The Knights of Lithuania are most grateful for his counsel and guidance throughout the year. He has continued the monthly policy of offering a mass for all deceased members, in particular, those names submitted by various councils. Father has hosted the Supreme Council meeting in October with the assistance of Council 3, Philadelphia. Not only is he our Spiritual Advisor, but also our very best friend.

President, Evelyn Ozelis, organized four meeting and presided over all. Meetings were held in Philadelphia, Pittsburgh, Chicago and Detroit. The able assistance of host councils for these meetings was most appreciated. They were all most gracious and accommodating. There has been much correspondence from various organizations, and Knights of Lithuania members as well. All correspondence was acknowledged. I re-appointed the business manager and the editor for VYTIS with the approval of the Supreme Council for the year 1995-1996. Initiated several new projects such as Resolutions Revision Committee with 30 years of resolutions, Budget Resolutions Committee. I represented the K. of L. at a "Draugas" fund raising banquet, Lithuanian American Council Conference, an award dinner for Ambassador A. Eidintas, the Feb. 16 Commemoration in Chicago, were I greeted

in Lithuanian and English. Received invitations to attend Feb.16 Commemorations in Washington, D.C. and New York City. Unable to attend, I acknowledged the significance of this special date with a letter in Lithuanian. I greeted the Ateitininku Federation as they were honored by the Mid America District. I was a member of the Honorary Committee for the 40th Anniversary of the Lithuanian Opera of Illinois.

I met with the Brockton Convention Committee and kept very close contact for all convention arrangements. I appreciated their courage and fortitude for a grand convention time. I have remained active with my council and district, representing the Knights of Lithuania as a Director with the Lithuanian Chamber of Commerce, and am the Lithuanian American Council Vice President. I am also a Eucharistic Minister for the Lithuanian mass at my home parish.

I conferred with all Supreme Council officers for various reasons. Their opinions and suggestions were most appreciated. I have been fortunate to have an outstanding Supreme Council. For this I am grateful.

This June 30, three women of the Chicago area were awarded "Outstanding Lithuanian American Women" by the prestigious Chicago Lithuanian Woman's Club, and I was honored to be one of them. We were selected for our outstanding work with the Lithuanian American Community and our other organizational works.

I will be in Lithuania this September and intend to represent the Knights of Lithuania while visiting church dignitaries and others.

One of my saddest obligations this year was to preside at the wake and funeral of First Vice President, Tom Bruzga. We lead him to his final resting place as a true Knight of Lithuania.

<u>First Vice President</u>, Tom Bruzga, attended 3 meetings during his term. He was the chairman of the newly appointed Resolutions Revision

Committee. Tom attended to his job with much enthusiasm. He was a most able assistant to the president. Tom was very active with his council and district. He kept contact with other members of the Supreme Council on matters relevant to the business of the Knights of Lithuania. Rest in peace, Tom!

Second Vice President, Robert Martin, Jr., attended all Supreme Council meetings. He has been working diligently to promote membership to the Knights of Lithuania in spite of the fact that he was attending evening classes. He managed to complete the membership pamphlet and the convention hosting manual. Rob has been active with his council and district. He also is an active member of the Mid America District Knights of Lithuania Choir. Rob has been a board member of the Supreme Council for 6 years.

Third Vice President, Elena Mikalauskas, is a very capable and energetic young lady with her work with and for the Juniors. Elena has written articles for VYTIS for her Juniors. She herself has come up from the ranks, as a Junior, and today has shown how well she can work with the youngsters. Her road has been a difficult one, as there were times when there was a lack of communication from the Junior Councils. She has planned good Junior convention activities.

Recording Secretary, Agnes Mickunas, has served her position as National Secretary extremely well. She is an asset to our organization. She found time to make arrangements for our meeting in Philadelphia. Her minutes were precise and always sent out on time. Agnes has willingly obliged to send out council rosters and mailing lists whenever other Supreme Council members had made their requests. Agnes has always been a straight forward person, and never hesitated to address you with her statements. The president has been extremely fortunate to have Agnes as secretary. She never hesitated to give of herself. With all of her secretarial duties, she prepared letters of greetings to the many organizations to our 83rd national convention. Aciu Agute!

Treasurer, John Baltrus, attended all but the Chicago meeting. He is extremely knowledgeable and scrutinious in this job. He has kept constant contact with me and also with our legal advisor. John has kept an unrelenting vigil on our finances. has prepared He the budget from the recommendations of the Budget Resolutions Committee and his own findings. He will present a complete report of our financial standing at this convention. He has served untiredly for this past year and has been very cooperative! A job well done

Financial Secretary, Dorothy Banos, participated in all but one Supreme Council meeting. This is her first time as Financial Secretary and she found it a challenge. She has kept contact with the Business Manager of VYTIS so that changes would be implemented as soon as possible. She has not hesitated to cooperate and work with all councils. She has kept all lines open for communication. Dorothy has done a fine job.

Trustees, Mary Beth Slakis and Mark Bell have done a thorough job in scrutinizing the financial books of the various committees within the Supreme Council. They are both young, energetic, outspoken and have accounting backgrounds. Relentlessly they pursued bid requests for the 1996 and 1997 conventions. And they were successful! Mark volunteered to find a way to put the K. of L. Manual on computer disk; Mary Beth worked with the Budget Committee. These two trustees have done an outstanding job and are to be commended. They have attended the Supreme Council meetings and have offered suggestions and opinions for the betterment of the organization.

Amber District, John Mankus, President of the District, is Chairperson of the Supreme Council Nominating Committee and has been in constant contact with district presidents to complete the nomination slate. He has been working with aid to convents and hospitals in Lithuania at a local level. The district councils have four monthly pickups for humanitarian aid to Lithuania. His district council have participated in ethnic festivals, spring festivals and at other events. His council sets goals for various fundraisers. John continues to translate letters from Lithuania. He has been a very cooperative member of the Supreme Council.

Mid America District, Peter Paul Zansitis, District President, attended all the Supreme Council

meetings. The Mid America District established the District Recognition Award. The first awards will be given at the Sept. 28, 1996 district meeting in Chicago. The Mid America District voted to donate equally to the K. of L. charities at the 83rd National Convention. The Mid America District also supports the Mid America District K. of L. choir and dancers. The dancers have participated for the past 50 years at the "Christmas 'Round the World" program at the Chicago Science and Industry Museum, United Airlines and others. The choir has participated at five different programs . They have also produced the Lithuanian Catholic Heritage video tape of Lithuanian Catholic parishes past and present in the Chicago area. The choir is now preparing for its 80th anniversary celebration slated for October 1996.

<u>Mid Atlantic District</u>, Ed Barkowski, District President, was involved with hosting a basketball game between the Lithuanian all-stars and Siena College in the Albany area. Siena's basketball coach was so impressed with the team from Lithuania, he spoke with its coach and offered one year scholarships to four students who have arrived. Hudson-Mohawk Council 136 is providing moral support for the students and the council periodically checks with them. Edward was selected to be the Budget Resolutions Committee Chair and is also a member of the Resolutions Revision Committee. He has aided Apolonia Ziausys of C-100, Amsterdam, with the shipment of scores of packages of medical supplies to Lithuania.

<u>Mid Central District</u>, Lillian Petravicius, attended all but one Supreme Council meeting. No report has been received at this time. The district and councils have set goals at various events and fundraisers. I am sure that their obligations have been met. There will be a complete report from the District at the 83rd National Convention.

New England District, Bertha Stoskus, District President attended all Supreme Council meetings. Two semi-annual New England District conventions, the first in September at Worcester, MA, hosted by Council 26. Twelve councils attended with a total of 140 delegates, clergy, honorary members and guests. Fourth degrees were awarded at the Mass. The Spring Convention was

held in Ansonia, CT, hosted by Council-135. Twelve councils attended with a total of 109 delegates, clergy, religious, honorary members and guests. The District had the annual fund raiser at Maironis Park. It was a tremendous success. Their Annual Retreat at the Franciscan Monastery in Kennebunkport, Maine, was well attended with 90 people present. I appointed Bertha Stoskus as 1st Vice President as a result of vacancy due to the death of Tom Bruzga, with the approval of the Supreme Council. I also asked Bertha to take on the Chairmanship of the Resolutions Revision Committee. She most willingly obliged!

Archives Committee, HM Longinas Svlenis has not been able to attend Supreme Council meetings. Larry has been able to procure a larger room for our archives at Alka. He has been to the archives rooms several times and had their committee meetings there. He has received valuable material but asks that you send material directly to Alka Museum in Putnam, CT, and not to Larry's home in Needham. The Archives Committee will have a display at this convention highlighting several of our past leaders and honorary members. Larry and his committee are to be lauded for their dedication in maintaining the archives.

Legal Advisor, Saulius Kuprys, was able to attend only one Supreme Council meeting in Chicago. He has filed all required reports with the appropriate government agencies to which the corporation must report. He has filed information return 990 to the Internal Revenue Service as required. An annual report to the secretary of the State of Illinois renewing our corporate status was sent. Mr. Kuprys maintains contact with the subsidiary corporations of the Knights of Lithuania. He has always responded to various miscellaneous matters which have come up from time to time. He has maintained contact with the President.

<u>VYTIS Editor</u>, Maryte Abbott, was appointed VYTIS editor by the President with Supreme Council approval. She is grateful to everyone who has given her assistance, constructive criticism and their time. She has done much to enhance VYTIS readers. VYTIS - the Knight, is a classic publication. Maryte has set many goals and has met a quite a few. She will continue to astound us with

her professionalism. Her council news editor is Dalia Bulvicius. Maryte and the business manager keep in constant contact. There are still some problems with the post office, production and other technicalities, but they will be worked out in time.

VYTIS Business Manager, Richard Niedvares was appointed VYTIS business manager by the President with the approval of the Supreme Council. He has kept in contact with Maryte Abbott, the editor, and Dorothy Banos, the Financial Secretary for a smoother operation. Richard has attended three meetings with the auditor of the U.S. Post Office in Chicago. Richard and I spent three hours with this auditor each time we were called in. Richard has spent hours with our legal advisor. An application through our legal advisor, is currently being presented to the postal service to amend the category under which VYTIS - the Knight magazine is being distributed. If approval is granted, this will the alleviate some of administrative and bureaucratic burdens with which the business manager is saddled with. He has invoiced all advertising. New guidelines for this position of business manager are available in the revision of the K. of L. Manual. This is a full time job!

<u>Cultural Committee</u>, John Mankus, chairperson continues to send out cultural articles to districts. He has contacted council and district members for cultural information feedback. John has translated many poems and articles for VYTIS. He is also chairperson of his council's humanitarian shipments to Lithuania. John is a talented individual and he willingly shares these gifts with us.

Honorary Membership Committee, HM Loretta Stukas, chairperson attended every meeting except one. Honorary membership will be conferred on Archbishop Paul C. Marcinkus and Alexander Akule during the 83rd National Convention Brockton, at MA. Honorary Membership Chairman, Stanley Vaitkus died on July 25, 1996. Please remember him in your prayers. There are currently 30 living honorary members, 17 men and 13 women. Councils and districts are invited to submit names of outstanding members for honorary membership. You must follow the guidelines printed in the Knights of Lithuania Manual. Also write to the Honorary

Membership Committee for information regarding presentation of a candidate, if necessary.

Lithuanian Affairs Committee, Vincent Boris, chairperson, attended all Supreme Council meetings this term. For quite a while now Vince has been preparing us for his resignation as Chairperson of Lithuanian Affairs. Each time I asked him, "Are you sure this is what you want to do." His contributions to VYTIS on various subjects is most gratifying. If you are in need of information on most subjects, he will find it. Vince has been involved as a representative for JBANC (Lithuanian American council member). He has widespread knowledge of world political affairs and contacts at most governmental levels. He has a magnitude of accomplishments and has shared his time. information and energy with us.

Lithuanian Language Committee, Dr. Virginia Vaitekonis Obando, chairperson, has attended two Supreme Council meetings. She has written articles for VYTIS and has translated articles that will be forthcoming. She has conducted sessions of a Lithuanian heritage hour for her council members and their children. Virginia is consulting members of several councils on Lithuanian language learning strategies. Virginia has done numerous translations for Knights of Lithuania members. She is an asset to our organization.

Public Relations, Regina Juska, chairperson, attended all Supreme Council meetings. The Knights of Lithuania activities were all covered with almost a weekly article in all three U.S. Lithuanian newspapers. Regina has translated articles for K. of L. Foundation, Aid to Lithuania and others. She prepared five articles for the 83rd National Convention events. Regina has never declined to assist whenever and wherever needed. She has taken on many responsibilities and has followed through on all of them.

Ritual Committee, Nellie Bayoras-Romanas, chairperson attended all but one Supreme Council meeting. She has fulfilled her duties and has conducted this committee quite well. She has received 14 applications for the fourth degree and is awaiting confirmation of eligibility. Nellie always kept in contact with the President and her committee members for clarification on different issues. She

continues to offer her assistance whenever needed.

Scholarship Committee, Maria Deksnis, chairperson attended all Supreme Council Meetings this term. Being a school teacher, Maria recognizes the need for young people to continue their education. She has worked very thoroughly with her committee members. She anticipates good support this year for the scholarship fund. I have had much contact with Maria. She is a very capable chairperson. With the help of the Knights of Lithuania scholarship fund, we are helping qualified young persons to further their education.

Aid to Lithuania, Inc. HM Robert Boris, chairperson, attended all but one of the Supreme Council meetings. Bob once again successfully initiated the third annual George Perles Golf Tournament this year. The proceeds of \$15,000 will be used for shipping necessary supplies to Lithuania. Through June of 1996, 38 containers of medicine and medical supplies have been provided for Lithuania. Bob's professionalism as vice president of sales (before retirement) is portrayed in his accomplishments with Aid to Lithuania, Inc.

K. of L. Foundation, Inc., HM Loretta Stukas, chairperson attended three Supreme Council meetings this term. The finances of the Foundation will be announced at the convention. As usual, the Foundation sponsors an essay contest. The winners will be announced during the convention. This year the foundation arranged to outfit 35 members of the Lithuanian order of Sisters of the Eucharistic Jesus. These sisters worked underground to prepare the Chronicles of the Catholic Church in Lithuania during the occupation. The fabric material was donated, and many Foundation and K. of L. members donated personally to this cause. The money was used to sew their habits, also, shoes, medication and some money to use in making needed repairs to their building. Donations from the general membership are needed on a regular basis to guarantee the tax exempt status of the Foundation. Loretta has contributed articles to VYTIS and is member of the Budget Resolutions also a Committee.

St. Casimir Guild, Inc. HM Anne Klizas Wargo, chairperson, was unable to attend any of the Supreme Council meetings for this term. On behalf of the Lithuanian Pontifical College of St. Casimir in Rome, Anne asks for continued support both financially, with mass requests and spiritually. The mass requests are forward to Rome each month along with the mass stipends. These masses support the student priests and the Priests at the college, since they do not have any other income. Anne has untiredly given of herself for this special guild. Anne is in constant touch with Msgr. Bartkus in Rome.

<u>History Books</u> - Frank Petrauskas has done a tremendous job on inventory of the few remaining books. The Supreme Council has voted to eliminate the cost of books and they are available to all at the annual convention.

Summary

I was pleased with the executive board members voted in by the delegates last year. We have had a very busy year. We initiated a few new projects and completed the old projects. My thanks to the members of the National Executive Board who attended the meetings and were faithful to the duties of the offices they accepted. A special thanks to our deceased member, Tom Bruzga. He worked so well!!

Looking over the Financial Secretary's report, I note that we had a total of 4,296 members for the year 1995. This year we are minus 117 members. The motto of the 83rd National Convention was "Pakelkime Balsus! Lift our Voices!"

Our convention began with on a beautiful day with an opening Mass at St. Casimir's Church in downtown Brockton. Ten priests celebrated the Mass including the area Bishop, John McCormack. Juniors dressed in Lithuanian costumes led the procession. Music featured a operatic solo by Maryte Bizinkauskas. The Mass was offered for God's blessings on our upcoming convention endeavors.

FIRST PLENARY SESSION

Supreme Council President, Evelyn Ozelis called the convention to order following the presentation of colors and Supreme Council Officers. The opening prayer was led by Rev. Dr. Joseph Anderlonis, National Spiritual Advisor, and delegates sang the American and Lithuanian National Anthems, A warm welcome to Brockton was given by Veronica Bizinkauskas. President of C-1, Maryte Bizinkauskas and Veronica B. Cote, Convention Chairpersons. Brockton's Mayor, Jack Yunits, who is of Lithuanian ancestry, spoke of the early Lithuanians in the area who were shoemakers,

tanners, and factory workers. The mayor noted the changes in the city of 100,000 people through the years and told how his own children were educated at St. Casimir's School.

Nominees for the Convention Presidium Officers were: Presidium Chair, John Mickunas; Co-Chairs, Fran Petkus and Robert Martin, Jr.; Secretaries, Barbara Schmidt and Bernice Aviza; Sgts. at Arms, Andy Kereiga (Amber), Glenn Perulis (MAMD), Joe Stelmokas (MAD), Brian Johnson (MCD) and Sylvester Marcavage (NED). Resolutions Committee, Vincent Boris (Chair), Terry Strolia, Frank Petrauskas, Sr.

Helen Ivanauskas and Fr. Volkovicius; Mandate Committee, Dorothy Banos (Chair), Georgiann Macke, Ann Marie Kassel, Agnes Mickunas and Irene Svekla; Greetings Committee, Isabel Peterson, Mary Kincius and Anna Helen McDonald; Elsie Kosmisky and Eleanor Vaicaitis reviewed the minutes from the previous convention; Peter Zansitis reviewed parliamentary procedure.

President Evelyn Ozelis gave her report on the State of the Organization. A budget proposal for 1996-1997 was presented by Treasurer, John Baltrus, and accepted by the delegates.

Additional greetings, a mandate report and prayer concluded the session.

SECOND PLENARY SESSION

Sr. Marilyn Kuzmickus, Mother General of the Srs. of St. Casimir, spoke of the need for the canonization of Mother Maria Kaupas, foundress of the order. Petitions were passed out and signed. The sisters also featured a table with information and copies of a children's book, *Kaze's True Home*, on the life of Mother Maria Kaupas. (See story in Jul./Aug. VYTIS.)

In recognition of the 50th anniversary of the formation of the Lithuanian Affairs Committee,

this morning's session was scheduled to feature a panel discussion regarding Lithuanian Affairs. In an earlier session, the 1996-97 budget, approved by the Supreme Council and adopted by the convention carried a zero budget for Lithuanian Affairs. After a quick adjustment, the panel focused on alternatives. The panel was led by retiring SC Lithuanian Affairs Chair, Vincent Boris and included Pranus Ciziunas, Operations Manager for the Joint Baltic-American National Committee (JBANC), Mark Bell, SC Trustee and C-96 Dayton member, and Maryte Abbott, VYTIS Editor-in-chief and member of C-110, Maspeth, NY.

Mr. Ciziunas explained that JBANC is a 35 year old organization in which representatives of the three Baltic-American Organizations, the Estonian American National Council, the Latvian American Association and the Lithuanian American Council maintain an office in Rockville, MD, with two paid employees to staff it. It is a liaison between these Baltic groups and Congress, the White House and the Administration. JBANC produces a periodic "Legislative Update" reporting the status of Congressional bills in progress that is available by fax, E-mail or postal mail. They also publish a quarterly newsletter, JBANChronicle which covers Baltic issues from a Washington perspective for a \$20 subscription fee. JBANC is also establishing a WebSite to provide action items and a list of current events. Call Pranus at 301-340-1954 for details.

Mark Bell, a Lithuanian-American activist who lives far from a Lithuanian enclave, discussed problems and solutions to maintaining current information on events in Lithuania. He shared a number of Lithuanian Internet addresses, which can be accessed via home computer or a local library that is on-line. He also spoke of the new English language weekly, Draugas, and the Baltic Times, also published on a weekly basis in Riga as sources.

Maryte Abbott rounded out the discussion with a proposal for future Lithuanian Affairs Committee people that focuses not only on political action but also on pro active advocacy for Lithuania. By promoting tourism, cultural information and encouraging investment and by widening our scope

into non-Lithuanian media, such as Catholic publications, travel and specialty magazines, she pointed out vehicles to get the message of Lithuania out. She suggested the use of VYTIS as an initial vehicle to hone writers skills and for those who don't like to write, to speak with radio talk show hosts.

Later action reinstated some funding to continue Lithuanian Affairs. An unprecedented amount was donated also at the Greetings desk, giving hope for the future of the Lithuanian Affairs Committee.

Following a closing prayer, special luncheon meetings were held for Aid to Lithuania and the K. of L. Foundation.

THIRD PLENARY SESSION

This session opened with a prayer and a report by the Trustees.

Robert Boris, president of Aid to Lithuania, Inc. gave his report on the activities of ATL during the year. The 3rd Annual George Perles Golf Tournament raised almost \$16,000.00 for ATL in July, enabling the shipment of much needed Hepatitis-B vaccine. Bob noted that the late Tom Bruzga, past 1st VP, had left 10% of his estate to ATL, Inc. and was thankful for Tom's generosity.

Bob said that besides much needed donations, Lithuanian hospitals are in need of bedsheets, vitamins, baby food, sanitary supplies, soap, ear thermometers, and other medicines.

A panel discussion entitled "K. of L. Reminiscing for Revitalization" featured Eleanor Sluzas and Loretta Stukas who described each decade and what the Knights were active in during the time. Eleanor broke out in song during this "lighter side" discussion, while Loretta gave a brief synopsis of what the Knights were actively engaged in during each decade such as the visit to the Knights by Blessed George in the 1920's, the California convention in the 1950's, the shrine at the NY World's fair in the 1960's, the acceptance of non-Lithuanian spouses in the 1970's and many other exciting activities. Eleanor and Loretta had the delegates laughing, naming the tunes and in a good mood following their panel. Delegates were also asked to fill out a questionnaire.

Nominations were then held for Supreme Council Officers. Resolutions, greetings and a

mandate report were made. The afternoon session was closed with a prayer by Fr. Anderlonis.

FOURTH PLENARY SESSION

Eligible fourth degree candidates were presented by Nellie Bayoras-Romanas. (See page 20 for list).

Robert Martin, Jr., 2nd Vice President, gave awards to councils and individuals who helped to increase membership. (See page 9 for listing.)

HM Loretta Stukas gave her report on the K. of L. Foundation and named the essay contest winners. There were 13 entrants and 6 winners. (See p. 14 -15 for winners and 1st prize essay.)

Elections were held for Supreme Council officers for 1996-1997. See inside cover for full listings of names and addresses.

Following the closing prayer and adjournment, a special luncheon meeting was held for the St. Casimir's Guild.

FIFTH PLENARY SESSION

Following a special greeting by Fr. William Volkovich, the St. Casimir Guild Report was given by Anna Klizas Wargo, president of the Guild. Anna reported that \$15,000. was forwarded to the Pontifical College from donations received in 1995.

From July 1, 1995 through June 30, 1996, 334 Mass requests were received. The requests along with the stipends of \$10.00 each are sent to Rome each month and used by the student priests who have no other income. There were 20 student priests this year attending the college.

The St. Casimir Guild will be planning a pilgrimage to Rome in March 1998 for the 50th anniversary celebration of the Pontifical Lithuanian College in Rome. More information on this special journey will be available early in 1997.

Anna Wargo thanked all who donated to the St. Casimir Guild financially and through their prayers during the year and at the Greetings desk.

Juniors gave their report and were awarded their conventionship stipends of \$25.00 each by Elena Mikalauskas, 3rd VP, Juniors. (See pg. 16.)

Following a brief discussion to maintain fiscal responsibility by Spiritual Advisor, Fr. Joseph Anderlonis, discussion followed on whether or not to accept the recommendations made by the budget committee to cut monetary resolutions. The delegates agreed to accept most of the budget committee's recommendations in a close vote with plenty of arguments both pro and con. Monetary donations that remained the same as 1995 (last year) were: St. Casimir's Guild at \$1,000.00, LRCA at \$100.00 and the Junior's conventionship stipends at \$25.00 each. The following were cut: Lithuanian Catholic Children's Relief from \$1,000.00 to \$500.00, Darbininkas and Dirva from \$200.00 to \$100.00; The Sisters of Jesus Crucified, Srs. of St. Casimir, Srs. of St. Francis of the Providence of God and Srs. of the Immaculate Conception from \$200.00 each to \$100.00 each; Aid to Lithuania's request for a \$3,500.00 operating budget for 96-97 was cut to \$500.00. An Amendment was made by Bernice Aviza for the Lithuanian Affairs Committee to provide \$300.00 to their operating budget, following the budget committee's original recommendation of zero. Last year's Lithuanian Affairs resolution was for \$1,500.00. An amendment was also made for Draugas, following the budget committee's recommendation to grant \$100.00 to the newspaper. The VYTIS editor's recommendation to provide four no-cost guarter page advertisements to promote the new English language edition in lieu of any payment, was approved. In total, the budget resolutions committee and delegates reduced monetary resolutions from \$8,775.00 in 1995 to \$3,275.00 for this year. (See Resolutions section elsewhere in this issue.)

Next year's convention site was selected at Dayton, Ohio with C-96 as our hosts. HM Fran Petkus and Eleanor Sluzas gave the delegates pre-convention publicity, emphasizing the room suites available and the sites proximity to the U.S. Air Force Museum and other local attractions.

VYTIS editor, Maryte Abbott presented the first annual Council News and Writer's awards. Certificates were presented to: Fran Petkus (C-96), Marie Lasky (C-74) and Vincukas (C-10) for council news and Ed Baranauskas (C-100), Antonia Wackell (C-116) and Vincent Boris (C-102) for articles and poetry writing.

The convention sessions were concluded with greetings, mandate, announcements and a closing prayer.



Freedom ... the word creates images of life as an individual, following one's personal path. While the idea is fundamental to some, to others it is frightening. The people of Lithuania have fought for freedom for fifty years. During that time, the Knights of Lithuania have also been fighting for Lithuania's freedom, as well as fighting to keep alive the customs and cultures of the country. Now that freedom has been achieved, the focus of not only the K of L, but also of Lithuania, must be changed. Lithuania needs to find a point of where and how to develop in order to become a competitive country. Since its independence, they have been offered many things; financial assistance, technological resources and nutritional aid However, this support has not always been delivered. (ATL) is affiliated.

Catholic Medical Mission Board, NY, provides the medicine while ATL covers transportation charges and arranges distribution in Lithuania.

"This partnership of CMMB and ATL has provided more urgently needed medicine for charitable distribution throughout Lithuania than any other group so far," said Mr. Boris.

Since some medicines have a shelf life, and the Lithuanian Ministry of Health cannot accept past dated medicines, Mr. Boris emphasized that monetary help is still needed. "It would be a sin to turn down medicine being offered, simply because we lack funds to provide transportation," he said.

2. Article X, Section 2, which now reads, in part: " ... editor and the legal advisor are appointed by the Supreme Council and are nonvoting members of the Supreme Council." will read: " ... VYTIS editor, VYTIS business manager, and the legal advisor are appointed by the Supreme Council and are nonvoting members of the Supreme Council. "

3. Article XI, Section 8, which now reads, in part: "The appointed members of the Supreme Council are the VYTIS editor and the legal advisor." will read: "The appointed members of the Supreme Council are the VYTIS editor, VYTIS business manager, and the legal advisor."

4. Article XI, Section 8, will have an added subsection c. to read; c. The VYTIS business manager handles the mailing, subscriptions, advertisements and other business matters of VYTIS.



When there's little hope... there is always St. Jude!

In early September, if you live in or near Baltimore, you begin to see ads in the Newspapers and hear spots on radio; all advertising the start of the Solemn Novena in honor of St. Jude, whose feast day is observed on October 28. The Solemn Novena begins nine weeks earlier. This devotion to the Patron Saint of hopeless causes or impossible situations continues one of the oldest and yet strongly enduring religious traditions of the Universal Church. How St. Jude became recognized as the prime intercessor for hopeless causes seems to be lost in antiquity. Yet, it is an ancient tradition which has endured possibly because St. Jude has proven to be a most powerful and effective advocate.

Little is known about St. Jude. He was one of the original twelve selected by Jesus as His disciples. Yet, while three of the four Gospels include him in an enumeration of the Apostles, there is no recorded information on when or how he was chosen. He has been identified as one of the "brethren" of Jesus suggesting a blood relationship.

The name, Jude, by which we know him is an anglicized version of Judas; it was adopted very early to avoid confusion with Judas Iscariot, the one who betrayed Jesus into the hands of the soldiers in the Garden of Gethsemane. In the Gospels, he is also referred to as Thaddeus and as the brother of James, the Lesser. By tradition, it is believed that it was St. Jude who asked Christ the question, "Do you intend to show yourself to us and not t o the



world?" In response, Jesus answered, "If anyone loves me, he will hold to my words, and my Father will love him, and we will come to him, and make our home with him."

The activities of St. Jude after the ascension of Christ are also little known. It is believed that he embarked on the evangelization of the East and spent preaching in much time Persia. According to ancient texts, he was joined in this mission by St. Simon, another of the twelve and with whom he shares this feast day in the Roman calendar. Both were martyred in Persia. It is believed that St. Jude was crucified in the territory of present day Armenia which, at that time, was part of the Persian Empire.

St. Jude's significance for us today rests largely in his advocacy for the resolution of impossible causes. It should be noted that it was through his question, that Jesus provided affirmation of that most consoling truth: that the Trinity dwells in the souls of the just.

Convention Banquet features Friend of Lithuania Award Winner and New Honorary Member



Sr. Margaret John Kelly, D.C. accepted the 1996 Friend of Lithuania, presented by retiring Lithuanian Affairs Chairman, Vincent Boris award at the convention banquet on Saturday, August 10. Sr. Kelly is the Board liaison at St. John's University and noted modestly that the University itself should have been given the award along with other members of her committee.

The major achievement which led to the award is Sr. Kelly's coordination of the Bernadine Complex, an extensive 4.2 million dollar project which will renovate a centuries-old complex located in Old Town Vilnius. The complex includes the former Church of St. Michael, the old convent and workshop of the Bernadine Sisters, who occupied it since the mid fifteenth century. The restoration plans will create a Lithuanian heritage center which will include classrooms, cultural and commercial activities. Sr. Kelly is supervising the business proposal, the project timetable, managing the architects, and the fundraising activities. She is also working closely with the Peace and Justice Commission at the Vatican, the United Nations and trustees of St. John's University to make this project a reality. Present timetables indicate. The Bernadine Complex to be completed in 1999.

Sr. Kelly also recommended a program for St. John's University of NYC to send professors to Vilnius University and have them teach business and ethics to Lithuanian students. Sr. coordinated the program in 1992 and it is ongoing today. Each college semester two St. John's professors teach at the University of Vilnius. Recently, one of the professors received a Fulbright Scholarship to teach in Lithuania.



Although Knights were disappointed that Archbishop Paul C. Marcinkus did not attend the banquet to accept his Honorary Membership award, Alexander Akule, the other candidate, from Council 17, South Boston, was on hand along with his family to receive this special degree.

Mr. Akule tearfully gave an acceptance speech thanking the Knights for this great honor. He thanked his wife, Pat, for encouraging him to join the Knights in 1947. He has been an active member of the K. of L., participating in council activities as well as parish activities at St. Peter's Lithuanian parish in South Boston. Mr. Akule has held many council, and New England District offices, including NED president for three consecutive terms.

First Lady Visits East and Central Europe

On August 22, 1996, the First Lady, Hillary Rodham Clinton, met with a number of East and Central European representatives and East/Central European-American activists for a one-hour slide show with personal commentary by Mrs. Clinton and featuring scenes from her recent visit to several Central and East European Countries. Mrs. Clinton stated that the trip had been planned to further demonstrate United States solidarity with, and concern for, all the emerging democracies in the area, even though not all the countries

could be visited. Her itinerary included Romania, Hungary, Poland, the Czech Republic, Slovakia and Estonia. Each stop featured a traditional welcoming presentation of bread and salt by children in national dress; a protocol visit with governmental leaders and

in some cases with the leadership of women's activist groups. Each segment ended with a tour of a local hospital or orphanage. Hospitals in each of the visited countries are benefiting from a "sister hospital" program being conducted under the aegis of USAID. In each case, a hospital is paired with a comparable American health facility and involves an exchange of personnel (doctors, nurses, technicians, administrators). The scope and intensity of the exchange is mutually agreed upon by the two participating "sisters." Following the slide presentation, the group moved to the White House for a reception which allowed individuals to meet personally with the first Lady.

(Side note: No! Lithuania does not participate in this AID-sponsored program and will not qualify for participation until "Health Care" is formally established as a National Priority requirement.)

Dates to Remember:

- Sept 8 Feast of the Nativity of Mary, also called "*ŠILINĖ*" in Lithuania. The feast is closely associated with Our Lady of Šiluva. It marks the beginning of an eight day *atlaida* at Šiluva, which is the major religious festival in Lithuania; it attracts faithful by the tens of thousands.
- Sept. 23 Commemorative day in Lithuania, on which attention is drawn to the Holocaust in Lithuania. Over 90% of the Jewish population of Lithuania (in 1939 they constituted 17% of the overall population) were killed at the hands of the Nazis.
- Oct 2 Feast of the Guardian Angels.
- Oct 14 Feast of St. Francis of Assisi, Founder of one of the world's greatest religious Orders, the Friars Minor. Then, with St. Clare, he founded a counterpart Order for women. Lastly, came the "Third Order of Penance" which was to include lay people.
- Oct 9 "Discoverer's Day" a National Holiday in the US commemorating the valiant explorers that opened up the New World and Continents. Expanded from the simple observance of Columbus Day.
