

Meet New K. of L. President, John R. Mankus



John R. Mankus

When John Mankus realized he was elected to the office of President of the Knights of Lithuania at the convention on Aug. 9, his initial reaction was tears of joy. John, from Binghamton Council 72, will be the K of L president for a three year term, ushering in the new millennium.

John was born on March 9, 1939 in Alytus, Lithuania, the eldest son of a police chief and schoolteacher, and has two younger brothers. His family fled the Communists during WWII and lived in Displaced Persons camps in Germany until arriving in the U.S. in 1949. Settling in the Binghamton, NY area, John completed high school and was accepted by IBM Corp. into the Tool and Die Apprentice Program. Later, he completed college and rejoined IBM in the engineering area.

In 1963, John married Grace Moughan and they later became the proud parents of three sons and one daughter. His family has always been involved with Lithuanian activities, whether through Saint Joseph's Church or the American Civic Association. He participated in many Lithuanian Independence Day Commemorations, radio and TV interviews and celebrations prior to joining the Knights of Lithuania.

Since the forming of Council 72 in Binghamton NY, John has worked tirelessly to make C-72 a viable member of The K of L. He has held council offices as: President, VP, Vytis correspondent, Cultural Chair and Lithuanian Language chair and chaired numerous committees. In addition, working with Saint Joseph's Parish, he has coordinated aid shipments (420 packages) to convents, hospitals, clinics, orphanages and needy families in Lithuania. As a result, monthly package pickup has been established in Binghamton by Viltis Lithuanian Relief Parcel Service (Boston).

Being fluent in Lithuanian, John served as a translator for letters, numerous articles and manuals and has acted as an interpreter for Lithuanian basketball teams visiting Binghamton.

During the Soviet occupation, John organized demonstration activities against the Russian occupation of Lithuania.

John has been Amber District President and National Cultural Chair, contributing numerous articles on Lithuanian history, culture and language, and council activities for VYTIS.

He has been a lector and Eucharistic minister at Saint Joseph's Church, Binghamton, NY, for over twenty years.

John received six US and International Patents in the Electronic Connector field at IBM and received numerous engineering awards. He has also coached youth baseball, basketball and track teams. In 1995, he was awarded the "Outstanding Official of the Year" Award as VP of Southern Tier N.Y. State Track and Field Association.

When asked why he wanted to take on the Presidency of the K of L, John replied, "I'd like to have a personal hand in strengthening the K.of L."

Kniches of Lichagnia 84th National Convention State of the Organization Report

Presented by EVELYN OZELIS NATIONAL PRESIDENT August 7, 1997

In accordance with ARTICLE XI, SECTION 2 of the Knights of Lithuania Constitution, the National Executive Board's Annual Report, wherein, all reports have been submitted and combined before the National Convention. It is important to note that this is but a summary of the work done by your Executive Board. The officers have provided reports of their activities. I urge you to take home a set of these reports, read them thoroughly and share the contents with your council members.

SPIRITUAL ADVISOR, Rev. Dr. Joseph J. Anderlonis, S. T. D., attended only two meetings, Philadelphia and Dayton on Wednesday Aug. 6. Father was always here to advise and counsel K of L members and, especially, the Supreme Council. But this year, we were in a state of frenzy due to his severe illness. We are so fortune today that he is in our midst and has recovered. Our many prayers did not go unanswered. Dėkojame Dievui!

PRESIDENT, Evelyn Ozelis, organized four meetings and presided over all. Meetings were held in Brockton, Philadelphia, Dayton and pre-convention Dayton. The host councils for these meetings were very accommodating and extremely gracious. As usual, there has been much correspondence from various organizations and Knights of Lithuania members as well. correspondence was acknowledged either by letter, fax or telephone. I reappointed the business manager and the editor for VYTIS with the approval of the Supreme Council. Also requested that Father Anderlonis remain as our Spiritual Advisor and Saulius Kuprys as Legal Advisor.

We were able to accomplish some of the goals, such as Constitution Revision committee, Resolution Revision committee and Revenue committee. Established an Internet Website and

computerized the K of L manual. At the invitation of C-90 Pres.. J. Nakrosis, I attended the dedication of the Wayside Cross in Kearny, NJ. I attended the JBANC conference in Washington, D. C. in place of our Lithuanian Affairs Chairman who was assigned to Korea for a month. I wrote to each District president requesting information on the status of each of their councils. The response was very good. We must assist each other, not compete with each other. Met with Ambassador A. Eidintas in Chicago for a special conference and briefing on the situation with Lithuania for NATO and conditions in Lithuania. Also, was briefed by Major Sarapinas, Military attache, while in Chicago. Also, attended a special reception for Prof. V. Landsbergis. While in Lithuania last fall, I attended a commemoration at the Kaunas Medical clinic honoring my deceased father in law and was introduced not only as a family representative, but also as the President of the Knights of Lithuania (visų žinoma garsusis Lietuvos Vyčiai).

I represent the Knights of Lithuania as a director for Margutis Radio II, Lithuanian Chamber of Commerce, as an elected officer of the Lithuanian American Council, at the national and local levels. I have attended all of my District's meetings, am active in my council and also in my parish. This Convention committee has been very cooperative and have extended many kindnesses to me. They are well organized, considerate and enthusiastic! I attended the wake and funeral mass in Detroit for Vincent Boris how do you say good-bye?..... until we meet again.

FIRST VICE PRESIDENT, Agnes Mickunas, has been a most able assistant to the President. This year her assignment was to check out all the amendments to the K of L constitution that were approved by the delegates since its revision in 1994. As efficient as Agnes was to the Supreme Council as recording Secretary, she carried this onto her new assignment. Every time I

needed assistance in all matters, Agnes was right there. The next president is indeed fortunate to have her as a teammate.

SECOND VICE PRESIDENT, Robert A. Martin, Jr., attended all Supreme Council meetings. Unfortunately, this past year has not been one of our best with regards to membership. He was not able to sign any new councils nor see an uptrend of membership. Robert is an active member of his district and council. He is also a very active member of the MAMD Choir.

THIRD VICE PRESIDENT, Maria Deksnis completed her first year as Juniors' chair. She has been very active in trying to organize new Junior Councils. A new Junior council was started at C-72 in Binghamton, NY. She has written articles for VYTIS, sent information packets to Junior Councils encouraging them with special projects. Maria is a school teacher and certainly knows how to work with youngsters well. I hope that she will continue to be enthusiastic with this job!

RECORDING SECRETARY, Bernice Aviza attended all of the Supreme Council meetings. This is her first term as Secretary and she is doing an excellent job. There are new routines, new methods of doing things and she has proven herself. Bernice is very active with her District as Vice President for Juniors and active with her own council. She has been a very obliging individual. She has computerized Council Presidents and Supreme Council officers names to be able to generate mailing lists and labels when requested.

TREASURER, John Baltrus has attended all Supreme Council meetings. He has prepared the budget from the Budget Committee which he will present at this convention. He has also organized a Revenue Committee which will present a panel at one of the convention sessions. John keeps close watch on the financial needs of the K of L. He has been in close contact with me and also with our legal adviser. He has proven himself time and again for his dedication to the K of L. John, you are a gem!

FINANCIAL SECRETARY, Dorothy Banos participated at three Supreme Council meetings. She has met the challenge for the second year and has done well. Any changes that

had to be implemented were done quickly. She kept almost daily contact with the Business Manager of VYTIS. She did not hesitate to call me for any discussions that were needed to clarify a point. Her cooperation was extended to all councils and all persons. Good job!

TRUSTEES, Mary Beth Slakis and Mark H. Bell have been a great team. They have worked together to update the K of L Manual. As members of the Revenue committee, they are looking to the financial future of the K of L.

They will be auditing the various books of the ancillary committees. Both Mary Beth and Mark have contributed to the discussions during the Supreme Council meetings. Mary Beth has received one bid for the 1998 National Convention (that's her job) and Mark has worked with Agnes Mickunas to develop an Internet Website. In spite of all their jobs, they manage to keep everyone's spirits up!

AMBER DISTRICT, John Mankus, President of the District, with the cooperation of his councils, has been working with VILTIS LITHUANIAN RELIEF SERVICE and Vilnius Cathedral Religious Center by sending packages to selected needy families. They have established a monthly pick up in Binghamton for Humanitarian Aid to Lithuania. John continues to translate letters from Lithuania and to coordinate Lithuanian cultural presentations and language lessons. His district has been very active in participating at Christmas Festivals, Aid to Lithuania, Ethnic festivals and aid to convents, orphanages and hospitals in Lithuania. Everyone is a noteworthy cause.

MID AMERICA DISTRICT, Peter Paul Zansitis, President of the District, has established the Awards Recognition. Awards were given at the September Assembly in Chicago and at the May assembly in Kansas City, MO. The District sponsors their annual February banquet at which they honor an individual or organization that has done outstanding work for Lithuania and also here in the U.S. This District also supports its Choir and Dance Group. They have many projects forthcoming!

MID ATLANTIC DISTRICT, Edward Barkowski, President of the District, attended all



S.C. meetings except April in Dayton. He and his councils have created a caravan in the Fall and also in the Spring to bring much needed supplies to Lithuanian Children's Relief in Wessley, Massachusetts, where they are merged and shipped to Lithuania. His council had an eyewitness account of the tragic confrontation at the TV Tower in Lithuanian on January 1991. A Lithuanian exchange student gave this report at the C-136 Independence Day commemoration. A true representation of patriotism.

MID CENTRAL DISTRICT, Elena Mikalauskas, President of the District, and her councils have kept their Bowling Tournament alive and well. This is very reminiscent of the past Midwest tournaments that brought everyone together. Elena responded to my call for letters to the government and also to my request on how to encourage and further participation in the K of L. Six of the eight councils remain active. The District is well represented on the Supreme Council. Elena offers many fine suggestions.

NEW ENGLAND DISTRICT, Bertha Stoskus, President of the District, attended all but one of the Supreme Council meetings for 1996-1997. As of June 30, 1997, Bob has sent out 49 shipments valued at \$45,820,124.00 at a COST of \$248,642.00. He has received numerous donations from other organizations in response to his requests. Bob also received the CATHOLIC HUMANITARIAN Award from the Catholic Federation in Chicago. The monetary award was donated to ATL. Congratulations for a magnificent job.

K. of L. FOUNDATION, INC., HM Loretta Stukas, President attended all but one Supreme Council meeting. 84th National Convention Sessions Dayton, Ohio- Hugust 7-10, 1997

The motto of the 84th National Convention was Tikėjimas - Šeima - Kilmė...Mūsų Stiprybė Faith - Family - Heritage...Our Strength

Our convention began with a beautiful cool August 7th day and an opening Mass at Holy Cross Church in Dayton. Father Michael Holloran, Spiritual Advisor of C-96, Fr. Joseph Anderlonis, SC Spiritual Advisor and Fr. Tony Markus, C-112, Chicago officiated.

As usual, Father Joe did not disappoint us with his homily. Stressing the convention's motto: Faith, family, heritage our strength, Father said we should be proud of our roots in humble ways. Our links to the world's oldest living language, our blessings and crosses in tears and blood and the promise of a democracy in Lithuania should make us be proud to be Lithuanians.

FIRST PLENARY SESSION

Supreme Council President, Evelyn Ozelis called the convention to order following the presentation of colors and Supreme Council Officers. The opening prayer was led by Rev. Dr. Joseph Anderlonis, National Spiritual Advisor, and delegates sang the American and Lithuanian National Anthems.

A warm Midwestern welcome to Dayton was given by Robert Pant, President of C-96. He noted that at Dayton's last national convention 21 years ago, he was only a 5 year old. "It took a village to raise this child," he quipped.

Nominees for the Convention Presidium Officers were: Presidium Chair, Evelyn Ozelis; Co-Chairs, John Mickunas and Edward Barkowski; Secretaries, Barbara Schmidt and Ann Marie Kassel; Sgts. at Arms, Steve Soha (Amber), Richard Niedvares (MAMD), John Sakal (MAD), Brian Johnson (MCD) and Larry Svelnis (NED). Resolutions Committee, Robert Martin, Jr. (Chair), Teresa Strolia, Mary Kincius, Bertha Stoskus and Clemencine Miller; Mandate Committee, Dorothy Banos (Chair), Georgianna Macke, Agnes

Mickunas and Doris Snirpunas; Greetings Committee, Isabel Peterson, Lee Moore, Sophia Sakalys, Jean Mihalick and Helen Karpovich. John Mickunas, Frances Petkus and Robert Martin reviewed the minutes from the previous convention; Peter Zansitis reviewed parliamentary procedure.

President Evelyn Ozelis gave her report on the State of the Organization. The Treasurer's report and budget proposal followed. A budget proposal for 1997-1998 was presented by Treasurer, John Baltrus, and accepted by the delegates.

Additional greetings, a mandate report and prayer concluded the session.

SECOND PLENARY SESSION

Sr. Helen Ivanauskas, CJC, spoke on behalf of Lithuanian Children's Relief (LCR) and thanked the Knights for helping to support this cause. LCR helps orphanages, institutions and poor families in need of food, clothing and medicines in Lithuania.

John Mankus, National Cultural Chair gave an insightful report on the first Lithuanian Book by Martynas Mažvydas *Vaikunas* in 1547, as a part of the 650th anniversary which proclaimed 1997 as the "year of the book".

The Ritual Committee gave their report as a special panel led by John Mickunas, Ritual Chair. John handed out a 15 page report of the point system used by the K of L and answered questions from delegates on degree points.

Following a closing prayer, special luncheon meetings were held for Aid to Lithuania and the K. of L. Foundation.

THIRD PLENARY SESSION

This session opened with a prayer and a report by the Trustees.

Robert Boris, president of Aid to Lithuania, Inc. gave his report on the activities of ATL during the year. The 4th Annual George Perles Golf Tournament raised nearly \$15,000.00 for ATL in July and continues to be a successful endeavor. To date, ATL has shipped \$45 million dollars worth of medicines to Lithuanian hospitals, including donations to soup kitchens helping the poorest. He thanked the Knights for continued support.

The Trustees report was given followed by a special panel discussion by the Revenue Committee on ways the Supreme Council can raise funds. (See pg. 13) Bertha Stoskus then gave a report from the Resolutions Revision Committee (See pg. 24)

Nominations were then held for Supreme Council Officers. Resolutions, greetings and a mandate report were made. The afternoon session was closed with a prayer by Fr. Anderlonis.

FOURTH PLENARY SESSION

Robert Martin, Jr., 2nd VP, gave awards to councils and individuals who helped to increase membership. (See page 16 for listing.)

Eligible fourth degree candidates were presented by John Mickunas. (See page 18 for list).

HM Loretta Stukas gave her report on the K. of L. Foundation and named the essay contest winners. There were only 4 entrants this year and the response was disappointing, but those who did enter wrote very good essays. (See pages 14-15.)

Mrs. Stukas spoke of reaching \$100,000. in the Foundation as a goal for the Millennium.

Elections were held for Supreme Council officers for 1997-1998. Our new K of L president, elected for a three year term is John R. Mankus from C-72, Binghamton, NY. See page 3 for more

about John and inside cover for full listings of elected SC officers names and addresses.

Following the closing prayer and adjournment, a special luncheon meeting was held for the St. Casimir Guild

FIFTH PLENARY SESSION

The St. Casimir Guild Report was given by Anna Klizas Wargo, president of the Guild.

Anna reported that donations received from July 1, 1996 to June 29, 1997 amounted to \$10,941. and during that same time period, 347 Mass requests were received. The requests along with the stipends of \$10.00 each are sent to Rome each month and used by the student priests who have no other income. There were 20 student priests this past year, plus regular priests, attending the college.

The St. Casimir Guild is sponsoring a pilgrimage to Rome in March 1998 for the 50th anniversary celebration of the Pontifical Lithuanian College. (See back inside cover for more details.) Anna Wargo thanked all who donated to the St. Casimir Guild financially and through their prayers.

Msgr. A. Bartkus of Rome addressed delegates stating that next year most of the priests attending the Lithuanian Pontifical College will be returning to Lithuania. He added that three seminaries are now operating in Lithuania, with a fourth to follow soon. He invited K of L'ers to Rome for the 50th Jubilee and thanked them for support.

The Juniors gave their report and entertained delegates with a comedy skit. They were awarded their conventionship stipends of \$25.00 each by Maria Deksnis, 3rd VP, Juniors. (See pg. 17.)

Next year's convention site was selected as Waterbury, CT with C-7 as our hosts. Council 7 representative, Joe Stiklius, added that dates would be August 6-9, 1997 and it would be held at the Sheraton Hotel in Waterbury. The pre-convention tour would be to the newly built Foxwoods Casino and Juniors would enjoy a visit to Mystic Seaport. Mark your calendars.

The convention sessions were concluded with greetings, mandate, announcements and a closing prayer.

REVENUE PANEL

A panel held on Friday afternoon presented the results of the Revenue Committee's efforts to provide viable suggestions for ways the Supreme Council can raise additional revenue in the coming years. The revenue would be used to continue funding current projects or in order to take on new projects. The committee's mandate was provided at the previous National Convention after several years of deficit spending resulting in severe cuts to a number of K of L expenditures.

The panel consisted of chairman and Supreme Council Treasurer, John Baltrus; the two Trustees, Mary Beth Slakis and Mark Bell; and member, Rita Sussko. The committee included these panelists plus Robert Martin, Richard Niedvares, Marion Hobitz and John Mankus. Most members met at the Philadelphia and Dayton Supreme Council meetings and there was extensive correspondence by mail. Suggestions for raising revenue were generated by the committee members and also solicited from all members through VYTIS. All suggestions were considered and voted upon by the members. The top four suggestions were presented by the panel.

Mary Beth Slakis discussed the sale of Christmas Cards by K of L members. Several options were presented including the quality of cards and whether artwork could be done by members or districts. The logistics of distributing and selling the cards were also discussed. Profit margin would depend on the quality of the cards and the amount of customization. There was concern that the cost of the cards might discourage purchase and focusing on a single occassion may limit sales. Delegates suggested broadening the scope to include all-occasion cards or changing the concept to selling note cards with a K of L cover design. The best we could do with this project is raise approximately \$2,000.

Mark Bell discussed raising funds by having a national raffle. Prizes could be cash or a trip to Lithuania. The profit margin would depend on the number of tickets sold and the value of the prizes. Tickets would be assigned to the districts to

distribute to members. Assigning two tickets at \$1 each per member would gross approximately \$8,000. The legality of such a concept was questioned and would have to be researched. Other Lithuanian organizations have taken this route.

Rita Sussko discussed the option of charging dues for spouses. Currently spouses pay no dues while two non-married members living in the same household pay \$7.50 over the base dues charge of \$15. per single. If spouses were to pay the \$7.50 charge, dues revenue would increase by approximately \$7,500. provided there would be no loss of membership.

John Baltrus discussed setting up a special fund prior to the National Convention. Members could make donations from \$1. to \$10. to the fund, the contents of which would be used to supplement annual donations approved by the National Convention. Those donations were severely cut back in 1996 and then rose approximately \$1,000. this year. All donations would be anonymous and it would be a way for those who normally can not attend the convention or afford to make large donations to support these worthy causes.

Many excellent comments were received from the delegates once all four ideas were presented. The delegates were then polled on the suggestions by a non binding show of hands. supplemental dues for spouses idea received by far the most support. The greeting card and raffle ideas were next best received and had about the same support while the idea of small donations received the least support. It was emphasized that this was just an exercise to determine what avenues to pursue should additional revenue become necessary. Given the fact that the past fiscal year had a positive balance in revenue, there was no immediate need to implement any of the ideas. However, they will be presented to the Supreme Council for their action, should a financial crises arise in the near or distant future.

The Revenue Committee thanks all members who had taken the time to make suggestions, especially those who responded to the earlier article in VYTIS.

St. Casimir... An Appropriate Saint for The Knights of Lithuania

Edward Baranauskas, C-100 Hon. Mention

St. Casimir was of Lithuanian origin. This should be one of the reasons for considering him to be the appropriate Patron Saint of the Knights of Lithuania.

Historical facts show that not one of his ancestors was a descendant of Poland. Genealogical records prove that.

Grand Duke Gediminas was his great, great-grandfather. He was the Grand Duke of Lithuania, and also the ruler of the Grand Duchy of Lithuania.

When Gediminas died, Algirdas, one of his six sons, succeeded him, Algirdas was the great-grandfather of St. Casimir.

It was the wish of Algirdas that Jogaila, his son, take his place when he passed away. Algirdas was married twice, His first child, with his second wife, was Jogaila. He was the grandfather of St. Casimir.

When Jogaila, the Grand Duke of Lithuania, married Queen Jadvyga of Poland, he became the King of Poland. She died shortly after giving birth, and their daughter lived for only a few days.

Jogaila married twice more, and was widowed twice. His daughter, by his second wife, passed away at a young age.

Jogaila was married, for the fourth time, to Sophie, the daughter of Lithuanian Prince Andrew, ruler of the principality of Kiev. Her mother came from Ukrain- ian royalty, but Polish historians called Sophie a Lithuanian princess.

They had three sons, but their second child died as an infant. When Jogaila died at the age of

Like the recently departed Mother Teresa, St. Casimir rejected all riches, remained celebate, wore meager clothing and devoted himself to the sick and poor.

84, his first son succeeded him and was crowned King Ladislas III at the age of 10. He died in battle against the Turks.

Casimir, their sole surviving son, was crowned Grand Duke of Lithuania at the age of 13, and six years later became King Casimir IV of Poland.

King Casimir IV married Princess Elizabeth of Austria. They had eleven children.

Their third child, and second son, was named Casimir. He was born in Cracow, the capital of Poland. He died on March 4, 1484. He was canonized by Pope Leo X, but the exact date is not known. Casimir became the Patron Saint of Lithuania.

In 1518, a large Moscovite army threatened to occupy the Lithuanian fortress of Polotsk. A small group of Lithuanians came to defend the city and the castle, but were unable to cross the swollen Dauguva River. Suddenly, a rider on a white horse appeared, wearing a white cloak with his sword held high. He led the charge across the river, and the tide of battle was turned.

Those who fought were convinced that they had seen the apparition of St. Casimir. The nuncio accepted this as well founded.

St. Casimir defended the Lithuanians in their hour of crisis. His example should encourage all of us to help Lithuania, politically as well as economically.

This is the second reason why St. Casimir is an appropriate Patron Saint for the Knights of Lithuania.






