Supreme Gouncil Report

Presented by JOHN R. MANKUS NATIONAL PRESIDENT August 7, 1998

In accordance with Article XI of the Knights of Lithuania Constitution, I submit to the Delegates of the National 85th Convention, the National Executive Board's Annual Report. Wherein all reports have been submitted and combined before the National Convention. Please note that this is but a summary of the work done by your Executive

Board. The officers have provided reports of their activities. You are urged to take home a set of these reports, read them and share the contents with your council members.

Spiritual Advisor, Monsignor Dr. Joseph Anderlonis, S.T.D. Father Anderlonis was elevated to Monsignor on June 14th, 1998. I know that every member of the Knights of Lithuania extend to Monsignor Anderlonis their hardiest congratulations. Monsignor Anderlonis has been an outstanding spiritual leader and advisor to the Knights of Lithuania for many years. The Knights of Lithuania are most grateful for his counsel and guidance throughout these years. He has enriched us both spiritually and culturally He has continued the monthly policy of offering a mass for all deceased members, in particular, those names submitted by various councils.

President, John R. Mankus, I organized and presided at all Supreme Council Meetings. I sent out letters to Father Albert Contons, President of Lithuanian Roman Catholic Priest League of America for approval of Father Anderlonis as

I also sent letters of greeting and congratulations to President Valdas Adamkus, Monsignor Dr. Joseph Anderlonis S.T.D.and to many Lithuanian American Organizations, in Lithuanian and English. At District and Council level, I attended all Amber District meetings and

was invited and attended both Mid-Atlantic District meetings in Maspeth and Brooklyn, NY. Prior to stepping down as Amber District President, I chaired and presided at the Amber District meeting on September 14, 1997. I attended many special events at council level, including Lithuanian Mass at Saint Ann's Basilica, Scranton Pa.

In September 1997, I was added to State University of New York, Binghamton translation board for Lithuanian translations and as an interpreter. During the past year I translated many letters from Lithuania. As president of Supreme Council I received a large number of correspondence from various sources and responded to all, by letter and/or when appropriate by phone. Many of these items I discussed with Supreme Council members and at the Supreme Council meetings.

At the end of last year, the Vytis Editor's computer malfunctioned and could not be repaired, with the approval of Supreme Council new equipment was purchased. The equipment has been received, is on line and is functioning well. I am happy to report that no VYTIS issues were late or

lost because of this problem.

I participated in the trip to Rome on the occasion of the 50th jubilee of the Lithuanian Pontifical College. Wrote letters in Lithuanian of greeting on behalf of the Knights of Lithuania. Participated at the Jubilee Mass, banquet and open house at the Lithuanian Villa. I gave a short congratulation speech, also in Lithuanian, to Msgr. Algimantas Bartkus and guests at the banquet and exchanged greetings with Lithuanian priests and bishops attending the jubilee.

As I reported in the Vytis, I attended the Baltic Charter signing at the White House on January 16th. The following day I met with Republic of Lithuania President Algirdas Brazauskas, Foreign Minister Algirdas Saudargas, senator Richard Durbin, Ambassador Stasys Sakalauskas, United States Ambassador to Lithuania Keith Smith and many other U.S. and Lithuanian state officials. I communicated to District Presidents that Lithuanian Embassy staff would be happy to be invited and participate at District meetings and other K. of L. events.

I conferred with all members of the Supreme Council on a variety of issues, including membership, updating of mailing list, finances, Vytis printing and mailing, our legal obligations. Friend of Lithuania selection, convention preparation and activities at the Lithuanian Embassy. I also communicated on a number of occasions with Draugas administrator Valentinas Krumplis on quality and punctuality of Vytis.

Representing the K. of L., I attended Lithuanian Independence Day Celebration at the Lithuanian Embassy in Washington D.C. and several informational meetings with Embassy staff and leaders of Lithuanian American Organizations. On March 28, all Embassy staff met with presidents of seven leading Lithuanian American Organizations. During the meetings, all discussion was in Lithuanian. Visiting members of the Seimas (Lithuanian Parliament) joined the meeting. Since Lithuania has been isolated from the diplomatic arena for fifty years, one of the main task of these Seimas visits and Embassy meetings is to establish good working relationships between the Lithuanian Embassy, Lithuanian American Organizations, Seimas and US government officials.

First Vice President, Agnes Mickunas, attended all S. C. meetings. Agnes is doing a fine job in continuing the updating the K.of L. Constitution. Agnes mailed to all District and Council Presidents copies of the amendment passed by the delegates last year which merged Lithuanian Language and Culture Committees into one committee. This amendment was prepared for easy insertion into the Constitution booklets. At the request of the Trustees, she worked to update portions of the K. of L. Manual. Agnes is very active in her Council, she has held every office in Council 3 and she is also Vytis correspondent for the Amber District. Agnes is also a candidate to be awarded Honorary Membership at this years convention. Congratulations to Agnes from all of us.

Second Vice President, Maryte Sepikas. Maryte has been working diligently to promote membership. As a result of her activity, a new council has started in the Washington area and another is in the planning stages in Northern California. Maryte has been active with her council and district. She has contacted many Lithuanian Americans from California to Washington in hopes of generating new councils. Maryte had a booth at Los Angeles Lithuanian Days Celebration where she distributed information about the Knights of Lithuania. She has written articles for the Vytis and the Lithuanian press and has placed adds in Catholic newspapers and magazines. Maryte is also involved in a project to ship a church pipe organ to Our Lady Mary, Star of the Sea Church in Sventoji.

Third Vice President, Maria Deksnis, is a very capable and energetic young lady in her work with and for the Juniors. Maria has written articles in VYTIS for her Juniors. She has communicated with Junior advisors on present and planned Junior activities. She has shown how well she can work with Juniors at every age level. She has been in contact with Joe Stiklius to finalize Junior activities at the convention. She will run the Junior meeting Saturday morning. Maria has done a very good job with the youngsters.

Recording Secretary, Bernice Aviza, has served her position as National Secretary extremely well. She is a great asset to our organization. Her minutes are precise and on time. Bernice has always send out council roster updates and mailing lists whenever other members had made their requests. The president has been extremely fortunate to have Bernice as secretary. She never hesitated to assist

the President or Supreme Council members. With all of her secretarial duties. she also served as MAD Vice President for the Juniors, participated in the K. of L. trip to Rome, participated at the Darius and Girenas Commemoration in Brooklyn and found prepare time to letters of greetings the many to organizations for our 85th national convention. Bernice has done an outstanding.

Treasurer, John Baltrus. In the past ten years, we have been very fortunate to have outstanding people elected as National Treasurers and John is no exception. He attended all Supreme Council meetings. He is extremely knowledgeable and meticulous in his job. John has kept a careful eye on our finances. He has been in constant contact with me and with our legal advisor. He has prepared the budget from the recommendations of the Budget Resolutions Committee and his own findings. John will present a complete report of our financial standing at this convention. He has been very cooperative S.C. member. John has done a very fine job.

Financial Secretary, Dorothy Banos. She attended and participated in all Supreme Council meetings. This is her third year as Financial Secretary, she has learned the job well. She has been in constant contact with Council Financial Secretaries and with the VYTIS Business Manager so that changes could be updated as soon as possible. She has not hesitated to cooperate and work with the president, all councils and districts. She has kept all lines open for communication. Thank you, Dorothy, for a job well done.

Trustees, Mary Beth Slakis and Mark Bell have done a thorough job in reviewing the financial books of the various committees within the Supreme Council. They are both young and energetic and have accounting backgrounds. They pursued bid requests for the 1999 convention. They successfully completed the audit of the books of St. Casimir Guild and completed the update of the Knights of Lithuania Manual to the point of mass printing and distribution. The inventory of the K. of L. assets has been completed and will be discussed during the trustees presentation at the convention. At the convention they will audit the records of the National Treasurer, Financial Secretary and the ancillary K. of L. organizations. They have attended most Supreme Council meetings and have offered sound suggestions and opinions. Mark and Mary Beth have done a very good job.

Amber District, Dorothy Banos, President. Dorothy organized and presided at District meeting at Shamokin - Coal Township, but, due to surgery, was unable to attend the District meeting in Philadelphia. Frank Petrauskas, District Vice-President conducted the meeting. Seven members of the district will receive their fourth degrees at this years convention. Third District meeting and pilgrimage is planned at the Franciscan Monastery

in Kennebunk Port, Maine in September. Many District councils are participating in shipment of medical and humanitarian goods to convents in Lithuania. Dorothy is a hard working individual and is the Chairperson of the Mandate Committee. She has been a very cooperative member of the Supreme Council.

Mid America District, Peter Paul Zansitis, District President. The Mid America District has held four assemblies since our 1997 National Convention. District spiritual advisor celebrated Mass for the deceased on November 13, 1997 at the Marian Fathers Monastery. MAMD recognition awards were presented at the St. Casimir Day celebration on March 21, 1998. Lithuanian Consul General Giedras Apoukas was the guest speaker at the summer MAMD assembly on June 6, 1998. Although Peter was unable to attend the Philadelphia or Waterbury meetings, I have been in contact with him on a number of Supreme Council issues. Peter will be the parliamentarian at this years convention.

Mid Atlantic District, Ed Barkowski, District President. Ed attended all Supreme Council meetings. He organized and chaired district meetings in Maspeth and Brooklyn, guests included Bishop Paul Baltakis, OFM as main celebrant and speaker. Dr. Petras Anusas, Consulate General of Lithuania and other dignitaries. He coordinated the annual joint picnic in August of Amsterdam and Hudson-Mohawk Councils. He has aided Apolonia Ziausys of C-100, Amsterdam, with the shipment of scores of packages of medical and humanitarian supplies to Lithuania. In June the district commemorated the 65th anniversary of Darius and Girenas Transatlantic flight, with a ceremony at the site of the start of the flight at Floyd Bennet Field. Ed has been the chairman of the nominating committee and has worked with all district presidents for viable candidates for national office. Ed has been a very active district president and a very cooperative S.C. member. Due to family illness Ed is unable to attend this years National Convention.

Mid Central District, Frances Petkus, District President, Frances attended the Waterbury Supreme Council meeting. MCD held its fall convention/pilgrimage in September 1997. The district and councils have set goals covering their

annual donations to Aid to Lithuania, St. Casimir Guild, Inc., K. of L. scholarship fund and K. of L. Foundation. MCD Spring convention/bowling tournament was hosted by council 16, Chicago. District councils are busy maintaining the activities of the K. of L. such as holding meetings, St. Casimir's Day Mass Celebrations, participating in local Lithuanian Independence Day celebrations, supporting K. of L. programs financially etc. Frances maintains close contact with all district councils and works with members when approached for help. She has been actively working with other district presidents for viable candidates to the Supreme Council Board and Presidium.

New England District, William Piacentini, District President, attended Both Supreme Council meetings. New England District spring convention hosted by C-78 was held in Lawrence MA. The District Cultural Festival was held at Maironis Park in Schrewsbury, MA. At the festival. Rev William Wolkovich was recognized on the occasion of his being honored by the government of Lithuania. In addition District Scholarship was awarded to Christina Peterson C-50. The district conducted a special meeting in January 1998, with Foreign Minister Algirdas Saudargas and Lithuanian Ambassador Stasys Sakalauskas. Members of the New England District were updated on events in Lithuania. NED received a bequest of \$100,510.73 from the estate of Irene Tamulevich. Bill continues to work closely with his councils to promote ideals and goals of the Knights of Lithuania.

Archives Committee, HM Longinas Svelnis attended Supreme Council meeting at Waterbury CT. Larry has traveled to Putnam five times and had three meetings with his Archives Committee. Three new members were added to the committee, they are Frances Bumila, Sophia Sakalys and Agnes Waitonis. Larry reminds everyone that contributions to the Archives should be addressed to Knights of Lithuania Archives, c/o ALKA, Putnam, CT 06260. Larry and his committee are to be lauded for their dedication in sorting, filing and maintaining the archives.

Honorary Membership, HM Loretta Stukas, chairperson. We mourn the death in June, 1998, of Committee Member Rita Pinkus. During this years National Convention, Agnes Mickunas and Clemencine Miller will be awarded Honorary

Membership. Loretta invites councils and districts to submit names of outstanding members for Honorary Membership.

Legal Advisor, Saulius Kuprys, Mr. Kuprys has filed all required reports with the appropriate government agencies to which the corporation must report. He has filed information return 990 to the Internal Revenue Service as required. Mr. Kuprys maintains contact with the subsidiary corporations of the Knights of Lithuania and has filed all the necessary government forms. He has always responded to various miscellaneous matters and legal questions which have come up from time to time. He has maintained contact with the President and other S.C. members.

VYTIS Editor, Maryte Abbott. Maryte was reappointed VYTIS editor. She has done a good job during a year of transition and changes and is grateful to everyone who has given her assistance, constructive criticism and their time. She has done much to enhance VYTIS readers and to continue to keep VYTIS a viable informative magazine and at the same time attempting to keep the cost minimal. Maryte has set a number of goals for continued improvement of the magazine. Her council news editor is Dalia Bulvicius. Maryte and the business manager, Mary Kincius, keep in constant contact with each other. There are still some problems with the Chicago post office and Draugas, our printer, on mailing, production and other technicalities, they are being addressed. The new VYTIS computer equipment purchased last year should take us well into the new millennium. This equipment allows the editor to store entire issues on an additional drive which in turn can be send to the Archives, minimizing valuable space.

VYTIS Business Manager, Mary Kincius is completing her first year as VYTIS business manager. She attended both meetings of the Supreme Council. She has kept in contact with Maryte Abbott, VYTIS editor, and Dorothy Banos, the Financial Secretary for a smooth transition of VYTIS activities. Mary works very closely with Dorothy to update dues payments, include new members, deceased members, answer internet inquiries etc. Back up disks are made each month and copies taken to the printer. Mary has attended a number of meetings and made numerous phone calls to the auditor of the U.S. Post Office in Chicago and Valentinas Krumplis of Draugas to resolve problems as they occur. She constantly updates the VYTIS mailing labels and invoices all advertising. She gathers left over copies and keeps them on hand for special requests.

Language and Cultural Committee, Faustas Strolia, chairperson. Faustas wrote a comprehensive synopses of the highlights of last years National Convention which was printed in DRAUGAS. Although I have not received his report, I have been assured his report will be available at the convention. Faustas is a very talented individual and will be presenting a cultural presentation to the delegates at this year's convention.

Lithuanian Affairs Committee, Len Barcousky, chairperson, attended all Supreme Council meetings. Len wrote an essay for the Vytis on the visit of Lithuanian Parliament members to Pittsburgh, which was published in June. Len also wrote an essay for the monthly newsletter published by the Lithuanian Citizens Society of Western Pennsylvania. Len is preparing a panel for the National Convention. The general topic will focus on the interrelations among the three Baltic countries. Len is preparing a small packet of columns and news stories to be distributed to delegates at the convention. Len is a diligent worker and I am confident he will have an outstanding panel for us.

Public Relations, Regina Juska - Svoba, chairperson, Regina is a very dedicated member of the Supreme Council. Her numerous articles on The Knights of Lithuania activities appear regularly in DRAUGAS, DIRVA and DARBININKAS, Regina has translated articles and letters for K. of L. Foundation, Aid to Lithuania and others. At district and council level she participated in a number of meetings and commemorations held by Lithuanian American Organizations, including the welcoming Foreign Minister Algirdas Saudargas and Ambassador Stasys Sakalauskas to the Detroit area. She prepared synopses of these activities, aired on both Lithuanian radio programs - Lithuanian Melodies and American Lithuanian Voice Inc. In spite of personal tragedy, Regina has taken on many responsibilities and has followed through on all of them. Although Regina will not be able to attend our National Convention, she has indicated in writing of her interest to run for Public Relations Chair.

Ritual Committee, Elsie Kosmisky, chairperson attended all Supreme Council meetings. She has fulfilled her duties and has conducted this committee very well. She answered each letter and call from council chairs and individual members. Elsie and committee members Clemencine Miller and Georgianna Macke worked diligently to assure that all qualified members are approved to receive their degrees. There are 41 applications and points approved for the fourth degree in 1998. Elsie has always kept in contact with the President and her committee members for clarification on different issues. She has been working with ritual chairs of various councils in updating points and recording degrees She continues to offer her assistance whenever needed. She has done an outstanding job as ritual committee chair.

Scholarship Committee, Irena Gecas McCarthy, chairperson attended all Supreme Council Meetings this term. She has worked very thoroughly with her committee members Richard Schultz, Charles Rupsis, Veronica Bizinkauskas-Cote and Eleanor Vaicaitis. The Scholarship Committee was the beneficiary of a generous gift of approximately \$100,000 from the Tamulevich estate, which stipulated that these proceeds will be used to establish a scholarship fund entitled "Svikias and Tamulevich Memorial Scholarship Fund". She is a very capable chairperson. With the help of the Knights of Lithuania scholarship fund, we are helping qualified persons to farther their education. Irena and her committee are looking into ways to increase applications of qualified persons.

Aid to Lithuania. Inc., HM Robert Boris, chairperson. Bob once again successfully initiated the fourth Annual George Perles Golf Invitational tournament with a profit of over \$15,000. Through July of 1998, 12 containers of medicine and medical supplies have been shipped to Lithuania. Bob's professionalism from the days in private sector proved to be a valuable asset in his activities with the Aid to Lithuania, Inc. No other person could have achieved the degree of accomplishment that Bob has. Bob will present his complete report on Friday, Aug. 7.

K. of L. Foundation Inc., HM Loretta Stukas, chairperson. The finances of the Foundation will be announced at the convention. As usual, the

Foundation sponsors an essay contest. The winners will be announced during the convention. Donations from the general membership are needed on a regular basis to guarantee the tax exempt status of the Foundation. Loretta has contributed articles to VYTIS and is also a member of the Budget Resolutions Committee. Loretta has been a very cooperative member of the S. C.

St. Casimir Guild, Inc., HM Anne Klizas Wargo, chairperson. From July 1, 1997 to June 30, 1998. Anne received 562 requests for Mass Intentions at the Pontifical College in Rome. On behalf of the Lithuanian Pontifical College, Anne asks for continued support both financially, with mass requests and spiritually. The mass requests are forward to Rome each month along with the Mass stipends. These masses support the student priests and the Priests at the college, since they do not have any other income. The pilgrimage to Rome in March was a huge success. Msgr. Bartkus met the group at the airport and bussed the group to St. Peters Square for a special Papal blessing in Lithuanian. Lithuanian Bishops and Priests attending the open house at the College spoke very highly of what the Knights have done for the Pontifical Lithuanian College .

SUMMARY

Your elected National Executive Board members have worked diligently in fulfilling their duties of the offices they accepted.

In closing, I would like to leave you with this thought. I attended a number of meetings at the Lithuanian Embassy in Washington with leaders of other Lithuanian American - Organizations. The views and ideas exchanged, I believe, will lead to greater cooperation and understanding between us. We all worked hard to make Lithuania free again, we all want Lithuania to be independent and democratic, we all want Lithuania to be the type of country we all can be proud of. We can take the leadership role in achieving these goals. The Knights of Lithuania are the oldest Lithuanian American organization, we are the largest, we have done more to help Lithuania than any other Organization. We will become stronger, our accomplishments will be greater, we will be working for God and Country.

Convention Sessions and Activities

Gouncil 7 chose - Lithuania Forever in Our Hearts or Lietuva, Amžinai Mūsų Širdyse as the motto of the 85th National Convention in Waterbury.

Those who had arrived earlier, had the chance to attend the preconvention trip on Wednesday to Foxwoods Casino and discuss their winnings at a dinner afterwards.

It was a cooler than usual August morning when our Knights boarded three packed city school busses from the Four Points Hotel (on the outskirts of town) to downtown City Hall in Waterbury. Swarming around the outside of the building, the day warmed up and some of the traditional Lithuanian costumed ladies looked a bit uncomfortable in the heat. But it wasn't long before the Mayor of Waterbury, Philip Giordano, along with our own K of L President, John Mankus, arrived and greeted us. The Mayor spoke of the early Lithuanian immigrants who settled the area in the late 1800's and early 1900's and their work in the brass factories.

(In fact one of nicest bit of memorabilia we received in our welcome kit from Council 7 was the beautiful and functional brass key chain adorned with the VYTIS (knight) and the 85th convention date.)

The Lithuanian flag was raised and a special proclamation was read by the Mayor emphasizing the City of Waterbury's warm welcome. City Hall workers had prepared a special cake and coffee for us, and afterwards we again boarded the busses for our opening Mass.

Opening Mass at St. Joseph's in Waterbury began with a procession of flags from all districts, followed by Supreme Council officers and officiating priests which included St. Joseph's pastor, Fr. Francis Karvelis, Msgr. Anderlonis and Msgr. Contons.

As usual, Msgr. Joe left us thinking with a beautiful homily where he emphasized the convention theme Lithuania Forever in Our Hearts (Lietuva, Amžinai Mūsų Širdyse) and asked us to take it one step further, so that Lithuanian would not just be in our hearts but in our hands as well. He stressed this is a time for renewal and to review the ideals of the organization asking for God's blessing in the future. He also left with us a simple but effective prayer, "Speak, Lord your servants are listening."

Besides the beautiful church, stained glass windows and packed crowd, most notable was the choir which boasts new Lithuanian immigrant members. They sang Lithuanian hymns with such heavenly voices many of us in other choirs wished we had them with us. The unique long history of this choir included performances at the 1939 and 1964 World's Fairs in NYC and the dedication of the Lithuanian Our Lady of Šiluva Shrine in Washington, DC in 1966. It was once led by Alexander Aleksis (1924-1974) who had composed the hymn for the Knights of Lithuania and an operetta, I Tevyne (To the Fatherland).

FIRST PLENARY SESSION

Supreme Council President, John R. Mankus called the convention to order and the presentation of colors followed with Supreme Council Officers. The opening prayer was said by Msgr. Joseph Anderlonis, National Spiritual Advisor and delegates sang American and Lithuanian national anthems.

C-7 President and Convention Chair, Joseph Sticklius gave conventioneers a warm welcome to Waterbury and noted that the last time C-7 hosted a national convention was 1926 or 72 years ago. Mayor Philip Giordano also welcomed the group, welcoming those he did not see at City Hall in the morning.

Nominations for the 85th National K. of L. Convention's Presidium were made and officers were voted on. Presidium members were: Chairperson, William Piacentini (C-103, Providence); Co-Chairs, Loretta Stukas (C-29, Newark) and Frank Petrauskas (C-140, Syracuse); Recording Secretaries, Bernice Aviza (C-136, Hudson Mohawk) and later in the second session Mandate Anthony Grein (C-1, Brockton); Committee, Dorothy Banos-Chair (C-143, Pittston) with Agnes Mickunas (C-3, Phila.) Anne Marie Kassel (C-36, Chicago), Doris Snirpunas (C-7, Waterbury), Nellie Bayoras Romanas (C-143, Pittston) and Irene Svekla (C-3).

Resolutions Committee included: Robert Martin, Jr. (C-16, Chicago), Elinor Sluzas (C-96, Dayton), Jean Kapochus Mihalek (C-143, Pittston), and Theresa Strolia (C-36, Chicago).

On the Greetings Committee were: Leonard Kapochus, Chair (C-3, Phila.), Helen Karpovich (C-143, Pittston), Lee Moore (C-86, Dubois), Antoinette Sakal (C-152, E. Long Island), and Sophie Sakalys (C-103, Providence).

Minutes of last year's convention had been reviewed by Evelyn Ozelis (C-36, Chicago), Ed Barkowski (C-136, Hudson Mohawk), and John Mickunas (C-3, Philadelphia).

Parliamentary Procedure was reviewed by Peter Paul Zansitis (C-16, Chicago).

And the Sergeants-at-Arms representing their Districts were: Maryann Cipolla (Amber), Joseph Stelmokas (MAD), Glenn Perutis (MAMD), Paul Moore (MCD) and Kathryn Urban (NED).

A brief list of convention rules was adopted to keep things orderly followed by verbal and written greetings from various organizations (See page 34).

President John Mankus gave his State of the Organization Report (See page 4), followed by National K. of L. Treasurer, John Baltrus report of our fiscal status. The largest increase from our budget last year, was the increase in the cost of printing VYTIS issues. A Treasurer's Budget Proposal for the coming year (1998-1999) was presented and approved by the delegates.

Additional monetary greetings were read along with a mandate report and announcements. The meeting was closed with a prayer.

SECOND PLENARY SESSION

Following the opening prayer, and acceptance by the delegates of the minutes of last year's 84th Convention through the Committee, Frank Petrauskas spoke on behalf of Aid to Lithuania, Inc. ("ATL") the K. of L.'s largest ancilliary organization. Frank spoke of all the work that has been done and thanked donors. He then introduced Robert S. Boris, President of ATL, who

gave his annual report.

Bob spoke of a possible change of direction for Aid to Lithuania which would include the financial support of young seminarians studying in Vilnius. It is these seminarians, he added, that go out to the poor in the country and attend to the needs of those most destitute, such as orphans, homeless, unemployed and pensioners. These seminarians are the ones "in the trenches" helping to address the worst needs of the country. He advocated the support of the seminary (more details to be published in next month's issue) and asked people to financial greetings mark their ATL with "Seminarian Fund" (See p. 34-35).

ATL has shipped 61 full containers of goods and medical supplies to Lithuania since its inception in 1991, at a total value of over \$51 million dollars. The cost for shipping is \$283,290, according to ATL records, that sum having been donated by the Knights and others.

Faustas Strolia, National Cultural Chairman gave a most interesting presentation on the first Lithuanian book in America. (See story on pg. 18)

The session ended near noon, when Aid to Lithuania and K. of L. Foundation had separate luncheons, while delegates enjoyed a luncheon in the ballroom.

THIRD PLENARY SESSION

Outgoing Supreme Council Trustees, Mark Bell and Mary Beth Slakis, gave their report and wished their replacements well. Many in the group

thanked them for their time spent in this task.

A Panel Discussion entitled "Baltic States Today and Tomorrow" was moderated by Len Barcousky, Lithuanian Affairs Chair. Len, an editor and reporter for the Pittsburgh Post Gazette, arranged a special group to represent all three Baltic Nations, as he feels that knowing more about each other and working together will help all the newly independent countries maintain their democracies. On the panel was Latvian-American, Valdis Vinkls, an attorney from Hartford who served as vice president for public information for the American Latvian Association. Mr. Vinkls said that although both Lithuania and Latvia share a similar language. we know little else about each other. 40% of the population in Latvia is Russian or another ethnic minority, compared to much less in Lithuania, so the problems of integrating these groups into Latvian society also are greater than Lithuania's. He further stated that from his view, 15% of Latvians are doing well, while the other 85% are not. This is similar in Lithuania, along with too small sums allotted to pensioners.

Estonian, Enn Koiva, a retired school teacher living near Hartford, the second panelist, received a National Endowment for the Humanities grant to study and write about medieval Estonia. As a member of the Estonian World Council, he stressed the linguistic differences between Estonia and the other two Baltic countries. Estonian is similar to Finnish, which in turn, is the country the Estonians model themselves after.

Although a deeply religious people, as evidenced by the magnificence and magnitude of many churches, the predominant religion is Lutheranism, introduced by both the Germans and the Swedes, who introduced religious grammar schools.

He further noted that Estonians are very private with their beliefs, and only 30% were active church goers.

K. of L. Pres., John Mankus was the panelist to represent the Lithuanians. He stressed the changes in land mass, and emphasized that Lithuania's Golden Age was between 1236 to 1430, when the country stretched from the Baltic to the Black Seas.

All three agreed that Baltic countries had experienced an economic "revolution of rising expectations", a quote from Adlai Stevenson remarked by Mr. Koiva. All three countries also have a wide gap between rich and poor, leaving a lack of a middle class. Another similarity is the low birth rate, such as the Estonian pointed out. In 1997, he said, approximately 23,000 people died and only 13,000 were born. A massive "brain drain" meaning the best and brightest scholars move to other countries, along with a high crime rate, high suicide rate (Lithuania's is the highest in Europe) and alcoholism remain severe problems which must be addressed in the years to come.

After each panelist had a discussion, the delegate were given a question and answer period. It was overall an extremely enlightening session, and to those of us who traveled to the other two Baltic Countries, it helped fill in the gaps and reassure us we must work together.

Nominations for Supreme Council Officers, were followed by greetings and a mandate report. A closing prayer was led by Msgr. Anderlonis.

FOURTH PLENARY SESSION

Maryte Sepikas, 2nd VP, Membership distributed special awards for those individuals and councils who made efforts to increase membership. She also gave special acknowledgments to Dorothy Banos and Mark Bell for helping to make her job easier. (See 1998 Membership Awards elsewhere in this issue).

Forty One Fourth Degree candidates were read by Elsie Kosmisky, Ritual Chair. Many were present to receive their awards that were presented to them by the Archbishop of Hartford at the Sunday closing Mass. (See page 17.)

Loretta Stukas, Chairman of the Knights of Lithuania Foundation announced the Foundation's Annual Essay winners. She emphasized the need for more entries into this special contest, designed initially by Msgr. Juozas Prunskis to keep writers promoting the Knights of Lithuania and our heritage. (See winners in "K. of L. Foundation Essay Contest" elsewhere in this issue.)

A new Director, Mary Beth Slakis was announced. She will replace the recently deceased, Rita Pinkus.

In her annual report to the delegates, Mrs. Stukas thanked those who have donated to the K. of L. Foundation, and added that she's like to reach a \$100,000 goal for the Foundation in the upcoming millennium.

Elections were held for Supreme Council

officers for 1998-1999. Elected by the delegates are: Msgr. Joseph Anderlonis, National Spiritual Advisor; John R. Mankus, President; Agnes Mickunas, First Vice President (assistant to the President): Maryte Sepikas. Second Vice President (membership); Maria Deksnis, Third Vice President (Juniors); Bernice Aviza, Recording Secretary; John Baltrus, Treasurer; Rita Sussko, Financial Secretary; Richard Niedvares and William Kolcius, Trustees; Joseph Zukas and Irene Yanick. Ritual Committee (replacements for those whose term expired); Len Barcousky, Lithuanian Affairs Chair; Faustas Strolia, Lith. Culture-Language; Karen Domalakes, Scholarship Committee; Regina Juska-Svoba, Public Relations and Longinas Svelnis. Archives Committee.

Following greetings, resolutions and announcements, the session ended with a prayer. A special luncheon meeting of the St. Casimir Guild was held.

FIFTH PLENARY SESSION

The St. Casimir Guild report was made to the delegates by Anna Klizas Wargo, its Chairwoman. She stated that the pilgrimage to Rome in March for the 50th Anniversary of the Pontifical Lithuanian College had 45 members attending, receiving special blessings from the Holy Father. Anna stated that from July 1, 1997 to June 30, 1998, 562 requests for Mass intentions were forwarded to the Lithuanian Pontifical College in Rome. (The Mass offerings are \$10 each, payable to St. Casimir Guild and sent to Ms. Wargo - see address on front inside cover).

Additional donations to the Pontifical College for the printing of the commemorative program book, amounted to \$21, 500. Books were distributed to those who contributed \$50.00 or more. The K. of L. was praised highly on all occasions during the trip. During the Jubilee Mass, John Mankus, K. of L. National President did the Lithuanian readings and Guild President. The First Lithuanian Book In America

by HM Faustas Strolia

At the 85th National Convention in Waterbury, Connecticut, I had the privilege of introducing the First Lithuanian Book printed in America: TLUMOCZIUS ARBA SLOWNIKAS -"Interpreter or Dictionary". (Notice that both words in this title are of Polish origin, but they surely have Lithuanian endings, just the way many of us in America would say: "graži dresė", "atnešk man šūšius", "boifrentas ant raidos pavadino", "nais karas", etc.) It was written and printed by Mykolas Tvarauskas in 1875. Today we might want to give more significance to this dictionary's 123rd "birthday" when we remind ourselves that Lithuania

was under the Russian czar's In 1863, this 19 year old school involved in the uprising government, was wounded This uprising caused a massive the region on the left of the

Tvarauskas arrived in 1867 PA, at Shenandoah, (as Lithuanians called it "Šenadorius") where he worked for 7 years in the coal mines. Here he learned quite fluent English. He then moved to another Lithuanian settlement in Shamokin (Lithuanians called it Šamukai). In this little Pennsylvania city the first Polish-Lithuanian parish in America had its start. And although many of the

migrants had little formal education, as time passed, it became evident that one needed a book from which they could learn English and learn it quickly.

It is remarkable that Tvarauskas in his eighth year in America was able to become not only the owner of a printing shop but also the author and publisher of the first Lithuanian book in America. Until 1930, it was believed that a fire at the print shop had destroyed all these books. However, a copy accidentally was found in Lithuania. The author's friendly, unpretentious address to the readers "miely brolej" "slobnas ir swiatymas", "asz pyrmas atejnu pas jus", in a way, reminds us of Mažvydas, who opened his first Lithuanian book several centuries earlier with the simplicity of "prastus

szadzius...broliai, seserys, imkit mane ir skaitykit!".

One find many will "Lithuanian-ized" Polish and some German words, but this was a reflection of the social and cultural state of the Lithuanian people at Lithuanian that time. The language became anemic and quite few forgotten by a Lithuanians. We know that before his conversion, even Vincas

Kudirka, the author of the Lithuanian National Anthem, considered himself of Lithuanian birth, but of Polish Nationality. So it should not surprise us, when in his conversations Tvarauskas teaches his buddies from Užnemunė to say "I come from Poland" - "asz atejnu isz Lanku".

This book promised his "dear brothers" to replace the need for an interpreter, because it contained ready expressions for a conversation -"susiszneket su koznu angliku". The book contained 159 numbered pages, and was divided into 5 sections, which he named "padeimas" - "placement", "step". He started out his first section with 26 English letters, continued with numerals, then introduced the pronouns and auxiliary verbs. The

conversational phrases. More than half of the pages (82) contained alphabetical dictionaries: 46 for English-to-Lithuanian (1200 words), and 36 for Lithuanian-to-English (1000 words). Tvarauskas showed a scholarly attitude in pointing out how English words could have several meanings: "wood" - miadzej; malkos; "man" - žmogus, wiras; "ride" - "jot", "wažiuot", etc.

It was definitely a book that attempted to teach correct pronunciation, a very ambitious undertaking. Can we imagine what Tvarauskas went through when he tried to "translate" the phonetics of English words into "Lithuanian spelling? There were no spelling rules for the Lithuanian words which they all knew how to pronounce! And he put so much heart into correct pronunciation. If the English language, even suggesting that his readers should memorize the whole book, chapter by chapter.

As we know, in 1864 the Russians imposed a press ban in Lithuania. For forty years they prohibited the printing (or importing from abroad) of Lithuanian books in Latin characters, so the young entrepreneur was on his own, with no spelling dictionaries, not even a standard Lithuanian language!

Tvarauskas used "w" instead of "v"; "sc" and "cz" instead of "š" and "č"; every time he wanted to make a distinction between the short "i" sound (like in English "sin") and a long "y" sound (like in English "seen"), Tvarauskas very consistently reversed our modern Lithuanian spelling practice: he spells "dvilyka", "ira", "zidy " instead of "dvylika", "yra", and "žydi". Such spellings are common to the Polish language, and were used for Lithuanian at that time. Some of us might remember that even our Lithuanian American newspaper "Saulė" in Mahanoy City used such Polish spelling until its closing in 1959. (There were no "nosines" - "a, e, j, u" nor long "ū" and "ė" until the turn of the century, with the arrival of Jonas Jablonskis when the Standard Lithuanian was established.).

Since there was no Standard Lithuanian, Tvarauskas used his own dialect from Užnemunė. Many times he added an "ie" sound: "eitie", "jotie", "suprastie" to the verb-infinitives: or he would cut the second syllable completely off- "eit, jot, suprast". This dialect would also like to start certain words with a "w". like "wuodega", "wuoga" (uodega - tail, uoga - berry), etc.

One has to admit that this young teacher from Lithuania, who learned his English not at Yale, but at a Pennsylvanian coal mine, was quite ambitious. It appears that he was interested with the printing of this dictionary and other Lithuanian books in America in keeping the Lithuanian consciousness alive, or as the scholar Bronius Raguotis put it, "through books to enhance the prestige of Lithuanians living in America..."

Although Tvarauskas did not create and publish any time transcending works, his name has gone down in the history of Lithuanian culture for all time.(^{Therefore} cont. with Excerpt on page 20)

Did you know?

On August 19, 1955 Waterbury was hit with one of the most disastrous floods in its history. The rectory of St. Joseph Lithuanian Catholic Church became a depot, the classrooms at the school became grocery storage rooms, clothing rooms and a first aid room for evacuees. The school continued to house people until September 1 of that year. Thirty people died in that flood, many were parishioners.





Whereas, this has not been a true representation of the entire organization, nor does it provide an ability to understand the organizational involvement of members in each individual district, and

Whereas, at times this results in difficulty to properly award the Fourth Degree to deserving members;

Therefore, be it resolved that Article XII, Item

They are elected at a National Convention for a three year term on a rotating basis of not less than two per year but no more than three. The committee elects its own Chair, Secretary and Treasurer annually.

Be it further resolved that the Supreme Council Ritual Committee determines the form and the rules for all degrees and the ceremony, after consultation with the Supreme Council, and approval of the National Convention. All decisions within the committee must be unanimous for presentation of change of rules from the committee. All other decisions of the committee will require a majority vote of the committee members. In the event of a deadlock the Supreme Council President shall break all ties.

Constitutional Amendment -Yearly Dues - Spouse

WHEREAS In order to eliminate any reference in the Knights of Lithuania Constitution to the specific amount of dues to be paid by spouse of member, the following changes are proposed. Spouse dues will then be set at the 1998 National Convention according to Article VI, Section 1.

Be it resolved that Article VI, Section 4d of the Knights of Lithuania Constitution be eliminated. Section 4e will become 4d.

Be it further resolved that Article VI, Section 5 and all its subsections be eliminated. Section 6, 7 and 8 will become 5, 6 and 7, respectively.

National Nominating Committee



dinner. The food was good but I had the most fun talking with my new friend when we went outside to cool off. On Friday we went to the amusement park which had lots of rides.



The three Baltic nations were featured this year in the annual outdoor Smithsonian Folklife Festival on the Mall held June 24-28 and July 1-5, The Philippines and the State of Wisconsin also participated.

A widely renowned ensemble from the village of Marcinkonys in southern Lithuania, comprised of older men and women, presented a variety of music. They were outstanding! After the festival closed for the day on Saturday, they participated in a private concert that evening for the local Lithuanian community, with guests from New York and Baltimore.

Lithuania's treasure, Veronika Povilionienė, a folk singer who has seven hundred folk songs in her memory, captivated young and old alike with her songs. She particularly charmed the children with her presentations and personality, and they were quick to gather round her.
