It is important to remember that this report is just a summary of their work and activities. I strongly encourage delegates to pick up a set of their full reports and after reading them share them with your fellow council members. The work that has been accomplished in the past year is truly remarkable and worthy of your time.

Spiritual Advisor Rev. Msgr. Dr. Joseph Anderlonis, HM

Msgr. Joe has continued to offer a monthly Mass for our deceased members and includes new names of our deceased as he receives them. At this Mass Msgr. also offers prayers for the intentions of our entire organization.

Msgr. attended the spring meeting of the SC in Dayton and offered Mass for those attending at C-96's home parish of Holy Cross.

As always our charities, Aid to Lithuania, Inc., St. Casimir Guild, K of L Foundation and Scholarship will need our continued financial support, let us not disappoint them. However, let us also consider the following as well. The coming year will see very important decisions being made for Lithuania's future and her becoming part of NATO, in particular. We must all work to insure that our Representatives and Senators in Washington support Lithuania's inclusion in 2002. This year, as in years gone by, letter writing is of utmost importance, together we can help to make a difference. Along those lines, I ask you to consider making donations to the Fr. Jutt Fund for Lithuanian Affairs. This fund is the sole source of income for our Lithuanian Affairs Committee. Let us insure that the funds needed for mailings and news bulletins are readily available.

Also, this past year has seen several, hopefully welcome, changes to the presentation of Vytis. Those changes, for the most part, have met with positive responses. Let us all consider a personal contribution to insure that needed funding is there for our Staff to continue.

As always, our Junior members remain the key to our future. Assistance we offer their cultivation today will work to insure our continued success tomorrow.

And please consider joining our Summer 2002 Tour of Lithuania. The tour is scheduled so that as Lithuanians from all over the world gather once again for the Song and Dance Festival in Vilnius, we can be part of it. Your Supreme Council is pleased to be sponsoring the "Official Knights of Lithuania Tour", in cooperation with American Travel Service. You may have noticed that a copy of the trip's itinerary has been included with everyone's convention handouts. Additional copies are available should you need them.

In conclusion

Now, as I bring this year's annual report to a close I would be remiss if I didn't take time to offer a few words of thanks. First, to you, our delegates, all my thanks for intrusting me with the honor of leading our organization this part year and for having the foresight to elect such a dynamic group of people to serve on your Supreme Council. It has truly been a pleasure to serve with them this past year. To the members of this year's Supreme Council I offer my thanks. Your support and willingness to work together is truly appreciated and a great asset to our organization.

It is my hope, that after having listened to all that has been happening during the past year we will all be motivated to use this convention to re-dedicate ourselves to working "For God and Country" as we continue building the bridges between our generations both for now and for our future.

Now, let us continue with this year's meetings and deliberations in friendship and understanding. May our deliberations over the next four days be fruitful and always be in the best interest of the Knights of Lithuania.

Kennedy Space Center Wednesday, August 1st Bernice Aviza

Prior to the official start of the National Convention a group of K of L'ers participated in a trip to the Kennedy Space Center. Elena Nakrosis, C-90 was the guide for the day.

The Kennedy Space Center is located on what is known as Florida's "Space Coast". It covers more than 140,000 acres of land, swamp and waterways. It is also home to two Launch Pads, one of the world's longest runways and the nation's biggest building.


Our tour of the Space Center started at the Visitor Complex where displays tell the story of NASA's past, present and future. We then boarded buses for a complete tour of the Kennedy Space Center.

Our first stop was the *Apollo/Satum V Center*. In the "Firing Room" theatre the final countdown of the US's first mission to the moon was reenacted. When the countdown reached zero we could feel and hear Apollo 8 leaving the launch pad.

As we left the Apollo/Saturn V Center and traveled to the *LC 39 Observation Gantry*, we were able to view how space shuttle orbiters are transported to the landing site. The "Crawler-Transporter" is about the size of a baseball diamond and has the ability to bear 6 million pounds of weight. The observation deck of the Gantry allows a 360 degree view of the entire complex area – the shuttle launch pads, the vehicle assembly building, the control center and the 130-foot-wide Crawlerway. Weather conditions that day prevented us from seeing an actual shuttle launch. We were able to get photos of ourselves inside of a rocket.

The visit to the International Space Station Center allowed us an up-close look of the actual facility where NASA is processing the components of the International Space Station. From the observation room we were able to see the actual processing bay where each space station module is checked out and processed.





The mock-up of the Habitation Module showed us what it would our living accommodations would be like if we were put into orbit.

We could not leave without visiting the IMAX film theatres. The screens are five stories high and have 3-D special effects. What an adventure! It made you feel that you were there.

As we traveled back to the hotel everyone marveled at the combination of historical elements and future dreamss that abounded at the space. center.

Ginger Houghton - "Friend of Lithuania"

"I am deeply honored to be the recipient of the Knights of Lithuania 'Friend of Lithuania' award, remarked Ginger Houghton, a Certified Registered Nurse Anesthetist, of Schenectady, NY., during the Award presentation. Quite frankly, I was very proud and delighted to be able to present Ginger with our award for her huge contribution to the people of Lithuania.

Ginger and her Lithuanian friend and partner, Bob Duda, made a foil presentation, at the National Convention, of their activities during the past two years and of their future plans to assist Lithuania. As I indicated in the July/August Vytis, their work for Lithuania has been nothing short of monumental. I want to summarize the highlights of their activities and presentation:

- Seven Heart-Lung machines were shipped through the "Great Circle Tour."
- Tons of donated equipment, including pallets of birthing beds, blood-pressure machines, wheelchairs, monitors and medicines were packed and shipped. In all, eleven cargo containers of medical supplies to Lithuanian Hospitals. Ginger has received help from Lithuanian Mercy Lift, to pay for the shipping cost.
- An open heart surgery was provided to a Lithuanian patient in 1997.
- An electric wheelchair was shipped to a patient.
- An electric bed shipped to a quadriplegic man along with two years of cardiac medication.
- Working with Lithuanian friend, Bob Duda, Ginger sends humanitarian support to four

families in Lithuania as part of "Saulute Kids" program.

- In April, 2000, she and Bob organized the 109th Air National Guard medical deployment unit for a two week exercise with Lithuanian Medical Teams in the Kaunas area.
- Working with the Shriner's Hospital in Springfield, MA, an eleven-year old boy was provided with a right arm prosthesis.
- Ginger has hosted many visiting Lithuanians in her home and has had as many as 18 for Christmas dinner.
- In March, Bob Duda rented a truck and traveled 4000 miles to Hospitals in California, Missouri, Oklahoma and North Carolina to pick up donated heart-lung machines. "If you don't ask people, you will never know," said Ginger.
- Her contacts with St. Peter's Hospital of Albany include the use of warehouse space, temperature controlled storage, loading and dock equipment, including the use of a fork lift.

In progress is, to provide an Orthopedic Surgeon to Kaunas Poly Clinic, and to a hospital in Marijampole for Orthopedic surgeries, and to find two ambulances to assist the hospital in Kaunas in getting its fledgling transportation program off the ground. "Our goal is to keep doing this work until they don't need our help any more." Ginger has been to Lithuania four times and is planning another trip in October, to help train nurses and physicians in arthroscopic surgery. "This has been a project that God has given me and I love doing it," said Ginger.

I wish to thank Bernice Aviza and Ed Barkowski for their assistance in choosing such a worthy recipient of the "Friend of Lithuania" Award.

K of L scholarships are awarded based on a numerical voting system that takes into account the following attributes: K of L involvement (2-year membership requirement); Financial need, character reference, Academic Record, and Community Service. These 5 characteristics are still deemed to be important and are used to distinguish potential recipients.

Now...for the fun part...let's give away some money. This year the Committee has awarded a total of \$12,925 to nine lucky members.

As always, I start off with the <u>Irene</u> Sankus Memorial Scholarship for \$1,000 that is awarded each year to a seminarian attending the Pontifical Lithuanian College-Seminary in Rome. It is customary for Monsignor Bartkus to select the recipient, who is from a Diocese in Lietuva, and is studying in either his first or second year in Rome.

The second scholarship, our top scholarship, the Sviklas and Tamulevich Memorial Scholarship will be for \$3,000 and it is awarded to Mary Mankus, a member of Council 72 - Binghamton, NY. Mary is pursuing completion of her PhD, Doctor of Philosophy in History, from the Maxwell School of Citizenship & Public «Affairs of Syracuse University. Her current area of research deals with United States immigration history, specifically that of World War II Eastern European Displaced Persons. Upon completion of her dissertation and degree, she plans to pursue a career as a professor of history, and an attorney specializing in immigration matters. Congratulations Mary!!! Mary also attended the Convention this year.

The next scholarship, the <u>Alice</u> <u>Karklius Memorial Scholarship</u> (which is provided through the K of L Foundation), is for **\$1500** and is awarded to a previous scholarship winner from C-112, Chicago - **Nina Padalino**. Nina finished her Bachelor of Arts degree in English from Marquette University, and has applied for the scholarship for her pursuit for a law degree from the University of Chicago, and ultimate career in international intellectual property law.

The next highest award was granted to Robert Medonis of C-133, Los Angeles, CA. Robert recently moved to Los Angeles from Pittsburgh, where he was a members of C-19. Robert applied for a scholarship to allow him to pursue post-graduate independent research studies. His intention is to present his independent research on the history and culture of Lithuanians in Western Pennsylvania at the 18th Conference on Baltic Studies, to be held at Johns Hopkins University on June 5-8, 2002. Robert was awarded a \$1,000 scholarship, along with a special one-time award of \$425 funded through a memorial fund for this year only. Over the last year, family and friends of deceased member, Edmund Stumbris, have contributed to a special one-time award in his memory. Edmund was a long-time member of C-141, Bridgeport, Connecticut.

In addition, we awarded several general fund scholarships to several worthy individuals seeking bachelor's degrees:

Meghan Rudmin, C-16 (Chicago) was awarded \$1,250. She will attend the Institute of Art in Chicago, studying fashion design. Meghan also attended the Convention this year.

Lisa Baranauskas, C-136 (Hudson-Mohawk) was awarded \$1,250. She will attend SUNY in Plattsburgh, studying criminal justice and business.

Sarah Miller, C-141 (Bridgeport, CT) was awarded \$1,250. She continues to attend Clemson University, studying French International and Trade Speech and Communication. Sarah attended the Convention this year.

Mary Cius, C-36 (Chicago, IL) was awarded \$1,250. Mary plans to pursue a nursing degree.





Aid to Lithuania, Inc. Report...

The annual Aid to Lithuania, Inc. report was presented by H.M. Robert Boris, chairman of the Board of Directors and founder of ATL, and ATL President, Regina Juska-Svoba. During the 2000-1 fiscal year, five 40foot long containers were sponsored by Catholic Medical Mission Board, NY, NY. The value of the medicines exceeded over 5 million US dollars. Four of the containers were gratis shipments from CMMB. The fifth container's transportation costs will be approximately \$2,500. As the container shipment decreases, and the future is uncertain concerning the shipments, ATL must refocus its goals for medical/humanitarian aid.

The Vilnius Archdiocese founded CARITAS in 1989. During the last 11 years, the CARITAS program has evolved into 8 programs: the Betanija Soup kitchen, the children's daycare center, Home for unwed mothers and children, the pharmacy, social services agency, the united country division and the Mother Theresa's homeless and emergency shelter. When the Board of Directors met during convention, it was discussed and the recommended to adopt or support one of the CARITAS social programs. It was, therefore, decided that ATL would assume the support and financial assistance of the Mother Theresa's homeless and emergency shelter. According to a report received from the ATL in country representative and CARITAS director, Balys Stankus, the Vilnius Archdiocese financially supports 90% of the social programs. The 10% balance is supported by the local government and the generous donations received from our benefactors. During the last three years, the local government's support to the social programs decreased from an average of \$42,500/yr. To only \$14,200/yr. The Vilnius Archdiocese services and supports a significantly large number of the local residents, the homeless, the exploited and the vulnerable. During fiscal year 2000, Mother Theresa's homeless and emergency shelter serviced 18, 480 residents. Each night, approximately 50 people slept in the shelter; and 25 - 50 patients were seen for medical treatment daily. The cited number of residents serviced by CARITAS demonstrated how well the Vilnius Archdiocese contributes to the vital needs and well being of our less fortunate brothers and sisters.


The seminary program is still an active project with ATL. Seventeen (17) seminarians have been adopted. Currently, St. Joseph's seminary in Vilnius has 70 seminarians studying at the facility. Two (2) seminarians will complete their four year program this year and will be ordained as deacons. Financial assistance is still needed for 53 seminarians. It has been announced that Rev. Gintaras Grusas, originally from California, has been appointed the new rector of St. Joseph's seminary.

The CARITAS pharmacy in Vilnius has enlisted the services of Sister Onute Meskenaite, Congregation of Christ the King. She is a registered pharmacist and is employed on a full-time basis by the Vilnius Archdiocese. ATL purchased a computer for Sister's use.

When Robert Boris met with then archbishop Audrys Backis last year, the mission and vision of a trade school was discussed. Although the Archdiocese secured a building in Vilnius, major renovations were needed to the facility before it could be utilized. The archbishop requested financial support in renovating the building. However, another charitable organization financed the total renovations. When Robert Boris met with the Cardinal at his Consistory in Rome in 02/01, a request was made by the Cardinal to assist in financing equipment and tools needed for the trade school. Once completed and furnished, the trade school program would be geared toward the homeless youth, youngster from large families, children with physical and special needs and challenges. The knowledge learned by acquiring a skill would allow the youth to become self-sufficient and independent. The types of courses projected for the trade school include: sewing, plumbing, carpentry, culinary arts and basic home economics. All equipment for the aforementioned programs are needed. Therefore, ATL adopted the project to assist with the trade school furnishing.

ATL will now have four separate humanitarian programs of support: the medical fund, St. Joseph's Seminary fund, CARITAS project - Mother Theresa's homeless and emergency shelter, and Vilnius trade school furnishings/equipment fund. Our benefactors will have a choice as to which program they wish to donate to and financially support. ATL is grateful to the delegates of the Convention and guests for their ongoing financial support to assist our less fortunate brothers and sisters in Lithuania.

Bartkus thanked all who helped the College since the Convention adopted it and became its official Godparents in 1984.

Monsignor stated that Lithuania is still economically weak, and cannot help the College in Rome. It is through donations from outside of Lithuania that the College can still function. The Holy Father continually encourages all the Bishops and Religious Superiors to send their very best students to Rome. It is Divine Providence that Lithuania has its own Seminary-College in Rome, the Center of Christianity, by the Holy See, next to the Vicar of Christ.

Every year books, etc., must be updated, and books are very expensive. He suggested a donation of \$100 per book, or just a "donation for the library." Anna Klizas-Wargo also thanked all and reported on the Masses. There are now Mass cards for Health and Special Intentions, as well as the deceased. Anyone can write her to obtain Mass Cards which are signed by Msgr. Bartkus.

He told of his days in Rome, when he was a Seminarian and the Lithuanian College was his home away from home. 

KNIGHTS OF LITHUANIA FOUNDATION, INC. ACTIVITIES AS REPORTED TO THE 88TH NATIONAL CONVENTION, BY PRESIDENT, LORETTA I. STUKAS



The Knights of Lithuania Foundation met for its Annual Meeting on Thursday, August 2, 2001, immediately following the First Session of the 88th National Convention. The meeting was well attended by Foundation members, and many ideas were enthusiastically discussed.

The Foundation was established in 1983, as an endowment fund of the Knights. It is meant to be a back-up for the Knights, providing funds to support various activities of the Knights and helping Lithuania and Lithuanian projects in the name of the Knights of Lithuania. According to its by-laws, all donations are invested as capital, which cannot be spent. Only interest and dividends earned on the investments may be spent for donations, expenses, etc. Thus, it is to the K of L advantage to raise funds for the Foundation, for the larger the base, the more interest is available for use for special projects. Currently, Foundation Capital is over \$100,000. Funds are invested in banks in Kearny, NJ and Chicago, IL, that are operated primarily by Lithuanian Americans, and in Smith Barney Investment Co.

Anyone donating at least \$100.00 is considered a voting member and has a voice in Foundation decisions. Anyone donating \$5,000 or more may designate how the interest from that investment is to be spent, within the confines of the Knights of Lithuania goals. Such special donations have been made thus far by **Ben Karklius** -- \$25,000, for use for a special annual scholarship, by **Msgr. J. Prunskis, HM,** -- \$10,500, for use in conducting an annual Essay Contest for members, and by **Larry Svelnis, HM, --** \$5,500 for use in special needs of the K of L Archives Committee.

Last year, besides the Karklius Scholarship, the Essay Contest, and Archives equipment, and other expenses, \$1,000 was donated to provide books for poor Lithuanian children, via the Lithuanian National Foundation (Tautos Fundas), and \$622 was spent helping the K of L produce a book of hymns by HM Faustas Strolia. This year, the meeting decided to again help Lithuanian students, via a program of the Lithuanian National Foundation, which allows individuals and organizations to "Adopt a School", and all donations from \$100 to \$500 are matched 50% by the Tautos Funds. The K of L Foundation will donate \$500.00 for a Lithuanian school, so that the school will receive a total of \$750.00 at this time. The K of L Foundation will also donate \$100.00 to help the Vazgirio Church, in Lithuania's Jurbarko district, in the diocese of Kaunas. The church was closed and suffered great disrepair under the Communist occupation, and now is being repaired by the parishioners because of their great need for a church.

The Foundation is led by 11 directors, made up of two directors from each district, plus the National K of L President. This year, two directors – Elinor Sluzas (MCD) and Anna Wargo (AMD) were relected, and a new director, Bernice Aviza, was elected to represent the Mid-Atlantic district. Elinor Sluzas was also elected to serve as Foundation Vice President, and Bernice Aviza was elected to serve as Foundation Secretary. A new project was introduced by Elinor Sluzas and Loretta Stukas, namely a brochure describing the work of the Foundation. The brochure will be completed and distributed to councils and members, as a self-mailer. Also, thanks to a supporter in Dayton, donations can now be made to the Foundation via Credit Card, with minimum cost and work for the Foundation. Printing of the first batch brochures is also being donated.

This year, \$1,500 is available for the Karklius Scholarship, which will be awarded under the auspices of the K of L Scholarship Committee.

A banner year was enjoyed by the K of L Foundation Essay Contest this year, with 17 fine entries. Members were asked to write on a topic of their choice, relating to their Lithuanian Heritage, their K of L membership, or Lithuania itself. Winners this year were as follows:


