





#### Dear Members:



#### 2003 State of the Organization Report

Pursuant to Article XI of the Knights of Lithuania Constitution, I submit to the Delegates of the 90th National Convention, the Annual State of the Organization Report, wherein all reports of the Officers, Committee Chairs, District Presidents, Charity Presidents and organization staff have been summarized for presentation. It is important to remember that this report is just a summary of their work and activities. I strongly encourage each delegate to read each member's full report and after reading them share them with your fellow council members. The work that has been accomplished during this past year is truly worthy of your time and recognition.

Spiritual Advisor – Rev. Msgr. Joseph Anderlonis, STD, HM Msgr. Joe continues to offer a monthly Mass for our deceased members; the names of our newly departed members are included as they are received.

Msgr. attended the Supreme Council Meeting in Washington, DC but was unable to be with us for our meeting in Dedham, MA.

Msgr. served as co-chair for our 1st National Pilgrimage at the Basilica of the National Shrine of the Immaculate Conception where he concelebrated the Mass and led our prayer service in the Chapel of Our Lady of Šiluva.

Msgr. has always made himself available to offer his guidance and counsel when asked. Msgr. remains active in the activities of Council 3.

Due to his parish schedule, Monsignor is unable to be with us for this convention.

President - Robert A. Martin, Jr.

In addition to attending all meetings of the SC this past year I have been honored to represent our organization at many banquets, receptions, meeting and memorials. Some of these include the Capital Hill reception to celebrate the NATO invitee Nations, JBANC Conference and the ALTAS Convention, I sent condolences to the family of HM Archbishop Charles Salatka, attended the wake service for HM Rev. Msgr. Joseph Prunskis, ALTAS's Chicago area Lithuanian Independence Day Commemoration and the Chicago Lithuanian Consulate's commemoration of the 750th anniversary of Lithuanian statehood. During this banquet I was honored as your president to receive the Ordinas "Už Nuopelnus Lietuvai" Komandoro Kryžiumi from K of L Honorary Member and former Lithuanian President, Valdas Adamkus.

Bernice updated the Council President's listing, chaired the Lithuanian Display at the Albany International Festival, assisted with her council's Lithuanian Independence Day, attended the JBANC Conference in Washington and assisted with the 70th Anniversary Commemoration of Darius & Girenas in Brooklyn, NY.

She remains active in her council and district.

Financial Secretary - June Greiner

June attended all meetings of the Supreme Council during this past year. She maintained our mailing list and was responsible for making all updates. In addition, June worked with the Ritual committee to begin the computerization and integration of the national records.

During the year June also submitted articles to Vytis. You will all have the opportunity to work with June as she is chair of the Convention Mandate Committee.

The coming year will see new challenges for the Knights, new experiences and new courses to plot. Our past has shown that together we can achieve any task that comes before us in the future.





At that time, chairman Petrauskas will travel to Chicago to present the Honorary Award to him.

# KNIGHTS OF LITHUANIA FOUNDATION, INC. ACTIVITIES AS REPORTED TO THE 90<sup>th</sup> NATIONAL CONVENTION, BY PRESIDENT, LORETTA I. STUKAS

The Knights of Lithuania Foundation met for its Annual Meeting on Thursday, August 14, 2003, immediately following the First Session of the 90<sup>th</sup> National Convention. The meeting was well attended by Foundation members, and many ideas were enthusiastically discussed.

The Foundation was established in 1983, as an endowment fund of the Knights. It is meant to be a back-up for the Knights, providing funds to support various activities of the Knights and helping Lithuania and Lithuanian projects in the name of the Knights of Lithuania. According to its by-laws, all donations are invested as capital, which cannot be spent. Only interest and dividends earned on the investments may be spent for donations, expenses, etc. Thus, it is to the K of L advantage to raise funds for the Foundation, for the larger the base, the more interest is available for use for special projects. Currently, Foundation Capital is over \$110,000. Funds are invested in banks in Kearny, NJ and Chicago, IL, that are operated primarily by Lithuanian Americans, and in Smith Barney Investment Co.

Anyone donating at least \$100.00 is considered a voting member and has a voice in Foundation decisions. Anyone donating \$1,000 or more is considered an Honored Member of the Foundation. Anyone donating \$5,000 or more may designate how the interest from that investment is to be spent, within the confines of the Knights of Lithuania goals. Such special donations have been made thus far by **Ben Karklius** -- \$25,000, for use for a special annual scholarship, by **Msgr. J. Prunskis, HM,** -- \$10,500, for use in conducting an annual Essay Contest for members, and by **Larry Svelnis, HM,** -- \$5,500 for use in special needs of the K of L Archives Committee.

The Foundation is led by a Board made up of two members from each District, plus the National President. Board members need not have donated to the Foundation, and are selected at the recommendation of the District President and are elected, for a three year term, at the Annual Foundation Meeting. They may be reelected at the Annual Meeting when their terms are up. Currently, Board Members include:

MAD - Loretta Stukas (President) and Bernice Aviza (Secretary)

MAMD - Ann Marie Kassel (Treasurer) and Saulius Kuprys (Legal Advisor)

NED - Clemincine Miller and Arlene Stiklius

MCD - Elinor Sluzas (Vice-President) and Lee Moore

AMD - Irene Ozalis and Anna Wargo

National President - Agnes Mickunas

This year, Board Members Ann Marie Kassel and Clemincine Miller were reelected .

Last year, besides the Karklius Scholarship, the Essay Contest, and Archives equipment, and other expenses, Foundation funds were sent to Lithuania via the Lithuanian National Foundation to support the Lithuanian. Children's magazine "Bitute", and to purchase

Religious Texts for the schools, and to the Rumsiskes Nursing Home to help in renovation.

This year, it was decided to allocate the \$1,500 available to spend on charities as follows: \$1,000 to an Old Folks and Orphans Home in Alytus, Lithuania, operated by the Immaculate Conception Sisters of Putnam. Several K of L members who visited there this past summer reported that the institution is in great need of repair and updates.

\$500 will be donated to adopt 5 schools in Lithuania (\$100 each), that are in need of help. This will be done via the Lithuanian National Foundation (Tautos Fundas), who will match the donations to each school by 50% (\$50.00 each). Because the names of 6 schools were given as in need, and the Foundation had only \$500 available for this project, Mary Beth Slakis, former Foundation Treasurer, donated another \$100, to accommodate the 6<sup>th</sup> school. We are very grateful to her for her generosity.

A brochure describing the work of the Foundation, completed last year and distributed to councils and members, as a self-mailer is being updated and will be available shortly to members.. Copies of the brochure will be available from Loretta Stukas or Elinor Sluzas.

This year, \$1,200 will be given for the Karklius Scholarship, which will be awarded under the auspices of the K of L Scholarship Committee.

The Essay Contest this year yielded not very many essays, but all were interesting and well-written. A report on this year's contest is found elsewhere in this issue.

For next year's and future contests, it was decided that writers be asked to write between 450 and 600 words. Entries not meeting this requirement will be returned to the writers with a request that the essay be modified to fit the rules. For the 2004 Essay Contest, it was decided to allow members to write on any topic of their choice, relating to Lithuania, their travel there, their Lithuanian Heritage, or their membership in the Knights of Lithuania.

Currently, there are 107 members in the Foundation (who have donated \$100 or more). This includes also 18 Councils and all 4 District. Members are thanked for their past generosity and are urged to continue to be generous with the K of L Foundation, keeping in mind that an investment in the Foundation is an investment in the K of L Future. Capital will always be available to invest – and proceeds of these investments will always be used to enhance the name and goals of the K of L.



## Friend of Lithuania Award

#### Recipient: Dr. Kenneth M. Leavitt

"I am deeply honored to be the recipient of The Knights of Lithuania Friend of Lithuania Award," remarked Dr. Kenneth M. Leavitt, during the award presentation. I was very pleased and delighted to present Dr. Leavitt with our Friend of Lithuania Award for his tremendous contributions to the people of Lithuania. Since the reestablishment of Lithuania's independence, his work for Lithuania has been nothing short of monumental.

I would like to share some of his comments and remarks to the delegates at our National Convention and review a few highlights of Dr. Leavitt's activities and achievements. He addressed the delegates, "Fellow citizens of this beloved United States and fellow citizens of our beloved Lithuania. In 1992, I began a journey that took me to the place that you call land of your heritage, and a land that I now call my second home. It was during the evening news in 1991, as the Soviet tanks made their attacks upon the TV production studio, the TV tower and the Parliament in Vilnius, that I first began to take an interest in the country of Lithuania. Lithuania's successful, though costly fight Independence, were the seminal events and the foundation for the many important decisions I would be taking over the next vears."

\*In 1992, Dr. Leavitt invested in and developed The Baltic-American Medical and Surgical Clinic in Vilnius, Lithuania. To this date, it is the first and only private inpatient hospital in Central and Eastern Europe granted a hospital license.

 He received a Doctor of Podiatric Medicine from Illinois College of Podiatric Medicine, Chicago, Illinois in 1983, and started a Private Medical Practice for Foot Surgery in Wilmington, Massachusetts. In 1996, he became the General Director of the Baltic-American Medical and Surgical Clinic in Vilnius, and also maintained a private practice. Since 2001, he has been associated with the Boston Arthritis and Spinal Surgery, Chestnut Hill, MA.

- Dr. Leavitt's work in Podiatric Medicine (foot and ankle surgery) consists of dozens of publications, lectures and training presentations throughout the world, including numerous lectures in Vilnius University Emergency Hospital. Klaipeda City Hospital, Siauliai City Hospital, Pasvalys Regional Hospital, Grodno (Gardinas) Orthopedic Hospital, Belarus, and training programs at the Baltic-American Clinic. He has received numerous professional awards, including the Award for Outstanding Academic and Clinical Contributions, Residency Training Program, Cambridge Hospital (Harvard Teaching Hospital), Cambridge, Massachusetts.
- In 1992, while performing surgery, he met Dr. Manvilius Kocius, who at that time was the chief of Orthopedic Surgery of the Republic of Lithuania. Dr. Kocius was a member of an exchange program organized by Attorney Timothy Jaroch of Belmont, between Winchester Hospital and Vilnius University Emergency Hospital. With the acquaintance of Dr. Kocius and after the exchange of several letters, a formal invitation-was extended to Dr. Leavitt to visit and teach in Lithuania.
- Throughout 1993, Attorney Jaroch, Dr. Leavitt and a close friend, Bob Hawking, grappled with the idea of creating what would become the first such endeavor in eastern Europe, the legal framework for the Baltic-American Medical and Surgical Clinic. Throughout the summer, Dr. Leavitt and Mr. Jaroch shipped supplies of medical equipment and made several visits to Vilnius to participate in the construction of the Clinic. By the end

of 1993, the Clinic was legally chartered. On Sept. 28, 1994, the Clinic officially opened.

- The goals of the Clinic were plain and straightforward: 1) It would be run honestly. 2) It would provide health care to U.S. standards. 3) It would serve as an alternative example to socialized medical system. 4) It would host visiting lecturers and teachers for the benefit of all physicians in Lithuania. 5) From money not used to run the Clinic, free care would be given to those who could not afford to pay.
- Unfortunately, the sacrifices that Dr. Leavitt would be called to make would be much greater than first anticipated. In 1996, Dr. Leavitt made the decision to move to Lithuania to insure that the Clinic would not be destroyed by evil forces. By the end of 1998, Dr. Leavitt lost his home and medical practice to service debits incurred to establish the Clinic. By the end of 2000, attorney Jaroch had made over 15 visits to Lithuania at his own expense, and donated over 7000 hours of legal time to deal with the corrupt behavior of a few, Soviet era Lithuanian doctors, who tried for years to close down the Clinic.
- From July, 1996 to June, 2001, Dr. Leavitt, his wife, and daughter lived, worked, fought and succeeded in Lithuania. In the face of many hardships, the Clinic prevailed and succeeded. It hosted over sixteen visiting U.S. Nurse and Physician volunteers and has provided free care for over one thousand people of which more than 80% were disabled and suffering children.
- Mr. Andrew Silski, U.S. State Dept. Country Officer for Estonia, Latvia and Lithuania Office of Nordic and Baltic Affairs, wrote to Dr. Leavitt: "I want to thank you for the extraordinary health care that the Clinic brings to that country. The facility you helped create remains an island of quality medical care

and hope in Lithuania and surrounding areas. That is a testimony to your medical skills and your commitment to the Clinic's mission."

Although I spoke with Dr. Leavitt by phone numerous times, I was honored to meet and speak with him and his daughter, Rebecca, in person at the Convention. From our conversations, I am certain that we could not have chosen a more dedicated and deserving individual for the Friend of Lithuania Award.

I wish to thank Maryte Bizinkauskas for her assistance in choosing such a worthy recipient for this Friend of Lithuania Award.

A new stove has been ordered at a cost of ten thousand American dollars. He thanks all who helped in the past, and asked the Knights to continue their support and help in maintaining the College.

Anne also thanked members who have supported with donations and Masses. Mass stipends are \$10.00, and the student priests rely on these stipends for their living expenses, as they come to Rome with nothing. Mass Cards can be obtained from her, for the deceased, the ill and special intentions. She asked members to support the Mass intentions. Many churches have closed or been combined and Masses are hard to obtain. By supporting the Masses at the College, you are assured you loved ones will be remembered and you are helping a Lithuanian priest. The Knights officially adopted the Lithuanian Pontifical College in Rome, and she asked members to remember the Knights Godchild. It is important to the Lithuanian Church, as it is the Lithuanian gateway to the Vatican. By helping the

Aid to Lithuania Report...

Fellow Knights,

On behalf of Robert S. Boris, founder and Chairman of the Board of Directors of Aid to Lithuania, Inc., I express and extend his and the Officers' greetings to all the delegates and guests of the 90<sup>th</sup> National Convention gathered here in Dedham, MA.

By now, most of you had the opportunity to see, or even to read, my detailed annual report. 2002-2003 was a good year for Aid to Lithuania. Since the 1990 National Convention in Pittsburgh, ATL continued to help our less fortunate brothers and sisters in Lithuania. With the ongoing publicity about the Knights of Lithuania's ancillary arm of ATL in the Lithuanian press, particularly in DRAUGAS, a worldwide daily newspaper, donations continue to flow in. The Lithuanian public around the world is aware of the Knights of Lithuania's activities and assistance.

The summer of 2003 marked two significant events in Lithuania - the International Song and Dance Festival and the 750th anniversary King Mindaugas' coronation Lithuania's first and only king. Spectators from all four corners of the world converged in Lithuania to witness the events and participate in the celebrations. Many people took excursions to visit their parents', grandparents' or great-grandparents; homeland. For some travelers, it was a first visit to the motherland, while for others it may have been the 5th or 6th trip.

While touring the famous historical treasures of Lithuania, dining in fine restaurants, staying in 4 star hotels with all the amenities one could imagine, it may be assumed by tourists, and even some of our own members, that the current living situation in Lithuania appears to be looking good and has vastly improved over the last several years, and that poverty does not exist. People are becoming more prosperous, jewelry and art galleries abound, shops are busy, boutiques carry

designer merchandise. restaurants iammed. casinos are promoting good people business. drive BMW's and Mercedes. Walking along Gedimino Prospektas in Vilnius and Laisves Aleja in Kaunas, people are well-dressed and exude a certain confidence about themselves. With what the average tourist is shown on an excursion, a false conclusion may be drawn about Lithuania as a country and her people. One only has to seek out and look a few blocks from the main streets, places tourists and perhaps some of our members seldom or never see, to visualize and experience the true needs of the Lithuanian people. For the last 13 years of ATL's existence, and with the ongoing and committed support of many members' financial donations, we have been able to assist and promote many of the requested projects in Lithuania. We were able to send 92 containers of medications. medical supplies, equipment, church pews, statuary, etc., whose value exceeds 71.5 million dollars!

During my trip to Lithuania last month, I was able to witness first hand the day-to-day activities of the various projects that ATL supports.

ATL's in-country representative, deacon Balys Stankus, provided an intensive 4-day program. We visited Mother Teresa's Homeless and Emergency Shelter. During the summer months, approximately 60 people reside in the shelter on an ongoing basis. Upon entering the shelter, each resident is required to sign a contract indicating that he will abide by the rules and regulations. The average length of stay is 30 days. Residents are encouraged to seek employment. The residents prepare their own meals. Those who cannot may go to the soup kitchen where the Mother Teresa's sisters and two male volunteers serve up a meal. A volunteer physician treat residents with minor medical problems. During the winter months, the third floor attic area is used to provide warmth and shelter from the cold elements. Last summer, Vilnius was doused with torrential rains, and the shelter was severely damaged. A plea for emergency assistance was made. ATL, generous donors and particularly "angels" from Dayton, helped finance the repairs. A significant amount of the work has been completed.

We visited the CARITAS pharmacy and spoke with Sister Onute, pharmacist who sorts and categorizes all medical supplies and medications received from CMMB from New York. She supervises the distribution of the medications/supplies to the nearby hospitals, clinics, shelters and smaller pharmacies. During 2002-2003, three 40-foot long containers, whose total value is \$3,837,120, were shipped. Much needed antibiotics, aspirin, vitamins, beta-blockers, motrin, immodium, shampoo, syringes, bandages and orthopedic supplies were received and distributed.

The Vilnius Handicraft Center or Trade School is progressing since it first opened its doors in 2001. Currently, 18 students from large families, some adults, and those who have minor physical/emotional challenges study and live at the facility. The living quarters are located on the third floor. The Trade School has established the following programs: culinary arts, wood carving, art and furniture restoration, sewing, knitting, crocheting, metal work, printing, electrical repairs, auto mechanics and jewelry repair. In the near future, a computer program will be established. The most popular program is the culinary arts. The practical work is done next door at the Betanija Soup Kitchen. Local masters of each of the programs teach the students. For truly effective training, only 3 students are assigned to each master instructor. The average training program lasts 2 years.

The Betanija Soup Kitchen is opened daily and feeds nearly 600 people daily. A volunteer physician visits weekly to examine and treat patients who have medical ailments. During holidays, Cardinal Backis visits, dines and interacts with the people.

The Mother and Children's Home was also visited. Presently, 10 mothers and 18 children and three pregnant girls reside in the

home. The youngest girl is 15, while the oldest is 29. There was an opportunity to speak with the mothers. It is evident that the mothers love and have a special bond with their children. They are concerned about them and their future. The mothers prepare their own meals for themselves and their children. There are classes where they learn to cook, sew and care for their children, and learn independent life skills. The Mother and Children's Home employs one psychologist and four social workers. Two physicians and several university medical and social students volunteer their services. The psychologist works closely with the mother to determine her and her child's problems and crises. She assists in document preparation for financial assistance and helps rebuild relationships with family and friends. The physician treats the mothers' and children's medical problems, gives lectures on health, hygiene, sexually transmitted diseases, HIV and AIDS. It is interesting to note that most of the children's fathers are from Germany, and it is difficult, if not impossible to obtain any financial assistance from them for their children (there is no Friend of the Court of Child Support system in place yet). Fifty percent of the mothers are Lithuanian born, and 50 percent Lithuanian citizens from Germany Poland

I visited St. Joseph's Seminary. Rev. Robertas Salasevicius is the newly appointed rector of the seminary. During my visit, he was out of the country, and I spoke with his assistant, Rev. Albertas. Presently there are seminarians; from Vilnius Kasiadorys (14), and Panevezys (14) dioceses studying at the seminary. All are Lithuanian citizens. ATL supporters have "adopted" 17 seminarians for six years, by committing to finance their room and board care and educational expenses in the amount of \$2,000 per year. It gives great pleasure to announce that 4 priests have been ordained in 2002-2003! And, two seminarians were ordained deacons. Algis Simkus, whose sponsors are Adele Bagdon and Olympia

Zielinski, and Tadeus Jasinski, whose sponsor if Rev. Peter Shakalis, were ordained in 2002. In 2003, Vaidas Vaisvilas, whose sponsor is Mr. and Mrs. Bednediktas Karkllius, and Janus Andriuskevic, whose sponsor is Mrs. Nellie Stodolski, were ordained priests. Andrius Sukys, whose sponsor is Bob Boris (in memory of Vincent Boris), and Liudvikas Liutkevicius, whose sponsor is Mr. and Mrs. Jonas Motiejunas (in honor of the Motiejunas family), were ordained deacons. The youngest seminarian is 19 years old, and the oldest is 35 years old. During their free time, the seminarians engage in sports activities, act as pilgrims and visit parishes, serve as spiritual advisors and counselors at schools and social settings. During their summer vacations, they spend time at youth camps serving as spiritual advisors, return to their families, and others visit churches and lead pilgrimages.

Holy Cross parish was visited. One of the buildings is used as a warehouse to store the medications and medical supplies received from CMMB. The building is old and in need of repairs. The leaking roof, gaping cement floors, broken windows and beams were minimally repaired. No further repairs could be completed due to lack of funding. As the parish is not located in the best of areas, three German Shepherds serve as guards to monitor the building from theft.

As of May, 2003, the All Saints parish program, located in the highly trafficked poor area near the train station, was assigned to CARITAS by Cardinal Backis. It consists of a day center and residential facility for teens aged 14-18. Presently there are 12 residents, (6 boys and 6 girls). The youths come from families with chemical substance abuse neglected/abused problems, environment, and the youths themselves have a chemical dependency problem. Gluesniffing is prevalent, as it is an inexpensive habit. The youngsters attend a local school. While at the facility, the youths learn independent living skills: clean and maintain their immediate surrounding living area, meal preparation, and care for their clothing and

themselves. The director and social worker make valiant attempts to reunite the families, but oftentimes are unsuccessful, and the youths reside in the shelter for up to three years. Various activities, groups, sports are encouraged. The day center program includes tutoring, catechism, games and sports. The residence and day center employs one director and three social workers. A volunteer cook helps with meal preparations. The physical appearance of the outside and inside of the day center is at utmost, disturbing. Black mold (pelesai) is prevalent everywhere - on walls, ceilings and floor. There is a strong, profuse, musty odor throughout the center, which poses a danger to the staff and youth. Emergency financial assistance is needed to alleviate the danger. On July 5, 2003, Cardinal Backis hosted a

conference, "Karalius Mindaugas-krikscionis (King Mindaugas-Christian). Over 100 dignitaries and guests attended. Among them, LR President R. Paksas and wife, Laima, prof. Vytautas Landsbergis and his wife, Grazina, LB(LAC) president, Vytautas Kamantas and wife, Theresa, bishop Paulius Baltakis, correspondents from Veidas and Elta After the conference. commemoration of King Mindaugas' 750th anniversary of his coronation, Cardinal Backis presented awards of gratitude in aiding Lithuania. Among the 14 recipients -Bishop Boruta, Bishop Baltakis, prof. Vytautas Landsbergis, ATL founder and Chairman of the Board, Robert S. Boris, and ATL president, Regina Juska-Svoba.

The CARITAS program activities would be virtually impossible to continue without the active and ongoing support of various organizations, individuals and private donors.

Visiting the various ATL supported programs, it is evident that all the financial donations received from K of L members, councils, districts and individuals, are well utilized to aid Lithuania's less fortunate. Financial assistance from the local government is ever decreasing, while the ongoing maintenance of the programs and the

expenses are always increasing. Due to the current situation, financial support is extremely necessary to continue the much needed and required programs. ATL's primary focus continues to be that our brothers and sisters in Lithuania are at least a bit more comfortable, healthier, a bit more satiated, formally educated and spiritually renewed today and in the future. The Knights have always been supportive, generous and have come through whenever the call for assistance was made. Only with your support of the CARITAS programs, Vilnius Handicraft Center and St. Joseph's Seminary adopt a seminarian program, will the services continue uninterrupted and bring a brighter hope for tomorrow's future today!

The Financial Secretary must have knowledge of using a computer and access to one, as the organization membership records are computerized.

after the games.


The resolution to reestablish was passed unanimously, and Linas Balsys was officially elected as Chair of the new Committee during the Saturday session.

Summary of Sessions ...

Council 1 of Brockton, host of our 90<sup>th</sup> Convention, chose as its motto,"Pakelkime balsus - Let us lift up our voices," and that the delegates and other participants did, whether by the beautiful liturgies with hymns and songs, during the sessions with reports, the entertainment evenings, by their greetings and resolutions, donations to the various charities as voices for the unfortunate, and ending in voices of Joy and celebration for 90 years of the existence of the Knights of Lithuania.

After the Opening Mass, initial ceremonies and presentation of the Presidium members, Robert Martin, Jr., began with his State of the Organization address. Greetings in person were given next. The Mandate Committee then reported 105 participants attending this First Session. That same evening we were delighted by the entertainment of the "Sodauto" folkloric dance and song group.

August 14th, Friday, the Feast of Mary's Assumption and a holy day of obligation found us attending Mass at St. George Parish in Norwood, MA. Rev. W. Wolkovich, pastor, and his parishioners, extended their true hospitality to the K of L'ers. Father then uplifted our spirits by playing on his violin after Communion, the hymn, "Lord, You Have Come to the Seashore." The second session then began with the distribution of membership awards by Becky Pataki, Supreme Council 2nd Vice-president. She then reported that the K of L added 101 new members to its roster this year. Kathy also informed the Convention participants that the K of L now has approximately 3,000 member nationwide. An important feature of the second session was the revival/reinstatement of the K of L Sports committee as part of the Supreme Council. A presentation/proposal was made by Larry Misevicius, Linas Balys and Joe Stiklius. The proposal was unanimously accepted by the delegates, and Linas Balys was selected as chairman of this committee.

Loretta Stukas, HM, then presented the K of L Foundation Report, and also announced the winners of this year's essay contest. A reading of various resolutions followed. Ninety-four delegates attended this session.

The third session began with an excellent panel presentation by Rev. William Wolkovich, regarding the emigration of Lithuanians to the U.S., and a bit of the history of the Knights of Lithuania. Rev. Wolkovich was also awarded Honorary Membership during this Convention. Frank Petrauskas, HM, presidium chair for this session then repeated the names of this year's candidates for Honorary Membership. The candidates for 2004 are: Bernice Aviza (C-136), Ann Marie Kassel (C-157), and Veronica Bizinkauskas (C-1).

Lee Moore then gave the Ritual Report and announced the names of those members who would be receiving their Fourth Degree this year. Regina Juska/Svoba, ATL president, then proceeded with her annual report to the Convention.

The fourth Plenary Session consisted of the Donations' Committee Report, St. Casimir Guild Report, the Mandate Committee report and the Election of Officers for the Supreme Council for the 2003-2004 term, selection of a Convention site for 2004, the Juniors' Report and Presentation, Resolutions, Final Donations' Report, and announcements and instructions. The session ended with a prayer and the singing of the Vyciu anthem. Everyone then rushed to get ready for the evening banquet. Presentations during the Banquet were: 2003 K of L Scholarship, Honorary Membership presentations, and the "Friend of Lithuania Award" to Dr. Kenneth Leavitt, followed by his acceptance speech. People staved to dance the night away, and the Juniors had their banquet in the New England Room. They later joined the adults for dancing.

Sunday, August 17th, found us boarding the bus for the closing Mass at St. Casimir's Church, with Bishop Richard Malone of the diocese of Boston in attendance. Immediately after the Mass, the convention photo (with people expertly arranged by Maryte Bizinkauskas), was taken on the steps outside the church. All then enjoyed a farewell luncheon in the hall. The new and old Supreme Council members then went to the parish rectory for their first meeting of the year. The buses then took everyone back to the hotel where delegates and friends bid each other farewell, with a promise to meet again in Kearny for the 91st Convention. Everyone agreed that C-1 did a superb job! Kudos to them!




