

Knights of Lithuania 92nd National Convention State of the Organization Report

In accordance with Article XI, Section 2 of the Knights of Lithuania Constitution which states that the President prepares the Annual State of the Organization Report, the following is a summary of all reports that have been submitted. All delegates are urged to take home a set of these reports, read them and share the contents with your Council members.

Spiritual Advisor - Rev. Msgr. Joseph Anderlonis, STD, HM

- Msgr. Joe hosted the Supreme Council meeting in October in October 2004 with the assistance of Council 3.
- Monsignor also traveled to Pittsburgh, PA to attend the Supreme Council meeting held there in April.
- A monthly Mass is offered by Msgr. Joe for deceased members of the Knights of Lithuania.
- Monsignor has met with the President on several occasions to discuss issues important to the Knights of Lithuania. Monsignor has provided advice and counsel for which we are grateful.
- We are very grateful to Monsignor for his continued friendship and support.

President - Agnes V. Mickunas, HM

- I presided over three meetings Kearny, NJ; Philadelphia, PA; and Pittsburgh,
 PA. I represented the K. of L. at the Lithuanian Embassy in Washington, DC on
 February 16 and also Lithuanian Independence Day ceremonies in Philadelphia
 and the St. Casimir Day celebration in Gulfport, FL I was privileged to meet with
 Ambassador Ušackas at these three events.
- It was an honor to be invited to the 45th "Memories of Lithuania" banquet in Chicago on February 5. I was able to address the guests on behalf of the Knights of Lithuania and most importantly, to meet and be in the company of Honorary Consul Vaclovas Kleiza and his spouse. ST. CASIMIR GUILD REPORT

Saturday morning's session began with the St. Casimir Guild report. President, Anna Klizas Wargo, thanked all who supported the Lithuanian Pontifical College. The TV project was successful and the Guest House now has a TV in each room.

There was one change in the Board of Directors.

Betty Tumas of Council 144, Amber District, resigned as Secretary-Treasurer. Lillian Greymas, Council 3, Philadelphia, Amber District, was appointed and accepted.

Anna again stressed the importance of requesting Masses at the College. The Student Priests depend on the Mass Stipends to help them with their personal needs. Mass cards can be obtained from her. There are Masses for the deceased, healing and special intentions. Many members have supported the Masses. Some of our churches have been closed or combined. Since it is no longer possible to obtain Masses in some of these places, she suggested members use the

Pontifical College through the St. Casimir's Guild. Specific dates can be obtained, if required.

Msgr. Algimantas Bartkus, Rector of the Pontifical Lithuanian College, then spoke. There will be ten new Student Priests at the College this year. He stated that many renovations have to be done. Thanks to the Vyciai, he had started an endowment fund many years ago and much of the expenses will be covered from this fund. His project for this year is to improve the rooms of the students. Nothing has been done in the rooms for a long time. New desks are needed to accommodate computers and to freshen the rooms for the students. He asked for help in this project. There are ten rooms, and the goal is \$1,000.00 for each room. He again thanked the Vyciai for adopting the college and for all the good we have done through the years. Ours is the only Lithuanian organization that has done so. He expressed the importance of keeping the College alive and well, because it is Lithuania's entrance to the Vatican.

Jordi Rivero, pastor of St. Raymond parish in Miami Florida, expressing interest in the website and requesting permission to use the material on a Spanish website. Father Rivero is the webmaster of the largest Catholic Spanish internet portal which is faithful to the megisterium (www.corazones.org)

Celebration of the 40th Anniversary of the Siluva shrine in Washington is in the planning stages. Julia Schroder spoke to the basilica clergy, reserving a date of October 8, 2006, with a 2p.m. Mass for this celebration. The Knights have been asked to take the lead in this celebration by the Shrine officials. Julia and Rob Martin are cochairs of this celebration.

A GUEST SPEAKER from JBANC, Mr. Karl

Altau, who is also its managing director, was introduced by SC president, Mrs. Agnes Mickunas, HM. These are some of the highlights from his presentation:

In order to remain politically active, JBANC will focus on the following goals:

- the legacy of Communism and its effects
- the expansion of Democracy beyond the Baltic borders
- 3. keeping an eye on Russia
- 4. strengthening the Atlantic and the Baltics
- cooperating more with other likeminded organizations; power can be found in numbers.

A recent success, he mentioned, due to the efforts of Congressmen Shimkus and Durkin, was the passing of the proposal to make Russia apologize for its occupation and illegal annexation of the Baltic countries. Working with Poland on some of these issues is critical. He then added, that we have a collective responsibility to keep this issue (of apology) active. Many other European nations are also concerned about this matter.

Mr. Altau reminded the delegates of the project of the construction of a special memorial in Washington, DC, which will be dedicated to the victims of Communism. There is a committee seeking to raise funds for this purpose. Added to this project is also that of erecting a special museum. The memorial is expected to be completed some time next year. The design of

the memorial is based on the figure of the goddess of Democracy, since this is a nationally recognized symbol.

JBANC really depends on the funds of 3 organizations who give quarterly contributions. If anyone wishes to help with the Memorial, they can send contributions to ALTAS.

Mr. Altau ended by saying, that he would gladly accept any of our ideas and suggestions. Also, if anyone would like to see a Congressman, he can set this up.





FRIEND of LITHUANIA AWARD Recipient - Sr. Margaret Carney, OSF, STD

"I am truly honored to be the recipient of the Knights of Lithuania Friend of Lithuania Award," spoke Sr. Margaret Carney, OSF, STD, President of St. Bonaventure University. During her acceptance remarks she said "I am deeply touched by the faithful pursuit of my participation in the ceremony on the part of the Knights of Lithuania." Sister Margaret's academic achievements and her Lithuanian assistance activities have been nothing short of monumental.

Sr. Margaret most recently served as senior vice president for the Franciscan charism as well as director of the University's world-renowned Franciscan Institute, and previously as dean of Franciscan Studies. She has taught around the world at the Franciscan Institute of Asia in the Philippines, at the Antonianum in Rome, and has lectured extensively in the U.S., Africa, and Europe.

Sr. Margaret was the first woman to have earned a doctoral degree from Franciscan University in Rome. This degree, a doctorate in sacred theology (S.T.D.), is the unique degree given by Pontifical universities and promotes a particular recognition by the church. In addition to her doctoral degree, Sr. Margaret holds bachelor's and master's degrees from Duquesne University, a master's degree from the Franciscan Institute, and honorary doctorates from the Franciscan University of Steubenville (Ohio), and Madonna University of Livonia, Mich.

From 1995 to 1997, Sr. Margaret chaired a task force on leadership roles for women in the Catholic Church. She is a member of the International Commission on the Franciscan Intellectual Tradition, as well as a member of the International Society of Franciscan Studies. An internationally known speaker on Franciscan life, she has presented numerous lectures at national and international conferences.

Prior to becoming a member of the Franciscan Institute faculty in 1997, she served eight years (1988-1996) as general superior for her community, the Sisters of St. Francis of the Providence of God, in Pittsburgh, Pa.

Sister's Lithuanian activities began when she was a student at St. Francis Academy. For two years she sang in the Lithuanian choir that performed at the annual Christmas pageant in Pittsburgh. She can still sing these carols. In 1959 she joined the Sisters of St. Francis of Whitehall, Pa. . As a young teacher, she served in a number of Lithuanian parishes and

became acquainted with many Lithuanian priests in Pittsburgh and beyond.

As

Lithuania reestablished its independence, she responded to a call from Bishop Paul Baltakis to attend a special meeting for religious and church personnel with connections in Lithuania. Initially, two sisters volunteered to go to Lithuania to begin a small mission in Utena. Since the initial beginning, the sisters have collaborated with Caritas of Lithuania and with religious women working there.

During these years, US sisters have given various amounts of time in mission service. The sisters have worked in catechetics, lay formation, pastoral activities and the establishment of St. Clare Hospice in Utena. Also, for two years the sisters have worked with the Franciscan Friars (Kennebunkport) at their college in Kretinga.

Sister Margaret visited Lithuania in 1995 for a first hand understanding of the activities of the sisters and the opportunities for assistance to the Lithuanian people. This experience left a "profound impression and insight into the plight of a suffering nation trying to rebuild its economic, social, spiritual and international existence".

In 2004, St. Margaret became the President of St. Bonaventure University. Sister said she would like nothing better than to find a way to recruit students from Lithuania to the Franciscan university. This year, Lithuanian student and basketball player, Saulius Dumbliauskas, have graduated from the University.

I am very pleased and honored that we have presented this year's Friend of Lithuania award to such a worthy recipient as Sr. Margaret Carney.

Our Aid to Lithuania Board Members

AID TO LITH. REPORT HIGHLIGHTS

Since its inception 15 years ago, 92 forty-foot long containers of vitally needed medications, medical supplies and equipment (consisting of bandages, gauze, surgical gloves, scrubs, sutures, antibacterial soaps, walkers, crutches, canes, prosthetic devices and mannequin), X-ray machines, examining tables, hospital beds, night stands, dentist's equipment and chair, computers, clothing, have been shipped to Lithuania. The contents of St. Peter's Church in Detroit were shipped to Rev. Leonas Jakimavicius in Alytus for his new church, Our Lady Help of Christians. The total dollars' worth value of these containers is an incredible and astounding \$72,000,000! Who could have and would have thought at that time that so much could and would be accomplished?!

The contents of the containers were distributed to: Caritas – Kaunas, Vilnius and Marijampole, St. James hospital in Vilnius, the University of Vilnius Hospital in Vilnius, Kaunas Catholic Maternity Hospital in Kaunas, St. Clare's Hospice in Utena, the Children's Day Center – "Angel of Hope" (Angelo Vilties Centras) in Vilnius, the Family Center in Vilnius, Betanija Soup Kitchen in Vilnius.

Another of ATL's sponsored programs is the Seminary Fund. Well-trained priests are able to meet the challenge of Lithuania's greatest need for spiritual renewal. ATL, in cooperation with the archbishop of Vilnius, Cardinal Audrys J. initiated a program, whereby a seminarian studying at the St. Joseph's Seminary in Vilnius, would be "adopted" by donors willing to provide an annual scholarship of \$2,000/per for 6 years of studies. There are approximately 70 students enrolled in the seminary. Since its inception in 1999 until 5/20/05, there have been 95 adoptions at \$2,000 each, 224 misc. donations (under \$2,000) and the establishment of the Baronas Family Scholarship fund. The total amount received in the last 6 years totals \$338, 984.74. Since 2002 to the present, 14 deacons were ordained priests. Of these, 10 were ordained priests during the 2004-2005 fiscal year. In 2004-5, 3 seminarians were ordained deacons. On 4/10/05, Janus Andiuskevic, ordained priest in 1/03, was tragically killed in an automobile accident by a drunken driver.

Another ATL sponsored program is Mother Teresa's Homeless and Emergency Shelter, which opened its doors in the Fall of 1999. Mother Teresa' Shelter provides religious and humanitarian aid activities. The Shelter provides room, board and meals to approximately 124 homeless people in Vilnius on an ongoing basis. The sisters render medical, material and spiritual assistance and guidance to the individuals. The shelter provides a safe and warm haven for adult males and females who have little or nothing.

The next program of ATL is the Vilnius Handicraft Centre (Vilnius Trade School.) The Trade School opened in 2001. Currently there are 18 students from large families, those who are somewhat physically or mentally challenged and some adults study and live in the facility. The school established the following curricula: culinary arts, wood carving, art and furniture restoration, sewing, knitting and crocheting, metal work, printing, electrical work, auto mechanics, jewelry repairs and computer programming. The practical work is done next door to the Trade School, where the Betanija Soup Kitchen is located. Local masters in their respective area of expertise, teach the students a skill so that they can become independent and employed. The average training program lasts two years. In November 2001, Prince Charles visited the Trade School and presented the student and staff with gifts.

Aid to Lithuania's most notable achievement in the last 15 years is getting people involved. High level personal involvement and volunteerism from all corners of the United States has sustained its mission. It is individuals' voluntary commitment and participation coupled with donor generosity and the ongoing support of the Knights of Lithuania, that has brought about outstanding success.

If ATL is to continue this great work of Christian charity, we must *all* participate, work together harmoniously and support each other's valiant efforts. No one person can to it all. No one person can do it alone.

We are all members of a great organization, the Knights of Lithuania, that has been in existence for 92 years! What other organization can speak of such longevity?! We must continue to work

cohesively as a team. - Regina Justoa S.
