The Lithuanian Affairs committee of the Knights of Lithuania was organized by Fr. John C. Jutt (Jutkevicius) in 1946 as an all-out effort to keep Soviet-occupied Lithuania's plight known to the world outside the Iron Curtain and to the United States Government. Fr. John devoted much time and effort to this end and started the "100 letters a year" awards within the K of L.

Present day issues include legislation passed in the Senate and in the House to address the Russian Federation to acknowledge the illegal seizure of the sovereign Baltic nations from 1940-1991; erroneous news articles, most recently in the Chicago Sun Times by Andrew Greeley which termed the Yalta give-away of the Baltics as a "Big....Lie", persist. Action is still required.

Work continues by way of the Fr. Jutt Fund, formed in respect to Fr. Jutt's work. The Fr. Jutt Fund is used to disseminate information to the K of L Councils, nation-wide, for reponse to Lithuanian news and events- to correct and counter and/or to praise/thank for positive news/events. Different communication techniques are utilized due to different circumstances. Emails are augmented with regular mail.

At present, a request for donations is indicated. To this end, I write to ask your assistance. Many needy causes approach you, daily, and there are many worthwhile efforts underway. Please consider the Fr. Jutt Fund as worthy, also. Whatever your contribution may be, it is appreciated.

We shall also resume the recognition of "One Hundred Letters a Year" but the annual plaque will be replaced by a certificate. Please track your letters, individually, and submit the total in May/June (to National). C-157, Lemont, came up with the idea of incorporating letter-writing at their meetings; topics will be provided by their Council Lithuanian Affairs Chair. This is great! Because the whole world is "busy", we need to keep letters "short and sweet" - not just for us, but we also have about 10 seconds to get the recipient's attention. Each council/district has their own local and national leaders and newspapers to reach.

Some issues will be networked from "national" as they arise; If you haven't received email or US Postal news yet, and wish to do so, please let me know to add your name to the list. I'm still compiling adddresses.

Recent issues have been:

1. Continued monitoring of closing of Lithuanian churches.

2. Senators Lugar (IN) and Barak Obama (IL) detained in Siberia (8/29) while inspecting destruction of old Soviet WMD's. (Nunn-Lugar Amendment)

3. ARMED Russian jet crashed near Kaunas, Lithuania (9/15), violating Lithuanian/NATO airspace. .."accidental...

not a provocation.... pilot released". Plane was enroute to Kaliningrad from St. Petersburg.

4. The above incident is proof that Lithuania is in a high risk zone. The demilitarization of Kaliningrad is a project, especially because there have been no hostilities between the Kaliningrad residents and their NATO neighbors, Lithuania and Poland. (Address our State Dept., NATO, Legislators, Baltic Caucus-House and Senate,local newspapers)

5. Revision of issues that were corrected in the 40's - e.g Russian denial, again, that Lithuania was forcibly subjugated by the Soviets- have resurfaced and must be addressed again. On an ongoing basis, WE need to

prevent EROSION of the TRUTH.

We need to be PROACTIVE; if only REACTIVE, the goals and agenda are set by others.

XIV Lithuanian American Council Convention 90th Anniversary of A.L.T.A.S. October 21-23-2005 Knights of Lithuania Representative's Report

On Friday, October 21, the Pre-Congress Reception took place at Balzekas Museum, 6500 S. Pulaski, Chicago, IL. This event was very-well attended.

On Saturday, October 22, two business sessions took place at the SSC Motherhouse, 2601 Marquette Rd., Chicago Illinois. The morning discussions were in Lithuanian and the afternoon session was in English. After registration, Saulius Kuprys, President, opened the sessions with a welcome by Sr. Regina, SSC, and greetings; the first symposium was on ALTAS's 90 years - history, impact, questions,future. Participants were Petras Buchas, dr. Jonas Valaitis, and Pranas Jurkus. All presented frank, forthright facts and questions, even as to continuation of the organization. There was general approval that much purpose and work remains. Consul Daunoravicius spoke in behalf of Lithuania.

Next, Saulius Kuprys, President, presented information on changing immigration questions.(No visa relative to immigrant status/non-immigrant"visit" status)

Dr. Darius Furmonavicius of the UK then spoke on the Kaliningrad (Karaliaucius) issue. Re: demilitarization, Russian military aspects should be removed - in a rapid, orderly, and complete manner. A map of Stalin's red-line boundary was provided and information re: lack of documentation to Soviet "rights" to this territory. Also, the Victims of Communism Memorial progress and dissemination of information on Lithuanian issues via libraries, universities, etc. Attention needs to be increased re: restitution to victims, environment, etc. for the damage during the Soviet occupation.

Discussion on the "exodus" of young Lithuanians - the statistics, reasons, remedies and incentives followed. Participants were Dr. Jonas Valaitis, Prel. Edmundas Putimas, Jonas Stundzia, Algis-, and Tomas Rinkunas, a student at UIC.

A plentiful, delicious meal and beverages were provided before resuming the meeting.

The afternoon sessions started with a talk on the Lithuanian American Brigade by Henry Gaidis, formerly USAF, FBI, retired in MD, and a volunteer at JBanc. Starting with 1914, changes in names of the organization. Mr Gaidis developed the trail to the present.

Victims of Communism Memorial and JBanc were discussed by Dr. Lee Edwards, Chairman of the Foundation. The groundbreaking is anticipated for Spring, 2006, and the Dedication will be November, 2006.

Dr. Michael Szporer of the University of Maryland gave an eloquent and humorous talk on Solidarity and Sajudis.

Our State Department's Representative, Thomas Navratil, Office of Nordic and Baltic Affairs, presented "Baltic States Issues: A View from Washington. Numerous topics were included, e.g. The recent Russian Jet crash in Lithuania, Immigration, NATO, The friendly relationships between the US and Lithuania, etc. The topics and delivery were impressive. The Roundtable: Dr. Ramunas Kondratas, Dr. Darius Furmonavicius, Karl Altau, Tomas Rinkunas.



I ne Mid-Central District Fall Pilgrimage

After the Fall meeting and lunch, the delegates of the Mid-Central District gathered at Sweetest Heart of Mary Church in Detroit, for the pilgrimage. Sweetest Heart of Mary Church is truly an architectural gem. The style of design is classified as late 19th century Gothic or late Victorian Gothic of cathedral proportions. Its height and grandeur recall the mediaeval notion, that the cathedral was the center of the community. The guide gave an interesting history of its beginnings. In 1886, a group of Polish immigrants organized a school that was the beginning of Sweetest Heart of Mary parish. On December 8, 1888, the Rev. Dominic H. Kolasinski, former pastor and builder of the neighboring St. Albertus Church, became their pastor without Episcopal approval. Under his leadership, construction of the late Victorian Gothic Church began in 1890. On February 18, 1894, the parish officially became part of the Diocese of Detroit. Sweetest Heart of Mary Church was founded in 1889 by Polish immigrants who fled their homeland from oppression and settled in Detroit. The interior of the church is amazing, artistic and breathtaking. The church's uniquely beautiful stained-glass windows, made by the Detroit Glass Works, won prizes at the 1893 Chicago Columbian Exposition. Its organ, built in 1894, is one of the oldest _Austin organs in existence. The façade window, or the organ window, has what might be called a politically inspired motif. In its starshaped design, it features symbols of the Polish nation. In the center of the window is the Madonna with Child. On the left is the Polish Eagle; on the right is the Knight of Lithuania, and at the base, St. Michael, representing White Russia. Together, this was all to symbolize Greater Poland.

Other interesting facts about Sweetest Heart of Mary: its 217 foot spires house three large bells, named St. Mary, St. Joseph and St. Barbara; the elaborate main entrance has solid oak doors; the chandeliers are Victorian style, made of Tiffany glass; all candlesticks are hand-carved brass; and the interior was built to seat 2,400 people. This magnificent church was hailed as one of the most beautiful gothic structures in the State of Michigan, and as the largest and grandest Polish church in the US. In 1981, Sweetest Heart of Mary Church was dedicated as a Historical Monument by the State of Michigan.

MEMORIES OF THINGS LITHUANIAN

"Daug, Daug Daineliu," more than any other phrase or object, carries me with a rush into that special place where memories of things Lithuanian live strong. I can still hear the voices of my mother and my aunt as they sing it and reminisce about their girlhoods in Lithuania. Had I been born into my husband's family, those memories would be primarily about food — which is, undeniably, an essential element in life, especially in Lithuanian life. And the very thought of a golden kugelis and /or virtiniai with their many possible fillings startles the taste buds into glorious anticipation. My husband often said that I would rather dance than eat, so I guess it is, for me, all about the music.

Among my earliest memories, Margutis Radio Hour fills our home with Lithuanian songs and brightens the days of my grandmother, who rocks in her chair remembering how she attracted my grandfather, ten years younger than she, because she so loved to dance and sing. Normally, a little austere in appearance, music made her face glow like the sun. And when my parents gathered with family or friends, it was a rare evening that didn't include raising their voices in song – even if it was only, "Gerkim po Lašuka. "

Undaunted by gas rationing and retread tires, our family moved from Chicago to Los Angeles via Route 66 (another musical memory.) We were welcomed by Msgr. Maciejauskas, who had rooms to rent in a large house that included a chapel, the beginnings of a Lithuanian parish. Our days there rang with the sacred songs of Holy Mass, and the strains of "Pulkim ant Keliu," still take me back. When we made our home in a smaller community, my parents sought out rich Lithuanian cultural experiences that were often provided by incredible singers such as Polyna Stoska and Helen Bartush Swaggert. And when a magazine came to our house with the music to "Kur Bakužė Samanuota," mom helped me learn this lovely, nostalgic song.

It is God's grace, obviously, that has brought me to this place in my life where I can indulge my joy in lovely Lithuanian melodies. The generous and gifted director of our Knights of Lithuania Choir, Faustas Strolia, granted me the opportunity to participate in the performance of music "For God and Country," While every program stirs my soul, our participation in two festivals in Lithuania created some of my life's

most outstanding memories. There, in those woods, rivers, and valleys, I has a palpable sense of what the songs I had learned were about. And when thousands of voices gathered from all over the world sang out, "Parveski, Viešpatie," my soul rejoiced, and heaven must have smiled.

POLICY GOVERNING KNIGHTS OF LITHUANIA SPORTS INVOLVEMENT

Per resolution passed at the 92nd National Convention.

Based on the findings of research into sporting activities conducted in the Fall of 2004 on the Council and District Levels, this policy regarding future "Sports Involvement" on the part of the Knights of Lithuania is adopted as policy.

- The Knights of Lithuania encourages sporting activities and sports teams on the council and district levels of the organization. This leaves it up to each individual council and district to choose the extent of their involvement with sports. However, should a council or district's sports activities include sponsorship of a team, the following guidelines are to be adhered to:
 - A. If a council or district sponsors a sports related event or team (i.e., basketball team, bowling team, etc.) of any sort, said council or district accepts responsibility for any and all expenses incurred and all legal liability issues. The manner that they establish by which to cover the expenses, is at the jurisdiction of the council or district.
 - B. If the team is competing in a tournament sponsored by an outside organization, all team members representing the Knights of Lithuania <u>MUST</u> be registered members, in good standing, of the Knights of Lithuania.
 - C. The team members are allowed to wear jerseys or shirts depicting the organization's national logo. Said logo is the <u>ONLY</u> logo that is to be used and may be obtained by contacting the National President, who will forward a copy of the logo in JPEG format.
 - D. If a district is sponsoring a sporting event, they set the rules for the event. Should non-members be allowed to participate, their involvement is at the discretion of the district. However, these participants may not wear K of L logos or be referred to as a K of L team.
- Districts and councils are encouraged to elect/appoint a Sports /Chair on their level.
- Should circumstances change in the future regarding the need for a national sports chair, members
 may petition the SC, in writing, to have a national chair elected. Petitioners must show proof of
 the need for the position to the SC before it can be presented to the delegates of a national
 convention for consideration.

91st Annual Lithuanian Festival Is Nation's Oldest

The 91st Annual Lithuanian Days, sponsored by the Knights of Lithuania, Anthracite Council #144, was held at the Schuylkill Mall, Frackville, PA, on Saturday, August 6-7, 2005. This event began in 1914 at then Lakewood and Lakesides Parks to bring together Lithuanian immigrants and their families for a day of culture, fun, and good fellowship. The Lithuanian Catholic Priests' League sponsored this.

It was held on August 15th, the Feast of the Assumption, a holyday of obligation until the end of World War II. At that time many mines would close so that the miners could participate in the festivities. After WWII it was held on the Sunday closest to August 15th to accommodate the young people who had left the area for better job opportunities. As many as 25,000 people attended the festival first held in Lakewood. When Lakewood closed, it moved to Rocky Glen Park.

After Rocky Glen Park closed, Schuylkill Mall very generously allowed the celebration to be held there. The Knights of Lithuania charities benefit from these days: the Church in Lithuania trough the Pontifical Lithuanian Seminary in Rome, the orphanages and schools in Lithuania, as well as the needy poor.

This year's celebration featured the Lithuanian "Zilvinas" Folk dancers of Philadelphia, and the world famous Malunas Lithuanian Folk Dance Ensemble from Baltimore MD. Participants enjoyed the Sing-a-longs with Lynne Cox, accordionist. The Famous Sensations Band played here for the first time.

Two Lithuanian freedom fighters made their appearance and spread the story of the goals and courage of their counterparts in reality who fought and gave their lives for Lithuanian freedom. Specially honored were the anthracite miners of Pennsylvania for digging the coal that melted the steel that built the railroads that pushed America into high gear during the Industrial Revolution.

The traditional Lithuanian food, arts and crafts were available. Information was available at the Lithuanian tables for Heritage and genealogy, Lithuanian Internet information, and much more. One could learn how to etch Lithuanian eggs, "Marguciai" or create natural straw decors "Saudininkai" or even do mushroom art.

Lithuanian Days in Pennsylvania is the longest running consecutive ethnic festival in the United States.

The women brought gifts and food and the men, home-brew and hard liquor. The women decorated a chair with a garland of fresh branches and flowers. Three men lifted mom and sister three times. Eating and merrymaking began and lasted until late evening. Being late June, all went outdoors. We lived close to the center of town and a stone's throw from the police station. Our good neighbors did not call the police to break up the party, possibly wanted to join us."



ITS 91ST ANNIVERSARY



The first Lithuanians began to arrive in Athol in the late 1880's. They left their Russian dominated homeland to avoid being drafted into the army, to better their living standards, to enjoy freedom of the press and to be able to freely use their language, and above all else, to enjoy their ethnic heritage and Catholic religion without suppression.

The first Lithuanian to arrive in Athol was, Jonas Braska, followed by Antanas Andraliunas, both from Vabalninkas parish, as were the majority of the Lithuanians that followed.

Realizing the need of being organized, they formed societies, and St. Francis parish for their spiritual and material betterment. It is worthy to note, that Rev. Juozas Montvila had agreed to come to St. Francis as their first pastor, but all were saddened on the news that he went down with the "Titanic." The K of L was founded by Mykolas Norkunas on April 25, 1913. The K of L took quick root and Athol was granted a charter on May 29, 1914.

At the first organization's meeting held in the old Eagle hall, 98 young Lithuanians joined Council 10, at which time the speaker was Norkunas. Pastor, Francis Mekškauskas was named spiritual advisor, and Domininkas Karoblis, president. Dues collected were \$3.25, and a collection netted \$3.37, and a gift from the pastor gave the treasury \$16.72.

The newly formed Council was a beehive of activity. English classes were held, picnics, dances and concerts were the norm. A drama

club was directed by Antanas Losius. On Aug. 24, 1914, a library was established on Exchange St. Members bought Lithuanian bonds after World War I, to help their war devastated homeland. The first member to die was, Emilia Vinciunas. The most active members in the early days were, Pres. Karoblis, Ladis Matulis, Jonas Gailiunas and Antanas Losius.

In later years, with the second generation, Council 10 parties paled in the NED basketball and bowling tournaments. The local girls' bowling team were District champions from 1927 to 1930.

In years past, the council made many more large gifts to the parish, and were famous for their winter carnivals and annual Mother's Day programs.

The Council lost many members during World War II, as the boys were called into the service. Membership fell, and in 1952 a group from neighboring Gardner joined, and to this day work together.

Our motto, "For God and Country" is well-lived, as each year we celebrate the feast of our patron, St. Casimir, and sponsor Lithuanian Independence Day and a supper to benefit their charities. Our annual "kūčios," could be called our highlight.

Many happy marriages were sealed through the K of L.

Howard Beaudette organized a Youth Day in 1963, including a street parade by the AmericanLegion, the local K of C participating, Now ...



that marched to the War Memorial and held services. Brone Wisniauskas, Cultural chair, has done an excellent task of promoting Lithuanian culture in the area. We are proud of our K of L professionals and business persons; Dr. Henry Gailiunas, pharmacist Alec Kuzmickas, Richard Genaitis, owner of Rite Media, Richard Gatautas, realtor, James Krasauskas, owner of Anthony's Package store, Dr. Marie Shatas, Dr. Jackie Doherty, who also was recently elected to the Athol School Board, Marie and Tom Colo, owners of Athol Glass Co.


