





Knights of Lithuania 93rd National Convention State of the Organization Report

In accordance with Article XI, Section 2 of the Knights of Lithuania Constitution which states that the President prepares the Annual State of the Organization Report, the following is a summary of all reports that have been submitted. All delegates are urged to take home a set of these reports, read them and share the contents with your Council members.

Spiritual Advisor - Rev. Msgr. Joseph Anderlonis, STD, HM

- Msgr. Joe hosted the Supreme Council meeting in May 2006 with the assistance of Council 3.
- Monsignor also traveled to Lake Buena Vista, Florida in December 2005 to attend the Supreme Council meeting held there.
- A monthly Mass is offered by Msgr. Joe for deceased members of the Knights of Lithuania.
- Monsignor has always made time available to meet with the President when the necessity arose. Monsignor's counsel and advice have been most helpful.
- We are very grateful to Monsignor for his continued friendship and support.

President - Agnes V. Mickunas, HM

- I presided over three meetings Pittsburgh, PA; Lake Buena Vista, FL; and Philadelphia, PA. The final meeting was held here at the Grosvenor yesterday, August 2.
- During the year I handled correspondence as it arose. I received invitations to participate in meetings sponsored by other Lithuanian organizations. On behalf of the Knights of Lithuania I extended greetings to each of them.
- Traveled to North Jersey with Irene Ozalis, the newly elected Chair of the K. of L. Foundation, and assisted with the orderly transfer of the Foundation's assets and records to her care.
 Ellie Nakrosis also assisted in this process. We are grateful to Ms. Ozalis for accepting the responsibility to Chair the Foundation and are

most thankful to Loretta Stukas for accomplishments realized during her tenure as Chair.

 I am pleased to report that the Vytis is being printed and mailed in a timely and efficient manner. To date, I have received positive feedback on the VYTIS issues that have been produced since the changeover that began with the December issue.

Sister Janine, our former Vytis Editor, unfortunately had to resign her position because of additional responsibilities as Co-Vocation Director of the Sisters of St. Casimir. 


Our Convention Plenary Sessions



College of Worcester for Pre-medical studies. Erin will receive a \$1,750 scholarship from the Sviklas-Tamulevich Scholarship Fund.



Subject: Change Terms Lengths Supreme Council Trustees

We, the Presidents of the Amber, Mid-America, Mid-Atlantic, and New England Districts, present this proposed change to the constitution regarding the term of office of Supreme Council Trustee& We have presented this to the members of the Supreme Council during their meeting on May 6, 2006 in Philadelphia, PA at which time they voted to endorse it as well. We now present it to you our membership for your consideration.

WHEREAS, the constitution currently calls for two trustees as members of the Supreme Council; and said trustees to be elected each year allowing for three consecutive terms per trustee, this has caused from time to time for the trustees to be elected concurrently, which does not allow for proper training of the trustees from a senior elected trustee to a junior elected trustee. And as currently the duties of the trustees include the auditing of all nationally held funds which is a most important service to the organization and is deserving of having an experienced trustee in office at all times.

THEREFORE, BE IT RESOLVED.... That the delegates of the 93rd National Convention vote to change the term of each trustee to one consecutive term of three years and these terms not to be served concurrently. And that in the event of a trustee's resignation, their replacement only fulfills the remaining term.

If passed by the delegates of the 93rd National Convention this resolution takes effect with this year's elections allowing for one trustee to be elected to a two year term and one to be elected for a full three year term so that the proper rotation process can be implemented.

This resolution will change Article X, paragraph 4 of the Constitution to read;

A Supreme Council Officer is elected for a one year term and can succeed himself or herself for only two additional successive years, except for Trustees who will be elected for three year terms and these terms not to be served concurrently



Aid to Lithuania, Inc.

On behalf of Robert Boris, HM, Founder and Chairman of the Board of Directors of Aid to Lithuania, Inc., I extend his, the Board of Directors and the Officers' greetings to all of you gathers at the 93rd National Convention. Bob sends his sincerest regrets of not being able to participate in the Convention business and has asked me to address the National Convention and present the ATL annual report.

Last year when I presented the annual report to the delegates in Pittsburgh, the original site of the formation of the ATL committee in 1990, I announced that ATL was celebrating its 15 years of assisting our less fortunate brothers and sisters in Lithuania. A request for continued financial support was made on this special occasion. And, again, as always, the Knights of Lithuania and their friends came through. During last year's convention, \$15,203.00 was donated; several donations arrived after the convention. A total of \$15,748.00 was received. What a wonderful sum to mark ATL's anniversary! Thank you for your kindness, generosity and continued emotional and spiritual support and financial assistance. special thanks and acknowledgement is due to ATL's Board Member, Robbie Martin, for preparing the 15th anniversary issue of the annual ATL newsletter. His gift of time.

professionalism and creativity are truly appreciated, and we thank you, Robbie, for your efforts in preparing the annual newsletter into a beautiful keepsake memento of the history of ATL, its projects and accomplishments.

Since its inception 16 years ago, 92 forty foot long containers of vitally needed medications, medical supplies and equipment, computers, clothing, have been shipped to Lithuania. To get these supplies to the people most needing them, ATL pleaded for your support and you responded wholeheartedly. No shipments were ever turned down due to ATL not being able to pay for the transportation costs. When the financial well went dry temporarily, an "Angel" was found to help fill in up. In some cases, the very medical organizations contributing the supplies saw our desperation and funded the shipments. The contents of St. Peter's Church in Detroit were shipped to Rev. Leonas Jakimavičius in Alytus for his new church, Our Lady, Help of Christians Church. The contents consisted of pews, altars, statuary, liturgical vestments and a pipe organ. Also, the pews, statues and Stations of the Cross from St. Casimir's Church in Pittsburgh and the pews, which seated 1,200 people from Our Lady of Sorrows Church in the Detroit area, were shipped to Bishop Juozas Žemaitis in Vilkaviškis. The total dollars' worth of these containers in an incredible and astounding \$72,000,000.00! Who could have and would have thought at that time that so much could and would be accomplished?

The contents of the subsequent containers were distributed to: Caritas-Kaunas, Vilnius and Marijampole, St. James Hospital in Vilnius, the University of Vilnius Hospital in Vilnius, Kaunas Catholic Maternity Hospital in Kaunas, St. Clare's Hospice in Utena, the Children's Day Center-"Angel of Hope" (Angelo Vilties Centras) in Vilnius, the Family Center in Vilnius, Betanija Soup Kitchen in Vilnius.

The major source of the donations of medicine, Catholic Medical Mission Board in NY, has not been able to provide medications for the last 4 years as the medicines continue to be diverted to nations most in need and those that have suffered devastation and tragedies.

Due to the non-receipt of medicines and medical supplies, and lack of container shipments, ATL refocused its purpose for the humanitarian aid program. New needs emerged and we were called upon to further respond to them. On an ongoing basis, ATL provides financial assistance to the following Caritas programs: the Betanija Soup Kitchen, the "Angel of Hope" Day Center (Angelo Vilties Centras) and the Mothers and Children's Center. Donations to youth programs, parishes needing help or sponsoring events are made by donor requests or specific bequests.

The second ATL sponsored program in the Seminary Fund. Future priests are prepared to meet the challenge of Lithuania's great need for spiritual renewal. ATL, in cooperation with the archbishop of Vilnius, Audrys J. Cardinal Bačkis, initiated a program, whereby a seminarian studying at the St. Joseph's Seminary in Vilnius, would be "adopted" by donors willing to provide an annual scholarship of \$2,000.00/per for 6 years of studies. Enrollment is down from 80 students. There are approximately 60 students enrolled in the seminary. Since its inception in 1999 until May 20th of this year, there have been 101 adoptions at \$2,000.00 each, 229 misc. donations (under \$2,000.00), the establishment of the Baronas Family Scholarship Fund and the newly established Krizinauskas/Schuvacage Scholarship Fund. The total amount received in the last 7 years totals \$456,594.74. Since 2002 to present. 18 young men were ordained priests. Of these, 3 were ordained priests during the 2005-2006 fiscal According to Cardinal Backis, currently there are 116 diocesan priests in Vilnius, while 10 years ago, there were approximately 100. Moreover, the priests are very young. Cardinal Backis states that 65% of the priests are less than 40 years old. "The age of the clergy will not be so important for the future as the fact that they are faithful to their vocation and are apostles of the new Evangelization, "Cardinal Backis stated during a recent interview with ZENIT after participating in the adlimina apostolorum visit of the Bishops of the Episcopal Conferences of Estonia, Latvia and Lithuanian in June.

Last November, Mgr. Anne Krizinauskas, Retired USA, a staunch supporter and benefactor of the St. Joseph's Seminary made a substantial donation of \$50,000.00 for the establishment of the Krizinauskas/Schucavage Scholarship Fund for deserving seminarians in the 3rd, 4th and 5th year of studies at the St. Joseph Seminary in Vilnius.

ATL's third sponsored program is Mother Teresa's Homeless and Emergency Shelter, which opened

its doors in the Fall of 1999. Mother Teresa's Homeless and Emergency Shelter continues to provide religious and humanitarian aid activities. The Shelter provides room, board and meals to approximately 125 homeless people in Vilnius. The sisters render medical, material and spiritual assistance and guidance to the individuals. The homeless, those who are capable, can prepare their own meals in the kitchen, launder their clothing, socialize with others, read the press, and watch television. The Shelter provides a safe and warm haven for adult males and females who have little or nothing. The Sisters medically treat and care for the residents on the Shelter. They also help the individuals complete and prepare various documents, provide the sick with the most needed medication, assist in getting the ill hospitalized and assist the ill in renewing their relationships with family and friends. On Sundays Sisters organize religious studies and activities. During the last fiscal year \$7,500.00 was donated to the shelter; of that sum, \$2,000.00 was designated for Easter meals for the residents of the shelter, who, otherwise, would not have had any Easter celebration and gathering with others.

The Vilnius Handicraft Centre (Vilnius Trade School) is ATL's 4th program. The Trade School opened in 2001. Currently there are 18 students from large families, those who are somewhat physically or mentally challenged and some adults study and live I the facility. The trade school established the following curricula: culinary arts. wood carving, art and furniture restoration, sewing, knitting and crocheting, metal work, printing, electrical work, auto mechanics, jewelry repairs and computer programming. The culinary arts program is by far the most popular of the studies. The practical work is done next door to the Trade School, where the Betanija Soup Kitchen is located. Local masters in their respective area of expertise teach the students a skill so that they can become independent and employed adding to the success of Lithuania today.

During the 2005-2006 fiscal year, ATL dispersed various donations in Lithuania. For the General /humanitarian fund, \$2,000.00 was sent to the Betanija Soup Kitchen for Easter meals; \$250.00 was given to the "Vilties Angelo" Centrui (Angel of Hope Day Center); \$200.00 was sent to the Mother and Children's Center; \$9,000.00 was slated for the Telšiai Seminarians; St. Clare's Hospice in Utena, where Sister Dolorita Butkus and Sister Michele Garas of the Sisters of St. Francis Providence of God continue their mission,

\$1,000.00 was designated. \$13,710 was sent to Cardinal Bačkis for the seminarians studying at the St. Joseph's Seminary. \$7,500.00 was designated for the Mother Teresa's Homeless and Emergency Shelter. Of that sum, \$2,000.00 was used to provide Easter meals for the local homeless people. \$7,500 was forwarded to the Vilnius Trade School. In all, \$41,710.00 was distributed among the 4 funds ATL supports. Again, thanks to all of our ongoing supporters for your continued generosity.

Last year ATL was fortunate to receive donations through the estates of generous benefactors. The estate of Dr. Aldona Rugis, M.D., of Florida, designated \$3,000.00, which was slated for the Mother Teresa's Homeless Shelter; and \$5,000.00, which was received fro the estate of Vladas Jomantas of Detroit, which was designated for the Vilnius Trade School.

Last fall, Victoria Wintersberger of Brookfield, Wisconsin, read about the K of L organization and ATL on the internet, joined the organization and sent a generous donation of \$5,000.00 in support of the Telšiai Seminarians. Truly an unexpected member and a most surprising and generous gift!

ATL's primary sources of income are derived from donations that are received at the K of L National Convention, the ATL annual newsletter, councils and districts that solicit donations during the Lithuanian Independence Day (February 16th) commemoration, and in memory of deceased family and friends. Some donations are still received as a result of employer matching funds and from estates of deceased K of L members or friends. In the past, ATL received several generous donations through stock issues.

ATL's most notable achievement over the last 16 years is getting people involved. High level personal involvement and volunteerism from all corners of the United States has sustained its mission. It is individuals' voluntary commitment and participation coupled with donor generosity and the ongoing support of the Knights of Lithuania that has brought about outstanding success.

If ATL is to continue this great work of Christian charity, we must <u>all</u> participate, work together harmoniously and support each other's efforts. Please continue to reach out and support the ATL program of your choice.

In closing, ATL is appreciative to all the delegates of the 93rd National Convention, Supreme Council, local councils and districts for your ongoing support, counsel and camaraderie.


Candidates were presented at the Altar by Lee Moore, Ritual Chair and Georgianna Macke and Lillian Greymas, members of the committee.
